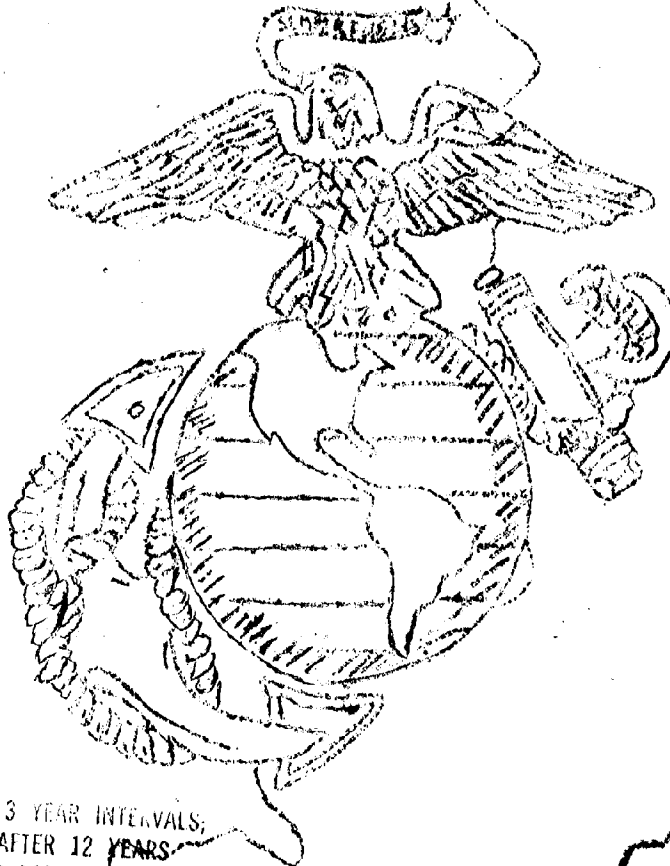

C. Problem Areas/New Developments.

1. The continued shortage of Officers still exists with twelve required to bring the Battalion up to T/O. There is an Enlisted shortage in the O1 field with ten needed to bring the Battalion up to T/O. There is a shortage of Enlisted in the MOS 0369 with twenty needed to bring the Battalion up to T/O. There is an Enlisted shortage in MOS 0351 with 53 needed to bring the Battalion up to T/O.

F. Morale, PX, Postal Affairs, Liberty, R&R.

Morale is excellent. The Battalion remained at the Dong Ha Combat Base for the entire month. At Dong Ha, showers were available, hot "A" and "B" rations were served, and the clubs maintained a supply of liquid refreshment. PX facilities were available to all hands. Liberty was not authorized during the month due to the tactical situation. R&R was not utilized during the month due to pending rotation of the Battalion to Okinawa. Postal facilities continue to be satisfactory with some delays due to flight cancellations during periods of heavy rains.

G. Chaplain's Activities.

The Chaplain, Lt Stephen E. ALMASY, conducted a total of 28 Masses in the month of October. The locations, dependent on where the troops were, ranged from Dong Ha to Cam Lo. On 4 Oct 1966, the Chaplain went to the USS Repose visiting all 1/4 patients aboard. Two Memorial Services were held, one for Company "D", 1/4 and another for 3/4. Civic action was continued with the Vietnamese Church in Dong Ha with donations of soap and clothing. The Chaplain assisted the doctor in caring for two critical cases affecting the staff of the school. Instructions and counseling continued throughout the month with personnel of 1/4 and any others who were seeking assistance.

APPENDIX: Supporting Documents.

INTELLIGENCESECTION IIIA. General.

The Battalion was engaged in the defense of the DONG HA Combat Base, during the reporting period. In addition the Battalion had the mission of security for the Bulk Fuel storage area at the mouth of the CUA VIET river (YD346698). The bridge located at YD148604 was provided security during the reporting period.

Enemy contact during the reporting period was light. The largest sighting was of 5 VC/NVA at 192250H made by a "B" Company defensive position.

There were no VC/NAV KIA's confirmed or probable during the reporting period.

One Thompson Submachine Gun and 3 magazines plus miscellaneous gear were captured after a Security Detail for a civilian Survey team had come under VC/NVA sniper fire. Weapon and miscellaneous gear found after VC/NVA fled area.

C. Weather and Terrain

1. The weather for the reporting period consisted of rain on numerous occasions. On one occasion flooding of the Cam-lo river caused displacement of the Platoon defending the bridge located at YD148604. The heavy rains caused the defensive positions around DONG HA Combat Base to be rebuilt above ground level. Heavy rain did not seriously hamper vehicular traffic in or around the DONG-HA Combat Base. On the days where there was no rain the sky was generally clear and sunny.

2. The Terrain in and around the DONG HA Combat Base consisted of rice paddies, populated areas and the SONG HIEU GIANG River to the North. To the Northeast of DONG HA Combat Base is Highway #1. To the North and West is Highway #9. A Junction of the two highways is located at YD243600, approximately 700 meters Northeast of DONG HA Combat Base. Loose surface roads connected all points of DONG HA Combat Base.

The bank at the mouth of the CUA VIET River encountered a sandy beach area. The terrain at the position on the Bridge Defense consisted of rice paddies and the SONG CAM LO River, which runs from West to East. A loose surface road runs Northeast through the Bridge Defense position.

During the period 1-31 October, 1st Battalion, 4th Marines participated in Operation PRAIRIE, Missions assigned were as follows:

- 1-31 Oct (1) Defense of the Dong Ha Combat Base
(2) Coordinate defensive efforts of all Forces within the Dong Ha Perimeter.
- 1-6 Oct Maintain one (Rein) Platoon as Rapid Reaction Force on 10 minute alert and remainder of the Company on one hour alert.
- 6-10 Oct Provide one rifle company as security for the Artillery Battery at CON THIEN, Grid Square (YD 1170).
- 10-31 Oct Provide one rifle company as security for the Naval Supply Activity at the mouth of the CUA VIET RIVER; (YD 346698).
- 19-31 Provide one rifle platoon (Rein) as security for bridge located near CAM LO (YD 344698).
- 24-31 Oct Maintain one Platoon (Rein) as a Reaction Force on a 15 minute stand-by.
- 29-30 Oct Provide one rifle company (Rein) as security for a grounded vessel at Grid Square YD 5452.

Summary of Operations/Activities

On 1 October 1966 this Battalion was relieved by the 2d Battalion, 9th Marines at the THON SON LAM area in Grid Square XD 9756.

All Companies of the Battalion returned by motor convoy to the Combat Base at DONG HA and assumed the mission of perimeter defense.

Task Force Delta designated this Battalion, the Combat Base Defense Coordinator. Several days were spent in improving positions and coordinating the other units manning sectors of the lines.

At 061200H October one reinforced platoon from Company D, Task Force Delta departed by Helo from DONG HA Combat Base to CON THIEN, Grid Square YD 1170 to provide security of an artillery position located thereat. The remainder of Company D followed at 071320H and were placed under OpCon of the 2nd Battalion, 5th Marines. With the assignment of Company D to the artillery position, Task Force Delta assigned the reaction company requirement to the 3d Battalion, 4th Marines, at 071455Z October. At 061820H Company A was notified to have one platoon (Rein) on standby as the Battalion Reserve. At 101400H October 1966 Company D returned to DONG HA from CON THIEN.

At 100915H a Platoon (Rein) from Company A under Operational Control of Task Force Delta took up defensive positions at the mouth of the CUA VIET River, Coordinates YD 346698.

This platoon was to provide security for a Navy Support Activity which was being established at the river mouth. The remainder of Company A joined the platoon at 102130H.

At 110730H October 1966 a (Rein) Platoon from Company B provided security for the 1st platoon "A" Company, 3d Tank Battalion from DONG HA to CON THIEN to join the 2d Battalion, 5th Marines. The unit returned at 111708H October, 1966 after being ordered back by Task Force Delta because of an ambush sighted by an AO.

Again at 120720H October a (Rein) platoon from Company B escorted the 1st platoon "A" Tanks to CON THIEN. The Tanks were ambushed at YD 136667 at 121130H October 1966 by an unknown number of enemy. Five VC KIA were confirmed with the capture of enemy weapons and ammunition. The Company B platoon returned to the DONG HA Base at 121900H October 1966 by Helo lift.

At 151538H a Reinforced Squad with an Arty FO was sent from Company D to provide security at a bridge near CAM LO (YD 148604). This squad was relieved by a unit from the 3d Battalion, 4th Marines and returned to DONG HA Combat Base at 161630H. Again a Platoon (Rein) from Company D was assigned as security for the CAM LO Bridge relieving the 3d Battalion, 4th Marines unit at 191100H.

At 221135H October 1966 storm warnings were issued by the 3rd MarDiv G-3 of approaching rains and strong winds. Company A (-) at the mouth of the CUE VIET River was evacuated back to the DONG HA Base arriving at 221815H. Two squads of Company A remained in position. At 221635H, the Platoon from Company D, which was guarding the bridge at CAM LO was evacuated to the ARVN compound at CAM LO because of rising water. The platoon again returned to the Bridge at 250720H.

At 240700H a Sparrow Hawk Platoon from Company A was Helo lifted to Grid square YD 1169 to provide security for a downed helo. The Sparrow Hawk returned at 241453H.

At 240800H the 1st Battalion, 4th Marines reverted to OpCon 4th Marines.

Company A started returning to the mouth of the CUE VIET River at 241530H arriving at YD 346698 at 241725H.

A platoon from Company B providing security for a civilian survey party received 5 rounds of enemy S/A fire at 251350H from coordinates YD 253552. S/A fire and grenades were returned. The VC fled leaving a Sub-machine gun, several items of 782 gear and 2 packages of documents. The security detail for the surveyors the following day also received sniper fire. Arrangements were made with MAG-16 to have a gunship standing by in case of further sniping at the survey parties.

At about 281830H October 1966 the Battalion Commander made an aerial recon in Grid Square YD 5452 of a grounded Vietnamese Cargo Ship. The aerial recon received fire and it was decided to commit a Reinforced Company for the protection of the vessel. The Reaction Force was comprised of 2 Platoons (Rein) from Company D, 1 Platoon (Rein) from Company B, 2 81mm Mortars and crews, 2 106mm RR and crews, 4 .50 Cal. Machine Guns and crews, along with Artillery, FAC, and NGF teams for a total of 231 Marines. The Reaction Force was helo lifted from DONG HA Base to Grid Square YD 5452, the first lift arriving about 282045H and the last of the unit arriving about 282330H.

Defensive positions were dug in and consolidated during the night of 28 October and the morning of 29 October. The vessel was boarded early in the morning of 29 October 1966, papers were examined and the vessel searched. All was found to be in good order. The ship had been hauling fertilizer for the USAID. The ship's captain and crew were all Vietnamese civilians.

The provisional Company returned to LONG HA Combat Base by Helo at 301106H October 1966 after being relieved by a unit from the 2d ARVN Regiment.

At 1400H on the 31st of October 3d Battalion, 7th Marines relieved 1st Battalion, 4th Marines of all assigned missions.

The month of October closed with the preparations and planning for the movement of 1st Battalion, 4th Marines to the Phu Bai area on 2 November.

Training.

Training consisted primarily of Orientation of newly joined personnel in such subjects as customs and culture of the Vietnamese and the rules of engagement. Some of the local patrolling was done with the aim of training newly joined personnel as well as security. Classes and training with crew served weapons was stressed as much as possible, and field firing was accomplished on a limited basis. A flame thrower Section was organized and received training which included one afternoon of firing. There were some classes on the general subjects particularly aimed at newly appointed junior NCO's in such subjects as Map Reading and the five paragraph order.

The Communications Platoon conducted training mainly consisting of maintenance and normal operation of the Comm Equipment. A limited amount of training was held on the MARC-83 and PRC-47.

Motor Transportation conducted drivers training resulting in the licensing of 34 drivers.

SECTION V

1. LOGISTICAL SITUATION

a. On 1 October the Battalion returned from the "ROCKPILE" (THON SONLAM AREA) in connection with Operation PRARIE and assumed defense duties at DONG-HA Combat Base. This included providing one company at the CUA VIET River, (Beach area), and one reinforced platoon at the CAM LO Bridge for security purposes.

b. Resupply was accomplished by LCU to the "Beach Area" and by vehicle to the bridge area. The method of using an LCU is considered adequate but water shortages caused minor difficulties due to its non-availability at CUA VIET.

2. SUPPLY

a. Supported Strength. 924 personnel

b. Supply

(1) Class I - Over 24,000 MCI's were issued, these were supplemented by fruit juice and at least one meal of "Alpha" rations daily to units deployed at CUA VIET and CAM LO Bridge. Sundry packs were issued as appropriate.

(2) Class II - Clothing and boots were issued as appropriate.

(3) Class III - POL provided consisted of 110 gallons of Diesel and 50 gallons of MOGAS daily.

(4) Class IV - Limited quantities of Class IV was received during the reporting period.

(5) Class V - B/A's and DOA's were maintained as appropriate.

3. EVACUATION and HOSPITALIZATION. See Section IX

4. TRANSPORTATION. One truck has been provided this Battalion for housekeeping and resupply. This proved to be inadequate and was supplemented by the use of "Mighty Mites" and "Mules".

5. SERVICE. Not applicable

6. MISCELLANEOUS. Elements of the Battalion located at DONG-HA Combat Base have sanitation problems due to low areas and cramped facilities provided.

COMMUNICATIONS/ELECTRONICSSECTION VI

A. OPERATIONS. THE COMMUNICATIONS PLATOON CONDUCTED NORMAL OPERATIONS IN SUPPORT OF BATTALION OPERATIONS THROUGHOUT THE MONTH. ELEMENTS OF THE BATTALION LOCATED WITHIN THE DONG HA COMBAT BASE WERE SERVICED BY THE INTERNAL BATTALION TELEPHONE SYSTEM WITH ENTRY INTO THE III MAF TELEPHONE SYSTEM. TACTICAL RADIO COMMUNICATIONS SUPPORT FOR THE ENTIRE MONTH WAS VIA THE BATTALION TACTICAL NET (VHF) EXCEPT FOR THE DEPLOYMENT OF "D" COMPANY, 29-31 OCT 1966, WHICH REQUIRED ACTIVATION OF A HIGH FREQUENCY (HF) TACTICAL NET FOR DIRECT COMMUNICATIONS.

1. RADIO. RADIO COMMUNICATIONS FROM THE BATTALION COMMAND POST, LOCATED AT THE DONG HA COMBAT BASE, (COORD 241598) TO ELEMENTS OF THE BATTALION DEPLOYED TO THE MOUTH OF THE COU VIET RIVER GRID SQUARE 3469 AND TO THE CAM LO BRIDGE (COORD 148604) WERE NORMAL. DISTANCES INVOLVED, APPROXIMATELY ELEVEN MILES AND SIX MILES RESPECTIVELY, REQUIRED THE USE OF RC-292 ANTENNAS AT EACH LOCATION TO ASSURE RELIABLE COMMUNICATIONS. ON THE NIGHT OF 28 OCT 1966 "D" CO (-) (REIN) WAS DEPLOYED TO A POSITION (COORD GRID SQUARE YD 5452) ON A "SPARROW HAWK" MISSION. DIRECT FM (VHF) COMMUNICATION FROM DONG HA TO THIS POSITION WAS NOT POSSIBLE WITH EITHER

THE AN/PRC-25 OR AN/MRC-109 FM (VHF). RADIO COMMUNICATIONS WAS MAINTAINED BY RELAY THROUGH "A" COMPANY. BECAUSE OF THE DISTANCE INVOLVED IN THE DEPLOYMENT AN/PRC-47 WAS DEPLOYED WITH THE COMPANY. AN HF NET WAS ESTABLISHED AND SATISFACTORY COMMUNICATIONS WAS MAINTAINED.

2. WIRE. WIRE COMMUNICATIONS WAS NORMAL DURING THE MONTH. A LOCAL WIRE SYSTEM WAS INSTALLED TO SUPPORT THE DEFENSE OF THE CAM LO BRIDGE IN ORDER TO COORDINATE ATTACHED SUPPORTING ARMS AND TO CONTROL ELEMENTS OF THE PLATOON DEPLOYED ON OPPOSITE BANKS OF THE RIVER. FOUR (4) LINES WERE INSTALLED ACROSS THE RIVER: TWO (2) ACROSS THE BRIDGE AND TWO (2) SUBMERGED. THIS WAS DONE TO INSURE CONTINUOUS WIRE COMMUNICATION SHOULD THE LINES ACROSS THE BRIDGE BE DESTROYED BY MORTAR FIRE. SUBMERGED LINES AFFORD A MEASURE OF PROTECTION AGAINST MORTAR FIRE. THE LINES WERE COMPLETELY WASHED AWAY ON 23 OCT 66 WHEN THE RIVER FLOODED AND WERE RE-INSTALLED ON 28 OCT 66.

During the month of October 1966, members of the 1st Battalion, 4th Marine Regiment Medical Department continued to help man and operate "E" Medical Company, a Collecting and Clearing Company located in Dong Ha. Working under the direction of the 4th Marine Regimental Surgeon and in conjunction with the Battalion Surgeons and Hospital Corpsmen of 3/4, 2/5, 3/7 and 2/9, the personnel of the 1st Battalion, 4th Marines Medical Department set up an effective triage center for the treatment and evacuation of all wounded in the Dong Ha TAOR. This Battalion also had the responsibility of resupplying and providing administrative support for "E" Medical Company.
4. There have been 545 laboratory examinations performed during the month of October. These included all laboratory procedures, and of these 102 proved positive for malaria. There were 35 positive cases of Gonorrhea in the Dong Ha area, none of which came from 1st Battalion, 4th Marines.


