## PART II

~~DECLASSIFIED~~NARRATIVE SUMMARY

At the beginning of January the 1st Battalion, 4th Marines continued its mission of search and destroy while part of operation SCOTLAND II. In accordance with Operation Order # 10-68, Co. "A" provided security for each of the following Fire Support Bases; Neville, Russell, and Mack. Companies "B", "C" and "D" continued to search out the area surrounding Nui Tia Pong, while Co. H&S (-) provided Battalion Command Post security at LZ Gazelle and conducted local security patrols.

On 1 January 1969, patrols from Co. "C" found bunkers and mortar pits in the vicinity of Grid XD 859569 and after a thorough search unearthed 27-82MM mortar rounds and one can of fuzes. Later in the day, at grid XD 844556, another patrol from Co. "C", while searching out a cave complex, found various medical supplies including, Stroptomycin, penicillin, Strychnine and Iodine.

The afternoon of 2 January found a Co. "C" patrol engaged by an estimated enemy squad at grid XD 853575. Air and artillery were called in resulting in three secondary explosions. Searching out the area after the strikes, the patrol found one body, severely burned, and 1 AK-47 rifle. The patrol suffered no casualties.

At 1000 on 4 January Co. "D" found 2 armed ChiCom mines, at grid XD 895536. An hour later a patrol from Co. "C" set off a booby trapped mine resulting in 1 killed and 1 wounded. At 1600, while searching out the area of the previous days fire fight, the same patrol found 4 NVA killed by M-79, M-60 and M-16's. Again on 5 January a Co. "C" patrol discovered 5 bunkers with mutually supporting command detonated mines. All the mines were booby trapped with pressure release devices. Numerous trails were in the area, grid XD 847573, and at least one of these was found to be mined.

Company "C" continued to search out this particular area, and uncovered, on 6 January an NVA Battalion Command Post site. Four large (12'X10'X6') storage bunkers were discovered and a total of 50 Tons of Rice was discovered. Also 30 ammunition bunkers, containing 300-82MM increments, 13-82MM mortar propaganda rounds, 150 cans of arming devices, 25 RPG rounds, 240 RPG increments, 65 boxes of 12.7 MM ammunition, 250 pounds of TNT and 30 booby trap devices.

Later the patrol found an additional 200 pounds of salt, a requisition form from enemy Battalions and a weighing scales

At 1415 on 9 January, the Alpha Command Group began the helo-lift to hill 715 North (LZ Cougar) and established the Battalion Command Post. Company "D" was lifted into the same LZ and commenced movement in a northerly direction. H&S (-) established CP security. Co. "B" at grid XD 841584 found a bunker complex containing the following munitions, 3-82MM mortar rounds, 1 RPG-7 round, 13-60MM mortar rounds, 100 pounds of rice and assorted small arms ammunition. At 2114 Co. "D" at grid XD 850595 had one man trip a booby trapped NVA Claymore mine. Result: 1 friendly KIA.

The line companies continued extensive patrolling activities in the general vicinity of Dong Long and uncovered several more important caches. On 10 January Co. "B" at grid XD 837586 found 36-82MM recoilless rifle rounds with Russian markings, 51-82 MM mortar rounds with fuzes and increments.

In order to increase the strength of the defenses at the fire support bases, a provisional platoon from H&S 1/4 at Vandegrift Combat Base was lifted to FSB Neville and Chopped OpCon to Co. "A", 1/4. Also FSB Mack was closed and that unit was sent to FSB Russell to bolster that position. Upon arrival of these units, Co. "A" conducted extensive long range patrolling from FSB Russell and FSB Neville, besides providing security for the artillery units located thereon.

At 1342 on 10 January, Co. "B" at grid XD 835587 found 6-60MM mortar rounds, 150 pounds of polished rice, this and the previous gear was lifted to the Battalion CP area and evacuated to Vandegrift Combat Base.

On 11 January, both caches, Co. "C" and Co. "B" were lifted to VCB allowing both companies to continue their mission of search and destroy. Also, Co. "D" at grid XD 837594 made contact with an estimated NVA platoon, they returned small arms fire and called in 81MM Mortars and artillery. Results were 3 friendly WIA.

The following day, Co. "D" found a bunker complex of 30 units. Searching the area they found assorted medical gear, 150 pounds of rice, 42-82MM mortar rounds, assorted 782 gear and equipment. The patrol destroyed all positions and gear.

On the 13th at 0800, the Bravo command group was activated and awaited lift to LZ Russell. Co. "C" was helo-lifted to hill 477, LZ Catapult, as the movement remained generally oriented to the North and West. As the first helicopter set down, it exploded a trip wire type booby trap.

The "bird" was damaged and unable to fly. The crew was evacuated and 1 helo team from Co. "C" commenced to clear the LZ of more mines. The rest of the lift was completed and a helo-recovery team arrived to prepare the downed "bird" for extraction.

Searching the area of grid XD 829602, Co. "D" found assorted 782 gear and clothing of approximately four people. The clothes were blood stained and showed signs of profuse bleeding. Later at 1725, Co. "D" found three fresh graves and three bodies. All had died from shrapnel wounds. One body was carefully wrapped, marked and buried, perhaps indicating an officer. These deaths were directly related to "D" Co. contact on 11 January.

As Co. "C" Patrol left the lines on 14 January, the point man set off a D1-10 directional mine. Further down the trail were more mines placed to cover the width and length of the trail. Two friendlies were wounded as a result of the explosion. Later a "D" Co. patrol at grid XD (30005 found 40-82mm mortar rounds, 7 cans of increments and six fuzes. Nearby the same patrol uncovered 16 bunkers, 1 Chinese Claymore mine, 2-1 pound blocks of TNT and 1 ChiCom grenade. The patrol destroyed all gear and emplacements and continued the search of the area. The Bravo Command Group arrived at FSB Russell at 1400H.

At 1500 on the 14th of January, 1/4 assumed OpCon of Co. "K" 3/4 at Khe Gia Brigade and Co. "F" 2/9 at TSL (Elliott Combat Base).

A Company "C" patrol made contact at 1530 and were pinned down by heavy automatic weapons fire. Patrol called in COM, GHP and artillery and Huey Gunships. The patrol had 1 KIA.

At 1715, 1/4 assumed OpCon of 2nd platoon Co. "A" 1/9 (Sparrow Hawk) whose mission was to guard a downed CH-46 at Grid XD 982553. The following day, 15 January, 1/4 dropped OpCon to 3d Mar Div of A2 1/9, and Co "K" 2/9 were dropped OpCon to Task Force Hotel.

On the 17th of the month, a Co "D" patrol at grid XD 833626 found a cave complex. Searching the area the patrol discovered 500 pounds of rice, 13 cans of 82mm mortar shotgun shell propellant, 72-82mm mortar fuzes and assorted medical gear.

Alpha Command Group once more moved on the 18th to LZ Catapult and established the Bn CP at 1530. "H&S" (-) again

provided perimeter defense. The next day an "H&S" patrol at grid XD 825616 found a 105 shell and 256 M-564 fuzes which was all U.S. gear. It was evacuated to VCB.

A Co "D" patrol at grid XD 809641, on the 20th, found 18 boxes of .50 cal. ammo, 782 gear and fighting holes. Co "H&S" had a patrol uncover 40 "A" frame bunkers (4'X8'X5') and 600 pounds of rice, 100 pounds of salt, detonating cord and 10 blasting caps.

On 21 Jan at 1200 Co "B" commenced heli-lift to VCB, following in succession were Co "D", Co "C", and the Command Group with Co "H&S" (-). The Bn CP was established at VCB at 1630.

At the conclusion of the 25 day operation, 1/4 had uncovered 51 tons of rice, 355 pounds of salt, 14,560 rounds of small arms ammo, 2,375 rounds of mortars, recoilless rifle and rocket ammo and 48 AP mines. Elements of 1/4 destroyed 340 bunkers and had killed 25 NVA.

On 22 Jan, 1/4 assumed responsibility for perimeter defense at Vandegrift Combat Base, Ca Lu, FSB Cates, Hill 691, Hill 950, along with maintaining FSB Russell and Neville. To accomplish this mission 1/4 assumed OpCon of Co. "B", Co. "F", Co. "D" 2d 1/9. The responsibility of Reaction Platoon/Company went to Company "D" 1/4. (Ref: 221200H).

On the 23rd at 0800, a Provisional Platoon from 483 Co at Vandegrift Combat Base and assumed control of Signal Hill defenses and dropped OpCon of 2d Platoon Co. "D" 1/9. 1/4 assumed OpCon of Co. "F" 2/4 and dropped OpCon of 1st Platoon Co. "C" 1/4 to III MAF for duty as security platoon for the Commanding General III MAF. Co. "D" 2nd platoon was committed as reaction platoon and chopped OpCon to 2/4. 1st platoon Co. "B" 1/4 assumed duties as reaction platoon.

On the 24th, Co. "F" dropped OpCon to 2/4. The following day 1/4 assumed OpCon of Co. "D" 1/9. Co. "B" (-) lifted to FSB Fuller, Co. "C" 2nd platoon 1/4 assumed defense of the Khe Gia bridge. Co. "G" 2/4 dropped OpCon to 1/4. 1st Platoon Co. "B" (Sparrow Hawk) inserted as reaction force at grid XD 850648 and Recon team # 69 Dropped OpCon to 1/4. On 27 January Co. "L" 3/4 Chopped OpCon to 1/4 and proceeded to TSL, (Elliott Combat Base) Co. "G" 2/4 was relieved at TSL and were trucked to Vandegrift Combat Base to assume Sparrow Hawk/Bald Eagle reaction Platoon/Company.

On the 28th of January 1/4 dropped OpCon of Co. "L" 3/4, 2nd platoon Co. "C" 1/9, Co. "B" 1/9, to 3/4. Co "B" 1st. platoon 1/4 Sparrow Hawk was extracted from LZ Catapult to Vandegrift Combat Base.

On 29 January Co. "G" 2nd platoon 2/4 Sparrow Hawk was inserted at grid YD 082733 and dropped OpCon to 2/4. On 30 January, 9 Bru Chieu Hoi's came into Ca Lu and were detained for an ITT team from 4th Marines. Company "G" (-) 2/4 were transported from Vandegrift Combat Base to Con Thien by vehicle and dropped OpCON to 2/4. 1st platoon Co. "B" 1/4 relieved 2nd platoon Co. "C" at Khe Gia bridge. Co. "D" 1/4 placed on reaction platoon/company ( Sparrow Hawk/Bald Eagle.

On 31 January Co. "K" 3/4 arrived at Vandegrift Combat Base and chopped OpCon to 1/4. At the end of the month of January 1/4 maintained security for Vandegrift Combat Base, Ca Lu, Elliott Combat Base, Khe Gia Bridge, Signal Hill, FSB Russell, FSB Neville, and FSB Fuller, with an AO of over 1 Million square meters and at one time having operational control of 10 Companies in order to accomplish it's mission.

2. OPERATIONS.

01 Jan "t 1021H Co. "A" at grid XD 844557, patrol found 1 NVA grave, patrol dug up grave, found 1 body 4-5 months old, body had no identification or signs of cause of death, patrol covered grave and continued the patrol mission.

At 1110H Co. "D" patrol at grid XD 904524 found 1-250 pound bomb, destroyed in place.

1138H Co. "A" at grid XD 841556 found 9 old bunkers dug in the ground with log roofs, 1 kitchen with assorted utensils, various digging tools scattered around the area. 1 hand grip for M-16 rifle, a barrel and receiver group for Chinese machine gun, M.7.62 Ammunition bolt, medicine box and newspaper dated 10 November 1968 NVA type, two trails, one heading

in Northeast and the other heading in the direction of North, Patrol continued mission, checking out area.

1158H An "A" Co patrol at Grid XD 859569 found 2 bunkers 6'x3'x5', made of dirt and logs approximately 3 months old. Patrol found 3-82mm Mortar pits with mast clearance to northeast from the Mortar pit, patrol could see, Regimental Objective #1, Mortar pits were no more than three months old, also found 27-82mm Mortar rounds, 1 can of fuzes and 1 NVA E-tool, patrol continuing to search out area.

1251H Co. "A" patrol at Grid XD 844556 found 3 caves, inside found sketch Map, terrain marked with X's, found various medical supplies including a barrel for a 2½CC syringe, 63 vials distilled water, 4 unknown vials, 1 catheter size 16, 1 vial stryptomycin, 2 Penicillin vials, 1 vial unknown white powder, 7 empty vials of Stryctnine, a pint size bottle of brown Iodine powder, 2 pounds of NVA TNT, 1 letter with date of 6 Nov 68 saying "troops going into field for rice", gave name of village and amount of rice, all medical supplies being returned to Company patrol base.

02 Jan

At 1005H Col. GOGGIN, Commanding Officer, 4th Marines arrived at 1/4 Command Post. Col. GOGGIN departed at 1020H.

At 1055H an "H&S" Co. patrol at Grid XD 880530 found 1 bunker built of logs and dirt. Bunker was large enough for two persons, used one week ago, also found fire place and sleeping area for two persons in the open. Patrol destroyed bunker.

1345H Co. "A" patrol at Grid XD 853575 was moving along a trail and received fire from NVA automatic weapon, unit believed to be of squad size, patrol returned fire, killing 1 NVA and pulled back, calling in artillery, resulting in various secondary explosions.

At 1542H a Co. "C" patrol at Grid XD 842552 found a cave complex consisting of 10 caves and six huts, 8'x3' made of sticks and leaves; 2-3 weeks old.

02 Jan

Patrol found 1 NVA Claymore, 14 boxes of booby trap devices, 10 devices in each box, 29 AK rounds, 2 AK pouches, 5 AK Magazines, 1 ChiCom pouch, assorted letters, 12 bottles of injectible fluid, 1 bottle of sulphur, 3 bottles of penicillin, 1 cooking pouch with rice, 1 protective mask filter, and 1 NVA E-tool; patrol returned all gear to Company Command Post.

At 1425H aircraft in support of Co. "C" patrol initiated 3 secondary explosions, Artillery caused one secondary explosion.

1826H Co. "B" at Grid XD 883563 found 4 bunkers 2 of which were 4'x4'x3', 2 were 5'x5'x4' and approximately 2 to 4 months old, 11 fighting holes and four benches, benches of logs tied to trees, did not destroy anything.

2045H Co. "C" patrol at Grid XD 853575 made addition to Spot Report #127, patrol found 1 NVA body destroyed by Napalm, part of the head was found in a helmet. Patrol found 1 AK-47 rifle, 1 20 round magazine, one canteen on cartridge belt, 1 ChiCom grenade, patrol buried body and destroyed all gear.

1410H A Co. "D" patrol at Grid XD 897535 found some NVA Comm-wire, running in a northwest direction for approximately 30 meters. It stopped for 10 meters and started again for 20 meters, stopping again. Area has been hit by Air and Artillery. Patrol destroyed wire and continued on it's mission.

1635H Co. "D" at Grid XD 891538 has occupied Regimental Objective #6, will consolidate position for night position.

1750H Co. "D" at Regimental Objective #6 found 9 bunkers 6-8 months old. Bunkers were already destroyed. Patrol found 2 cooking and two rice bowls, area was heavily hit by Air and Artillery. No signs of enemy activity in the past six to eight months.

04 Jan

1003H Co. "D" at Grid XD 895536 found 2 NVA Claymore mines, net work of trench lines and fighting holes running in Southwest direction for 100 meters, also 1 trail going down in a North South direction.

Trail established to be 6 to 8 months old. No sign of recent activity.

1139H Co. "C" at grid XD 847574 was cutting thier way through brush, when the point man set off what is believed to have been an explosive booby trap. Patrol reported movement around them and pulled back, 2 artillery missions were fired in the area.

1233H Co. "D" at grid XD 893531 found eleven sleeping bunkers 6'X4'X4' with logs and dirt; 20 empty rocket cannisters with writing and date of 5/67; 1 rocket warhead carrier, also found aining stakes pointing in an easterly direction, all estimated to be 6 to 8 months old. Destroyed bunkers.

1601H Co. "C" patrol at grid XD 846574 searching out area of contact which had been prepared with artillery and air; found 2 NVA/KIA confirmed resulting from fire fight, 1 hit by M-79, 1 by M-60 Machine Gun. Two additional NVA/KIA later were confirmed by M-16 fire.

05 Jan

0829H Co. "H&S" (-) at grid XD 871537 had one confirmed KIA/nocturnal intruder, unidentified. length 2½ feet, waight 30 pounds, hieght 1½ feet, silver and black markings, banded tail like a racoon, head of a fox, feline body and ears, paws, has five pads like a dogs foot. Retained body for viewing.

1049H Co. "C" patrol at grid XD 847574 was searching area of contact from top of objective to the bottom of the draw. Patrol saw at least 4 NVA bunkers. Bunkers were mutually supporting with command detonated Claymore mines. Also saw clearing at the bottom of the draw, approximately 75-100 meters from the top of the ridge line. It is believed there are more bunkers beyond this clearing. Patrol cleared area of Claymore mines, searched for NVA and continued on mission.

1517H Co. H&S patrol at grid XD 882541 found fresh foot prints of one person, fresh axe marks on wooden box that was being chopped for fire wood, 1 rice bowl, 15 Ak rounds, 1 protective mask,

1 small weaving basket, 12 NVA bunkers estimated to be 4 to 6 months old, pieces of NVA comm wire cut in 15 inch lengths, and 2 NVA E-tools. Destroyed all gear.

1815H Co. "C" patrol at grid XD 847573 found five bunkers 5'X3'X6'; made of logs and dirt and strongly reinforced. Bunkers show signs of recent use. Each bunker had mutually supporting Command detonated mines. All Command detonating mines were booby trapped with a pressure release device. Two mines were blown, three were disarmed. There are two trails, one leading in a westerly direction, this trail shows signs of very recent use, and lead to more bunkers. Trail in northerly direction is very large and heavily used recently. This trail has not been checked out. On the trail to the West two booby trapped ChiCom grenades, with trip wires across the trail were found and disarmed. Patrol found drag marks along the trail, where a body had been dragged.

Found in this area a large kitchen 6X12'X10', inside were four stoves, and eight cooking pots. Patrol is continuing to check out the area.

5. TRAINING

a. During the month of January no training was conducted on the Battalion level due to operational commitments. Company level training was devoted to Map Reading and the use of the Compass, Maintenance of Weapons, individual equipment, and General Military Subjects.

b. All replacements recieved indoctrination briefings in accordance with the Battalion SOP for replacement training. Each replacement fired his T/O weapon for familiarization. During the latter part of January the 81MM Mortar Platoon conducted extensive training for new replacements.

6. FIRE SUPPORT.

During January the composition of the forward observer teams was changed with each team losing experienced enlisted men and receiving new personnel who required training. "C" Companies team improved when a new team leader was brought in. "A", "B" and "D" Companies went through the month with competent F. O.'s who continued to display good technique.

In the first three weeks of January the F. O. teams supported the 1st. Battalion, 4th Marines in operations sweeping from below the Nui Tia Pong to the D. M. Z. in the North. After that they were joined by OpCon units in giving Artillery support to Vandegrift Combat Base, Elliott Combat Base, Ca Lu, Fire Support Bases Cates, Neville, Russell, Fuller, Hill 950 and 691. F. O. teams also supported the Battalions " Sparrow Hawk" reaction force when they went into the D. M. Z.

All teams fired missions on active targets in January. For the "B", "C", and "D" teams, this was during fire fights with the enemy.

Vegetation and terrain made surveillance incomplete, however there were three confirmed NVA/KIA and one secondary explosion by artillery.

The Artillery support given to the 1st. Battalion, 4th Marines in January significantly improved over that of previous months. This is accountable to the Regimental F. S. C. C. giving this Battalion responsibility for its own Sav-A-Plane when there was enemy contact. In such cases the Battalion mustered quicker fire support and with more continuity than before. It was possible for the first time in months to develop a coordinated Air and Artillery attack.

Improved fire support was also possible during most contact was within range of 81mm mortars. In contact the grid of Artillery fire was also forward on and 81mm Mortar mission. Mortar fire filled in the time gap until heavier fire could be employed on the enemy.

The area needing stress lies in insuring that the fire support exploitation of contact does not hamper ground movement and unit advancement. Some enemy contact may have been given over to supporting arms to the extent that they put ground advancement in check. All F. O. teams have been made aware of this potential problem and have been instructed to keep the F. S. C. C. better appraised of the nature of contact from the moment of contact; also they will stress F. O. techniques that will allow quicker ground exploitation.

10. CIVIL AFFAIRS. No Civil affairs Activities were conducted by this Battalion during the month of January.
11. COMMUNICATIONS.
  - a. Message Center. The Message Center Section is deployed at two locations. The rear in Quang Tri is responsible for the acquisition of Classified Codes from 3rd Marine Division, as well as distribution of Classified and Unclassified traffic to the administrative offices at that location. The Vandegrift Message Center is responsible for the distribution of Shackle Sheets/ Authentication Codes to the tactical units and also to collect unclassified traffic from Regimental Headquarters for the Commanding Officers Daily Read Board.
  - b. Radio. Radio transmission is still the primary means of communications in the Tactical situation.

Relay stations on FSB Fuller, FSB Neville, FSB Mack, and FSB Russell, were essential in establishing continuous communications throughout the month of January of the tactical net. Stations located at Vandegrift and Quang Tri provided reliable communications for the administrative and supply traffic. Log Periodic Antennas were used for long distance Line of Sight Communications and were ideal for static FSB deployment. The field stripped, OMNI directional 292 Antennas were most practical for the widely dispersed units and gave more reliable communications than the Log Periodic System from the majority of Command Post Locations.

- c. Covered Circuits. The KY-38/PRC-77 was used extensively with positive results on the Regimental Tactical Net. The Battalion received it's T/E requirement of KY-38 Cypher units and KY-28 Cypher Keying units this month. Initially 3 KY-38 units proved defective after only days use each. The problem has not been resolved as yet.
- d. Wire. The wire section maintains 4 SB/22 units, two at Vandegrift and two at Quang Tri. The Switchboard at Quang Tri is in constant use where the one at Vandegrift is guarded only when the Battalion is located at Vandegrift Combat Base. Hot lines to the Combat Operations Center are utilized when the Command Group is not at Vandegrift Combat Base. Field wire loops are employed as needed in the defensive perimeter when the Command Group is in a tactical position.
- e. Electronics Repair. This section continues to provide second echelon maintenance from it's static position at Quang Tri. A projected future move is planned for an alternate shop to be constructed at Vandegrift to bring the required repair facilities closer to the deployed Battalion.
- f. Radio Relay. There was no use for this section during the month of January.
- g. Critical Shortages. Modules for the AN.FRC-25 remain in a critical status. In particular, they are as follows: A-1, A-2, A-5, A-9, A-10, A-25. There are no replacement parts available for the transmitter elements for the EE-8 or Transmitter/Receiver elements for the H-189. There are no Preventative Maintenance report sheets available in the tech. shop. Testing gear and meters for the tech. shop, such as ME-25/A and UG-255 and URM 438 are also unavailable at this time.

6. Weekly malaria prophylaxis was continued with the use of Chloroquineprimaquine tablets in the battalion area rear. Daily malaria prophylaxis was continued with the use of Dapsone in conjunction with weekly use of Chloroquine-primaquine in battalion forward areas. Personnel from all areas in the rear were mustered daily and given Dapsone.
7. Sanitation inspections were held daily, and weekly in accordance with art. p6000.4D in the Battalion area (Vandegrift Combat Base, and Quang Tri). Sanitary facilities, at present time are considered adequate.
8. Two Battalion Aid Stations were maintained during the month of January. 

5. Terrain

The AO is characterized by rugged irregular ridgelines with numerous draws running in all directions. Tien Hien creek serves as our NW and NE boundary while Giang Thoan creek serves as the SW and southern boundary. We can expect many small feeder streams running from within our AO into these larger boundary streams.

We will generally follow a descending ridgeline as we go SE and east to Nui Tia Pong. The elevation drops off sharply between objectives 6 and 8. To the north and south of this ridgeline there are numerous fingers jutting out with steep draws separating the fingers. There is secondary high ground on some of the fingers before the elevation drops off sharply into the more prominent draws.

There will be heavy forest throughout the AO except in the river valleys where the vegetation will thin out some.

The known trails in the area will run perpendicular to our route of advance, as shown on the trail overlay.

6. Enemy Situation

There are no known enemy units in the area. The trails in this area serve as infiltration routes from the north to the south. The recent rocket incoming into VCB probably resulted from NVA units coming down through this area into the Dong Ca Tu - Hill 705 area.

There are numerous old NVA fortifications and mortar pits within a .,000 meter radius of Nui Tia Pong.

There have been no recon or other friendly units in the area in the recent past. AO sightings have been nil in our portion of the operation, but there have been a few signs of trail activity in 3/4's area.
