5. Terrain and Weather:

- a. The terrain in the PHU BAI area is low rolling hills cut by swampy gullies. The TAOR is split to the right of center by a prominent ridgeline dominated at the north end by Hill 180, the commanding terrain in the TAOR. The south end of the TAOR contains a series of high hills and ridgelines which separates very distinct East-West corridors. There is a small fordable river in the northern portion of the TAOR. There is very little foliage except in the southwest portion of the TAOR, and the similiarity of the appearance of the hills at night makes night navigation very difficult.
 - b. The weather is predominately hot and humid. Daytime highs range from 85 to 115 degrees fahrenheit with an average humidity of 85%. There have been several days of rain and thunderstorms with temperatures in the 70's.

- 1 Aug Companies I, K and H&S with LSU and 4/12, maintained airfield and CP security. Company L helilifted from YD 882078 to YD 828087 and set in night position at that location with 3 squad sized night ambushes located at YD 841079, YD 825076 and YD 817086. Company M trucked to YD 859139 and set in two night ambushes located at YD 829139 and 836137. Negative contact. Formed Joint Action Company consisting of 1 Marine Rifle Platoon and 6 Popular Forces Platoons, 1st Lt. ~~EX~~ Commanding.
- 2 Aug Company I departed by fixed wing aircraft for Da Nang under OPCON 3d Marines. Company L trucked to Base Camp from night position. Recon Company trucked one squad to YD 861145 and conducted a recon patrol to YD 828150 then to YD 865156. Trucked back to Base Camp from that location. At 0700H Recon Company heliolifted one squad to YD 879063. From LZ the squad moved to YD 869057 and set up a daylight OP. Returned to Base Camp by helo at 1700H. At 1800 1 Platoon, Company M trucked to YD 881096 and then moved to YD 889087 for night ambush. Company L assumed duties as Bn CP security. Companies K and H&S with LSU and 4/12 maintained airfield and CP security.
- 3 Aug Company K moved by foot to YD 891101 and set in night ambush. One platoon of the Joint Action Company patrolled the village of Thuy Tan. Company M assumed duties as airfield defense company. Companies L and H&S with LSU and 4/12 maintained airfield and CP security.
- 4 Aug Company K returned to Base Camp first light. Company I returned to OPCON of 3/4 0930H. At 1600H Company I foot marched to YD 889087 and set in night ambushes in that vicinity. The Joint Action Company sent a platoon sized recon patrol to the villages of Thuy Phu and Thuy Luong. At 2000H, C Recon Company trucked to YD 843142, then set night ambush at YD 821155. Companies L, M and H&S with LSU and 4/12, maintained airfield and CP security. At 2230, a platoon from Company K with a light section of tanks were dispatched to YD 841156, to block a reported 2 companies of VC moving toward the TAOR. Negative contact.
- 5 Aug Platoon of Company K and light section of tanks returned to CP at 0800H. C Recon Company returned to CP by truck at 0830H. Recon Company helilifted one squad to YD 834125, where they moved to YD 822120, and set in daylight OP. Squad returned by helo at 1630H. Company I conducted squad sized patrols vicinity of YD 898098, then moved to YD 889087 and set two night ambushes in that vicinity. C Recon Company trucked one squad to YD 843142, where they moved to YD 827157 and set in a night ambush. Companies L, M and H&S with LSU and 4/12, maintained airfield and CP security.

6 Aug

The squad from Recon Company returned by truck at first light. Company I helilifted from night position to YD 842077 and conducted local patrols in that vicinity. Moved to YD 829094 for night position and set in two night ambushes that vicinity. Company K departed for Chu Lai by fixed wing aircraft. The Joint Action Company conducted platoon sized daylight patrols in the villages of Thuy Tan, Thuy Phu and Thuy Luong and set in a platoon sized night ambush in Thuy Luong. Recon Company trucked one platoon to YD 843142 where they moved by foot to YD 817153 and set in night ambush. Companies L, M and H&S with LSU and 4/12 maintained airfield and CP security.

7 Aug

Recon Company returned by truck at first light. Company I helilifted to Base Camp at 0700H. Company I moved by foot-march to YD 892101 at 1830H and set in two squad sized night ambushes in that vicinity. At 0930H the light section of tanks conducted a mechanized patrol to YD 884073 and returned to Base Camp at 1300H. A squad from Recon Company with a detail from Engineers conducted a road reconnaissance from YD 842152 to YD 830137. The Joint Action Company helped Popular Forces repair the road in the village of Thuy Tan and build heads and latrines in the village of Thuy Phu. One platoon from the Joint Action Company conducted a recon patrol in the village of Thuy Luong. The Commandant of the Thailand Marine Corps, Rear Admiral Somang Neisalak, visited this command. Company K returned from Chu Lai at 1820H. Companies L, M and H&S with LSU and 4/12 maintained airfield and CP security.

8 Aug

Company I helilifted from night position to YD 816091 and conducted squad sized patrols in that vicinity and set in three squad sized night ambushes in that vicinity. One platoon of Recon Company trucked to YD 841152 and set up a night ambush at YD 825154. One platoon from Recon Company helilifted to YD 898080 and set in a night ambush that vicinity. Companies L, M and H&S with LSU and 4/12 maintained airfield and CP security.

9 Aug

Recon Company trucked one platoon from YD 841152 and helilifted the platoon at YD 898080 back to Base Camp at first light. Company I helilifted one platoon to YD 830153 and set a blocking position while remaining part of the Company helilifted to YD 814124 and swept north to blocking force. After sweep company moved to night position at YD 841155 where they set in two squad sized night ambushes in that vicinity. The Joint Action Company conducted a recon patrol in the village of Thuy Phu. One platoon from Recon Company helilifted to YD 892082 and conducted a recon patrol to Base Camp. Companies L, M and H&S with LSU and 4/12 maintained airfield and CP security.

- 10 Aug Company I trucked to Base Camp and assumed duties as Reserve/Reaction Force. Recon Company trucked one platoon to YD 841152, conducted a recon patrol to YD 832120, then trucked back to Base Camp. At 1700H, Company K trucked to YD 889087 and set in two squad sized ambushes that vicinity. Recon Company trucked one platoon to YD 841151, where they moved by foot to YD 812151 and set in a night ambush. Joint Action Company conducted recon patrols in the Villages of Thuy Luong, Thuy Tan and Thuy Phu. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 11 Aug Recon Company trucked the platoon from YD 841151 to Base Camp then helilifted a platoon to YD 891077. This platoon conducted a recon patrol to YD 860046, then continued the recon patrol to Base Camp. Company K conducted a security patrol from night position to Base Camp. Joint Action Company conducted daylight patrols in the Villages of Thuy Tan and Thuy Phu, and a night ambush in the Village of Thuy Luong. At 1700H, Company K helilifted to YD 821119 and set in two squad sized night ambushes that vicinity. Recon Company helilifted one platoon to YD 895089 and set in night ambush vicinity YD 908088. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 12 Aug At first light, Recon Company helilifted the platoon from YD 895089, to Base Camp. Company K helilifted from night position to Base Camp at 0715H. Company I departed Phu Bai in C-130 Aircraft for Da Nang under OPCON 3rd Marines. Recon Company trucked one platoon to YD 841152, where they conducted a recon patrol to YD 819112 then returned to YD 841152 and trucked back to Base Camp. At 0745H, a light section of tanks and ontos conducted a mechanized patrol to YD 885104. Returned to Base Camp at 0930H. At 1700H, Company K trucked to YD 891078 for night position and set in two squad sized night ambushes that vicinity. Recon Company moved one platoon, by foot march, to YD 914162 and set night ambush that location. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 13 Aug Company K conducted a security patrol from night position to Base Camp. Platoon from Recon Company moved from night position by foot march to Base Camp, at first light. One squad from Recon Company trucked to YD 897082 and conducted a river reconnaissance of the Song Nong River, north to Route #1. One platoon from Joint Action Company conducted a recon patrol of the Village of Thuy Luong. At 1800H, Company K helilifted to YD 815105 and set in 2 squad sized night ambushes, west of night position. - 14 Aug At 0600H, Company K helilifted to Base Camp and assumed duties as Reserve/Reaction Force. One squad from Recon Company with a detail from A Engineers conducted a road reconnaissance and mine clearing operation on roads along the western border of the TAOR. One platoon of the Joint Action Company conducted a recon patrol in the Village of Thuy Tan. At 1800H, one platoon of Recon Company was helilifted to YD 830120 and set a night ambush that vicinity. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 15 Aug One squad from Recon Company conducted a security patrol to YD 870070 and returned to Base Camp. The platoon from Recon Company at YD 830120, returned to Base Camp by truck at 0630H. Co K departed Base Camp by truck to YD 841156, where they set in a night position and two squad sized night ambushes in vicinity, west of night position. One platoon of Recon Company helilifted to YD 896060 and set a night ambush at YD 904058. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 16 Aug At 0630H, the platoon from Recon Company was helilifted from night position to Base Camp. Company returned to Base Camp by truck at 0700H. At 1130H, a company of VC were reported approaching the western border of the TAOR. Company K moved by truck to YD 841155 and set in a blocking position. Company K was in position by 1200H. Air Observers were dispatched over area of reported VC company and reported a negative sighting. Company K was secured and returned to Base Camp by truck at 1300H. The Joint Action Company conducted platoon sized patrols in the Villages of Thuy Tan, Thuy Luong and Phu Bai. At 1400H, Recon Company trucked one platoon to YD 840153 and conducted a recon patrol to YD 824129, then set in a night ambush at YD 816124. At 1800H, Company K foot marched to YD 891101 and established four squad sized night ambushes that vicinity. Companies L, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 17 Aug Company K conducted a recon patrol from night position to Base Camp, at first light. Recon Company trucked platoon from YD 840153 to Base Camp. Company L airlifted to Chu Lai to participate in an operation at that location. At 1730H, one platoon of Company K foot marched to YD 873099 and set night ambush that location. Company K also trucked one platoon to YD 841155 that conducted a security patrol to YD 821119, where they set in a night ambush. Companies I, M and H&S, with LSU and 4/12, maintained airfield and CP security.
- 18 Aug Platoons from Company K conducted recon patrols from their respective night positions to Base Camp. Recon Company helilifted one squad to YD 889065 and conducted a river reconnaissance to YD 913117. Recon Company also helilifted one squad to YD 816105, that conducted a recon patrol to YD 841155 then trucked back to Base Camp. The Joint Action Company conducted platoon sized patrols in the Villages of Thuy Tan, Thuy Phu and Thuy Luong.

At 1700H, a platoon from Company M foot marched to YD 889087 and set in night ambush that location. At 1710H, Recon Company helilifted one platoon to YD 828130, then patrolled to YD 814118 and set in night ambush that location. At 1800H, Company M trucked one platoon to YD 841155, where they set in a night ambush. The Joint Action Company conducted night security patrols in the Village of Thuy Luong. Companies I, K and H&S, with LSU and 4/12, maintained airfield and CP security.

19 Aug

Company M conducted security patrols in vicinity of night positions. Recon Company trucked to Base Camp, at first light. Joint Action Company provided security for bridge repairs in the Villages of Thuy Tan, Thuy Phu and Thuy Luong. One platoon of Recon Company patrolled from Base Camp to YD 867113 and set in night ambush. Companies I, K and H&S, with LSU and 4/12, maintained airfield and CP security.

20 Aug

Company M conducted a security patrol from night positions to Base Camp. The platoon from Recon Company returned to Base Camp at first light. At 1500H, Recon Company conducted a platoon sized recon patrol from Base Camp to YD 906050 and set in a night ambush that location. At 1800H, Company M trucked 2 platoons to YD 821119 and set in night ambushes that vicinity. At 1830 the 3d platoon Recon Company trucked to YD 831114 and conducted a night patrol to YD 813104 then set in a night ambush that vicinity. Companies I, K and H&S with LSU and 4/12 maintained airfield and CP security.

21 Aug

1st Platoon Recon Company maintained a daylight OP at YD 906050. The 2 platoons of Company M returned to Base Camp by truck at first light. At 1630 Company M trucked 2 platoons to YD 912117 and conducted a security patrol to YD 897087 and set in a night ambush that vicinity. The 3d Platoon Recon Company maintained squad sized OP's located at YD 794107 and YD 796103. The 1st Platoon of Recon Company set a night ambush at daylight position. At 1900 the 3d Platoon Recon Company helilifted to Base Camp. Companies I, K and H&S with LSU and 4/12 maintained airfield and CP security.

22 Aug

Company M conducted a Recon patrol to YD 895030. The 1st Platoon Recon Company patrolled to Base Camp at 1235. At 1500 the 2nd Platoon Recon Company helilifted to YD 830110 and conducted a night patrol to YD 804053 and set in a night OP that location. The Joint Action Company continued daylight patrols and night ambushes in the villages of Thuy Luong, Thuy Tan and Thuy Phu. Companies I, K and H&S with LSU and 4/12 maintained airfield and CP security.

Company M conducted a security patrol from their night position to Base Camp passing through the village of PHU BAI in a show of force. The 2nd Platoon of Recon Company maintained a daylight OP at their night position until 1330 then helilifted to Base Camp. At 0820 a helicopter was reported down at YD 935094. The 1st Platoon of Company L was helilifted to the downed helicopter for security. Helicopter was repaired and flew out of area at 1400H. The 1st Platoon of Company L returned to Base Camp by helicopter. At 1600H Company L with detail from H&S helilifted to YD 868058 while Company M trucked to same location. Recon Company trucked to YD 891079 at 1600H. Companies set in night defensive positions and prepared to cross the line of departure for operation Jungle Foot (Operation Order 27-65). The Joint Action Company continued daylight patrols with night ambushes in the villages of THUY LUONG, THUY TAN and THUY PHU. Companies I, K and H&S with LSU maintained airfield and CP security.

24 Aug Operation Junglofoot started at 0400H with Company M conducting a search and destroy operation from night position to YD 849023 and Recon Company screening their flank from their night position to YD 844027. Company L followed in trace of Company M. 4/12 provided artillery support. Negative contact throughout the operation. Upon completion of the operation all companies returned to their respective night positions. Recon Company, Company L and CP group from H&S Company helilifted to Base Camp by 1240H. Company M moved to YD 891078 and set in a night defensive position. The Joint Action Company continued daylight patrols and night ambushes in the villages of THUY LUONG, THUY TAN and THUY PHU. Companies I, K and H&S with LSU and 4/12 maintained airfield and CP security.

25 Aug Company L trucked from night position to Base Camp. At 1300 the 1st Platoon of Company L trucked to YD 841155 and conducted a recon patrol to YD 831119. Moved to YD 821119 and set in a night ambush that location. The 2nd and 3d Platoons of Company L trucked to YD 889087 at 1500 and established a patrol base that location. The 3d Platoon Company L set in three squad sized night ambushes located at YD 891064, YD 908088 and YD 905089. The 1st Platoon of Recon Company trucked to YD 889087 with Company L. After dark the platoon from Recon Company moved to YD 907054 and set in a night ambush. The 3d platoon of Recon Company helilifted to YD 828087 at 1700H and conducted a recon patrol to YD 809079 where they set in a blocking position for an ARVN operation. - 26 Aug The 1st Platoon Recon Company helilifted to Base Camp at first light. The 1st Platoon of Company L conducted a recon patrol to YD 831118 then moved to YD 815129 and set in a night ambush. The 3d Platoon of Company L conducted a recon patrol to YD 908082 and returned to the patrol base. The 2nd Platoon of Company L conducted a night security patrol to YD 883068 and set in a night ambush at YD 881080. The 3d Platoon Recon Company maintained a daylight and night OP at YD 809079. At 1800H the 2nd Platoon of Recon Company trucked to YD 841155 then moved to an ambush site at YD 809157. At 2330H an estimated 15 VC's walked into the ambush of the 2nd Platoon Recon Company. They were fired upon and 5 VC were killed with no friendly casualties. There were also 2 MAT-49 submachine guns, 1 7.62mm CHICOM Rifle, 8 hand grenades, and 4 cartridge belts captured in this action. The Joint Action Company continued daylight patrols and night ambushes in the villiages of THUY LUONG, THUY TAN and THUY PHU. Companies I, K and H&S with LSU and 4/12 maintained airfield and CP security.
- 27 Aug The 2nd Platoon of Recon Company returned, by truck, to Base Camp at 1045H. 3d Platoon Recon Company moved to YD 816071 and maintained a daylight OP that vicinity untill 1330H at which time they helilifted to Base Camp. The 1st Platoon Company L conducted a recon patrol to YD 839145 and set in a night ambush that location. The 3d platoon Company L conducted a recon patrol to YD 900070 and returned to patrol base. The 2nd Platoon Company L conducted a night patrol to YD 889087 where they set in a night ambush. At 1900 the 1st platoon Recon Company moved by foot to YD 935140 and set in a night ambush. The Joint Action Company continued daylight patrols and night ambushes in the villiages of THUY LUONG, THUY TAN and THUY PHU. The 1st and 2nd Platoon Company L helilifted to YD 815091 and set up a patrol base with squad sized night ambushes at YD 811099 and YD 824080. The 3d platoon of Company L moved by foot to YD 914094 and set in night ambush. The 3d platoon Recon Company moved by foot to YD 830144 and set in a night ambush.  - (4) Interrogator - Translator Teams. Set up POW interrogation center vicinity MP area YD 884143. Arrange to have two interpreters present at interrogation center on D-Day.
 - (5) Counterintelligence Team. Assist ITT personnel in interrogation of POW's.
- b. Requests to higher, adjacent and supporting units.

- (1) Aerial Reconnaissance.

- (a) 220th Aviation Company will provide continual aerial observation for the duration of the operation.
- (b) HMM 161 will provide aircraft for aerial observation to supplement or substitute for aircraft provided by 220th Aviation Company. HMM 161 will provide aircraft for evacuation of POW's from area of operation and later if need be, to Division collection point.
- (c) Aerial Photograph. Aerial photographs of the area of operations have been requested through VM CJ. Uncontrolled photographs are available of the area at the present time.

4. MEASURE FOR HANDLING PRISONERS, CAPTURED DOCUMENTS AND CAPTURED MATERIAL.

- a. Prisoners of War. All POW's will be forwarded to the POW collection point via the most expeditious means. Interrogation by subordinate units will be limited to that required by tactical considerations. Interrogation of officers and high ranking enlisted will not be attempted. All VC POW's will be ~~separately searched and~~ separated from all documents and weapons prior to evacuation. All prisoners will be treated in accordance with the Geneva Conventions. WIA's will be evacuated immediately to A-Med prior to interrogation.
- b. Captured Documents and Materials. All captured documents and materials will be forwarded to the POW collection point simultaneously with POW's. All weapons will be marked and tagged to later identify the capturing unit or individual.



1. MISSION.

- a. Basic Mission. To conduct a search and destroy operation in the area to the south and southwest of Hill 303 (YD 848044).
- b. Previous Decisions. To move one reinforced rifle company into the jungle area along the axis of advance SCARLET, and kill or capture all VC and destroy all enemy installations in the area. Move "C" Reconnaissance Company along axis of advance GOLD to screen the left flanks of the rifle company.
- c. Purpose of Estimate. To familiarize the search company and supporting units with the terrain and enemy situation in the area of operations.

2. CHARACTERISTICS OF AREA OF OPERATIONS.

a. Weather.

- (1) Temperature. The maximum temperature during the day will be between 90 and 103 degrees. The heat will be accentuated by the dense jungle growth and the high humidity common to the area.
- (2) Precipitation. Heavy tropical storms are possible during the late afternoon and early evening hours. Such showers will effect helicopter lift capabilities and troop movement.
- (3) Visibility. Visibility forward of the jungle area will not be effected except during periods of heavy rainfall. Visibility will be extremely restricted by dense foliage and observation will be limited to several meters off the trails.

CONFIDENTIALb. Terrain.

- (1) Relief and Drainage. The area is characterized by steep heavily forested hills interlaced with streams. The streams in the area should not pose any problem for foot troops unless an exaggerated amount of precipitation falls just prior to or during the operation.
- (2) Vegetation and Cultural Features. The vegetation in the area is dense jungle growth composed of vine and saw-tooth grass. The tree canopy varies in height from 10' to 60'. The only cultural feature in the area is a village located SE of the area of operation (YC 895995).
- (3) Critical Terrain Features. Hill 303 (YD 848044), ridge line from YD 825060 to YD 844028, Route #14, parallel to the area of operation on the E, and the SONG TA TRACH River on the W.
- (4) Observation and Fields of Fire. Observation and fields of fire are non existent upon entering the jungle. Observation will be limited to several meters along trails. Fire will be hindered also by the dense growth in the area.
- (5) Obstacles. There are no man-made obstacle known to exist in the area. Extreme caution must be taken to avoid VC booby traps and mines that will most likely be present in the area. Such devices will possibly be present as two other units have worked this area previously.
- (6) Cover and Concealment. Both cover and concealment in the area are excellent due to the heavy foliage and draws which are abundant in the area.
- (7) Avenues of Approach. Trail leading into jungle from YD 870053 along a SW axis to YD 855044. Trail leading into jungle from YD 875048 to YD 849026.
- (8) Routes of Communication. The main route in the area is Route #14, bordering the eastern portion of the area of operation.
- (9) Landing Zones.
 - (a) HAWK (YD 863050) is capable of holding 3 helicopters. Zone slopes slightly to the W. Part of the zone is located in the bottom of a draw.

- (b) EAGLE (YD 858047) is capable of holding 2 helicopters. Zone provides poor security as it is bordered on three sides by heavy brush.
- (c) SPARROW (YD 862030) can only accomodate 1 helicopter. The zone is narrow and surrounded by heavy brush with troop exits.
- (d) DUCK (YD 857027) is capable of holding 3 helicopters. Zone has few troop exits and is surrounded by heavy vegetation.
- (e) FALCON (YD 878014) is capable of holding 8 helicopters. The zone is predominately rolling terrain with excellent troop exits. The zone is open to the N and the E.

3. ENEMY SITUATION.

a. Composition. It is believed that the following units may be present in the area of operations.

- (1) 802nd Main Force Battalion. On 11 August 1965, 1st ARVN Division agent reported that the VC District Headquarters previously located vicinity YD 833036, moved to YD 845036. It was also reported that elements of 802nd Main Force Battalion are in this area. Both reports are unconfirmed.
- (2) K-41 Company (C-106). This company has an estimated strength of 30 personnel due to contact with the ARVN and our forces. K-41 still has 1-60mm mortar and it is believed that the remaining members are all armed. As a company this unit is considered to be combat ineffective.
- (3) P-18 Company (C-117). Originally this company operated in the PHU VANG District but during the middle of July moved into the objective area to regroup after an encounter with ARVN. The encounter with ARVN has rendered the unit combat ineffective. Estimated strength is 25.
- (4) HUONG THUY Platoon. This platoon normally operated from THUY PHU Village but the presence of the Marines in the area has forced them into the jungle area S of the TAOR. The strength of this unit is estimated to be 25 or more. Due to lack of information to the contrary this unit is considered to have excellent combat efficiency.

- (5) AN NONG Platoon. This platoon formerly operated in the LOC BON Village area but has since operated almost exclusively from the jungle S of the TAOR. The presence of this unit in the area of operations is not confirmed. Their combat efficiency is considered excellent.

b. Arms and Armament.

*It is believed that all the members remaining in these units are armed.

- c. Reinforcements. It is not likely that these units would be reinforced if contact was made. All other local and main force units reported to have been in the area have moved E into PHU LOC District.
- d. Peculiarities and Weaknesses. Due to the combat ineffectiveness of the K-41 and P-18 Companies and the small size of the local platoon it is believed that these units will do all possible to avoid contact. It is not believed probable that the units have joined forces even though they are presently harbouring in the same vicinity. Extreme caution should be taken to avoid booby traps and mines in the area, especially along trails and in VC bivouac areas. The presence of elements from the 802nd Battalion in this area came from a unevaluated source.

4. ENEMY CAPABILITIES.a. Enumeration.

- (1) Capability #1. The enemy can move into the deep jungle at the first sign of our forces and avoid contact.
- (2) Capability #2. The enemy can fight small delaying actions while the bulk of their forces withdraw.
- (3) Capability #3. The enemy can utilize such devices as booby traps, mines and panjii traps to delay friendly forces and warn of their approach.

CONFIDENTIAL

(4) Capability #4. Utilize mortars to harass friendly units as they arrive in landing zones and approach enemy bivouac areas.

(5) Capability #5. Defend in force to prevent entry into the area.

b. Analysis and Discussion.

(1) Capability #1.

(a) Advantage. To avoid contact with our forces would enable the VC to conserve forces. The combined forces of enemy units do not have the capability of fighting as one unit.

(b) Disadvantage. This would leave VC bivouac and supply areas unguarded.

(2) Capability #2.

(a) Advantage. This would enable the VC to move supplies out of the area and at the same time inflict some casualties on our units.

(b) Disadvantage. Possible losses of men and materials to our superior forces.

(3) Capability #3.

(a) Advantage. This would delay our forces and inflict casualties with a minimum of chances of loss of men or equipment.

(b) Disadvantage. None.

(4) Capability #4.

(a) Advantage. There are limited landing zones available in the area and they could be covered with mortar fire from many points adjacent to the zones. This tactic was used against "C" Recon in July. There are numerous places which provide mask clearance and would enable several rounds to be fired without detection.

(b) Disadvantage. None.

CONFIDENTIAL(5) Capability #5.

- (a) Advantage. This capability would be utilized if the loss of valuable stores were involved. Also if the battle should turn against the VC they can melt in the surrounding terrain.
- (b) Disadvantage. The presence of elements of the 802nd Battalion would greatly enhance the combat power of the units in the area and make defense of the area a more realistic course of action. It must be assumed that the enemy knows of our supporting arms capability and will attempt to avoid being trapped in a defensive posture.

5. CONCLUSIONS.

- a. Relative Probability of Adoption of Enemy Courses of Action. The relative probability of adoption is as stated in paragraph 4.a. The VC will attempt to avoid contact if possible to conserve the remnants of their manpower. Contact will most probably be avoided by utilizing mines and booby-traps as early warning devices. It is unlikely that the VC will make contact with our units unless it is unavoidable.
- b. Effect of the Enemy Capabilities on the Commander's Mission. Enemy capabilities #1 through #4 will not materially affect the Commanders Mission in view of the fire power and supporting arms of the battalion. The narrowness of the axis of advance of both units will enable the VC to effectively utilize ambush tactics against units moving through the jungle. The possible presence of elements of 802nd Battalion in the area of operations will hinder the operation but not prevent the accomplishment of the mission.




