INTELLIGENCE

1. Enemy Situation At The Beginning Of The Period. The beginning of the period two companies of the 802nd Main Force was located adjacent to our TAOR, the 1st Company at vic YD 880223 and the 2nd Company located at vic YD 801053. The P-18 Local Force Company was located at vic YD 798076 and K-41 was located vic YC 857988. The Main Force Companies had approximately hundred personnel each and each of the Local Force Companies averaged seventy personnel.
2. Enemy Incidents During the Period.

070713 Nov - Aerial Observer received one round small arms fire vic YD 850045. Believed to be a Viet Cong Headquarters. Artillery fired mission. Excellent coverage of target.

201030 Nov - C Recon reports while moving vic Hill 54 (YD 792109) Viet Cong sniper fired one round about 1030H (YD 792106) that was not close to patrol, but was fired in direction of patrol as determined by sound of rifle. Two minutes later sniper fired again and crack of round was heard overhead by report of rifle. Less than a minute later another round was fired and results was one friendly WIA, possibly a ricochet as judged by Marines near the WIA when he was hit. 4/12 Artillery fired mission with excellent coverage of target.

212005 Nov - Combined Action Company - 1 while in ambush vic YD 871184 sprung their ambush when four to five Viet Cong were crossing river on big branches approximately 50 to 75 meters in front of their ambush. 4/12 Artillery fired illumination. CAC reported seeing two bodies floating down the river. They were unable to recover bodies due to strong current of river.

231610 Nov - Battalion S-2 Scouts with Battalion Snipers vic YD 776135 observed seven Viet Cong moving SW vic YD 775144 carrying weapons. Snipers opened fire. Two Viet Cong KIA, one Viet Cong WIA. Bodies could not be recovered due to previous report from PF Platoon Commander that there were 30 to 35 Viet Cong in area.

251140 Nov - H&S Company OP (YD 880136) reports one round going over his head. Believed to have come from his right approximately 300 meters.

251145 Nov - Company K OP (YD 894150) reports three to four small arms rounds coming from vic YD 893153.

272300 Nov - Combined Action Company - 3 while in ambush vic YD 908108. Two Viet Cong entered left flank. CAC sprung ambush, possibly one Viet Cong WIA. Uniform unknown, believed to have one semi-automatic weapon. Checked area out with negative results.

281245 Nov - Aerial Observer spotted 15 Viet Cong who were attempting to cross river in small boat vic YD 789101. Viet Cong were moving west to east across the river. Viet Cong were wearing green shirts and camouflage utilities, and khaki uniforms. Type of weapons unknown. 4/12 Artillery fired mission, Viet Cong dispersed. Mobile Strike Force was sent out to check area. While moving to make contact a booby trap was set off vic YD 796099. Results one friendly WIA. Negative results with Viet Cong.

282130 Nov - Combined Action Company - 3 while on a routine patrol of PHU BAI I spotted two Viet Cong armed and fired upon them at YD 900115. They did not kill or wound either of them, however they did find one K-50 magazine full and a M-26 grenade at this location.

282200 Nov - Combined Action Company - 3 continuing on patrol received fire from left flank at YD 903114. After firing had ceased and they checked out the area. They found blood stains and one cartridge belt with two carbine magazines and two grenades, one plastic cape, one camouflaged cape, one plastic bag, one small bottle of medicine, one possible trip rope across trail. Also found drag marks and three large spots of blood. Possible body was dragged some distance and then carried.

280330 Nov - FLSU-2 reports LP YD 889152 sighted two Viet Cong vic YD 887153. LP fired seven rounds with negative results.

292046 Nov - Combined Action Company - 3 on patrol encountered estimated 20 Viet Cong vic YD 906114. Patrol opened fire and after fire fight Viet Cong moved south. Three Viet Cong KIA. Vicinity YD 908111 CAC ambush fired at Viet Cong and 4/12 Artillery fired HE rounds. The following morning CAC recovered another Viet Cong^{KIA} vicinity of first encounter, and found one Viet Cong corpsman WIA. The S-2 scouts made a patrol of where artillery was fired and found blood at vic YD 892102, YD 892109, and YD 900104. The following equipment was captured:

4. Significant Trends During Period. The Combined Action Company encountered on 29 November 1965 showed that the enemy was willing to fight instead of immediately breaking contact. During the period there was a total of 144 Viet Cong sighted by either Observation Posts or Visual Reconnaissance flights in or near the Tactical Area of Responsibility as compared to 258 the previous month.

5. Enemy Situation At End Of Period. The 802nd Battalion at sometime at the beginning of the month moved their troops out of the HUONG THUY and NAM HOA Districts and moved into the QUANG TRI District. They suffered heavy casualties in an engagement with ARVN and now have returned to the HUONG TRA mountainous area to undergo rebuilding.

The P-18 Local Force has been reported to be using the vicinity of YD 798076 as ~~where~~ Headquarters but operating in the PHU VANG District.





LOGISTICS

1. Supply. On 23 November the direct delivery package from MCSC, Barstow, California arrived at this unit. This package, containing such critical items as M-14 magazine pouches, 45 Cal. magazines, mess utensils and vehicle tires and tubes, has alleviated some of this units problem supply items.

2. Cantonment and Camp Facilities Development. During the month of November the cantonment program was the most significant logistical event. a. The month of November a noted increase of colds and a slight increase in Upper Respiratory Infections and skin infections due to the heavy rains were seen. There were seven cases of Gonorrhea and seven cases of Non Specific Urethritis this month.

b. The Village of Gai Le, which has a dispensary run by Civilian Public Health Nurses, Midwives, and Student Nurses, now has the Medical Assistance twice weekly by a Doctor and Corpsman from 3rd Battalion 4th Marines Battalion Aid Station.

c. The CB'S have built five "8-Holers" and one "4-Holer" that are very well constructed and walled and screened in.

d. Straggler immunizations were given last month, however, there are still some stragglers plus new men which will be taken care of between the sixth and tenth of December.

e. Medical Indoctrination talks are now being given to ~~PN~~New Men reporting to the Battalion and Vietnam.

f. One day weekly (Thursday) has been designated "training ^{or} day" for all corpsman of 3rd Battalion 4th Marines. A lecture and/or instruction period is given in the Battalion Aid Station at 1330 or thereabout on such subjects as advanced first aid, sanitation and health records.

a. The need for more intensification in the handling, cleaning, and especially the safety factors of the Army .45 Caliber Pistol for Hospital Corpsman.

1. During this period, the civil affairs program continued as in the past. The Battalion Medical Team visited the Villages of Thuy Luong, Thuy Tan, Thuy Phu, Loc Ben and Gia Le once each week. The medical team treated an average of ninety-three (93) persons per visit. Food-stuffs, toys, clothes, soap and candy were distributed throughout the above named villages. The Catholic Chaplain said Mass twice a month in the Villages of Thuy Phu, Loc Ben, Thuy Luong and Thuy Tan with a total attendance of 178 people.
2. Thirty-one (31) persons were medically evacuated to hospital facilities.
3. Two (2) foreign claims were processed and forwarded while one (1) claim is still pending.
4. Marine Corps Birthday celebrations were held in the Village of Thuy Luong, Thuy Tan, Thuy Phu and Loc Ben. The Village Chief, Village Council and PFs attended the festivities in their respective villages.
5. Thanksgiving Dinners were held in the Villages of Thuy Luong, Thuy Tan, Thuy Phu and Loc Ben on Thanksgiving Day. The Village Chief, Village Council and PFs attended the dinners in their respective villages.
6. The Civilian Military Advisory Council held its monthly meeting on 3 November. Village defense, betterment of villages, training of PFs and timely reporting of intelligence were discussed.

Combined Action Company

1. The CAC continued to conduct counterinsurgency operations in the four villages of Thuy Luong, Thuy Tan, Thuy Phu and Loc Ben. Civic Action was conducted each day which involved minor road repairs, drainage repairs and bridge support. Medical assistance was rendered each day by the platoon corpsman who treated an average of twenty-two (22) patients in Thuy Luong, eleven (11) patients in Thuy Tan, twelve (12) patients in Thuy Phu and eight (8) patients in Loc Ben per day.

2. During normal operations, the CAC platoons remained in their respective villages six (6) days per week and averaged eighteen (18) operations per week. The following special operations were conducted:

a. Three platoons conducted a sweep and clear operation in the Hamlet of Hoa Phung from (913163) to (916162) on 19 November. Six (6) VCS were apprehended.

b. On 29 November, CAC #3 encountered a platoon of VC in the Village of Thuy Phu. The results were. one (1) friendly KIA, three (3) friendly WIAs, four (4) VC KIAs, one (1) VC WIA, two (2) weapons captured and evidence which indicated four (4) other VC casualties.

3. Through the activities of the CAC, the villages of Thuy Luong, Thuy Tan, Thuy Phu and Loc Ben remain pro-RVN and ^{HAVE} successfully denied their use ^{to} the VC overtly and have curtailed any covert activities.
