1. Enemy Situation at the Beginning of the Period. The only confirmed unit in the vicinity of our TAOR was the P-18 Local Force Company located at vicinity of (YD 789076). The strength of this company averaged eighty-five personnel. There were numerous reports of an unidentified battalion in the vicinity of (YD 755107) but this was never confirmed.

2. Enemy Incidents During the Period.

a. 011930 Dec. Company M, 1st Platoon in ambush vicinity (YD 814183) sighted 6 man VC patrol which came to left flank of ambush. Marines and Popular Forces opened fire on VC. VC did not return fire. Two rounds of illumination were fired by artillery. Two Marines and 4 PF's observed 2 VC fall into rice paddy. A thorough search of the area was made, but the bodies were gone. Marines pulled back temporarily from ambush site and then started combat patrol. As patrol was going back in vicinity of ambush site they saw at 012145H approximately 6 VC moving east towards patrol on railroad tracks. Marines fired on VC and VC turned around and ran in a westerly direction. Search was made of area and the following was found: 1 Chicom 7.62 Carbine, 1 bottle cough medicine, 1 bottle quinine, 1 tin box with medicine, 2 tubes of aspirin, 1 small bottle alcohol, 4 M-26 grenades, 1 poncho, 1 carbine magazine pouch, 1 pouch (unknown) and 3 7.62 shells.

b. 012130 Dec. Combined Action Company-4 sighted 3 to 4 VC vicinity (YD 926107). CAC-4 fired and VC moved in southeast direction. Negative results.

c. 022115 Dec. Company M, 2nd Platoon, while in ambush vicinity (YD 908089) spotted 15 to 25 VC in a very close column moving north carrying small arms. Approximately 15 VC passed ambush position when Marines opened fire, but VC did not return fire but dispersed in many directions. Five VC came on left flank of ambush and left flank opened fire on them. VC, after being fired upon moved north along river bank. Patrol from ambush was sent to search killing zone with negative results. 2nd Platoon, Company M moved 25 to 30 yards, spotted 2 VC believed to be looking for weapons or bodies. Marines opened fire upon VC, VC fled east. The following morning a search was conducted and the following was found: 1 Chicom 7.62 Carbine, 3 long stem frag grenades, 1 canteen pouch and 1087 pisatres. One Marine moved to check brush, spotted 1 VC WIA trying to pull string of grenade, Marine opened fire on the VC, result 1 VC KIA. Platoon leader stated that signs indicated that 7 to 10 bodies were dragged off in a northerly direction.

d. 032215 Dec. Company M, 2 Alpha, while in ambush vicinity (YD 908089) right flank spotted 1 VC trying to cross in front of their position. Marines and VC spotted each other approximately at the same moment. Marines opened fire and VC disappeared.

e. 052155 Dec. Company K, 3rd Platoon made contact with 6 VC at vicinity (YD 818176). After brief fire fight VC broke contact. Platoon searched area with negative results.

f. 110150 Dec. Company M, 2nd Platoon while in ambush YD 792150 made contact with 9 VC moving from north to south. Second platoon opened fire and fired 60mm Mortars as a blocking fire. Second platoon moved carefully and aggressively into killing zone and cleared area. Search was made of area results as follows: 3VC KIA, 2 VCC, 2 M-1 Carbines, 2 MAT-49, 2 MASS-36, 1 cartridge belt U.S., 2 MAT-49 magazine pouches, 1 tube of salve (Tetracyclini), 1 canteen pouch, 5 carbine magazines, 56 30 Cal carbine rounds, 4 MAT-49 magazines, 66 rounds MAT-49 (7.62 short), 3 grenade pouches VC, 2 VC cartridge belts, 2 carbine magazine pouches, 2 short stem frag grenades, 1 pair black trousers, 2 pair blue shorts, 1 dyed green shirt, 1 pair khaki trousers, 923 piasters, 1 pair trousers green, 5 bags of rice. The 2 VC KIA were wearing black shorts and khaki shirts, 1 VC KIA wore khaki shorts with green utility jacket.

g. 150050 Dec. Combined Action Company-3 while on patrol met unknown number VC at YD 906109. CAC-3 immediately opened fire and VC dispersed. 4/12 Artillery fired mission. CAC-3 made search of area at first light with negative results.

h. 150250 Dec. B Recon with 4 man team of Battalion S-2 Scouts in ambush YD 786126 received a short burst of automatic weapons fire approximately 50 meters from 7 VC. Recon immediately returned the fire and 4/12 Artillery fired mission. Recon at the first light made thorough search of area and found footprints.

i. 160416 Dec. B Recon received 1 grenade incoming at 0345H vic YD 786126 from 4 VC moving south towards river.

j. 171234 Dec. Company K, 3rd Platoon reports that one 6x6 truck hit land mine at YD 818179. One friendly casualty.

k. 182158 Dec. Combined Action Company-1 fired upon 2 boats approximately 100 meters. Shot illumination YD 883165 but couldn't see anyone. Boats were too far out to check. PF called to boats for them to answer. Negative answer.

l. 182221 Dec. Combined Action Company-4 reports receiving 5 rounds at night position YD 929091. Negative casualty.

m. 182246 Dec. Combined Action Company-3 reports approximately 3 VC moving north through PHU BAI-3 vicinity YD 908123. Marines opened fire but didn't receive any rounds.

n. 182330 Dec. Combined Action Company-3 reports 1 VC attempted to cross road from south to north 100-meters from their position YD 908123. CAC-3 fired, VC headed north. Negative results.

SECRETCOMMUNICATION-ELECTRONICS

1. It is recommended that limited third echelon parts such as battery plugs for PRC-6, AFC stages, battery cables for PRC-10 and switches for PRC-6 be authorized for battalions in order to keep the communications equipment deadline percentage down. The AN/URM-48 Signal Generator and the AN/PSM4 multimeter are sufficient to handle the increased capability.
2. In order to provide a base camp with the necessary power that is required, a heavy duty, high output, continuous operating diesel generator of 30KW capability is needed, along with a sufficient amount of heavy duty electrical wire, about 10,000 feet.
3. Guerrilla Warfare also brings about the necessity to dispatch a technician to outlying companies that are divorced from a base camp. In order for the technician to diagnose trouble and make on the spot repairs, an increase of one (1) AN/USM15 is required.
4. A problem that also arose, particularly in the rainy season, was the need of protecting the radios. Each company was issued an ample supply of waterproof bags. However, the line companies were reluctant to use these bags, because the "whitish" color would give away their ambush and patrol positions and pin-point the units CP group. A green or camoflouge bag, with a non-reflective surface, would be ideal in place of the white, CW-436 and CW-437 bags, that are now in use.

1. Significant Events:

(a) Numerous artillery missions were fired at actual and suspected VC targets. ARVN operations also received support from artillery fires. Many illumination shells helped to spot and destroy the enemy.

(b) The 4th Battalion, 12th Marines continued conducting a busy schedule for readiness with both day and night displacements for it's units. These displacements enabled fires to be placed at a greater range outside the TAOR on suspected VC positions or targets of opportunity. During one operation all of the units displaced simultaneously. Battery "M" moved one platoon of guns forward, Battery "I" took two platoons out, and Whiskey Battery displaced entirely. These forward units fired, massing fires, reinforcing fires, TOT's, and registrations. Each Battery had it's own FDC accompanying it, and, in addition, the Battalion FDC was also in the field.

a. General Status. The status of supply for this command is considered to be very good, with the exception of certain problem areas listed below:

b. Arrival of Criti-Pak shipments of supplies during the period of this report has been instrumental in improving the supply support capabilities of this command.

c. Significant problem areas.

(1) As stated in previous reports, shortage of typewriters is still considered to be a major supply problem area. Of the eight (8) typewriters on valid requisition, none have been received to date.

(2) Unavailability of SLIT cards (NAVMC 10493-SD) has created a problem, since this is the required document used to introduce supply demands into the supply system. Since arrival of this battalion in Vietnam, SLIT cards have been in critically short supply on three separate occasions.

(3) Some members of this command are still without such items of individual equipment as air mattresses, knife, fork, spoon, canteen cups, and in many cases do not have sufficient M-14 ammo pouches to house their required basic allowance of ammunition. Some of these items have been on priority 05 requisition since April 1965.

7. Maintenancea. General Status.

(1) Electronics. The general status of equipment is reaching the critical stage. More than 40% of our T/E of both types of radios AN/PRC-6 and AN/PRC-10 are in FLSU #2 for repair. Deadlining of radios at second echelon for tubes is becoming prevalent.

(2) Ordnance. The general status is good at this time. Outstanding documents for replacement items still exist. These are for two M-60 Machine Guns and three M-79 Grenade Launchers.

(2) Unit commanders are responsible for the coordination and timely movement of their personnel, vehicles and supplies to designated staging areas as designated in Annex B (Staging, Berthing and Loading Schedule).

(3) FLSU-2 provide wreckers to escort vehicle convoys.

(4) Security:

(a) Company K be prepared to provide a security detachment of 20 men for landing sites R 1 through R 4.

(b) Company M provide 20 men for security of the Col Co Causeway and Hue Ramp R 1 through R 4.

(c) Engineer Platoon provide adequate security for the Hue Ramp from R 1 minus through R 4.

(d) Battalion ALO arrange air coverage for litterage traveling Song Hue River and for truck convoys traveling from Phu Bai to Hue Ramp and Col Co Causeway on R 1 through R 4.

(e) Battalion Liaison Officer to 1st ARVN Division arrange for PF's to act as route security.

3. Personnel

a. Uniform, Equipment and Baggage

(5) Only 1 Seabag will be transported. This seabag will accompany personnel to landing sites and aboard shipping. The second containers will be stowed in accordance with Annex B (Staging, Berthing and Loading Schedule).

b. Advance Details

- (1) Working parties, and security details will be removed to respective embarkation points prior to the movement of any materiel or vehicles.
- (2) Embarkation Team Commanders will make arrangements for billeting and messing of advance details.
- (3) Company L provide 1 platoon for working party on an as required basis.

d. Movement of the Main Body

- (1) In accordance with Annex C to be published separately.
- (2) Commencing on R 3 and thereafter commensurate with reference (d), troop convoys will be formed at designated staging areas (Annex B) and shuttled to embarkation points.
- (3) S-4 office will be the convoy control and coordination point.

e. Embarkation Rosters. S-1 will promulgate instructions for submission of embarkation rosters.

- (3) Staging Control Officer ensure that all vehicles and cargo are staged by Hull Number, Hold and Deck Level in all staging areas to facilitate loading.
- (4) Staging Control Officer prepare adequate signs to aid in staging control.
- (5) Annex B (Staging, Berthing and Loading Schedule) indicates where and when vehicles and supplies will be staged.

c. Material Handling Equipment

5. Embarkation Schedules

- a. Relieving Dates. Loading will commence as soon as the relieving Battalion has completed offloading. Total relief will be accomplished in 96 hours. The days during which the cycle will take place have been designated as R 1, R 2, R 3, R 4 in reference (d).
- b. Berthing and Loading Schedule. Annex B (Staging, Berthing and Loading Schedule).

6. Control

a. Traffic Circulation and Control

- (1) Convoy routes and traffic control points are indicated in Appendix 1 and 2 of Annex B to reference (b).
- (2) RIO, provide personnel to man traffic control points and to ensure continuous, smooth traffic flow to and from staging areas in accordance with Annex B.

7. Miscellaneous

- a. Loading Plans. Individual Ship Loading Plans will be prepared and distributed in accordance with reference (a).
- b. Loading Reports. Each Team Embarkation Officer will be provided with a package of required reports. He will be responsible for their accurate and timely submission to the headquarters indicated.
- c. Debarkation. In accordance with Annex D.



1:50,000) Not To Scale.





- a. Debarkation will commence on order of CTG 76.7 upon arrival in Okinawa.
- b. Sketches of the primary routes of march on Okinawa and of the White Beach area are included as Appendix 1 and 2 to this Annex.

2. Advance Partiesa. Advance parties will:

- (1) Make arrangements for debarkation and inform BLT 3/4 by messenger of any significant events which would effect debarkation.
- (2) Arrange for transportation of troops and equipment to respective camps.
- (3) Make liaison with 3rd FSR and 1st Service Battalion to pick up vehicles and equipment requiring third and fourth echelon repair.
- (4) Coordinate the timely arrival at POD of representatives from the parent organizations of the units attached to BLT 3/4.
- (5) Construct signs to indicate where units/vehicles/cargo should stage for further transportation to respective camps.
- (6) Provide guides from POD to camps.

3. Debarking Unitsa. Troops

- (1) One representative from each major unit to debark (Company, Battery, Attachment or Detachment) report to Embarkation Control point (Appendix 2) immediately upon arrival debarkation area to coordinate transportation requirements. Reporting individual must know the number of personnel and amounts and types of supplies requiring transportation.
- (2) Debarking troops must not become detached from their packs and seabags. If conditions permit, troops will be loaded immediately on trucks with their gear stacked in an attached trailer. This will minimize troop baggage "losses".

b. Vehicles

- (1) Operable vehicles will be offloaded and formed into convoys at points to be established by the advance parties.







1. HELICOPTER. Inclement weather greatly curtailed Helicopter Support Operations during December 1965. Because of the inclement weather, only an average of approximately one hour per day was flown in support of the Battalion. The support flown, included outpost resupply, reconnaissance flights, airborne Hunter-Killer flights, and small unit lifts. There were no noteworthy events concerning Helicopter Support during December.
2. CLOSE AIR SUPPORT. There were no close air support missions flown in support of the Battalion during December.

~~SECRET~~MEDICAL AND DENTAL SUPPORT1. SIGNIFICANT EVENTS

- a. Ten B.A.S. Personnel were helilifted to ships on 22 December 1965.
- b. On 23 December 1965 the B.A.S. personnel completed packing all supplies and records for embarking for Okinawa. Remaining medical supplies, including Morphine Syrettes, were turned over to the Medical Officer of 2nd Battalion 1st Marines with an inventory of the same.
- c. The remainder of B.A.S. personnel were helilifted aboard ship on the afternoon of 23 December 1965.
- d. On 25 December 1965 the advance party of which two Hospital Corpsman were attached, left by air and arrived in Okinawa 26 December 1965. They drew Sick-Call supplies to be used by the main body, which later landed on White Beach, and then proceeded to Camp Hansen on 29 December 1965 and set up new B.A.S.
- e. On 30 December 1965 the B.A.S. received Medical Block and placed it in storage.
- f. There were two medical cases that required admitting while aboard ship. One inguinal hernia repair case and one Punji-stick wound case who later came down with measles. Surgical repair of the former was performed on board ship. Both cases were released to duty by 1 Jan 66. There was a moderate increase of foot infections mostly fungi, as a result of the people coming up from the Chu Lai area of operations.

2. MEDICAL TRENDS

- a. A maximum effort by all hands to cure all fungi and parasitic infections present or believed to be present in persons returning to the Republic of Vietnam.
- b. An intensification on lectures to medical and non-medical personnel alike on first-air, malaria, V.D., hygiene and sanitation, and lessons learned in RVN prior to deployment.
- c. A special lecture to all corpsman pertaining to heli-evacuations and advanced first aid.

d. Full utilization of the four week course on the Vietnamese language, 2 MedCAP corpsman assigned.

3. BATTLE CASUALTIES

5. PREVENTIVE MEDICINE

a. Twelve new urinals were ordered to be built by "A" Engineers for installation throughout the Battalion area at Hue, Phu Bai, RVN.

b. Ten basket type rat traps were ordered from a civilian store. These weren't ready before the Battalion embarked, However the relieving medical department was informed of this.

c. Twenty-two rodents were caught during the month, from 1 Dec to 12 Dec 1965.

d. A new five-hundred man galley and mess-hall and three new showers were under construction prior to leaving the Hue, Phu Bai area.

6. CIVIL AFFAIRS RENDERED

a. All records of patients treated, medications (by type), and schooling conducted were reviewed with and turned over to the relieving Medical Department, 2nd Battalion 1st Marines, prior to departure of 3rd Battalion 4th Marines.

7. PROBLEM AREAS

a. The Battalion Ambulance continues in a deadline status. Also the lack of a typewriter for the B.A.S. has created many difficulties when trying to maintain Health and service records. Both of these deficiencies should be rectified prior to BIT 3/4 returning to RVN.

1. The Medcap Team visited the villages of Thuy Luong, Thuy Tan, Thuy Phu, and Loc Bon once a week and visited the dispensary at Gia Le twice each week. Approximately 1500 patients were examined/treated during the month of December.

2. Christmas Parties for children in the following villages were held on 21 December 1965, with a total attendance of over 3000.

- (a) Thuy Luong
- (b) Thuy Tan
- (c) Thuy Phu
- (d) Loc Bon

3. Parties were also held at:

- (a) Phu Luong School -250 children- by "A" Med
- (b) Phu Luong Refugee Camp -1800 children- by 4/12
- (c) Thua Thien Buddhist Orphanage -250 children- FLSU-2

4. 1500 lbs of soap and 200 lbs of clothing were distributed through CAC, and 4/12, to villagers and refugees. A small amount of captured food was also donated to refugees.

5. A party of 200 high school students from the Hue area were hosted by the battalion on 21 December 1965. The students brought Christmas greetings and gifts to all the troops of the Phu Bai Complex.

6. Combined Action Company continued its program of road construction and the repairing of dikes in the villages of Thuy Phu, Thuy Luong, Thuy Tan, and Loc Bon. The CAC repaired approximately 6 foot bridges in the villages mentioned above.
