1. Enemy Situation At The Beginning Of The Perioda. Operation Holt, 2 July 1966 to 6 July 1966.

Elements of two VC Battalion were operating in the SONG BO River Area from coordinates YD 562180, North to YD 604240. As a result of Operation JAY, the suspected enemy battalions, the 802nd and the 806th, were believed to be at no more than two thirds strength, or 500 men in both forces combined. Enemy sites and areas of use that were reported to be in the area of operation by previously conducted reconnaissance patrols and aerial observation flights were a VC camp site located at YD 561192, four huts at YD 576201, a fording site at YD 592205, battalion assembly area at YD 587208, and a VC installation of unknown type at YD 584215.

b. Operation Hastings, 14 July 1966 to 31 July 1966.

On 19 May 1966 a North Vietnamese Army Soldier surrendered to South Vietnamese Army Forces operating 10 miles south of the Demilitarized Zone (D.M.Z.) in Quang Tri Province, South Vietnam.

This N.V.A. soldier stated that he was a member of a 200 man advance party from the 324 B N.V.A. Division that was making a recon of the Quang Tri Area. He further stated that it was the intention of the 324 B N.V.A. Division to infiltrate south across the D.M.Z. into South Vietnam and seize Quang Tri Province.

During the latter part of May and the month of June, low level agent reports stated that elements of the 324 B N.V.A. Division were infiltrating into Quang Tri Province from North Vietnam.

Reconnaissance units began operating in the Quang Tri Area on 22 June 1966. During the period 1 through 15 July, a total of eighteen recon patrols were conducted, fourteen of which had to be extracted prematurely due to significant enemy contact. A total of 343 North Vietnamese soldiers were observed by the recon elements, indicating infiltration of a major enemy force into the area.

In the meantime, South Vietnamese forces were conducting limited operations in the Quang Tri area. On 5 July 1966 they captured a North Vietnamese soldier who stated that he was a member of the 5th Battalion, 812th Regiment, 324 B N.V.A. Division.

On 10 July, a Lieutenant from this same unit surrendered to South Vietnamese Forces operating in Quang Tri. The Lieutenant stated that the mission of the 324 B Division was to liberate Quang Tri Province and further destroy South Vietnamese Forces operating in the Province.

Based on the intelligence reports, numerous low level reports, aerial photographs and reconnaissance and the reports received from recon units, the following North Vietnamese units were established to be in the vicinity of the area of operations: the 90th Regt., the 812th Regt., and 803d Regt.

Each of the three infantry regiments composing the 324 B Division, was estimated to have a strength of 1500 men.

a. Enemy Equipment and Material Losses.

- (1) Individual: 29 ChiCom carbines, 7 AK47 SMG, 4 Sten Guns (British), 1 Pistol Cal. .45 (US), 2 Pistols (9mm) British, 1 K53 SMG, 1 Buckshot Signal Pistol, 3 7.62 Russian MGs, 2 82mm Mortars w/base plates.
- (2) Ammunition: 361,760 rds S/A, 73 ChiCom grenades, 183 82mm Mortar rds, 24 AT Mines, 32 empty shoe mines, 16 stick grenades adapted for use as booby traps, 1 M-26 grenade (US), 5 blasting caps, 10 82mm Mortar HE light rounds.
- (3) Equipment: 20 packs, 65 assorted magazines, 250 lbs assorted web gear, 1200 lbs. medical supplies, 3 82mm Mortar base plates, 2 82mm Mortar bipods, 3 7.62 Russian MG barrels, 30 small shovels and picks, 25 canteens, 12 hammocks, 1 armor shield to MG, 1 heavy MG mount, assorted extra parts to MG, 5 ID cards, 1 US canteen, 4 sets mess gear, 50 lbs. Individual clothing, 30 lbs. of Documents, 30 lbs. of Khaki uniforms, 20,000 piasteres.

4. Significant Trends During Period.

a. Operation HOIT 2 July 1966 to 6 July 1966.

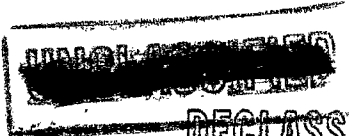
During the operation the suspected enemy sites and areas mentioned in Section I were checked with negative results. Significant findings included a river ford and harboring site located at YD582198. This is a flat sandy beach area with trails and evidence of enemy inhabitations. A network of tunnels, trenches, and trails is located at YD607225. Based on the contacts, sightings, terrain, and trails in the area it appears that the SONG BO River is a main VC route used for the movement of units and supplies.

b. Operation HASTINGS, 15 July 1966 to 31 July 1966.

Contact with NVA soldiers commenced immediately as 3d Bn, 4th Mar. began landing in the LZ (YD041649) on 15 July and continued, with slight lulls until the Battalion was extracted from YD [REDACTED]

05365. July 1966. The captives taken, the bodies recovered, the tactics employed, and the equipment and weapons captured were those of North Vietnamese Army Units. Extensive fortifications and living positions along stream vicinity (YD 038642), medical supplies, a "jungle hospital" at (YD 036641), and well stocked ammo and weapons caches at YD 042652 and YD 036641 indicate enemy forces of considerable size were present in the area of operations. Medium caliber anti-aircraft weapons were employed by the enemy in an attempt to interdict helicopter traffic. Indications were that USMC supporting arms played a major role in keeping the enemy from massing his forces for a concentrated attack. It appears that the enemy seeks to avoid contact except at a time and place of his own choosing. Boobie traps were not encountered by friendly forces.

5. Enemy Situation at End of Period.

a. Operation Holt, 2 July 1966 to 6 July 1966.

The lack of significant contact or sightings during the operation indicated that the remnants of the two suspected enemy battalions, the 802d and the 806th, were not present in the area of operations. It is probable that the enemy had moved further south along the river and out of the operating area or possibly utilized and inhabited a different area after operation JAY.

b. Operation Hastings, 15 July 1966 to 21 July 1966.

Contact between 3d Battalion, 4th Marines and the enemy was initially light, becoming heavy and generally continuous by the evening of 15 July (SEE SECTION IV) until 24 July when contact became light and no significant enemy personnel sightings were reported by reconnaissance patrols or aerial observations.

A total of 14 North Vietnamese soldiers have been captured by Task Force Delta units operating in Operation Hastings. These captives were from five of the battalions of the 324 B Division. Most of them were young and had been drafted into the North Vietnamese Army. All reported that their units had infiltrated South Vietnam during May and June. The majority of these captives reported that their units had been headed in a northerly direction towards the D.M.Z after 15 July.

Detailed interrogation of captives, translation of captured documents, and decreasing intensity of contact between Task Force Delta units and elements of the 324 B Division indicate that the enemy forces have suffered extensive casualties, are disorganized, of low morale, and presently avoiding contact.

- a. On 9 July 1966, "I" Company was placed under OPCON 4th Marines.
- b. On 9 July 1966, "I" Company was returned to OPCON of 3d Battalion, 4th Marines.
- c. On 19 July 1966, "G" Company, 2d Battalion, 1st Marines was placed under OPCON of 3d Battalion, 4th Marines.
- d. On 20 July 1966, "G" Company was returned to OPCON 2d Battalion, 1st Marines.
- e. On 20 July 1966, "K" Company was placed under OPCON of 1st Battalion, 4th Marines.
- f. On 20 July 1966, "M" Company was removed from OPCON 1st Battalion, 4th Marines at 0600H.
- g. On 21 July 1966, "M" Company was placed under OPCON 3d Battalion, 1st Marines from 0600H to 1630H.

4. Close Combat

(1) 2 July 1966

- (a) At 2030H, "K" Company (YD 564187) made contact with approximately six (6) VG in three (3) boats, moving northeast down the SONG BO river at YD 566185. The VC were taken under fire with S/A. Results, 1 VC KIA, 5 VC KIA (probable), 3 boats sunk.

- (b) At 2115H, "L" Company (YD 572180) spotted 1 to 3 VG in a boat at

571180. The VC were taken under fire with S/A. Approximately 10 rounds of automatic fire was received from the VC. Results, search of area at first light revealed 1 sunken boat, riddled with bullet holes; containing personnel clothing and a U.S. helmet liner.

(2) 3 July 1966

- (a) At 0710H, "K" Company received 1 round of sniper fire, returned fire with S/A. Results, 1 VC KIA (probable).

(3) 5 July 1966

- (a) At 1930H, "K" Company patrol received 7-10 rounds of automatic fire from 2-3 VC, located approximately YD607224. Returned fire with S/A and called for Artillery mission. Results, 2 friendly WIA's, 3 VC KIA (probable), captured 1 bag of rice, clothing, food container, hammock, and one rubber sandle.

(4) 6 July 1966

- (a) At 0541H, "I" Company lines observed approximately 12 VC fording river at YD 581194. VC taken under heavy small arms fire, 60mm mortars; Artillery mission was called on suspected route of egress. Results, 7 VC KIA, 4 VC KIA (probable), 1VCC, 7 packs containing food, clothing, documents, and personal gear. 1 U.S. .45 Cal. Pistol, 2-9mm Canadian Pistols.

(5) 14 July 1966

- (a) At 141620H, H&S Company received one incoming .50 Cal. round at YD 254598. Results, 1 friendly WIA.

(6) 15 July 1966

- (a) At 150935H, "K" Company spotted 1 North Vietnamese soldier guarding a rice cache at YD 037641. Results, "K" Company opened fire - 1 North Vietnamese KIA, 1 Chi Com carbine.
- (b) At 151030H, "I" Company spotted approximately 12 North Vietnamese soldiers moving in stream at YD 037655. North Vietnamese were taken under fire and they withdrew upstream. Results, 2 North Vietnamese KIA (confirmed), 3 North Vietnamese (probable), 1 K47 automatic carbine, 1 Chi Com carbine, 1 buckshot pistol (signal), 10 packs with individual equipment, 1 USMC WIA.
- (c) At 151215H, "K" Company was taken under fire by approximately 15 North Vietnamese soldiers. Fire was returned by "K" Company. Results, 2 NV KIA (probable), 1 Chi Com carbine, 2 grenades, 2 friendly KIA, 2 friendly WIA, 3 rifles missing-M14, 3 packs, and 1 machete.
- (d) At 151350H, "I" Company recovered 1 NV body, YD 035655, which resulted from earlier firefight. Recovered magazines and assorted 7.82 gear.

- (e) At 151740, 2d Platoon, "K" Company received incoming sniper fire. Sniper was taken under fire. Results 1 North Vietnamese KIA.

- (f) At 151808H, Helos inbound east over river received automatic weapons fire. One helo was hit, caught fire, and crashed in Battalion C.P. Several minutes later the C.P. was taken under fire from the North, South and East. S/A fire, 81's and Arty missions were called. Ensueing fire fight lasted until approximately 2030H. Results, 2 friendly KIA, 5 friendly WIA. 3 WIA crew members from downed helo and 13 bodies in wreckage. Effect on enemy unknown at this time.

- (g) At 151850H, "K" Company fired at 1 sniper which had been firing on them since early morning. Results, 1 North Vietnamese KIA.

(7) 16 July 1966

- (a) At 160628H, Battalion C.P. and "I" Company lines received approximately 20 rounds of incoming mortar fire at YD 039648. Arty mission was called on suspected enemy position, fixed wing was also called in. Mortar fire ceased. AO observed approximately 20 North Vietnamese in impact area. Good effect on target, however the AO was unable to give count of bodies.
- (b) At 160830H, "I" Company searched area of suspected movement fixed on during darkness, YD 042647. Results, 2 KIA, 1 carbine, 7 Chi Com grenades, parts to machine gun, assorted 7.62 gear.
- (c) At 160930H, "K" Company reported 50-75 North Vietnamese soldiers had attacked their position. North Vietnamese soldiers were taken under fire by S/A, M-79's and grenades. Results 4 friendly WIA, 25 North Vietnamese KIA (confirmed), 25 North Vietnamese KIA (probable). 7 Chi Com automatic rifles, 1 .50 Cal machine gun with armor shield and extra barrell, 2 light machine guns, 2 7.62 Cal Com carbines and 20 Chi Com grenades captured.
- (d) At 150950H, "L" Company searched area where it had fired at an unknown number of North Vietnamese soldiers the previous night with S/A, M-79 and grenades. Results of search: 1 North Vietnamese KIA, 7 North Vietnamese KIA (probable by virtue of 7 bloody drag marks) 1 K47 Sub-machine gun, 2 Chi Com carbines, 400 S/A rounds, 6 Chi Com grenades, 1 heavy machine gun mount, web gear, small shovels and picks, and 2 packs captured. (See 151808H entry)

At 161500H, "L" Company spotted 4 North Vietnamese heading south down river (YD 037654). Lead man was not carrying weapon. Fired upon North Vietnamese with 60mm mortars, M-79, and S/A. North Vietnamese continued south up river on the run. Results, 1 NV KIA, 1 pack containing personal gear and papers.

At 161134H, "I" Company fired upon 1 NV moving up stream bed at YD 041649. Results, 1 NV KIA, 1 Chi Com semi-automatic rifle, 3 stick grenades, 220 rounds of ammunition.

- (g) At 162000H, "K" Company made contact with estimated 1 North Vietnamese company of approximately 100 men. Enemy taken under fire with S/A, grenades, M-79's, and artillery. Results, 1 friendly KIA, 5 friendly WIA, 32 North Vietnamese KIA (confirmed), 40 North Vietnamese KIA (probable), 7 Chi Com carbines, 1 Chi Com light machine gun, 1 heavy machine gun with extra barrel and spare parts, 3 Chi Com service rifles, 31 North Vietnamese grenades, 33 magazines, 8 canteens, 2 picks, 4 E-tools, 3 hammocks, 8 leather pouches, numerous documents captured.

(8) 17 July 1966

- (a) At 171300H, one man from "I" Company went to watering point. NV in tree threw one concussion grenade. "I" Company swept the area, found 1 North Vietnamese who appeared willing to surrender. IIT sent to position and the prisoner surrendered. Recovered 1 K53 submachine gun, cartridge belt, canteen, 2 magazines, 40 rounds of ammunition, 1 tablet blank.
- (b) At 172008H, "K" Company fired at 1 North Vietnamese (YD 035-640) who tripped a flare in front of their position. Opened fire on NV. Results, 1 North Vietnamese KIA.
- (c) At 172250H, "K" Company spotted 4-5 North Vietnamese near river (YD 038640), North Vietnamese opened up with grenades. 81mm illumination fired, also S/A. Effect on enemy unknown.
- (d) At 172355H, "K" Company reported probing of their perimeter with S/A and grenades. 81mm illumination fired, S/A and M-79 rounds were fired in return. Effect on enemy unknown.

(9) 18 July 1966

- (a) At 180210H, "K" Company reported continuous probing of lines through the night. North Vietnamese S/A and throwing grenades. "K" Company returned fire with M-79, S/A, grenades, and effect on enemy unknown.
- (b) At 180303H, "K" Company reported that they had made contact with approximately 50 VC around their perimeter. "K" Company opened fire with S/A and an artillery mission was called in. Effect on enemy, 3 North Vietnamese KIA (confirmed), 15 North Vietnamese KIA (probable), 1 magazine captured.

(c) At 180945H, "K" Company spotted 1 North Vietnamese at YD 040639, 75 meters SE of "K" Company CP. Enemy was taken under M-79 and S/A fire. Effect on enemy unknown.

(d) At 181021H, Battalion CP and "L" Company lines received incoming S/A fire. Arty, 81's and S/A fire returned. Estimated North Vietnamese numbered 5 or 6. S/A fire stopped, contact broken. Effect on enemy unknown.

(e) At 181500H, the Battalion column, moving east toward new position, began receiving an estimated 20 rounds of 82mm mortar fire along the column. The column became separated in several places and separated from the two rear security platoons still in the CP area. As the mortar fire was received, an estimated 1,000 NVA assaulted the old battalion CP and closed with 2 platoons of "K" Company (66 Marines). The NVA assaulted the position from four separate avenues of approach. Six mortars were set up by the NVA in the same mortar positions used by the Battalion earlier. Heavy fighting at close range took place between the NVA and the 2 platoons of "K" Company. After the attack began, the Battalion Executive Officer, with "L" Company began moving back to the CP site to reinforce the two platoons of "K" Company. Movement was difficult and the column was receiving S/A fire. The Battalion Commander in the meantime was directing artillery and airstrikes on the NVA. The two platoons of "K" Company fought their way out of the CP while artillery and air strikes were being conducted. The artillery and air strikes were extremely effective and inflicted heavy casualties on the NVA. As the two platoons moved out from the CP site, approximately 20 minutes after the initial attack, they were not physically pursued due to their heavy casualties. The Marines were pursued by fire however. The two platoons met "L" Company who had come to reinforce them, still receiving small arms fire until approximately 181800H. Results, 15 USMC MIA, 48 USMC WIA, 139 NVA KIA, 362 NVA KIA probable.

(10) 20 July 1966

(a) From 201700H to 202000H, "I" Company reported contact with approximately 75 NV soldiers. Air was called in support. One platoon from "I" Company and one platoon from "L" Company with the Company Commander from "I" Company in command went to assist the patrol and aid in a Medical Evacuation. While the Medical Evacuation was in progress, incoming mortar fire began and the helicopters were forced airborne. At this time two platoons, one from "L" Company and one from "I" Company assaulted through the enemy strong point with success. "G" Company, 2d Battalion, 1st Marines

then directed to assist the elements of "I" Company and "L" Company in the clearing of the area, recovery of lost gear and helping to evacuate the friendly casualties to the Battalion C.P. The Battalion C.P. recieved S/A fire intermittently throughout the action. Results, 7 USMC KIA, 35 USMC KIA, 19 NVA KIA (confirmed), 27 NVA KIA (probable), 1 mortar base plate, 2 82mm bipods, 8 rounds 82mm HE, 3 light machine guns, 1 carbine, 2 submachine guns, 1,000 rounds of S/A linked, 1 grenade, 1 extra machine gun barrel and 1 pack captured.

(11) 27 July 1966

- (a) At 272240H a patrol from "L" Company reported that PF's reported 2 VC in the vicinity of YD 177586 and requested illumination be artillery. Negative results in observing the VC.

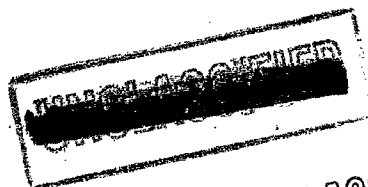

SECTION VI

COMMUNICATIONS-ELECTRONICS

1. Operation Holt - 2 July 1966 to 6 July 1966.

a. On Operation Holt the normal Battalion and Regimental nets were utilized (i.e. Battalion Tac, Regimental Tac, Regimental command). Continuous communications was maintained with Regiment. Communications with the companies was less satisfactory, however, due to the company movement into jungle vegetation and valleys.

2. Operation Hastings - 14 July 1966 to 31 July 1966.

a. On Operation Hastings continuous contact was maintained with Regiment. Communications on the company level was spotty due to the relative unreliability of the radio sets AN/PRC-10 and AN/PRC-6. Jamming was experienced on the Battalion Tac net and one of the company nets. This jamming was generally weak and ineffective to a good operator. It lasted for less than fifteen minutes on several occasions. There was no imitative deception.

b. Three AN/PRC-10's and four AN/PRC-6's were lost in the intense fighting on 18 July 1966.

SECTION VIIFIRE SUPPORT COORDINATION, NAVAL GUNFIRE1. Significant Events:

- a. On 1 July 1966, 3d Battalion, 4th Marines commenced Operation HOIT. 3d Battalion, 12th Marines was in direct support employing one 105 battery and one 155 battery. H&I fires were fired generously to deny the enemy routes of escape. Blocking fires were also effectively employed to channelize enemy movement.
- b. On 13 July 1966, 3d Battalion, 4th Marines began Operation Hastings with the 3d Battalion, 12th Marines in general support. Artillery firepower was provided by three 105 batteries, two 155 batteries and one mortar battery. During Operation Hastings many enemy positions were silenced with the foe either destroyed or forced to withdraw by observed artillery missions. Targets included automatic weapon positions, mortar positions, sniper positions, assembly areas, and supply areas. On three occasions heavy artillery fire helped to break the back of human wave assaults on 3d Battalion, 4th Marines positions. Blocking fires were effectively used to screen friendly movement until new defensive positions were established. Heavy H&I fires helped secure enemy routes of withdrawal from the operation area; illumination missions helped light up the battle area at night, and prevented surprise enemy activity during the hours of darkness.
- c. During Operation Hastings artillery firepower was used extensively in each of the roles it is capable of playing in warfare, and it played each role well.

AIR SUPPORT - DEFENSE

1. Air Support - July 1966

a. Air support provided the Battalion during the month of July was primarily in support of Operations HOIT and HASTINGS. During this month the following missions were flown in support of the Battalion.

1. Close Air Support: 22 missions (16 fixed-wing and 6 UH-1E missions).
2. Flare Aircraft: 3 missions (Two of these missions involved continuous illumination from 2030 until 0600).
3. Helicopter troop-lifts: 8 missions
4. Helicopter Medical Evacuations: 18 missions
5. Helicopter Resupply: 16 missions
6. Helicopter Reconnaissance: 6 missions
7. Command and Control Helicopter: 2 missions
8. Airborne Observer (O1E): 16 missions

No problems were encountered with Air Support during Operation HOIT. During Operation HASTINGS several problem areas were brought to light. These incidents generally involved a lack of adherence to established procedures. The following paragraphs will attempt to point out these incidents and bring about a re-emphasis of the procedures not being adhered to.

On the first day of Operation HASTINGS the Battalion Air Officer was unable to contact any helicopters inbound to the Battalion Landing Zone or in the vicinity of the Battalion Operating Area. It was later learned that the helicopter pilots had been briefed to monitor different frequencies. It is believed that two helicopters would not have received hits from enemy gunners during this operation had the pilots been monitoring the same frequencies as the ground unit's Air Officer. It is imperative that both pilots and ground unit Air Officers be briefed to monitor the same frequencies prior to the commencement of an operation such as this. The ground unit's Air Officer can brief the pilots on these frequencies - prior to the aircraft's entering the battle area - on such matters as disposition of landing zone, enemy positions, safe approach routes, possible enemy fire, etc. Adherence to such procedures is mandatory in order to avert the loss of friendly lives and aircraft.

Another problem encountered was the fact that too often helicopters working in support of adjacent units interfered with artillery and close air support missions in the operation area of this battalion. Since these aircraft, when working with adjacent units, are not always able to monitor the same frequencies as the unit receiving the artillery or close air support, this unit cannot always inform them of this support. All units should be aware of any artillery or air support being provided adjacent units. This information should be passed to any aircraft entering the area by the DASC, regimental FSOC, or the unit for which these aircraft are performing a mission. If such interference continues legitimate enemy targets may be lost or friendly aircraft inadvertently destroyed as a result. If the aircraft interfering with such support are on a higher priority or more urgent mission than that support, then the unit receiving this support should be so informed and the support missions ceased or postponed by either the DASC or regimental FSOC until such time as they can be safely continued.

Another incident indicating non-adherence to established procedures involved an aircraft firing a rocket into friendly positions (no casualties). The pilot of this aircraft did not have communications with the TAC (A) or the ground units FAC and had only sporadic communications with his flight leader. The 4th Marines Operation Order 301-66 clearly states that no close air support strikes will be flown without positive control of a TAC (A) or an FAC. It must continually be emphasized to pilots flying close air support missions that they are not to participate in such strikes when they do not have communication with the person controlling the strike, whether TAC (A), FAC or both. This procedure has been established to preclude ordnance being dropped on friendly positions. Non-adherence to these procedures can result in the same type of incident as this, which quite possibly, friendly casualties as a result.

The above incident also points out the all-important fact that positive target identification is absolutely necessary prior to running a Close Air Support Strike. This also is to preclude ordnance being dropped on friendly positions.

The above incident also pointed out a lack of adherence to established radio procedures. The ground FAC had switched his radio frequency to the Battalion TAC net from the air control frequency so that the patrol leader could make a report to the Battalion COC. It is mandatory that FAC's remain on air control frequencies at all times. Any information that must be passed to higher echelons can be relayed over these air nets if the proper nets are inoperative. When an FAC switches to another frequency in such a situation he is, in effect, relinquishing control of any aircraft that may be working with him at the time. Again, these procedures must be adhered to in order to prevent ordnance being dropped on friendly units.

- b. It should be noted that timely air support saved many lives during the month of July. Particular notice must be taken of the support pro-

vided on the 18th of July when a large enemy force attacked the rear elements of the Battalion during movement from a position occupied for several days. Continuous Air Strikes were flown in support of the Battalion from approximately 1430 until just prior to sunset. These strikes prevented the enemy from pressing his attack and inflicting even greater casualties on the Battalion. The subsequent medical evacuation of 35 WIA's by aircraft from HMM-161 and HMM-163 was an indicator of the professionalism and spirit of the pilots of these squadrons. The evacuations were conducted from a small, tree surrounded zone, under the cover of darkness, with flashlights as the only source of illumination and identification in the zone.

The diversity of Air Support provided this Battalion during the month of July proved effective in helping defeat the enemy forces encountered.

SECTION X

CIVIL AFFAIRS -- PSYCHOLOGICAL WARFARE ACTIVITIES

1. During the period of 1 July to 31 July 1966, sick call was held for 2666 Vietnamese. 425 bars of soap, one blacksmith kit, and 50 sewing kits were distributed. Sick call was held for the following villages:

2. On 8 July 1966 the Commanding Officer of Company "M" accompanied a Catholic priest from Loc An Village and distributed rice (VN GOV Rice) to the poor people of Loc Dien. The Commanding Officer of Company "M" also passed out 50 sewing kits to the people.

3. On 14 July 1966 the Commanding Officer of Company "M", accompanied by the village chief, presented a blacksmith kit to the blacksmith in Loc Dien (YD 969062). After the presentation the Commanding Officer of Company "M" was invited by the village chief for soft drinks which was accepted.

4. For the remainder of the month, civil affairs programs were limited due to the lack of MedCap supplies and Operation Hastings.

SECTION XIPROBLEMS ENCOUNTERED, LESSONS LEARNED BY SUPPORTING UNITS1. ITEM: Dead radio batteries upon receipt.

a. Discussion: Due to extreme heat and humidity in RVN, a large percentage of the radio batteries received were dead or weak and found to be useless upon receipt.

b. Recommendation: That attention should be given to proper storage at all times and whenever possible radio batteries should be checked at the LSA prior to being issued to requesting units.

2. ITEM: Breaking point of CH-46.

a. Discussion: Upon hard impact of downed CH-46's, it was noted that the plane collapses just forward of the engine. This resulted in the death of one Marine and one Hospitalman and injuries to three others by rear rotor blades.

b. Recommendation: That all personnel be indoctrinated to remain seated upon impact of downed aircraft until all rotors have stopped, and if at all possible exit through the front emergency exit.

3. ITEM: Fire-support Coordination with helicopters.

a. Discussion: Often fire missions could not be granted or had to be cancelled due to friendly helicopters flying in or across gun-target lines while supporting other units.

b. Recommendation: That helicopter approach and retirement lanes be established, and helicopters be required to travel along these lanes.

4. ITEM: Fire mission Clearance.

a. Discussion: Frequently excessive delays were experienced in getting requested fire missions. Delays were due primarily to the large number of units operating in a confined area.

b. Recommendation: That consideration be given to expanding facilities of Regimental FSCC by additional augmentation when conducting operations involving seven battalions. In addition the problem of coordinating fire support in an environment that requires narrow battalion frontages, which result in overlapping of missions into adjacent zones of action, should be studied for possible new methods.

5. ITEM: Selection of Landing Zones.

a. Discussion: Due to ground fire, aerial reconnaissance for selection of landing zones was conducted at a high altitude. Aerial photographs of the area were not available .

b. Recommendation: That in all cases photographs of prospective landing zones should be taken on a priority basis as early as possible in the planning phase of an operation.

nation was Division G-2. Negative contact in objective area. A SHAU is located on a valley floor. The only cover available is that portion of the fort left standing and the trenches around the fort. There is excellent concealment in the valley provided by seven to eight foot high elephant grass that covers the valley floor. The only obstacles are the hills that border the valley. The only good avenue of approach is the valley itself which runs in a NW to SE direction. Critical terrain is the high ground to the east and west of the fort and the hills located at YC 486837, YC 493844, and YC 498838 in particular which completely dominate the fort. Observation from the fort is very poor due to the high grass and surrounding hills.

8. Mission. Destroy ammunition in A SHAU Fort and one pallet of ammunition 150 meters west of fort.

9. Concept of Operation.

a. Alfa Group - Secure A SHAU, provide security, and assist EOD personnel in the destruction of ammunition.

b. Bravo Group - Locate and destroy pallet of ammunition at coordinates YC 492834 and rejoin Group Alfa.

c. EOD - Destroy ammunition in A SHAU Area.

d. Engineer Unit - Provide mine sweeping teams as required.

10. Execution. On 16 June 1966, Co I, 3-4, OPCOM to 4th Marines, was given mission of destroying ammunition at A SHAU. The CO, XO, and Platoon Commanders received briefing by the Division G-2 and Regimental S-3. On 17 June 1966, Co I submitted an operation plan for approval. Upon approval of plan of operations, the raiding party was briefed on 18 and 19 June. A rehearsal was scheduled and held on 20 June. On 20 June the operation was postponed for 48 hours. At 230635H, the raiding party departed the Phu Bai Airport by eight CH-46 helicopters from HH-164. The raiding party was in two groups.

a. Group Alfa - At 230700H landed in LZ at YC 495835, debarked from helos, and swept through fort area and established security posts at the three corners of the fort and east of the airstrip. Ordnance disposal elements and

two infantry squads commenced collection of ammunition and stacked it in two 81 mm mortar positions on the east side of fort. Explosive charges of C-4 and detonating cord used in conjunction with a time fuze were set. Helos were called for extraction.

b. Group Bravo - At 230700H landed in LZ at XC ~~49~~2834, located and exploded two pallets of S/A ammo. Explosion took place at 230715H. Group Bravo then moved to fort via north wall and joined Group Alfa.

c. Helos returned at 230845H, raiding party was loaded, and helos took off with last helo off ground at 230855H. The time fuze set by Group Alfa detonated ammo at 230900H.

d. Helos arrived at Phu Bai Airport at 230915H.

7. INTELLIGENCE. Local force VC, estimated at two Companies, were in operation in the Bravo 5 Area. The 810th VC Battalion was believed to be operating some where in the area with a mission of directing the operations of the local VC force. During the first week of operations friendly patrols had several encounters with the VC. It is believed that the VC were trying to infiltrate into the village to collect taxes and food, deliver mail and reports, and to conduct psychological operations. Intelligence received from the local populace, captured enemy documents, and from the U.S. Army Advisor at PHU LOC indicates that the enemy was forced to utilize other areas for his operations. During the last stage of the operation, VC leaflets were distributed in the villages of NAM PHO HA and THON NAM PHO COM between the hours of 2300 to 0300 by the VC. The village chiefs contacted Marine units in area and notified them of the operation. Many of the leaflets were directed towards the Negro U.S. Service Man and the leaders of the U.S. Government and its current policies.

8. MISSION. Search out and destroy enemy forces in area and prevent enemy passage from mountain area across Route #1 to area NE of HUE PHU BAI TAOR. Intercept enemy forces attempting to destroy installations along Rt.#1. Prepare area for future possible expansion of Regt. TAOR.

9. CONCEPT OF OPERATION. See operation overlay (Enclosure 1)

10. EXECUTION.

(1) 13 May 1966

(a) At 1500H, Frag Order 6-66 was received from 4th Marines to conduct Operation ATHENS.

(2) 14 May 1966

(a) Battalion prepared to deploy southeast of the HUE PHU BAI TAOR.

(3) 15 May 1966

(a) At 0830H, Battalion commenced motor march to assigned operational area.

(4) 16 May 1966

(a) At 0130H, Company I night ambush fired on 1 VC at YD996-016. Results, negative.

(b) At 0230H, Company I night ambush fired on 10-11 VC at YD001021. VC returned S/A fire, and threw several hand grenades then fled NW. Results, 1 VC KIA, 1 US Cal. .45 SMG Model M-3, 2 long stem grenades and individual equipment.

(c) At 2145H, AN/TPS-21 picked up 10-12 VC at YD931061 on radar, VC were attempting to probe lines. Battery I fired direct fire. Results, negative.

(5) 17 May 1966

(a) At 1822H, 3d Plat, Company K, day ambush fire on estimated 8-12 VC at YD926023. Results - 4 VC KIA, 2 ChiCom carbines, 1 US M-79 Grenade Launcher, 2 ChiCom mines, 4 long-stem bamboo grenades, 2 M-79 grenades, 27 M-79 rounds, 47 ChiCom 7.62 rounds, numerous documents and individual equipment.

(b) At 2030H, Vicinity YD952025, 2nd Sqd, 1st Platoon, Company K, fired on 1 VC. Results, negative.

(c) At 2110H, Company I night ambush fired on 1 VC moving into friendly position at YD972016. Results, negative.

(6) 18 May 1966

(a) At 2158H, Company L's LP heard movement near their position. 81mm mortar illumination was fired which revealed 2 VC. 81mm mortar platoon fired 6 rounds HE. Results, negative.

(7) 19 May 1966

(a) At 1545H, 2nd Sqd, 3d Plat, Company I fired on 4 VC in stream at YD998010. VC did not return fire. Results, 2 VC KIA; 2 ChiCom K-50 SMG, 1 ChiCom Carbine 7.62, 4 grenades, individual clothing and equipment and approximately 70 pounds of rice.

(8) 20 May 1966

(a) At 2120H, 1st Platoon, Company I night ambush fired on 3 VC at YD958024 moving north along river. Results, unknown.

(9) 21 May 1966

(a) At 0445, 1 VC probing 2nd Platoon, Company M's perimeter, fired 1 round of S/A, wounded 1 Marine at YD970068. Marine returned 4 rounds S/A. Results, 1 USMC WIA.

(b) At 1655H, snipers attached to Company L, pinned down 8-10 VC at YD964994. Artillery fire mission called. Patrol directed to search area, found area honey-combed with tunnels out in heavy brush. Results of fire mission, unknown.

(c) At 2000H, 2nd Squad, 3d Platoon, Company K night ambush fired on 3 VC in ravine at YD924063. The VC were believed to have been part of a larger group. The VC returned 5 rounds of S/A then fled west. Results, unknown.

(d) At 2035H, Company M patrol fired on 3 VC at YD972041. VC fled north. Results, unknown.

(e) At 2111H, 81mm mortars fired on 2 VC at YD924063. LP observed 1 VC fall from probable wound. Results, negative.

(10) 22 May 1966

(a) At 0900H, 1st Platoon, Company L spotted 2 VCS at YD970984, did not pursue due to terrain.

(b) At 1300H, Company I patrol spotted 7 VC running south into tree line at ZD007006. Artillery mission was fired. Results, unknown.

(c) At 2054H, 3d Sqd, 2nd Plat, Company I fired on 2 VC moving SE at YC982996. VC returned 5 rounds S/A and fled NW. Results, unknown.

(d) At 2220H, AN/TPS-21 picked up approximately 5-7 VC at YD932057. 81mm mortar fire was called. Results, negative.

(11) 23 May 1966

(a) At 2125H, Company L, night ambush made contact with approximately 8 VC moving NE at YD935036. Results - 1 bloody shirt, 1 ChiCom grenade, 1 bloody poncho, 1 beret, 1 lighter, 3 sandals, and 4 pools of blood. Results, 3 possible KIA.

(12) 25 May 1966

(a) At 1000H, 2nd Plat, Company L daylight patrol discovered (vicinity YD946029 to YD946025) a lean-to, spots of blood, bloody bandages, and a well-travelled trail to the nearest stream. Results, 105mm WP destroyed target.

(13) 26 May 1966

(a) At 1145H, 1 VC sniping from YD954030 fired on 2nd Plat, Company L at YD995025. USMC returned fire and then sent in a squad to check area. A cave which had blood spots and bandages in it was discovered. This is the same area where huts and lean-to's were located and destroyed, YD946029. (See 25 May 1966)

(b) At 1853H, 1st Plat, Company L sighted 3 VC hiding in brush at YD925018. Artillery fired on position. VC were then seen fleeing south into jungle.

(14) 31 May 1966

(a) At 1120H, Company L patrol number 32 received fire from estimated 2 snipers at YD996005. Enemy position taken under mortar fire. Results, 1 USMC WIA. Effect on enemy unknown.

(b) At 1306H, 3d Sqd, 2nd Plat, Company L received automatic fire from 4 to 5 VC located in vicinity ZD003006. Artillery fire mission called. Results, 1 USMC KIA and 1 USMC WIA. Effect on enemy unknown.

(15) 01 June 1966

(a) At 1105H, 2nd Plat, Company L patrol apprehended 1 VCS approximately 50 years of age, no I.D. card in possession, working in rice paddy alone, no other Vietnamese in area. Took VCS to Company M's CP for investigation. Interrogation proved VCS to be friendly and was returned to village.

(b) At 1847H, Company L CP spotted 35 VC in open moving south up hill at YD994003. Artillery mission fired with complete coverage of target. 17 probable VC KIA's and 18 probable VC WIA's.

(17) 05 June 1966

(a) At 1132H, the 1st Sqd, 1st Plat, Company L reinforced with a MG squad came under what was believed to be sniper fire in the vicinity of YD989002. The patrol sustained two USMC WIA, and a third casualty due to a sprained knee. MED-EVAC helo was called

and was driven off by heavy automatic and semi-automatic weapons. The MED-EVAC helo was hit and withdrew without the casualties. Arty fire boxed in the patrol as a result of a HUEY observation that the patrol was surrounded on three sides by VC. The HUEY provided fire power support, and the casualties were then evacuated. A 5 man relief team was dispatched by helo to reinforce the patrol but due to the superior VC numbers the remainder of the original patrol and the 5 man relief team were extracted. Arty, fixed wing and helo aircraft continued to fire into the area after the evacuation. Results of the action: USMC- 2 WIA and 1 non-hostile casualty; VC casualties - unknown.

(b) At 2030H, L-22 patrol/ambush was sprung on 3-5 VC at ZD010014. Results, 2 USMC WIA, 1 VC KIA.

(18) 06 June 1966

(a) At 1035H, the 2nd Sqd, 3d Plat, Company L observed 3-6 VC at YD983019 and ambush was sprung on lead element. Results, negative.

(19) 12 June 1966

(a) At 1035H, the 1st Plat, Company M OP spotted 4 VC at YD969068. VC were fired upon and one round S/A was returned. Results, negative.

(21) 17 June 1966

(a) At 0335H, Company M spotted 1 VC at YD968102. 81mm mortar illumination (4 rds) and 200 rds S/A were fired. Results, negative.

(b) At 2103H, TPS-21 reported movement of approximately a squad at YD925063. Fired 60mm mortars under illumination. Results, negative.

(22) 18 June 1966

(a) At 2315H, Company K LP spotted 1 to 3 VCS 200 meters in front of their position. LP fired upon VCS and figures moved out in a northerly direction. LP moved to new position. Results, negative.

(23) 20 June 1966

(a) At 0345H, 1st Sqd, 1st Plat, Company K ambush opened fire upon 4 VCS in vicinity of YD929061. Results, negative.

(b) At 1040H, 1st Plat, Company K made contact with 1 VC at YD869015. Fired 1 round S/A and after searching area, found a pool of blood. Results - 1 VC WIA.

(c) At 1100H, 1st Plat, Company K again made contact with estimated 3 to 5 VC. Fired upon VC, VC returned 40 to 100 rounds S/A. 2 VC were seen hit. Results - 1 VC WIA and 1 VC KIA (probable). Received 1 USMC WIA, MED-EVAC.

(d) At 2225H, Company L fired on suspected movement at YD969020. Results, negative.

(e) At 2315H, Company L called in artillery fire mission on blinking light at ZD006008. Artillery fired 18 rounds on target. Results, unknown.

(24) 25 June 1966

(a) At 1000 Operation ATHENS terminated.

12. ADMINISTRATIVE.

- (a) Supply, adequate. Resupply was adequate.
- (b) Maintenance. No problems in this area.
- (c) Treatment and Evacuation of casualties was excellent.
- (d) Transportation adequate.
- (e) Communications. During Operation ATHENS the Radio Relay Set, AN/TRC-27 was employed for communications between Battalion and Regiment. Communication was unsatisfactory due to constant power failure of the PU/278 generator.
- (f) Medical. No problems encountered.

13. SPECIAL EQUIPMENT AND TECHNIQUES. Two sniper teams were employed during this operation. The terrain afforded only limited vantage points from which the snipers could observe. No conclusive evaluation could be made.

14. COMMANDERS ANALYSIS.

(a) This type operation conclusively proves that by aggressive patrolling and ambushing a unit can effectively deny an area to the enemy.

(b) One company lived and operated from the ARVN Compound at the TROUI Bridge. The company commander coordinated with the village chief and held a sick call every other day for treatment of the villagers. A total of 2849 Vietnamese were treated. In addition limited medical training was provided for ten Vietnamese. The success of the active C.A. program was evident by the friendliness demonstrated by the civilians toward Marines and the fact that more and more villagers provided information concerning enemy appearances, routes, and intentions.

15. RECOMMENDATIONS.

(a) That at least a rifle company be retained in the TROUI Area to continue operations to deny the area to the enemy until sufficient CACs are available to control the area.

(b) That a battalion be provided during the August rice harvest season to protect the villagers and deny the rice to the enemy.

(c) That snipers continue to be employed in the PHU BAI area and their effectiveness evaluated.

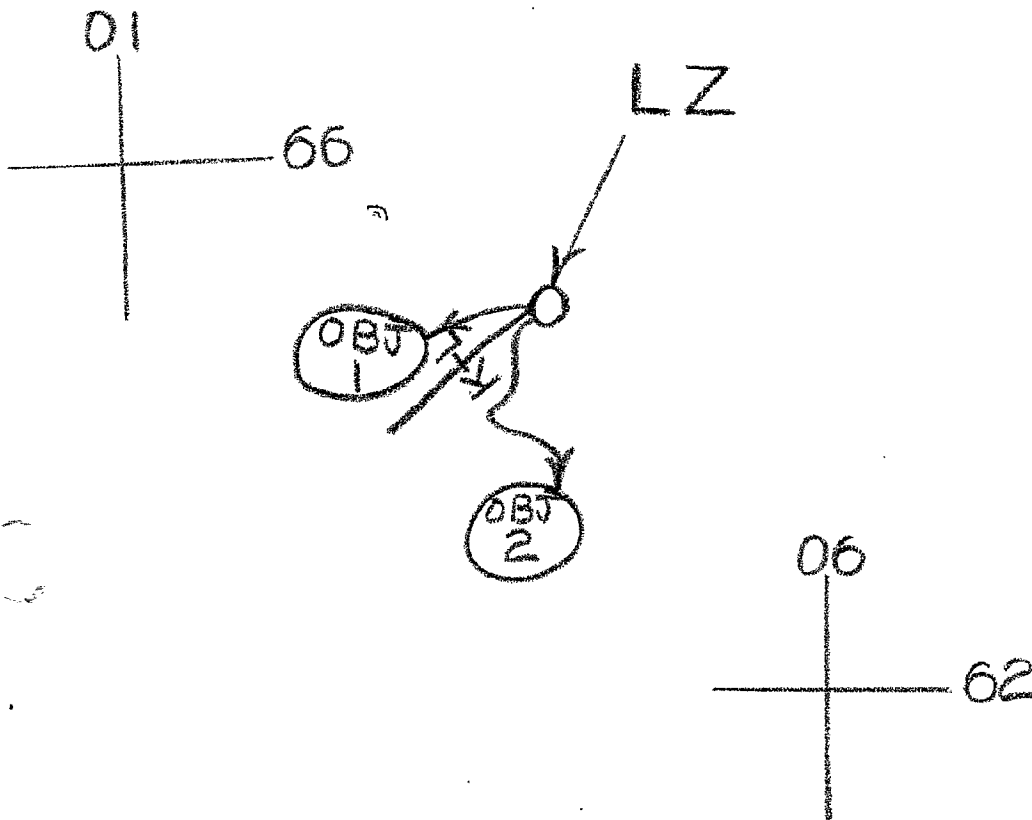
