SECTION III

INTELLIGENCE

1. Terrain. (Enclosure (1) contains map of area)

a. General. The area of operations for the 4th Marines Provisional Battalion during the period 22 November through 30 November 1966 lies within Gio Linh District, Quang Tri Province, Republic of South Vietnam. The area is bounded on the north by the southern boundary of the DMZ, on the east by north-south grid line (YD16), on the south from (YD 160672) to (YD 088673), and on the west by the river at (YD 088673) northward along the river to the southern boundary of the DMZ. This area lies within the piedmont between the coastal lowlands on the east and the mountainous area immediately to the west.

b. Physical Characteristics.

(1) Relief and drainage. Con Thien Hill at 158 meters in altitude lies approximately 1000 meters southwest of the geographical center of the area of operations. It is the highest terrain in the area and affords the best location for ground observation of the entire area. The terrain slopes gently downward in all directions from Con Thien Hill reaching the lowest elevation (approximately 10 meters) near the middle portion of the northern boundary. The uniform sloping terrain from Con Thien Hill facilitates excellent drainage outward from the hill to the area boundaries in all directions. Slopes throughout the area are less than 6%. A few streams start along the edges of the area and flow outward toward the area boundaries.

(2) Surface materials and vegetation. The soil is organic with inherent high fertility and high agricultural potential throughout the area of operations. Approximately 60% of the area is utilized for rice production. Paddy areas, as well as homes and hamlets are usually surrounded by hedgerows in excess of 7 feet in height. Approximately 40% of the area not utilized for rice production is covered with grass or scrub with scattered trees.

c. Man-made features. The principle man-made features include secondary roads, hamlets and villages. There is one abandoned unsurfaced airfield approximately 400 meters long at (YD 141694). It is unsuitable for use except as an HLZ.

(1) Roads. Four unsurfaced roads pass through the area of operations. They are routes 73, 74, 75 and 76. These routes are from 3 to 5 meters wide. They are trafficable to vehicles even during the monsoon rains, however movement must be slow and cautious due to scattered craters caused by ordnance and the possibility of unexploded ordnance lying in the area. Road bypasses are easily selected and there are no major bridges or water barriers.

(2) Built up areas. Small populated hamlets and villages begin 1000 to 2000 meters outward from Con Thien Hill and generally extend outward toward the area boundaries except in the northwest portion which is unpopulated with many

structures destroyed by bombing and artillery. Most of the area population is within the hamlets and villages in the southern and eastern portion of the area. Nearly all homes are of the thatched roof variety. The only permanent military post in the area is a company sized RF/PF outpost on top of top of Con Thien Hill which is isolated from the populated areas.

d. Military Aspects.

(1) Observation. Ground observation is poor due to numerous hedgerows higher than 7 feet throughout the area. Air observation is good to excellent however, hedgerows and foliage are extensive enough to hide small units.

(2) Cover and concealment. Concealment from ground observation is excellent because of numerous hedgerows throughout the area along with scrub and scattered trees, affording both offensive and defensive concealment. Cover is mainly in the form of slightly elevated roads and paddy dikes. The gentle rolling terrain offers few defilade areas. Cover can be provided by using numerous predug trenches, bunkers and fighting holes throughout the area left by prior enemy troop concentrations. Fair to good cover is available from structures in built up areas.

(3) Fields of fire. Fields of fire are excellent for distances of up to 50 meters when making maximum use of hedgerows. Longer fields of fire usually require clearing of scrub and portions of hedgerows.

(4) Obstacles. There are no major obstacles impeding troop movement in the area of operations. There are no major bridge or water obstacles and road bypasses are easily selected. Except during the monsoon rains, tracked vehicles can be utilized effectively throughout the area. Track vehicles are hindered during monsoon rains by rain soaked soil but can move on roads with little difficulty. HLZ's are numerous and easily selected throughout the area.

(5) Key terrain features. This area has one key terrain feature which is Con Thien Hill at (YD 117701).

(6) Avenues of approach. Little restriction is present for the approach of ground troops into the area from any direction. The main routes of approach are roads, cart trails, and trails which enter the area from all directions.

2. Weather

a. General. The effects of the full force of the Northeast Monsoon has been present during the period 22 through 30 November 1966. The terrain features as described in Paragraph 1 has minimized the effects of heavy rain by the excellent drainage features of this area. Movement of ground troops is only slightly impeded by slippery rain soaked terrain. Cross country movement of tracked vehicles is limited by rain soaked soil. Buildup of mud in track drive sprockets necessitates periodic cleaning out to prevent throwing tracks. Visibility has ranged from $\frac{1}{2}$ to 9 miles, averaging 5 to 7 miles.

b. Climatological data. (Period 22 through 30 November 1966)

3. Intelligence Summary. Extensive patrolling and ambushes throughout the area of operations have produced negative enemy contact or sightings during the period 22 through 30 November 1966. Questioning of local civilians along with captives and low level agent reports indicate that North Vietnamese Army units previously operating in this area moved to an undetermined location north of the southern boundary of the DMZ. Local civilians state that the VC have not collected taxes which were due approximately two months ago. North Vietnamese Army units operating in the area prior to their pullout were elements of the North Vietnamese Army 341st Division who had replaced elements of the North Vietnamese Army 324B Division. There has been no evidence of VC activity or identification of any VC units during this period. Fortifications in the form of trenches, bunkers, fighting holes, and punji pits, all at least 2-3 months old, have been located throughout the area. Two VC/NVA suspects were apprehended during this period. One was identified as a local farmer and released and interrogation of the other is incomplete and continuing. On 28 November 1966, 1500 pounds of rice was discovered in a burned out hut vicinity of (YD 114714). On 27 November 1966, a patrol found Chicom cartridge belt with 2 leather pouches containing 18 rounds of 9mm ammunition and 1 round of 7.62mm short ammunition in a house vicinity (YD 108723).

SECTION IVOPERATIONS1. Close Combata. 24 November 1966

(1) At 1452, Company L, while on daylight patrol apprehended 1 VCS at (YD 147716) moving northwest on Route 75. VCS was taken to Division Forward collection point for interrogation.

(1) At 1205, Company I, while on daylight patrol found 1 VCS hiding in hole at (YD 111722). VCS was taken to Division Forward collection point for interrogation.

SECTION VLOGISTICS

On 20 November 1966 the S-4 Officer, along with the Commanding Officer and other Staff Officers, of the Provisional Battalion arrived at Con Thien, RVN. On 22 November 1966 the Provisional Battalion relieved 2d Battalion, 5th Marines in place.

The Commanding Officer directed the S-4 Officer to maintain on hand 5 days of supply of Classes I (excluding water) and V. All resupply was accomplished via helicopter from Dong Ha. A Helicopter Support Team (HST) consisting of four personnel from 3d Shore Party Battalion directed the landing of helicopters and maintained radio contact with the LSA at Dong Ha. All resupply requests were transmitted by the HST to the LSA. Resupply requests were made daily prior to 1700 for resupply the following day. Resupply requests by subordinate units and attached units for all classes of supply except T/E items were submitted direct to the battalion S-4.

The battalion S-4 maintained a Class I and Class V supply dump. All 81mm ammunition and 105mm ammunition was taken directly from the landing zone to the using unit. All other Class V was placed in the battalion ammunition dump and issued to the using units as required.

Since there were no potential local water points available, water had to be resupplied from Dong Ha utilizing 5 gallon water cans. Daily water resupply varied from 150 to 190 cans with no more than one day supply on hand at any time. On 25 and 26 November rain and a low over-casted sky prevented resupply by helicopter. During this period action was taken by the individual Marine to procure water using ponchos to catch rain water. During the two days of no resupply it was not necessary to request an emergency resupply.

C-rations were supplemental with B-rations, i.e. fresh fruit, fruit juice, canned hamburgers and franks, fresh bread and canned fruit, whenever possible. On 24 November, Thanksgiving day, pre-cooked ham and turkey was delivered via helicopter and issued to subordinate and attached units.

On 27 November the battalion was resupplied by 12 helicopter loads of all classes of supply. On 28 November the battalion received 39 helicopter loads of supply consisting primarily of classes I and V. The large quantity of resupply enabled this battalion to raise the Class I and Class V stock level to 5 days. Routine resupply was received for the remainder of the month keeping the stock level at 5 days.

On 27 November, two EOD personnel arrived and were utilized to destroy high explosive duds in the area. A small quantity of small arms ammunition and approximately 50 rounds of 81mm WP ammunition classified grade III was returned to Dong Ha to be destroyed by the EOD personnel. On 28 November 1966, four engineer personnel arrived to be utilized by the battalion as required. Their primary employment has been to destroy bunkers and clear fields of fire. Generally, a team of two engineers accompanied a rifle company on daylight patrols as used as required by the Company Commander.

SECTION VICOMMUNICATIONS - ELECTRONICS1. Operation Prairie

a. Upon assuming operational control of the Nui Con Thien TAOR it was noted that merely a substitute of equipment was necessary to provide adequate communications for the Provisional Battalion. The equipment and personnel utilized were drawn from the Communications Platoons of the 4th Marine Regiment and the 3d Battalion, 4th Marines. They have received excellent support from the units.

b. There lines had been previously installed by 2d Battalion, 5th Marines enabling us to provide instant telephone communications to the Provisional Battalion upon assuming operational control.

c. The Radio nets established are the Regimental Commander, Regimental and Battalion tac. The supporting arms nets are artillery, Naval gunfire, air (VHF and UHF) and mortars.

d. We have experienced no enemy interference or jamming on our radion nets.

e. On 28 November 1966 a covered voice radio net was established between the 4th Marines and the Provisional Battalion for limited use on the Regimental Command frequency. At a later date the 3d Battalion, 4th Marines will establish a station on this covered net. The equipment used is the AN/MRC-110 plus the required cypher units.

f. Although no unusual problems have been encountered our lack of adequate back up equipment could present difficulties in the future. We have presently in excess one (1) EE-8 telephone, and one (1) AN/PRC-25 radio.

g. Items of equipment, which could be used, but are not necessary to maintain adequate communications are three (3) AN/GRA-39 remote units, and three (3) RC-292 antennas.

SECTION VIIFIRE SUPPORT COORDINATION1. Significant Events.

a. During the period from 22 November through 30 November 1966, the Provisional Battalion, 4th Marines had "A" Battery, 1stBn, 12thMar (OPCON 3dBn, 12thMar) in direct support.

b. The fires of "A" Battery were reinforced by fires from "I" Battery, 3dBn, 12th Marines.

c. These batteries fired a total of 1,876 rounds of 105mm ammunition in support of the Provisional Battalion's operations.

(1) Timely and accurate fires were placed on targets of opportunity.

(2) Preparation fires were placed on objectives and covering fires were placed on flank and rear areas.

(3) Extensive use was made of artillery in reconnaissance by fire.

(4) H&I fires were used to suppress enemy activity and deny access to key terrain.

3. Naval Ships

a. During the period from 22 November through 30 November 1966 the Provisional Battalion, 4th Marines was supported by fires from the USS CANBERRA, USS COCHRANE, and USS MARION.

b. Naval gunfire provided H&I fires over a wide area, suppressing enemy movement and denying access to key terrain.

c. Naval ships fired totals of 97 rounds (8"), 122 rounds (5"54), and 130 rounds (5"33) into the Provisional Battalion's TAOR.

SECTION VIII

AIR SUPPORT - DEFENSE

1. During this period air was used extensively for recon, resupply, TPQs and aerial observations. Recon flights were scheduled daily and were used to reconnoiter areas for proposed ambushes and company operations. Recon flights also aided in determining landing zones for troop lifts for recon in force operations.
2. Aerial resupply was a key factor during this period due to the inaccessibility of this position by vehicle. Aerial resupply was handled through the S-4 section with the air team assisting at the landing zone.
3. TPQs were used as H&Is and as tactical strikes on proposed targets. During this period over 120 targets were submitted and more than 160,000 pounds of bombs were delivered. Maintenance of TPQ gear caused cancellation of some TPQs.
4. Aerial observer planes were used in conjunction with all company size operations for recon and spotting proposed targets or possible ambush sites. In the event of enemy contact, the Aerial observer was already on station and in radio contact with the ground forces, which would reduce the time lag in calling in tactical air strikes.
5. Weather was a limiting factor during this period and in some cases caused cancellation of air requests.
