

PART II

NARRATIVE SUMMARY

On 6 Sept 1970, Communication Company embarked aboard the USS DENVER LPD-9 for the purpose of transfer to 5th Marine Amphibious Brigade, FMF. The unit embarked was designated Detachment 5th Communication Battalion. The unit consisted of Communication Company, at an actual strength of one Officer and (80) eighty enlisted, Detachment Headquarters Company at an actual strength of (0) zero, and Detachment Radio Relay and Construction Company at an actual strength of (0) zero. There was no equipment embarked with this unit. The manning level strength reductions were as follows: Communication Company - 192, Detachment Headquarters Company - 95, and Detachment Radio Relay and Construction Company - 63.

The unit debarked on the 23 of Sept 1970 and transferred (72) seventy-two personnel in accordance with CMC message 182052Z Sept 1970. The key personnel remained and turned in pertinent records. Selected key personnel

were released on 25 Sept 1970. On 1 Oct 1970, all turn in was complete and the unit strength was (1) one Officer. The unit deactivated on 5 Oct 1970 in accordance with CG, 5th MAB msg 052059Z Oct 1970.
