Part II  
Narrative Summary

During February 1969, the 5th 155mm Gun Battery (SP) (Rein) remained under the operational control of the 108th Artillery Group USA and continued its mission of reinforcing the fires of the 12th Marine Regiment.

Command of the 5th 155mm Gun Battery changed with Maj A. B. THOMPSON Jr. relieving Maj W. M. STEPHENS on 25 February 1969.

On 21 February 1969 a M-151 jeep from Alpha platoon hit a land mine three miles east of Fire Support Base Elliott. SSgt V. S. SCHLICHTING and PFC P. S. TIMMERMAN were killed and Sgt D. SOLIZ was wounded in the incident. The vehicle was destroyed.

Charlie platoon received incoming rocket and mortar rounds near their position on three different occasions on 25 February 1969. There were no casualties or materiel damage.

Alpha and Bravo platoons continued to improve their position at Vandegrift Combat Base. A number of bunkers have been completed. Powder and projectile bunkers under construction by the Seabees still have not been completed.

Charlie platoon continued work on their position at Fire Support Base Elliott. To date eight projectile and powder bunkers and two personnel bunkers have been completed by the Seabees.

Alpha platoon fired a total of 760 rounds during February. Bravo fired 532 rounds and Charlie fired 928 rounds during the same period. Targets were mostly unobserved intelligence/artillery/rocket suppression fires and long range support of recon units. A large number of rounds were fired in the defense of Fire Support Bases Neville and Russell when they came under ground attacks on 25 February 1969.

The Battery's personnel status remains C-3 with 77% of essential T/O ranks and MOSs on hand. Critical MOS shortages include 0848, 1345, 2144, 2151, 2531, 2533, 3516 and 3531. Equipment status has remained C-4 for most of February. During one 24 hour period the battery was C-2. At the end of the month, there was one 155mm Gun and one 8" Howitzer operational. Deadlines were due to tube changes, breech problems, engine failures and a lack of rear split rings. Two M64 Eimco Tractors and the VTR (M51) remain on deadline.

The Battery supported operations SCOTLAND, HI-RISE, KENTUCKY and DAWSON RIVER until these operations ended on 28 February. The Battery now supports Regimental AOs within the 3d Marine Division AO.

Sequential Listing of Significant Events

- 19 Feb 1969 - Capt T. W. STEELE, Battery Executive Officer, rotated to CONUS
- 21 Feb 1969 - M-151 jeep from Alpha platoon at Vandegrift hit a land mine three miles East of Fire Support Base Elliott. SSgt V. S. SCHLICHTING and PFC P. S. TIMMERMAN were KIA and Sgt D. SOLIZ, WIA, jeep was destroyed.
- 25 Feb 1969 - Maj W. M. STEPHENS was relieved by Maj A. B. THOMPSON Jr as Battery Commander.
- 25 Feb 1969 - Charlie platoon at Fire Support Base Elliott received incoming; 6 rockets at 0430, 12 mortars at 1100 and 6 mortars at 1630, no casualties or damage.
