NARRATIVE SUMMARY

The early part of March saw the First and Third Battalions, Fifth Marines return to the operation control of the Regiment after having been under the operational control of the Seventh Marines since October 1966. The Second Battalion remains under the direct OPCON of the First Marine Division.

Planning was initiated for two regimental operations to be conducted during the month but both were postponed by higher headquarters. If circumstances permit either or both plans can be reactivated on short notice. Of particular interest is the proposed Operation Plymouth in northern Quang Tin Province, operating area of the VC 72nd Provincial Mobile Battalion and suspected location of the 2nd NVA Division headquarters. Preparations for Operation Boone in Quang Ngai Province were in progress during the later part of March for execution in early April.

Transition training for the M-16 rifle has been completed this month and issue of the new rifles has begun. It is expected that change over from the M-14 will be completed by mid-April.

Emphasis on the Combined Action program continues and the establishment of two additional CAC platoons is being considered.

Preliminary liason with district and village officials has been conducted in connection with proposed Golden Fleece operations during the April rice harvest and it is anticipated that joint USMC/RVN security efforts for the harvest will begin about 7 April.

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

1. Personnel and Administration. The regiment experienced a turnover of approximately 237 persons; 207 were rotated to CONUS, 30 reassigned to other Division units. Two hundred and thirty-two replacements were received during the month. The average battalion strength was 33 Marine Officers and 1269 enlisted personnel.

Shortages of officers in the 0130, 0202, 0430 MOS's continue to exist. These shortages although not actually critical, tend to impair the capabilities of the regiment. Of primary concern in the 0302 shortages in the grade of Captain. Enlisted personnel strengths during this period have fluctuated with an overall average strength of approximately 2450 minus 2ndBn, 5th Marines. Replacement personnel arrive almost daily. Expected personnel losses for the coming month over 300.

2. Intelligence. During the week prior to being activated for operations, the S-2 Section made liaison with all surrounding sources of information of value to the intelligence collection effort. Organizations visited included Quang Tin Province Headquarters at Tam Ky, where contact was made with the Province G-2 Advisor, the National Police and the PRU (Provincial Reconnaissance Unit) Advisor. In addition, liaison was made with all adjoining units to the 5th Marines TAOR which include the 7th Marine Regiment, the ARVN's 6th Regiment and Chu Lai Defense Command. Liaison was also made with the 2nd ARVN Regiment in Quang Ngai to insure that the intelligence collection effort was coordinated extensively with all surrounding units of RVN and Free World Forces.

When the Regiment was activated the S-2 Section of the Regimental Headquarters was undermanned. The section was manned with one GySgt, 0369, one Cpl, 0231, one PFC, 0221, and two LCpl's, 0311. The section strength was increased to include one Captain, 0302, and five PFC/LCpl's, 03 11. The one Cpl, 0231, was transferred on 25 March. The selected personnel were chosen for their suitability for work in the intelligence field and have proven satisfactory in the preliminary stages of training.

Of the two combat operations planned for the month of March, the first, Operation Plymouth, was to search out and destroy the 72nd Local Force Battalion, the K-54 Local Force Company

and the headquarters of the 2nd NVA Division, all of which were located in Quang Tin Province to the north and west of Tam Ky City. The second operation planned for was Operation Pueblo which was to take place in the Song Ve Valley located to the south and west of Quang Ngai City. The targets for this operation were the 38th Local Force Battalion and the C-195th Local Force Company along with possible elements of the 21st NVA Regiment.

Although the operations were cancelled subsequent to planning, the planning processes gave needed experience to the S-2 Section. All personnel of the section were included in the planning and gained much valuable knowledge.

On 29 March, subsequent to the cancellations of Operations Plymouth and Pueblo, planning was begun for a joint operation in the eastern portion of the ROKMC TAOR. The enemy targets are 21st Local Force Company, 48th Local Force Battalion, the 506-B Local Force Sapper Company, the T-18 Local Force Company, the probable 401st Local Force Company and elements of the 21st Regiment of the 2nd NVA Division; all of which operate within the ROK Marine Brigade TAOR.

Weather changes had definite effects on combat operations within the 5th Marines TAOR during the month of March. The early part of March saw the last of the monsoon season with rains stopping after the 19th of the month. Dry weather increased trafficability of all roads in the TAOR and patrol effectiveness was enhanced due to the drying of the paddy areas and adjoining trail systems.

5th Marines combat operation resulted in the enemy casualty figures as follows:

CONFIRMED: 38 KIA and 1 WIA; PROBABLE: 25 KIA and 9 WIA

3. Training. The major training emphasis within the Regiment has been on the indoctrination program for new personnel in country. Indoctrination subjects include rules of engagement, history and customs of Vietnam, intelligence and counter-intelligence, civic action and small unit tactics. The indoctrination course also includes a three day landmine warfare class conducted by 1st Engineer Battalion and instruction and familiarization firing of the M-16 rifle.

Emphasis continues on NCO leadership training, transitional training for the M-16, and weapons handling safety. All members of the scout-sniper platoon have attended a one week school on the new sniper rifle, the M-700 Remington, at DaNang.

4. Operations. Until the 9th of March the Seventh Marines continued to exercise operational control over the First and Third Battalions of the Fifth Marines and of their respective TAOR's. Planning for Operation Plymuth, a combined USMC/ARVN search and destroy in northern Quang Tin Province was in full swing starting 3 March with D-Day set for 9 March, until plans were postponed due to other commitments.

At 1200 on 9 March this headquarters assumed OPCON of the two battalions and of the Fifth Marines TAOR including all fire support coordination responsibilities. Second Battalion, Eleventh Marines presently operates in direct support of the Regiment and both battalions have one amphibian tractor platoon and one anti-tank (ONTOS) platoon in direct support.

The Regiment continues to fill a commitment of one rifle company from the First Battalion to the Chu Lai Defense Command. A thirty man detachment from the Third Battalion guards the AN TAN Bridge, BT 497066, and a reinforce platoon from Third Battalion is providing security for a U.S. Army 175mm Gun Battery, BS 623845, in the ROKMC TAOR. A squad of scout/snipers from Headquarters Company is attached to the Second Battalion. Second Battalion, Fifth Marines, located at AN HOA in the DaNang TAOR is under the ADCON of this headquarters while their OPCON is exercised directly by Commanding General, First Marine Division.

Reorganization of the operating portions of the staff was completed after almost five months of inactivity. The FSCG and Air Liason party were constituted and the S-2 and S-3 sections were brought up to strength. The reorganization process was given impetus by the the planning for Plymouth, which, although it never materialized, re-established the staff functioning and coordination dormant for past months.

Planning for Operation Pueblo, a USMC/ARVN search and destroy to be conducted in the Song Ve Valley in Quang Ngai Province, reportedly the operating area of the VC 38th Battalion, also did not come to fruition, as the operation set for the middle of the month, was postponed. Again the development of staff functioning a coordination was furthered, despite cancellation of plans.

On 29 March planning was begun for a joint USMC/ROKMC/ARVN operation in the eastern part of the ROKMC TAOR. The objective area included Cape Batangan and the Operation Starlight area. The operation, code-named Boone, had a tentative D-Day set for 2 April.

During the month of March 1967 there was one battalion size operation conducted within the TAOR and one company size. There was several company size operations and long range patrols varying in size from company(-) to squad, reinforced. Areas within rocket or mortar range of the Chu Lai Airfield were given special attention from patrol activities as well as artillery H&I fires. In connection with this, a program has been established to more effectively control traffic on the inland waterways within the Regimental TAOR during the hours of darkness. The end of the month saw the Regiment back on a fully operational basis in control of the TAOR and prepared for operations in the field.

5. Fire Support. Artillery missions fired in support of 5th Marine units during March 1967 at Chu Lai were as follows:

7. Logistics. During the month of March the Regimental Logistic posture remained unchanged with the exception of the following areas: The capping of the access road and C.P. internal roads was completed by 9th Engineers. All that remains to be done by 9th Engineers is the installation of culverts and drainage ditches. Logistical planning for Operation Plymouth was undertaken and completed to 10 March 1967, however, the operation was postponed. Planning was completed for the phasing in of the EX16E1 Rifle into Battalions and Headquarters Company. It is anticipated that the change over will be completed by 15 April 1967.

During the first week of March, 9th Engineer Battalion completed a new grease trap for the messhall. The trap was connected to a 50' X 100' leechbed. The new grease trap has worked satisfactorily for three weeks. It is anticipated that this will solve our sewage problems in the messhall. A water read sprinkler, constructed from a causeway pontoon section, and

mounted on a 2½ ton truck is being used to help alleviate the dust problem endemic to the summer dry season. A bunker rebuilding program has been initiated this month, to replace the personnel bunkers which deteriorated during the monsoon season. It is planned to replace all old personnel bunkers by the end of April.

8. Civil Affairs/Civic Action. On 2 March the Regimental S-5 section functioned as coordinator for plague control following reports of cases in Ky Khoung Village. On 5 March HqCo, 5th Marines was assigned civic action responsibility in areas surrounding the Regimental CP. An NCO from the S-5 section was appointed to coordinate with the HqCo civic action NCO. MEDCAP's and miscellaneous assistance projects were initiated and a Headquarters Company laundry was established in a local hamlet. On 7 March the S-5 completed civil affairs preparation and annexes for Operation Plymouth which was later cancelled. On 15 March a system for warning local Vietnamese of 60mm and 81mm mortar registration was established. From 25 to 30 March the S-5 again acted as a plague control coordinator for the village of Ky Khoung. On 30 March a coordination meeting was held with the sub-sector advisor of Ly Tin District concerning forthcoming Golden Fleece operations. On 30 March the S-5 completed civil affairs planning and preparation and annexes for Operation Pueblo which was later cancelled. Throughout the month work continued on the preparation of a comprehensive Regimental Civil Affairs SOP.

9. Psychological Operations. On 7 March the psychological warfare officer completed preparation and annexes for Operation Plymouth which was later cancelled. On 20 March the psychological warfare officer prepared an extensive detailed request for leaflet drop and aerial broadcasts in the waterways near Chu Lai and other likely areas for VC ingress or rocket/mortar attacks. On 30 March preparation and annexes were completed for Operation Pueblo which was later cancelled. Throughout the month work continued upon a comprehensive Regimental SOP for psychological operations.

10. Nuclear Biological and Chemical or other Special Type of Warfare. During the reporting period NBCD training continued to be conducted at Company level with a minimum of 3 hours a month. Decontamination and fall-out predictions capabilities are satisfactory. NBC defense equipment is at T. E. level.

11. Medical. On 3 March 1967 Lt. T. E. Bunnell MC USN reported aboard for duty.

There were no major discrepancies noted during weekly sanitation inspection. The 9th Engineer Battalion has completed construction of a permanent grease trap. There were no extraordinary health problems noted during the past month. One case of NSU (VD) occurred in Headquarters Company. There were no cases of malaria.

Division Surgeon visited the Regimental Aid Station on 21 March 1967. A routine administration inspection. No discrepancies noted.



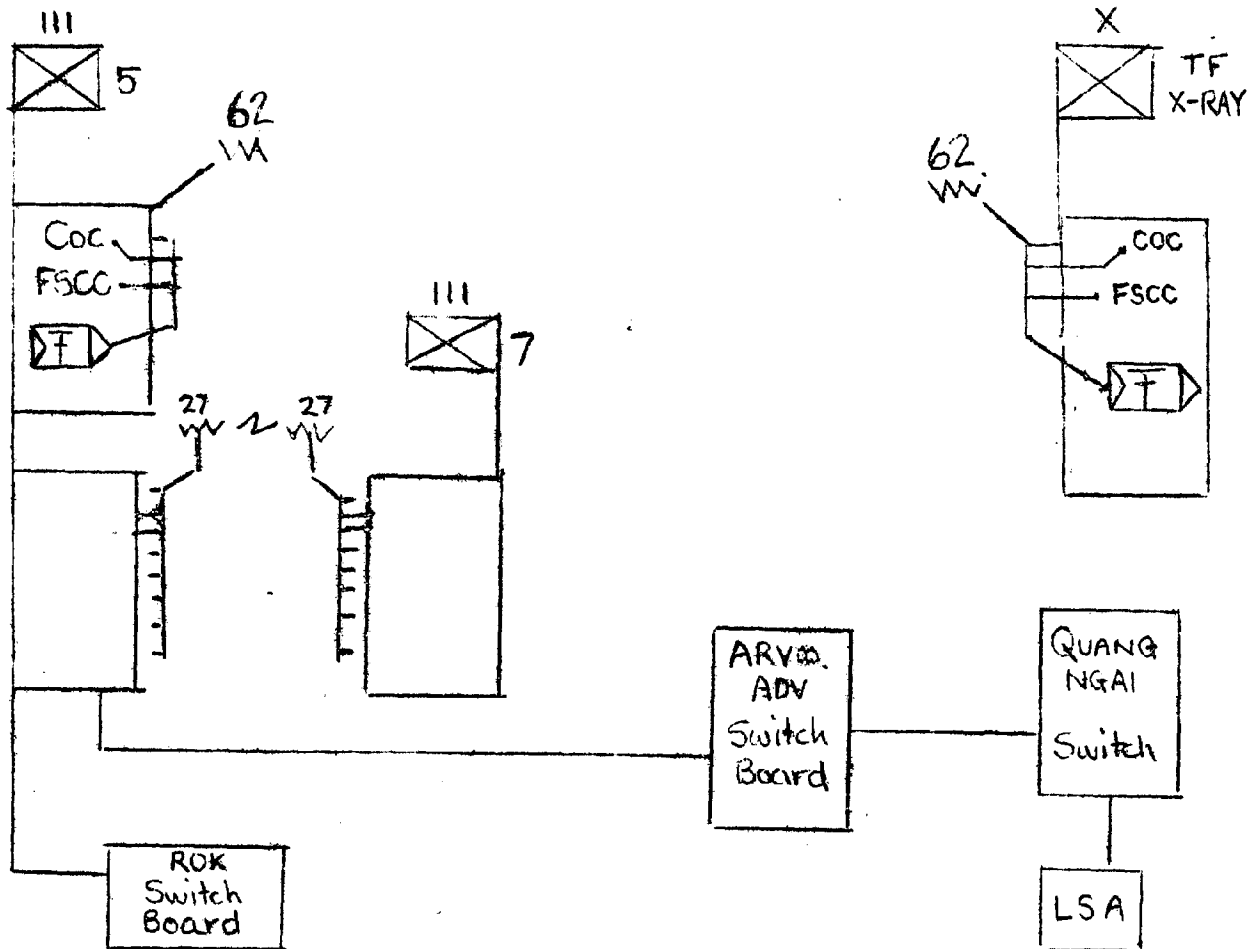

1. SITUATION. See Frag Order.

2. MISSION. 5th Marines will conduct Civil Affairs to control the populace in the objective area, minimize civilian noncombatant casualties and to give aid to the civilian populace within the availability of local resources and U.S. supplies as necessary.

3. EXECUTION.

a. Concept of Operation. Primary effort will be directed towards providing essential assistance to the populace to maintain order and to meet the minimum needs for survival of civilians left homeless or injured in the course of this operation. Wherever tactical considerations permit, efforts will be made to warn civilian noncombatants of impending danger to their persons or property.

b. Infantry Battalions.

(1) Establish Civil Affairs control in combat areas.

(2) Be prepared to execute or assist with the following:

(a) Psychological warfare indoctrination (Annex E to Frag Order).

(b) Medical assistance to civilians. Civilian casualties will be medically evacuated when feasible. Priority will be to U.S., ARVN, and ROKMC personnel.

(c) Operation of assembly areas for refugees.

(d) Warning civilian noncombatants by aerial broadcasts, aerial leaflet drops and ground loudspeaker broadcasts of impending danger to their persons or property.

c. Coordinating Instructions.

(1) Captured rice may be used in the feeding of refugees or turned over to the nearest Vietnamese government officials. Questions as to the disposition of captured rice will be referred to this headquarters. Rice bags are available from FLSG upon request. All commanders will be familiar with the provisions of I Corps Coordinator Instruction 05530.1 concerning the handling of captured food-stuffs.

(2) Combat claims arising out of this operation will be settled through GVN channels. The populace should not in any way be given indication that combat claims will be processed through U.S. channels.

(3) Civil affairs personnel will coordinate with psychological warfare personnel with respect to the warning of civilian noncombatants by audio and printed media.

(4) Commanders will inform the Regimental Command Post when refugee evacuation is required.

4. ADMINISTRATION AND LOGISTICS.

a. Civic action commodities will be requested through normal command/logistical channels.

b. Minimum MEDCAP supplies for use during the operation will be carried by units to provide the required civil medical assistance.

c. Care and support of displaced persons will be provided from MEDCAP supplies on hand and held in the FLSG, and other commodities from local ARVN sources.

d. Commanders will ensure that troops are especially careful not to damage or violate the premises of property, livestock, religious structures, and other property, such as graves, which hold particular significance to the people. Use of temples, churches and other religious institutions for military purposes is prohibited.

1. SITUATION.

a. Enemy Forces. Reference, basic order.

b. Friendly Forces.

(1) 244th Psychological Operations Company, capable of developing and reproducing printed media on request. This unit has available one ground loudspeaker team which may be useful for control of the local populace.

(2) Fifth Air Commando Squadron provides fixed wing aircraft equipped with loudspeakers, available for broadcasts and leaflet drops.

(3) The Task Force X-Ray Psychological Warfare Section has one polaroid camera and one tape recorder available on request for the exploitation of situations with psychological warfare potential. These photographs/tapes can then be used for the preparation of special leaflets and broadcasts.

2. MISSION. Fifth Marines conducts psychological operations to:

a. Instill in the enemy a respect for allied might.

b. Encourage the enemy to rally to GVN through the Chieu Hoi (Open Arms) program.

c. Cause dissension among enemy elements and between the enemy and the population.

d. Induce in the people a belief that allied forces have come for their benefit.

e. Support civil affairs efforts to warn civilian noncombatants of impending danger to their persons or property.

3. EXECUTION.

a. Concept. Psychological Operations will commence only after such time as friendly troops have been committed overtly and in forces. After such a commitment has been made, and on order of the Regimental Commander, aerial broadcasts and air dropped leaflets will warn the inhabitants of the danger of harboring VC and will warn them of the fact that their villages will be destroyed if they allow the VC to use them to fire at Marines or our aircraft. Subsequent broadcasts and leaflets to be disseminated on call will be utilized to convince the enemy that his forces will soon be destroyed and will offer him the opportunity to surrender to the Government of Vietnam under the Chieu Hoi (Open Arms) program. Further broadcasts and leaflets will be available on call as additional intelligence is received. A ground combat loudspeaker team will be placed on standby at the Regimental Command Post for heli-lift into the area to develop isolated psychological opportunities exploitable by ground loudspeaker operations, to control large numbers of people, and to exploit opportunities for personal contact.

b. Tasks. Units will be alert for situations exploitable by psychological operations and will report the same to this headquarters. Exploitable situations to be reported include VC atrocities, dissatisfaction with communist rule noted among civilians, allied acts of kindness, low enemy morale, and situations where the enemy is in an untenable position which leaves surrender as the only alternative to destruction.

c. Coordinating Instructions. Units will insure that their troops are instructed in the procedures for handling enemy personnel who give themselves up under the Chieu Hoi program or who utilize Government of Viet Nam safe conduct passes. These personnel will be evacuated to IIT for further return to government rehabilitation centers.

4. ADMINISTRATION AND LOGISTICS.

a. Requests for psychological operations will be submitted to this headquarters. Requests will include the following:

(1) Type support desired; e.g. leaflet drops, aerial broadcasts, loudspeaker teams, etc.

(2) Brief description of theme to be used or purpose of request.
