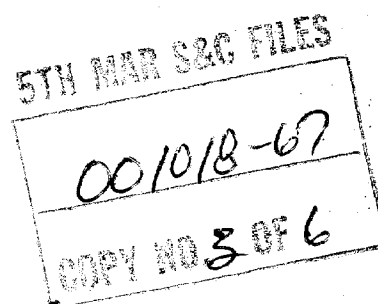

PART II

NARRATIVE SUMMARY1. Personnel and Administration.

a. The Administrative Rear, 1st Battalion, 5th Marines completed movement from the 11th Motor Transport Battalion Compound (DaNang, RVN) to Hill 51 Combat Base (Que Son, RVN) on 1 August 1967. The final consolidation of the forward and rear S-1 sections improved the administration of the Battalion.

b. Postal service for incoming and outgoing mail was improved when a daily courier service was established that brought mail directly from 1st Marine Division to the 1st Battalion, 5th Marines. A money order clerk was available at the Combat Base from 3-5 August 1967.

c. Mobile PX runs were conducted on 9 and 28 August by the 1st Marine Division Exchange. The bi-monthly runs were successful in providing exchange services for members of the Battalion.

d. On 28 August 1967 an awards ceremony was conducted at the 1st Battalion 5th Marines Combat Base. The Battalion Commander presented the following awards: 1 Silver Star Medal, 1 Navy Commendation Medal, 25 Purple Heart Medals and 2 Commanding General's Certificates of Commendation.

2. Enemy, Weather and Terrain.

a. Enemy. During August 1967, the enemy continued to operate in the vicinity of the Combat Base in an estimated strength of one regiment consisting of various identified and unidentified units. Information received from the Que Son District Chief, rated C-3 by the Battalion S-2, revealed the following information concerning enemy unit designations and locations: the 105th NVA Battalion operated generally to the north of the Battalion Combat Base; the 70th Independent NVA Battalion located in the vicinity (AT 9731), (AT 9831) and (AT 9832) was the remaining identified unit. Unidentified units according to local sources are company sized units at coordinates (BT 038317), (BT 049323) and battalion sized units located at (BT 0136), (BT 0137), (BT 0337), (BT 0238) and (BT 0736). Follow-up action was taken on intelligence reports received from Que Son District during August 1967.

b. Weather. The weather during August was humid with occasional rains. The average temperature was 97 degrees and low was 81 degrees.

c. Terrain. The Que Son area is a valley about nine miles long and four miles wide orientated in a general northeast to southwest direction. The area is divided by the Song Ly Ly River northeast to southwest. The river provides ~~corridor~~ ^{corridor} which is the best avenue of approach into the mountains located to the west and southwest of the combat base. The mountains southwest of the

UNCLASSIFIED

Battalion's Combat Base can provide an excellent withdrawal route for the enemy.

d. Vegetation. Bamboo and scrub are the prime vegetation features. This factor restricts long and short observation and limits the availability of suitable helicopter landing zones.

3. Organization and Operations.

a. During the month of August the Battalion participated in Operation COCHISE from 11-26 August and continued to actively patrol the areas adjacent to the Combat Base at Hill 51, (BT 025345). Company, platoon and squad patrols were conducted daily to include tank/infantry and Ontos/infantry patrols.

b. The Battalion assumed the Bald Eagle commitment for the 5th Marines Regiment on 4 August and maintained this requirement until 10 August. On 27 August the Battalion again assumed the Bald Eagle commitment for the duration of the month. During the period 27-31 August, operational control of Company A was passed to the 7th Marine Regiment. On 29 August Company B (-)(Rein) was OPCON to the 5th Marine Regiment for one day in response to a Bald Eagle commitment.

c. Improvement of field fortifications for the Combat Base was continued throughout the month. Decking and drainage facilities were completed in approximately 90 percent of the fighting positions in preparation for the upcoming monsoon season.

d. During the month, red alert drills were conducted to test the preparations of the Combat Base. All drills were considered to be successful.

4. Training.

a. Training was conducted on Battalion and company levels with continued emphasis on care and cleaning of the M-16 rifle, familiarization firing, weapons safety, patrolling, fire discipline, fire distribution, indoctrination of new personnel, map reading, small unit tactics and the E-8 Launcher (Tactical, CS).

b. The Battalion continued to utilize schools provided by higher Headquarters. During the month of August 1967, 10 Marines attended school in DaNang, RVN and Okinawa.

5. Logistics.

a. During the month of August 1967, the buildup of the Combat Base continued. On 3 August the communications bunker was completed and on 4 August

construction began on company CQC bunkers and the artillery FDC bunker.

b. On 6 August 1967 the Battalion received additional material for the perimeter fighting positions and rebuilding was initiated. On 25 August all fighting positions were finished.

c. On 9 August the Battalion received 30 mechanical mules and 1 personnel carrier with two trailers which improved the transportation capability of the command.

d. On 28 August drainage work was started in the area of the landing zone and construction of a heliport structure was initiated to improve the overall landing zone operation.

e. During August the Battalion received technical inspections on supply, fiscal management and embarkation.

6. Civil Affairs/Civic Action.

a. 991 Vietnamese civilians were treated by the Battalion MEDCAP Team during the month. To preclude the possibility of VC being treated by MEDCAP, Que Son District required a special ID card for any Vietnamese seeking medical care.

b. Clothing donated by American civilians was distributed to needy refugees in the Que Son District.

c. During the month of August various building improvements have been made in Que Son District as a result of recommendations made by the Battalion S-5 representative. District improvements included additions to education facilities in the Con Dong Refugee Hamlet, the remodeling of merchants shops in Son Lanh village and the improvement of facilities throughout the district.

7. Psychological Operations.

a. During the month Psychological Operations broadcasts were conducted to Vietnamese in the area using the themes "Don't Run From Marines" and "Little Boys Should be in School, not Fighting". Instructions were given for turning in weapons, mines and booby traps for rewards. An explanation of the Chieu Hoi program was given, and Vietnamese music was played. Leaflets have continued to be distributed by local patrols emphasizing the Chieu Hoi and reward programs.

8. Comptrollers Activities.

a. 1st Battalion, 5th Marines requested and received an additional \$20,000.00 budget authorization. An additional request for \$39,000.00 was

submitted to replace stocks depleted by past operations and to prepare for future operations.

9. Communications.

a. On 4 August 1967 the switchboard was moved into the new communications bunker and all wire lines were recabled. On 5 August the message center was relocated.

b. The Battalion received a communications-electronics readiness inspection on 7 August and was rated satisfactory with discrepancies.

(1) 1 August 1967 Company C continued under OPCON of 3rd Battalion, 5th Marines.

(2) 010545H From 010545H to 010615H Psy Ops teams conducted broadcast with theme "Don't Run From Marines".

(3) 010600H Company B continued search and destroy operations in accordance with 1st Battalion, 5th Marines Frag Order 88-67. See Tab (b) to Enclosure (1).

(4) 010640H Company B at (AT 993310) received 15 rounds small arms fire from unknown number of VC at (AT 985310) and (AT 993331). 30 rounds small arms fire were returned and area was searched with negative results.

(5) 010750H Company B at (AT 998298) received 5 rounds small arms fire from unknown number of VC at (AT 992304). Returned 25-30 rounds small arms fire, called 4.2 inch mortar mission. Area was searched with negative results. Results: 1 USMC WIAE.

(6) 010900H MEDCAP conducted in Lanx Thuong (5) Hamlet (BT 024345). 41 Vietnamese civilians were treated.

(7) 011030H Company B at (AT 994295) observed 6 VC at (AT 986296) wearing black clothing, two carrying weapons. Company B fired 65 rounds small arms fire and called 4.2 inch mortar mission. During search of area a 25 year old Vietnamese female wearing black clothing was apprehended. Questioning revealed that female was a VC secretary and wife of VC. Detainee escaped during fire fight at 011130H at (AT 987299). Results: 1 USMC WIAE.

(8) 011210H Company B at (AT 987294) received 60 rounds small arms fire from estimated 6 unobserved VC. Fire was received from the northwest at a range of 175 meters from (AT 985295) and (AT 985298). Company B returned 150 rounds small arms fire and 3 LAWs and searched area with negative results. Results: 2 USMC WIAE.

(9) 011310H Fire Team Patrol 5Y13 at (BT 023355) apprehended 1 Vietnamese male 30-35 years old without ID card. Detainee was wearing black clothing and had what appeared to be pack strap marks on shoulders and possible shrapnel scars on left arm and left side of chest. Detainee was forwarded to Battalion S-2.

(10) 011647H Company B relieved Company A and assumed responsibilities of Combat Base at Nui Lac Son. (BT 023288), terminating search and destroy operations directed by 1st Battalion, 5th Marines Frag Order 88-67. See Tab (b) to Enclosure (1).

(11) 011803H Company A commenced search and destroy operations to Objective X-Ray, in accordance with 1st Battalion, 5th Marines Frag Order 88-67. See Tab (b) to Enclosure (1).

(12) 011945H Psy-Ops team conducted broadcast from 1st Battalion, 5th Marines Combat Base using theme "Don't Run From Marines".

(13) 2 August 1967 Company A continued search and destroy operations in accordance with 1st Battalion, 5th Marines Frag Order 88-67. See Tab (b) to Enclosure (1).

(14) 2 August 1967 Company C continued under OPCON of 3rd Battalion, 5th Marines.

(15) 020900H MENDAP was conducted in Lanh Thuong (5) Hamlet at (BT 024345). 44 Vietnamese civilians were treated.

(16) 020920H Squad Patrol 5A3 at (BT 064303) received 50 rounds small arms fire from 10-15 unobserved VC. Fire was received from a distance of 225 meters to the northeast at (BT 065305). Patrol returned 80 rounds small arms fire, 3 M-79 rounds, searched the area and found one M-16 magazine with 6 rounds.

(17) 021510H Platoon (-) Patrol 5Y13 at (BT 024338) was directed to a ChiCom grenade by a Vietnamese boy. Grenade was destroyed in place by engineers. Marines rewarded Vietnamese boy with 100 piasters.

(18) 021600H Squad (Rein) patrol 5A5 at (BT 074315) observed 4 VC wearing black clothing, 1 carrying a weapon. As VC fled to the east, patrol fired 30 rounds small arms fire and 1 M-79 round. Search of area disclosed 1 VC KIA approximately 25 years old. Results: 1 VC KIA confirmed.

(19) 022025H Company A received order to continue attack to Objective X-Ray (BT 037321) at 030145H and on order to continue attack to 1st Battalion 5th Marines Combat Base (BT 024343).

(20) 3 August 1967 Company C continued under OPCON of 3rd Battalion, 5th Marines.

(21) 030645H Company A departed Objective Tango and continued search and destroy operation towards Objective X-Ray (BT 037321). See Tab (2) to Enclosure (1).

(22) 030855H Platoon (Rein), Company A established patrol base at Objective X-Ray and continued extensive patrolling within a 1500 meter radius.

(23) 030900H MEDCAP conducted in Lanh Thuong (5) Hamlet at (BT 024345). 63 Vietnamese civilians were treated.

(24) 030918H Company A continued attack to checkpoint Sidney at (BT 046347). See Tab (B) to Enclosure (1).

(25) 030918H Company A assaulted checkpoint Sidney (BT 046347) and were ordered to continue attack toward 1st Battalion, 5th Marines Combat Base. See Tab (B) to Enclosure (1).

(26) 031047H Company A (-) returned to 1st Battalion, 5th Marines Combat Base terminating search and destroy operation in accordance with 1st Battalion, 5th Marines Frag Order 88-67. See Tab (B) to Enclosure (1).

(27) 031050H Hamlet Chief brought a butterfly bomb to Company B's position at (BT 022286). Hamlet Chief stated a child was playing with it near (BT 023284). Engineers destroyed bomb.

(28) 031315H Company B commenced search and destroy operations in accordance with 1st Battalion, 5th Marines Frag Order 90-67. See Tab (C) to Enclosure (1).

(29) 031650H 2nd Platoon (Rein), Company A departed Objective A-Ray to establish patrol base at (BT 019324) and conduct night activities.

(30) 031700H Patrol 5D8 at (BT 004346) found one empty hand illumination case, 1 carbine magazine, wooden case of gun powder, 1 homemade bomb and a trench line running north to northwest 1500 meters long. Trench line was 3 feet deep, 2 feet wide and had numerous holes cut in the side. Bomb was destroyed in place.

(31) 032055H Company D destroyed 2 caves at (BT 009339). Both caves were approximately 15-20 meters in depth.

(32) 4 August 1967 Company D continued search and destroy operation in accordance with 1st Battalion, 5th Marines Frag Order 90-67. See Tab (C) to Enclosure (1).

(33) 4 August 1967 Company C continued under OPCON of 3rd Battalion, 5th Marines.

(34) 040700H Platoon, Company D and Heavy Section Tanks, Company A, 1st Tank Battalion departed 1st Battalion, 5th Marines Combat Base to link up with Company D at (BT 018342).

(35) 040840H Squad Patrol 5B18 at (BT 015357) received 2 rounds sniper fire from 2 VC at (BT 013356). VC were dressed in black clothing. Patrol returned 20 rounds small arms fire. VC broke contact and fled in a northwesterly direction. Area was searched with negative results.

(36) 040900H MEDCAP was held in Lang Thuong (5) Hamlet at (BT 024345). 62 Vietnamese civilians were treated.

(37) 040912H Platoon, Company D and Heavy Section Tanks, Company A, 1st Tank Battalion linked up with Company D at (BT 018342) to deliver cratering charges to destroy caves.

(38) 041000H Five Scout Sniper Teams arrived at 1st Battalion, 5th Marines Combat Base.

(39) 041000H Commanding Officer, 1st Battalion, 5th Marines visited Nui Lac Son at (BT 023288) from 041000H to 041030H.

(40) 041050H Company C returned to 1st Battalion, 5th Marines Combat Base terminating OPCON of 3rd Battalion, 5th Marines.

(41) 041100H Company D at (BT 018340) discovered a cave 4 feet wide, 5 feet high and 75 meters long. Cave was destroyed by engineers.

(42) 041715H Aerial observer sighted 6 VC with weapons wearing black clothing at (BT 002282). 4.2 inch mortar mission was called with excellent target coverage. Observer reported 2 KIA confirmed and one secondary explosion. Squad Patrol, Company B was dispatched to search area and found heavy blood trails but were unable to locate bodies. Results: 2 VC KIA confirmed, 2 VC KIA probable.

(47) 5 August 1967 Company D continued search and destroy operation in accordance with 1st Battalion, 5th Marines Frag Order 90-67. See Tab (c) to Enclosure (1).

(48) 050820H Scout Sniper Team attached to Squad Patrol 5A14 at (BT 007327) observed one VC with weapon, wearing white clothing at (BT 005327). Scout Sniper Team fired 1 round small arms fire and called 81mm mortar mission of 6 rounds HE and 2 rounds WP. Area was searched with negative results.

(49) 050830H Company D at (AT 996335) observed 4 VC, one wearing black clothing and one wearing a helmet at (AT 997333). Fired 40 rounds small arms fire and 8 M-79 rounds. VC fled in a southerly direction. Artillery mission was called and conducted with good target coverage. Area was searched with negative results.

(50) 050900H MEDCAF was held in Ianh Thuong (5) Hamlet at (BT 024545). 32 Vietnamese civilians were treated.

(51) 051000H Company D at (AT 091334) found assorted medical supplies, one BW gas mask, one VC uniform, one hammock and one homemade gas mask and equipment was forwarded to 5th Marines S-2.

(52) 051100H Squad Patrol 5D2 at (BT 006307) spotted 6 VC at (BT 006305). Two were wearing green utilities, 4 were wearing black clothing. All 6 VC were carrying weapons. Patrol fired 50 rounds small arms fire and 3 M-79 rounds, observing 2 VC fall as if hit. Area was searched and 1 VC KIA confirmed and heavy blood trails were found. Results: 1 VC KIA confirmed and 1 VC KIA probable.

(53) 051145H Squad Patrol 5B2 at (AT 993303) received 15 rounds automatic fire from 4 VC. Patrol returned 20 rounds small arms fire and called for 81mm mortar mission. Area was searched with negative results.

6. Supporting Forces.A. Air.

(1) Fixed Wing. During Operation COCHISE, fixed wing air support was provided by the 1st Marine Aircraft Wing.

a. D + 5 flight of F-4 aircraft controlled by an airborne tactical air controller was directed to target coordinates (BT 158264) in support of company B. Search of area was conducted with negative results.

3. H&I fires were used on over 300 different targets as part of the counter mortar plan. H&I's were also used daily to help suppress sniper fire in helicopter landing zones and to deny the VC freedom of movement.

4. FO Teams were assigned to all participating companies. The Artillery Liaison Officer moved with the Battalion Command Group.

The detainee and the following equipment were forwarded to 5th Marines S-2: 1 surgical mask, 1 pack, 1 mosquito net, 1 grey uniform, 1 large surgical sterilizes, 17 record books, 1 Vietnamese unit #1. 1 bag of pills, 1 blue sweat shirt. Other items were destroyed.

(6) 241030H Company I platoon patrol 5I2 located vicinity (AT 913 268) apprehended 2 Vietnamese males ages 20 and 35. 1 Detainee was dressed in a green uniform, the other detainee wore grey clothing, both detainees had pack strap marks on their shoulders. The area was searched and 1 green uniform was found. The 2 detainees and green uniform were forwarded to 5th Marines S-2.

(7) 241110H Company I platoon patrol 5I1 located vicinity (AT 915 270) observed 5 VC with weapons dressed in black clothing crossing a rice paddy vicinity (AT 914274). Patrol fired 60 rounds small arms fire, 4 rounds 60mm mortar fire, called an artillery mission which was fired with good target coverage. The area was searched with negative results.

(8) 241240H Company I located vicinity (AT 914272) observed 6 camouflaged VC carrying packs vicinity (AT 912275). Company I fired 300-350 rounds small arms fire at the VC; searched the area finding 1 VC pack containing personal gear, 1 empty map case and 1 gas mask. The captured equipment was forwarded to 5th Marines S-2.

(9) 241405H Company B arrived at Company A, 1st Battalion, 3rd Marines patrol base located in vicinity (AT 917243). See Enclosure (35).

(10) 241520H Company A 1st Battalion, 3rd Marines chopped from 1st Battalion, 5th Marines. Company B assumed responsibility for security of Battery F, 2nd Battalion, 11th Marines

(11) 241645H Battalion S-2 received the following information from a 19 year old detainee captured at 241000H. The detainee was a platoon leader of the 3rd platoon 510th Company 24th Main Force Battalion which is transportation unit. The detainee had no knowledge of his units whereabouts and stated that the VC disperse when Marines are in the area.

The detainee claimed that he couldn't read a map, but he agreed to lead Marines to his headquarters CP which is defended by 62 MG's armed with 10 U.S. carbines and 4 AK 47's. Plan formulated to attack the VC headquarters at 0500. 25 August 1967.

(12) 242015H 59 refugees requested evacuation to a government controlled area. Refugees were helilifted to safe area at 242030H.

(13) 242215H Company D commenced movement to reported enemy CP reported in event 241645H.

(14) 242130H 1st Battalion, 5th Marines Frag Order 104-67 was promulgated. See Enclosure (35).

(15) 242234H 1st Battalion, 5th Marines received 5th Marines Regimental Frag Order 5-67. See Reference (p).

D+6 25 August 1967

(1) 250400H Company D located vicinity (AT 874264) fired 2 E-8(GS) launchers at suspected VC CP and swept the area. The area was searched and 1 male age 60 was apprehended. 2 Large huts 40 feet by 20 feet were found. One hut had no evidence of recent use, the other hut contained 1 gallon of warm cooked rice. 3 holes 2 1/2 inches in diameter and 2 1/2 feet deep were found. The detainee was forwarded to 5th Marines S-2.

(2) 250600H Phase II Operation COCHISE terminated.

(3) 250730H Company I squad patrol located vicinity (AT 901253) encountered one Vietnamese male dressed in black clothing who fled from Marines. Marines ordered the VC to halt 3 times in Vietnamese. When the VC failed to respond to the challenge the Marines fired 5 rounds small arms fire killing the VC. Results: 1 VC KIA confirmed.

(4) 250750H Company I platoon patrol 511 located vicinity (AT 913 266) observed 2 Vietnamese males dressed in black clothing vicinity (AT 913 267). Marines ordered the 2 Vietnamese to halt, when they failed to comply Marines fired 8 rounds small arms fire and 1 M-79 round at the fleeing VC. The VC fled to the northeast into dense vegetation. The area was searched with negative results for VC. One Bamboo booby trap device was found and forwarded to Battalion S-2.

(5) 250900H Company K located vicinity (AT 906252) apprehended 3 Vietnamese males ages 30, 32, and 37 who tried to flee from patrol. Patrol searched the area and apprehended 1 male age 31 badly burned by napalm at coordinates (AT 911253). The 4 detainees were forwarded to 5th Marines S-2.

Patrol returned 20-25 rounds small arms fire and called a 60mm mortar mission which was fired with good target coverage. The area was searched with negative results.

(4) 261425H Company I located vicinity (AT 914254) apprehended 1 20 year old Vietnamese male dressed in black clothing who attempted to flee from Marines. The detainee was forwarded to 5th Marines S-2.

(5) 261450H Company I Squad patrol located in vicinity (AT 921254) received 3 rounds sniper fire from 4 VC dressed in black clothing at coordinates (AT 921257). Patrol returned 20 rounds small arms fire, 3 M-79 rounds and searched the area with negative results.

(6) 261500H Company D Squad patrol located vicinity (AT 915233) received 3-4 rounds sniper fire from 3 unobserved VC. COP observed enemy fire and 3 VC dressed in black clothing with packs. 6 rounds 60mm mortar were fired and Scout Sniper fired 1 round killing 1 VC. Results: 1 VC KIA confirmed.

f. Medical Evacuation.

(1) No problems were encountered in the collection and evacuation of casualties.

13. Special Equipment and Techniques.

(1) An E-8, CS Rocket Pack was successfully used during predawn attack 25 August 1967.

14. Commanders Comments:

a. The operation itself presented no unusual problems. All missions were accomplished.

b. It was noted that a large number of non battle casualties evacuated (total 83) during the operation. This total exceeds that of any previous operations. It is surmised that the following factors contributed to this:

(1) The high temperatures experienced during August.

(2) Inability of new replacements to acclimatize rapidly.

(3) No medical doctor on the operation. The corpsman appeared overly cautious, and reluctant to keep any man in the field who had any ailment, no matter how severe.

c. A large number of refugees (total 143) requested evacuation from the Hiep Duc area during Phase II of the operation. It is believed that USMC presence in the Hiep Duc/Que Son Valley area has been felt and that the people are beginning to realize the VC cannot win in this area. Subsequent operation in this area should increase the influence of the Government of Vietnam and the 1st Marine Division.

d. There was a minimum of Psy-Op/Civic Action activities during Operation COCHISE but 143 refugees choose to be evacuated to government controlled areas. This indicates that a strong Psy-Op/Civic Action program could produce significant results in the Hiep Duc Area.

15. Recommendations. On Battalion (-) or larger operations a medical Doctor should accompany the Unit.

(2) Each unit carried its organic machine guns, rocket launchers, 60mm mortars, and a basic allowance of ammunition.

(3) There were some problems encountered in resupplying the Battalion. These were incomplete resupply loads and failure of LSA to fill back orders.

b. Maintenance.

(1) Personnel carried their own cleaning equipment. Weapons were cleaned and inspected daily. There were no problems encountered with weapons or ammunition during the operation.

c. Treatment of Casualties, Evacuation and Hospitalization.

(1) Treatment of casualties was initially administered by the Company Corpse men and the Corpse men attached to the Battalion Command Group.

(2) Medical Evacuations were called by HST personnel attached to the companies. The Command HST attached to the Battalion Command Group then relayed the request to the LSA located at Thane Bien, hill 63, RVN. When the Helicopters were on the way, the unit requesting the medical evacuation was notified. The appropriate HST then guided the helicopter into the LZ and the Medical Evacuation was completed.

(3) Medical Evacuation being completed, evacuees were forwarded to a Collecting and Clearing company located at Hill 63 and further evacuated to DaNang or a Hospital Ship as required.

(4) A total of 85 NBC's were medically evacuated during Operation COCHISE. There was no medical doctor on the operation and the corpse men appeared overly cautious about keeping any men in the field who had any ailment.

d. Transportation.

(1) On Operation COCHISE, helicopters were used to provide the Battalion with heli-lift capabilities, normal resupply and medevacs.

(2) Helicopter support was adequate and the only type of transportation utilized.

e. Communications.

(1) On D+5 during heavy contact with a VC platoon at (BT 159249) it was impossible to communicate with any unit external to the Battalion by any means except airborne radio relay. This communication difficulty limited the effective employment of supporting arms.

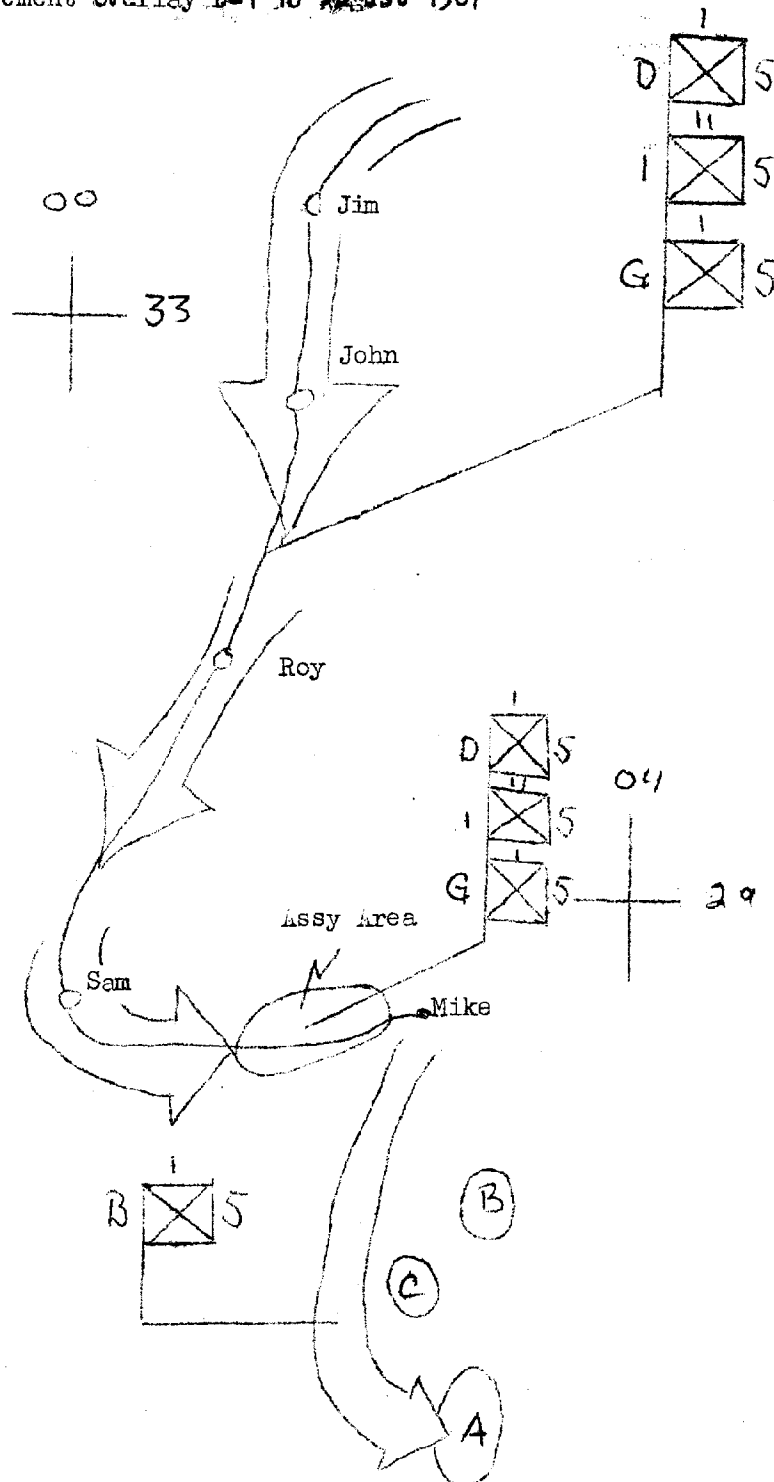

Movement Overlay D-1 10 August 1967

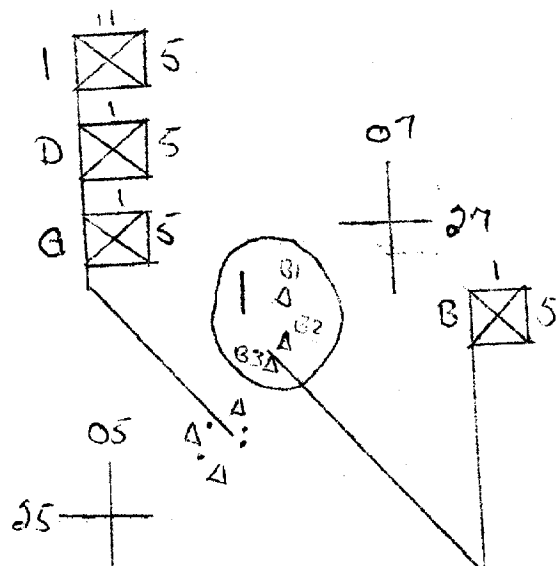

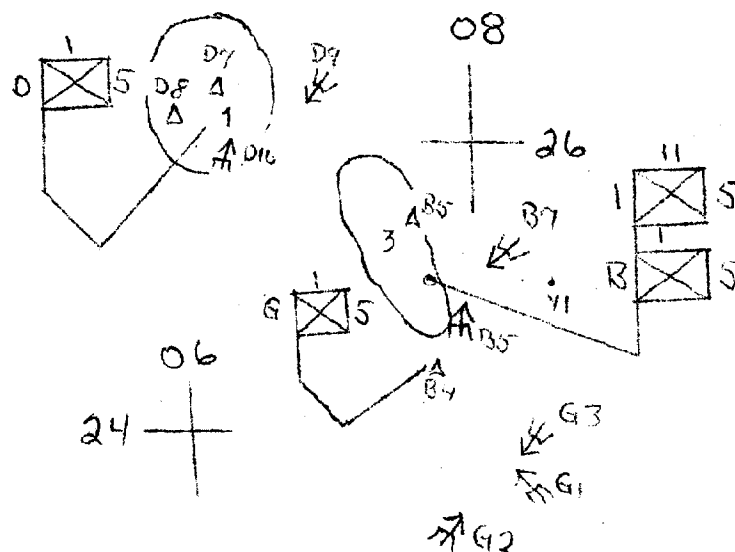

Day Movement Overlay D+5 16 August 1967

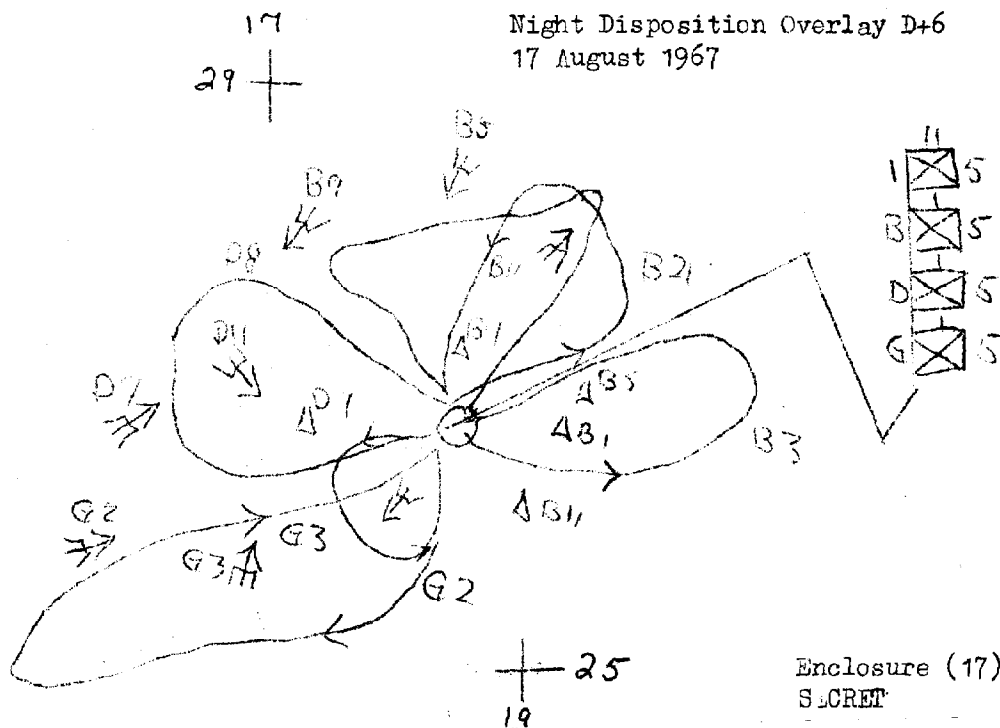

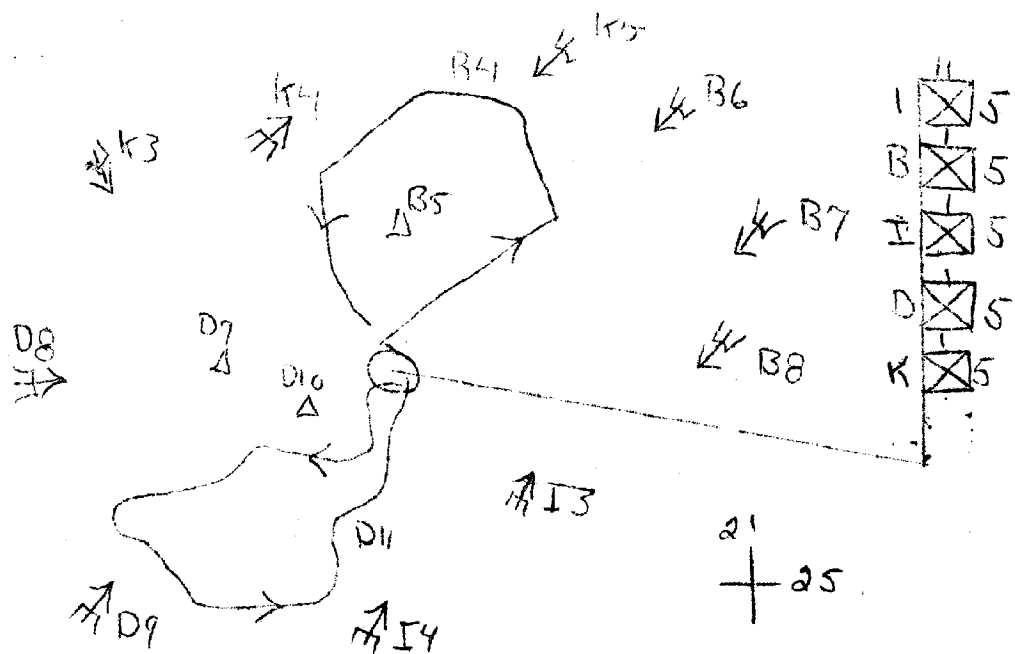
Night Disposition Overlay D+6

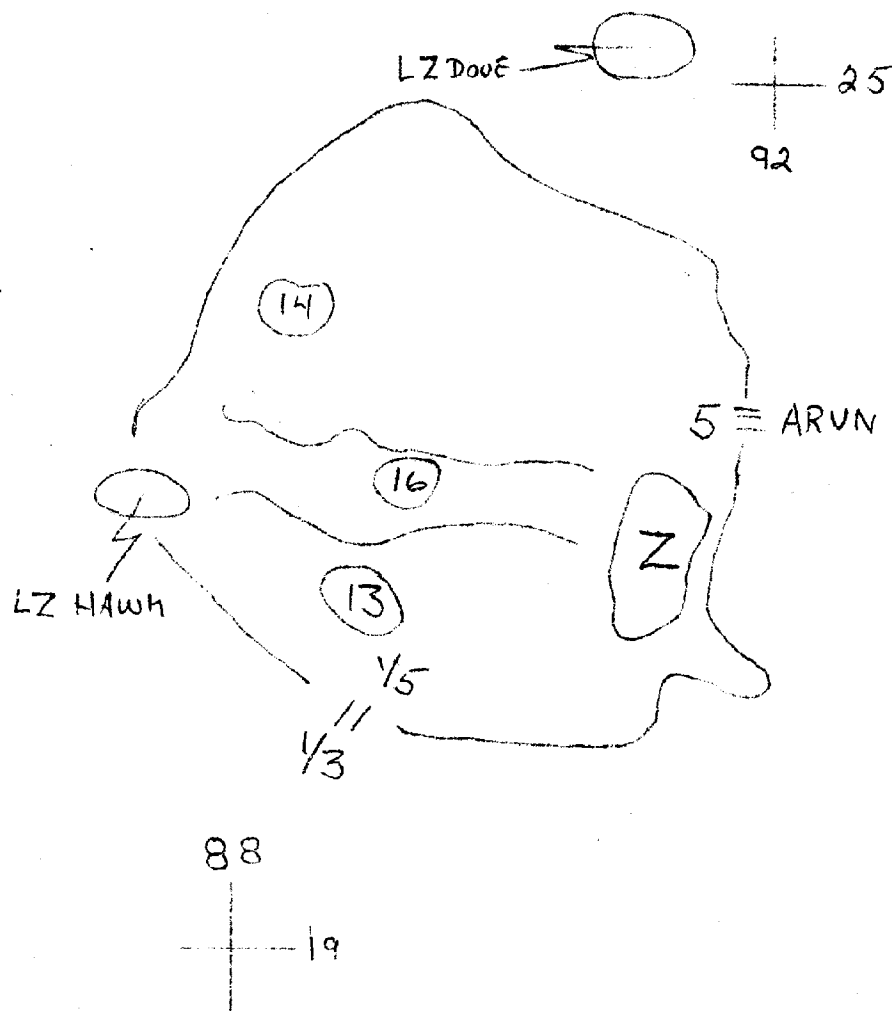

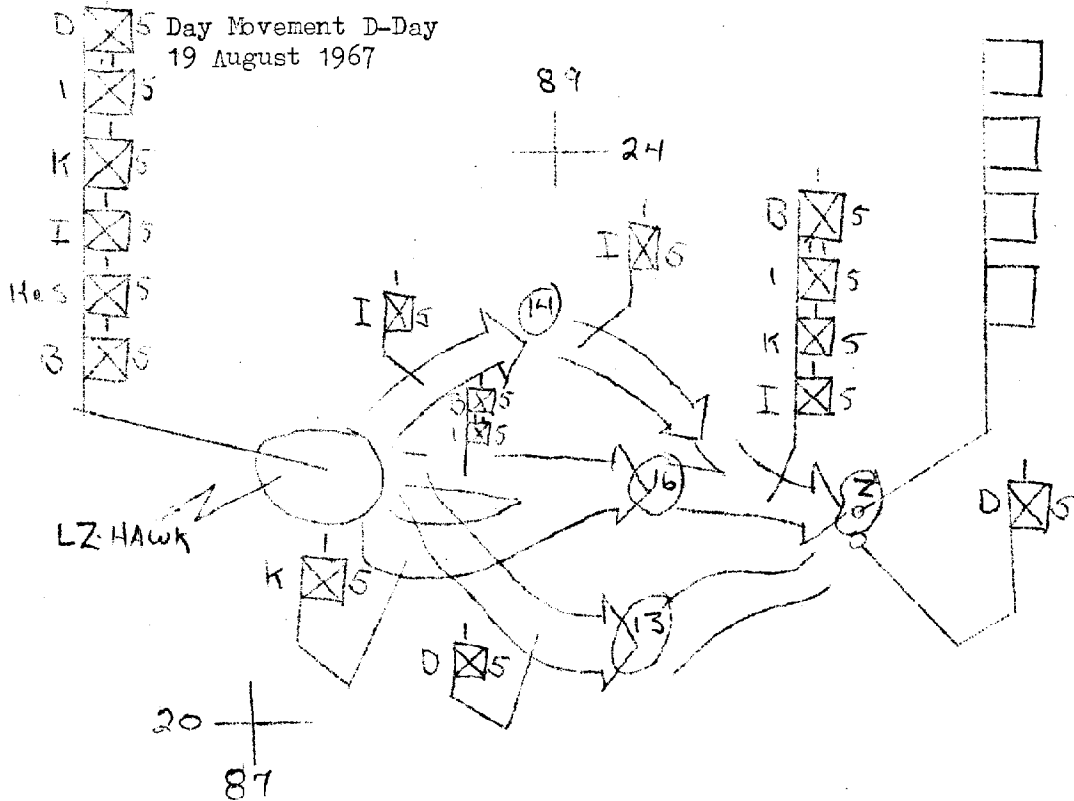
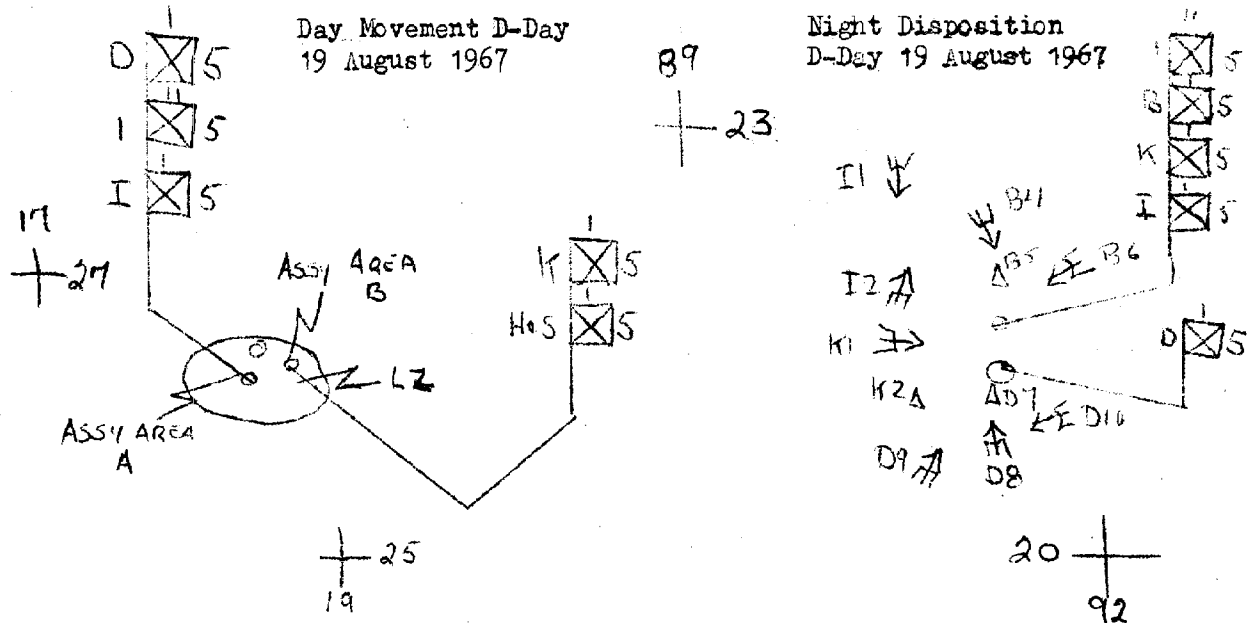
