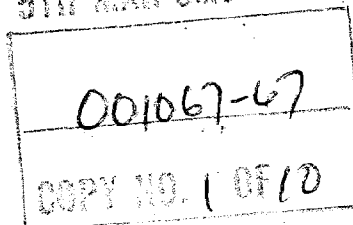

PART II

NARRATIVE SUMMARY1. Personnel and Administration.

a. Postal service during September deteriorated due to helicopter non-availability. There were several periods during the month when no mail was received for 3 to 5 days. The 5th Marines Regimental Post Office provided 2 Mobile runs to Hill 51 selling Postal Money Orders, envelopes and stamps. Mobile runs twice a month are satisfactory for the needs of this battalion.

b. Two mobile PX runs were conducted during the last ten days of the month by the Division Exchange. Both were well stocked with merchandise and were extremely well received by the members of this battalion.

c. Two award ceremonies were conducted by the battalion during September with the following awards presented: Bronze Star Medals-3, Navy Commendation Medals-2, Purple Heart Medals-23, and Commanding General's Certificates of Commendation 3. Total number of personnel recommended for awards during September: Medal of Honor-1, Navy Cross-1, Silver Star-5, Bronze Star-23, Navy Commendation Medal-8, and CG Certificate of Commendation-4.

2. Enemy, Weather and Terrain.

a. Enemy. During September 1967, the enemy continued to operate in the vicinity of the combat base in a estimate strength of two regiments consisting of various identified and unidentified units. The 1st NVA Regiment and parts of the 3rd and 21st NVA Regiment were encountered during Operation "SWIFT". Information received from Que Son District Chief, rated C-3 by Battalion S-2, revealed the following information concerning enemy unit designations and locations: the 105th LF Battalion operated generally to the north of the Battalion Combat Base; the 70th Independent NVA Battalion located in vicinity (BT 0939), (BT 1038) and (BT 1138), the 1st Battalion of the 3rd NVA Regiment located in vicinity (AT 9631), (AT 9632) and (AT 9734). Unidentified units according to local sources are company sized units at coordinates (BT 001389), (BT 054385), (BT 119388), and battalion size units located at (AT 9528), (BT 0934), (BT 0834), (BT 1034), (AT 9527), (AT 9627), (BT 0041) and (BT 0441). Follow-up action was taken on intelligence

reports received from Que Son District during September 1967.

b. Weather. The weather during September was humid with occasional late afternoon rain showers. The average high and low temperatures were 90 degrees and 75 degrees respectively.

c. Terrain. The Que Son area is a valley about nine miles long and four miles wide orientated in a general northeast to southwest direction. The area is divided by the Song Ly Ly River Northeast to Southwest. The river provides a corridor which is the best avenue of approach into the mountains located to the west and southwest of the combat base. The mountains southwest of the Battalion Combat Base can provide an excellent withdrawal route for the enemy.

d. Vegetation. Bamboo and scrub are the prime vegetation features which restricts long observation.

3. Organization and Operations.

a. During the month of September the battalion participated in Operation SWIFT from 4-15 September and continued to actively patrol the areas adjacent to the combat base at Hill 51, (BT 025343). In addition to a two company operation, company, platoon and squad patrols were conducted daily. (On 29 September the battalion was alerted to deploy to assume responsibility for 1st Battalion, 1st Marines FAOR on 1 October 1967.)

b. The Battalion assumed the Bald Eagle commitment for the 5th Marine Regiment on 20 September, and maintained this requirement throughout the remainder of the month.

c. Improvement of field fortifications for the combat base was continued throughout the month. Decking and drainage in the fighting positions were tested as a result of almost daily heavy showers and improvements were made where necessary.

d. During the month, red alert drills were conducted to test the preparedness of the combat base. All drills were considered to be successful.

4. Training.

a. Training was conducted on the battalion and the company level with continued emphasis on care and cleaning of the M-16 rifle and familiarization firing. During this firing the instruction stressed, confidence building, results, fire discipline, fire control, firing techniques, and weapons safety.

Training was also conducted in scouting and patrolling, field fortifications, map reading and use of the compass, field sanitation and hygiene, NCO leadership, and conduct of Marines in Vietnam.

b. The battalion continued to utilize schools provided by higher Headquarters. During the month of September 1967, 11 Marines attended school in DaNang, RVN and in Okinawa.

5. Logistics.

a. During the month of Sept 1967 the build-up of the combat base continued.

b. Contact teams from FMFPAC Maintenance Team, 1st Marine Division Maintenance Team, 1st Marine Division Embarkation, and an 81mm mortar Maintenance Team from Ordnance Maintenance Company, 1st Force Service Regiment visited the Combat Base to conduct inspections and give instructions in their respective areas. In addition a Division G-4 Assistance Team as well as a Supply Inspection Team from Division visited the Combat Base during this period. Two Officers from the Division Air Delivery Officer, G-4 and a Liaison and Survey Team from Naval Construction Battalion visited the Combat Base during September.

c. On 30 September work commenced on preparations for deployment to assume responsibility for 1st Battalion, 1st Marines TAOR.

6. Civil Affairs/Civic Action.

a. During the month of September 1967, 827 Vietnamese civilians were treated at Med-Cap.

b. After providing courtesy evacuation assistance for 50-60 persons, S-5 discontinued providing helicopter evacuation service for Vietnamese. Henceforth evacuation assistance will only be given on a very limited basis. This action was necessitated due to limited helicopter availability.

c. Meetings were held with the District Chief (Lt. DAP) concerning prostitution and sale of marijuana cigarettes in Lanh Thuong (5). The information was given to the National Police and arrests are to be made in the near future.

d. The people of Son Lanh Village completed and installed the necessary furnishings needed to run an efficient Med-Cap program.

e. Through the efforts of the ARVN Liaison Officer (Lt. KHA) and the Civil Affairs Staff a new identification card was initiated for the merchants of Lanh Thuong (5). This card is a permit to run an establishment that sells to Marines of 1st Battalion, 5th Marines. The new system will eliminate the possibility of strangers infiltrating into the village.

f. Liaison was made with Chief of Son Lanh Village to ensure a through police call daily in Lanh Thuong (5).

g. School kits, a sewing machine and rice thresher were from III MAF Supply Depots during this period. Distribution will be at a later date. A meeting was held at Que Son District Headquarters concerning the use of the rice thresher. The District Chief decided that the rice thresher will be given to the refugees. Before they receive the rice thresher they must construct a shelter in a centrally located position for harvest. The spot for the construction of the shelter has been picked and construction will soon begin. Profits from the rice thresher will be used to buy new and different types of seed.

h. Arrangements were made with local craftsman to make mugs and trays to be sent home by the Marines of 1st Battalion, 5th Marines as Christmas presents.

i. A Civic Action Technical Inspection was held by Division G-5 during this period. 1st Battalion, 5th Marines was given a satisfactory rating with no discrepancies.

j. S-5 Staff along with LTCOL VAN DEN BERG, JR. journeyed to Que Son District to take part in the festivities celebrating Vietnamese National Youth Day (18 September). 1st Battalion, 5th Marines donated 200lbs. of candy to the festivities.

k. The first few days of the month were comparatively inactive for the civic action program. This was due to the Vietnamese National Elections. Lanh Thuong (5) was closed for the time during the election and the few days that followed. However, liaison was made with local merchants making it possible for the Marines to get haircuts and pick up their laundry at the main gate.

l. Prices were lowered in Lanh Thuong (5) as a result of the meeting held by the Civil Affairs and ARVN Liaison Officer with local District and Village officials.

m. Three booby traps were reported to S-5 by youths of Lanh Thuong (5). The booby traps were located in the vicinity of the trash dump. The information concerning the booby traps was turned over to S-2 and Engineers.

n. Four scholarships were given out by LTCOL VAN DEN BERG to deserving youths of the Que Son District in the name of General Walt. The General Walt Scholarships will be given out every four months to those children in need of financial assistance to further their education.

7. Psychological Operations.

a. On 5 September the following leaflets were ordered from Regimental S-5: SP 1252-Real meaning of Chieu Hoi, SP 1233A-Chieu Hoi appeal and rally instructions, and others dealing with health and hygiene. The first two sets were dropped by air at coordinates (AT 985315) and (AT 993334) on 8 September. The remaining set was used for hand distribution in Que Son in relation with the MEDCAP program.

b. During the period from 6-17 September, daily broadcasts were made to the west and southwest of Hill 51 stressing the Chieu Hoi theme. Other themes used were harassment tapes, appeal for VC husbands to return home to their families, messages to rural compatriots, and don't pay VC taxes. Several broadcasts were made live using S-2 Scouts.

c. During the period from 17-20 September all PSY/OPS equipment was checked and found to be in proper working order. On 18 September this equipment was used for National Youth Day Festival in the Que Son District.

d. District Chief of Que Son and the Christian Minister visited 1st Battalion, 5th Marines Combat Base to pay their respects to LTCOL. P. L. HILGARTNER.

8. Comptroller Activities.

a. Appropriated funds were obligated in a timely manner during September, the last month of the first quarter FY 68. An additional allocation of \$50,000.00 was received and obligated to fund longtime supply deficiencies.

9. Communications.

a. Construction of a battery bunker was completed on 3 September work on a central transmission bunker began on 17

September. Thirty telescopic telephone poles were acquired on 24 September and the installation of new telephone and power lines is in progress.

(1) 1 Sept 1967 Company A continued OPCON to 1st Battalion, 7th Marines

(2) 010310H Company B, 1st Battalion, 5th Marines commenced search and destroy operation in accordance with Battalion Frag Order 106-67. See Tab (B) to Enclosure (1).

(3) 010735H Company B at (BT 00317) observed 4 VC at (BT 001-319) wearing black clothing. Company B fired 45-50 rounds small arms fire and 3 M-79 rounds. Search disclosed 1 VC KIA confirmed. Results: 1 VC KIA confirmed.

(4) 010755H Company B at (BT 000324) received 1 round small arms fire from (AT 994324) wounding one Marine in the left wrist. Area was searched with negative results. Results: 1 USMC WIANE.

(5) 010900H MEDCAP was held at Thanh Thuong (5) Hamlet at (BT - 024345). 28 Vietnamese civilians were treated.

(6) 011140H Company B at (AT 999329) received 10-15 rounds small arms fire from an estimated 3 VC at (AT 999328). Company B returned 25-30 rounds small arms fire and searched area with negative results.

(7) 011150H Company B at (AT 985328) observed 8-10 VC at (AT 985330) wearing black clothing and carrying weapons. Company B fired 45-50 rounds small arms fire as VC fled to the northwest into heavy undergrowth. Area was searched with negative results.

(8) 011235H Company B at (AT 982324) received 10-15 rounds small arms fire from an estimated 2 VC at (AT 976324) wounding 2 Marines. As Company B returned fire and maneuvered to close with the enemy, small arms fire was received from an estimated 10-15 VC at (AT 975328). Company B continued to return small arms fire and 60mm mortar fire. Enemy apparently broke contact to the west. As medical evacuation was being conducted, an additional 5 rounds small arms fire were received from (AT 974325). Area was searched with negative results. Results: 2 USMC WIAE, 1 USMC WIANE.

(9) 011445H Company B at (AT 999328) apprehended 1 Vietnamese male, age 27, who stated he was a VC. Initial interrogation by Battalion S-2 revealed detainee was a 60mm mortar man. A range card was found on detainee. Detainee was forwarded to 5th Marines

S-2. Results: 1 Detainee

(11) 011730H Company B at (AT 984355) observed 7 VC at (AT 98-3356) wearing black clothing, some wearing cartridge belts and carrying weapons. Company B fired 65-70 rounds small arms fire, 4 M-79 rounds and searched area finding 2 VC KIA confirmed, 1 cartridge belt and 1 wounded Vietnamese female. Detainee was forwarded to 5th Marines S-2. Results: 2 VC KIA confirmed, 1 Detainee.

(12) 011900H Company B at (BT 001351) found two anti-tank mine 1 foot in diameter with three prongs protruding from the ground. Mines were destroyed in place by engineers.

(13) 011945H Company B, 1st Battalion, 5th Marines returned to Combat Base terminating search and destroy operations in accordance with 1st Battalion, 5th Marines Brig Order 106-67. See Tab (B) to Enclosure (1).

2 Sept 1967 Company A continued OPCON to 1st Battalion, 7th Marines.

(1) 020631H Company D, 1st Battalion, 5th Marines commenced search and destroy operations in accordance with 1st Battalion, 5th Marines Brig Order 107-67. See Tab (C) to Enclosure (1).

(2) 020800H Company D at (BT 062361) received 15-20 rounds small arms fire from (BT 066365). Returned 75 rounds small arms fire. 1 Vietnamese male wearing blue clothing was apprehended during a search of the area. Detainee was forwarded to 5th Marines S-2. Results: 1 detainee.

(3) 021300H H&S Company Fire Team Security 5Y7 at (BT 024346) reported that 20 82mm mortar rounds, 4 57mm HE rounds and 1 60mm mortar round were uncovered by a bulldozer. Rounds were destroyed in place by engineers.

(4) 021720H Company D at (BT 071364) received 25 rounds small arms fire from unknown number of VC at (BT 073366). 110 rounds small arms fire, 12 60mm HE rounds and 3 M-79 rounds were returned. Area was searched with negative results.

(5) 021935H Company C Squad Patrol 503 at (BT 055314) observed 5 VC at (BT 055313) who did not halt upon order. Patrol fired 20-30 rounds small arms fire killing 1 VC wearing black and white

clothing. Results: 1 VC KIA confirmed.

(6) 022000H Company B defensive position in the 1st Battalion 5th Marines Combat Base perimeter at (BT 024342) received 5-6 rounds small arms fire from (BT 014334). 10 rounds 81mm HE were fired on suspected enemy position.

3 Sept 1967 Company A continued OPCON to 1st Battalion, 7th Marine

(1) 030725H Company D continued search and destroy operations in accordance with modification to 1st Battalion, 5th Marines Frag Order 107-67. See Tab (C) to Enclosure (1).

(2) 030830H 3rd Platoon, Company C arrived at Nui Mac Son Combat Base terminating search and destroy operations in accordance with 1st Battalion, 5th Marines Frag Order 124-67. See Tab (E) to Enclosure (1).

(3) 030845H Company D at (BT 081374) received 5-10 incoming mortar rounds or rifle grenades and 50-100 rounds automatic weapons fire from an estimated 20-25 at (BT 082378). Returned small arms fire and called artillery/air missions. Company D later observed 7 VC and fired 75-100 rounds small arms fire, observing 3 VC fall, one dropping a Browning Automatic Rifle. Search of area revealed heavy blood trails and one Browning Automatic Rifle, serial number 596256. Results: 1 USMC WIAE, 5 VC KIA probable.

(4) 031005H Company D received modification to 1st Battalion, 5th Marines Frag Order 107-67. See Tab (D) to Enclosure (1).

(5) 031040H Company B, Squad Patrol 5B23, at (BT 009316) observed 2 VC wearing black clothing with weapons at (BT 006320). Fired 85 rounds small arms fire and 7 M-79 rounds. VC fled to the north. Area searched with negative results.

(6) 031237H Company D at (BT 072373) received 3 rounds small arms fire from (BT 072376). Returned 50 rounds small arms fire. Searched area apprehending four Vietnamese males without ID cards. Detainees were forwarded to 1st Battalion, 5th Marines S-2 and later released.

6. Supporting Forces.

a. Air.

(1) 4 Sept. 1967. TAC(A) controlled 3 flights of A4's and 1 flight of F8's at coordinates (BT 073332) to (BT 075328) against enemy positions in support of Company D. TAC(A) controlled 2 flights of A4's and 3 flights of F4's at coordinates (BT 076331) to (BT 079338) in support of Company D. Company D's FAC also directed a C-47 "Dragon Ship" against enemy positions in all of the above target areas. All of the above missions were close air support against enemy forces attacking Company D, and they contributed towards breaking up the enemy attack.

(2) 4 Sept. 1967 TAC(A) controlled 2 flights A4's and 1 flight of F4's at coordinates (BT 070327) to (BT 070333); 1 flight A4's, 2 flights F4's and 1 F8 at coordinates (BT 070328) to (BT 076329). 1st Battalion, 5th Marines ALO controlled 4 flights of UH1E gunships and 3 C-47 "Dragon Ships" in the same target areas. The missions were in support of Company B, Company M, and H&S Company against attacking enemy forces; mortar and automatic weapons positions. The attack destroyed enemy mortar position and 3 automatic weapons positions. Company M FAC directed 2 UH1E's in a CS chemical agent attack against enemy forces, which assisted in breaking up enemy resistance on Company M's objective.

(3) 6 Sept. 1967. TAC(A) controlled 10 flights of fixed wing and 3 flights of UH1E gunships against attacking enemy forces, automatic weapons positions, and mortar positions in support of Company D, Company B, and H&S Company in the vicinity of coordinates (BT 100302). TAC(A) controlled 1 flight UH1E and 1 flight A4's in a CS chemical agent attack against enemy mortar and automatic weapons positions in same target area. Enemy resistance appeared to decrease significantly after the chemical attack.

(4) 7 Sept. 1967. Battalion ALO directed 2 C-47 "Dragon Ships" against enemy .50 cal. positions located at (BT 130300) and (BT 120305).

(5) 8 Sept. 1967. TAC(A) controlled 2 flights A4's in a direct air support mission against enemy automatic weapons positions located at (BT 088274).

(6) 10 Sept. 1967. TAC(A) controlled 1 flight F4's and 1 flight A4's in a direct air support mission against enemy automatic weapon positions located at (BT 126262) and (BT 125272).

(7) 11 Sept. 1967 TAC(A) controlled 3 flights of A4's against enemy fortified positions located at (BT 127278), (BT-125270) and (BT 165288). 11 structures and 1 bunker were destroyed. TAC(A) directed 2 flights A4's against a fortified village located at (BT 155290), destroying 3 fighting positions.

(8) 12 Sept. 1967. TAC(A) controlled 6 flights of A4's. 6 flights of F4's and 1 flight of F8's against an enemy fortified village located (BT 155290). The village was extensively damaged.

b. Artillery.

(1) During Operation "SWIFT", artillery support was provided the 1st Battalion, 5th Marines by artillery units of the 2nd Battalion, 11th Marines.

(a) Battery D, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines from 4 September through 11 September and on the 15th of September.

(b) Battery F, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines during operations on 12 September and 13 September 1967.

(c) Whiskey Battery, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines on 14 September.

(2) Direct artillery support was used through the hours of darkness on 4 September and 6 September to reinforce the perimeter defenses.

(3) Throughout the operation, preparatory fires, defensive fires, and fire missions on targets of opportunity were used extensively.

(4) H&I fires were used nightly during the operation on avenues of escape, avenues of approach, suspected enemy concentrations and areas of previous enemy contact.

(5) Direct Artillery support was coordinated and supervised by the Artillery Liaison Officer, who moved with the Command Group, and the Artillery Forward Observers, who moved with the Companies participating in the operation.

c. Engineers.

(6)

(1) Engineering support was provided by Company B, 1st Engineer Battalion with an engineer team assigned to each company and the command group. During the operation, engineers were employed to destroy the following: 5 enemy emplaced mines, 1 downed helicopter (CH34D), approximately 2000 lbs. of U.S. ordnance (duds) and about 2000 feet of enemy wire (electrical). The engineers used a total of 85 pounds of C4 to accomplish these missions.

7. Intelligence.

a. Estimate of Enemy Strength, Location and Disposition in the Objective Area.

(1) Enemy forces at the time Operation "SWIFT" commenced, were unknown.

(2) Units identified during the Operation were the 1st NVA Regiment, consisting of the 40th, 60th and 90th Battalions with an estimated strength of 600 men per Battalion. Elements of the 3rd and 21st NVA Regiments were also encountered in the operational area.

b. Enemy Strength Actually Determined during the Operation.

(1) Estimated actual strength was about 1800 in the 1st NVA Regiment with elements of the 3rd and 21st NVA Regiments, estimated 350 troops each. Total estimated strength was approximately 2,500 men.

(2) The main enemy force that engaged this Battalion was the 1st NVA Regiment.

c. Weather.

Throughout the operation, the weather was warm and humid with late afternoon showers and, for the most part, unrestricted visibility.

8. Mission.

1st Battalion, 5th Marines (-) (Rein) lands in designated LZ vicinity (BT 095330), attacks to the southwest to kill or capture the enemy, his weapons and supplies, and relieve/reinforce 1st Battalion, 5th Marines units presently in contact.

9 Concept. At H-Hour on D-Day 1st Battalion, 5th Marines (-) (Rein) lands in designated LZ, attacks with companies in column to secure Objectives 1 and 2 vicinity (BT 085333) and (BT 084326), continues the attack to relieve/reinforce Company B and Company D, prepares to continue the attack on order.

10. EXECUTION.

a. D-Day 4 Sept 1967 (See Enclosure (2)).

(1) 040430H Company D (-). 1st Battalion, 5th Marines, located vicinity (BT 076331) on a company search and destroy operation, received approximately 100 rounds automatic small arms fire and 3 rounds mortar fire from positions 100 meters Northwest and West of the company perimeter. Company D immediately returned fire of approximately 3000 rounds small arms, 50 rounds M-79, and 12 M-26 grenades. At this time the night COP's and a Squad Amb were recalled. Enemy fire which had not been accurate, continued sporadically. Company D had 4 USMC WIA. Artillery and 81 mortar missions were requested and fired.

(2) 040510H Company D, 1st Battalion, 5th Marines reported enemy on at least two sides, estimated 15 VB to the west.

(3) 040530H An air observer and an armed HUIE arrived on station. In directing aircraft to target, a strobe light was employed. Aiming in on this, the enemy mortar and small arms fire became more accurate and more intense. Some enemy also infiltrated the western portion of the perimeter, throwing hand grenades into Company D's positions. Company D returned fire with 60 mortars and 68 grenades. Artillery was requested and approximately 30 rounds of 105mm were fired to encircle the company position.

(4) 040545H Company D, 1st Battalion, 5th Marines reported 1 USMC KIA and 10 USMC WIA. Company D mounted a reaction force to clear the company positions and attack the enemy position to the west in vicinity of a village (BT 075329).

(5) 040600H Company D, 1st Battalion, 5th Marines reported small arms fire continuing from the west. 60mm counter-mortar fire caused a secondary explosion and enemy mortar and grenade fires ceased.

(6) 040620H Company D, 1st Battalion, 5th Marines was sweeping the village in vicinity of (BT 075329), when intense automatic weapons fire was received from the west at a distance of approximately 50 meters seriously wounding the Commanding ~~Officer~~ of Company D. The Executive Officer of Company D reported contact with approximately 1 Enemy Company and requested assistance

Enemy fire slackened and Company D commenced reorganization. Friendly casualties were estimated at 2 KIA and 20 WIA. Enemy casualties were 11 KIA confirmed and 8 KIA probable. Two fixed wing strikes were requested for Company D and controlled by the A.O. (TAC(A)) to cover the reorganization. Medical Evacuation was requested.

(9) 040810H Company D 1st Battalion, 5th Marines reported cumulative casualties as 14 friendly KIA and 15 friendly WIA, 11 enemy KIA confirmed and 8 KIA probable with 1 enemy WIA captured. One set of NVA Captain's bars was found on one of the enemy-dead.

(10) 040820H Company B, 1st Battalion, 5th Marines arrived in vicinity of Company D, 1st Battalion, 5th Marines position and commenced sweep of village at (BT 073329).

(11) 040835H Company D, 1st Battalion, 5th Marines reported that the enemy fired smoke grenades, misleading med-evac helicopters and downing two of the helicopters with small arms fire.

(12) 040849H Company B, 1st Battalion, 5th Marines located at (BT 069330) received 350-500 rounds automatic and semi-automatic weapons fire from an estimated NVA Company, camouflaged and entrenched in the vicinity of Dong Son (1) (BT 075331). Trench lines ran from coordinates (BT 073329) to (BT 073330). Company B returned approximately 400-600 rounds small arms fire and requested CS preparatory fire on the village. Results: 7 friendly WIA, 2 Enemy KIA confirmed..

(13) 040906H Company B, 1st Battalion, 5th Marines observed enemy elements moving to the rear of Company D's position.

(14) 040910H 1st Battalion, 5th Marines, Mobile Command Group alerted.

(15) 040914H Armed HUIE's delivered 400lbs. of CS on enemy positions. Fire ceased and an undetermined number of enemy were observed fleeing to the north across the river. Company B, 1st Battalion, 5th Marines conducted assault, physical pursuit and search of area. Cumulative results: 26 USMC KIA. 33 USMC

26 NVA KIA confirmed and 55 KIA probable. Captured one 60mm mortar tube, 1 rocket launcher, one AK-47, 3 AK-44, 1 AK-50 with 2 magazines. Captured equipment forwarded to 5th Marines S-2.

(16) 040925H Companies L and M of 3rd Battalion, 5th Marines alerted for helilift and chop to 1st Battalion, 5th Marines.

(17) 040937H 1st Battalion, 5th Marines Frag Order 108-67 promulgated. (See Enclosure (1)).

(18) 041043H Captain Heinz assumed command of Company D.

(19) 041150H Company B, 1st Battalion, 5th Marines located at (BT 072330), received heavy automatic and semi-automatic small arms fire from an undetermined number of enemy located in village (BT 073330). Enemy forces were well dug in and camouflaged. Company B returned approximately 2500 rounds small arms, 30 rounds M-79 and 2 M-26. An air strike was called, followed by Company B's assault on the enemy position and pursuit by fire. Results: 5 USMC KIA, 8 USMC WIA, 9 NVA KIA confirmed and 35 NVA KIA probable. 1 male and 1 female VC Suspects apprehended and forwarded to 5th Marines S-2.

(20) 041205H Company M and Company K, 3rd Battalion, 5th Marines landed in LZ vicinity (BT 108344) followed by 1st Battalion, 5th Marines medium Command Group. Lift complete 041245H.

(21) 041230H Company K 3rd Battalion, 5th Marines commenced movement to Objective 2 vicinity (BT 083326). See Enclosure (1)).

(22) 041240H H&S Company, 1st Battalion, 5th Marines located at LZ vicinity (BT 108344), apprehended 1 Vietnamese male approximately 60 years old. Forwarded to 5th Marines S-2.

(23) 041250H Company K, 3rd Battalion, 5th Marines, vicinity (BT 106330), apprehended 1 Vietnamese male approximately 15 years old. Searched suspect and found 2550 piasters, 1 razor, 1 watch guaranteed. Detainee upon being questioned said he had seen approximately 400 VC with about 7 mortar tubes, carbines and machine guns moving in a westerly direction. Detainee appeared to be shell shocked. Detainee was forwarded to 5th Marines S-2.

(24) 041335H Company K, 3rd Battalion, 5th Marines, vicinity (BT 083326), found one Chinese Communist semi-automatic weapon, 1 wallet with NVA money, one Vietnamese uniform, a pair of field glasses and one semi-automatic weapon, serial number

80987. Weapon and equipment forwarded to 5th Marines S-2.

(25) 041350H H&S Company, 1st Battalion, 5th Marines, LZ security elements while searching LZ, apprehended 18 Vietnamese (6 women, 5 men, and 7 children) wearing black clothing. Vietnamese were released as innocent civilians.

(26) 041430H-041900H Company K, 3rd Battalion, 5th Marines located (BT 090335) observed an undetermined number of camouflaged NVA vicinity (BT 085332). Received a heavy volume of automatic small arms and mortar fire. Returned 35,000 rounds small arms fire, 300 M-79, 35 60mm mortar H.E. and 20 rounds 105mm H.E.. While counter battery firing with 60mm mortar, Company K maneuvered elements to close with the enemy. The engagement continued until night fall, when Company K positions were consolidated at (BT 098335) with 1st Battalion, 5th Marines CP. Results: 1 USMC KIA, 13 USMC WIA, 28 NVA KIA confirmed, 35 NVA KIA probable. 1 AK-47 assault rifles, serial numbers 12855 and 10308, were captured and forwarded to 5th Marines S-2.

(27) 041445H-041900H 1st Platoon, Company M, 3rd Battalion 5th Marines, located at (BT 093337), was taken under heavy automatic and semi-automatic weapons fire by an estimated NVA Company located at (BT 089339). 2nd Platoon, Company M maneuvered to support 1st Platoon and also came under intense automatic and semi automatic small arms fire from another estimated NVA Company. Company M, CP. received 40 rounds 60mm mortar. Returned 2500 rounds small arms fire, 30 M-79 rounds, 5 60mm mortar, and 30 105 H.E. rounds. Four air strikes and an aerial CS attack were conducted which forced the NVA units to withdraw. Company M consolidated its position to stop camouflaged NVA who were attempting to infiltrate perimeter. An enemy mortar was knocked out by grenades at (BT 097337). At the same time Company K, 3rd Battalion, 5th Marines located at (BT 095331) also came under fire. Company M, 3rd Battalion, 5th Marines located at (BT 093336) also began receiving fire. Air and Artillery were called for. An estimated 2 Battalions were opposing the Marines forces. Heavy small arms fire and mortar fire continued as the Marine units maneuvered against the enemy.

As night began to fall, forces were consolidated. 1st Battalion

At one point 5 to 15 were within 10 meters of the perimeter before they were killed by the defensive fires. The perimeter was consolidated as 1st Battalion, 5th Marines continued to receive small arms fire and mortar fire throughout the night. Casualties were treated, and the night defense established as the enemy ceased activity except for small arms fire at the medical evacuation helicopters coming in to the LZ. Results: For 6 September 1967: 35 USMC KIA, 92 USMC WIA, 61 NVA KIA confirmed, 106 NVA KIA probable.

i. All areas in which air strikes were called were searched except strikes called against the following targets on 8 September:

Automatic weapons (BT 088277)

Automatic weapons (BT 126263)

Bunkers (BT 125272)

Automatic weapons (BT 128278)

The above strikes were called outside the Battalion's zone of action to protect the flanks of the Battalion on the move.

12. Administrative Matters.

a. Supply.

(1) Resupply was effected by helicopters, controlled by Helicopter Support Teams provided by the 1st Platoon, Company B, 1st Shore Party Battalion to the Command Group and all participating companies except Company I, 3rd Battalion, 1st Marines, which had a Helicopter Support Team provided by Company A, 1st Shore Party Battalion working under the 1st Platoon, Company B, 1st Shore Party Battalion while Company I was attached to the 1st Battalion, 5th Marines.

(2) Initially, 6 MCIs were carried by each individual which were adequate for a three day period. A basic allowance of ammunition and three canteens were carried by each individual. Ammunition resupply requests were processed through routine resupply missions. Water presented no problem due to the numerous streams and wells located in the operating area. In addition to individual weapons, machineguns, 60mm mortars and 81mm mortars were carried on the operation.

b. Maintenance.

(1) Cleaning equipment for crew served and individual weapons was carried by all units. Weapons were cleaned and inspected on a daily basis. No maintenance problems were encountered during the operation with weapons or equipment.

c. Treatment of Casualties and Evacuation and Hospitalization.

(1) Casualties were initially treated by five Corpsmen attached to each rifle company and three Corpsmen moving with the Command Group.

(2) Casualties were evacuated by helicopter and were transported to a Collecting and Clearing company located at the LSA at Hill 63, RVN except during some periods when the casualty overload was helilifted directly to the 1st Medical Battalion at DaNang, RVN. Casualties were then processed and further transferred to field hospitals and hospital ships located in the Chu Lai, RVN and DaNang, RVN areas.

d. Transportation.

(1) The only transportation utilized during the

operation was helicopters. Complete reliance was placed on the UH-34D helicopter for all medical evacuation. CH-46 helicopters were used on two occasions to effect the initial helilift on D-Day and the helilift which took place on the night of D+9. CH-53 helicopters were used on D+11 for the lift to the Combat Base.

e. Communications.

(1) Operating units were in close proximity to each other throughout the operation with no significant problems encountered with communications.

f. Medical Evacuation.

(1) Each Corpsman carried sufficient medical supplies to provide adequate treatment of the wounded until medical evacuation could be effected.

(2) Casualties were evacuated by helicopter. The arrival of the medical evacuation helicopters was timely whenever a reasonably secured landing zone was available.

(3) The Battalion had no heat casualties despite temperature highs of 100 degrees. Omission of upper body armor and command attention to the consumption of salt tablets were felt to be significant factors in the prevention of heat casualties.

13. Special Equipment and Techniques.

a. 4 September an aerial CS attack was delivered in conjunction with an artillery mission and air strikes. Five hundred gallon napalm tanks with CS-1 (micro-pulverized powder) were dropped in the vicinity of (BT 087336), (BT 098341) and (BT 098335) with good target coverage. This drop assisted in forcing enemy troops engaged with Company M, 3rd Battalion, 5th Marines, to withdraw.

b. In another chemical attack on 4 September, four 500 gallon napalm tanks of CS-1 were used as a preparatory fire on Hill 63 (BT 083324). Approximately 100 NVA were observed fleeing the attack. An air strike was delivered in pursuit of the fleeing enemy.

c. 6 September an aerial CS attack was conducted at (BT 103303) in support of the 1st Battalion, 5th Marines. Enemy mortar and small arms fire was significantly reduced. One E 159 Cluster and four 500 gallon napalm tanks with CS-1 micro-pulverized Powder were delivered on enemy forces. Three

E158 CS Clusters and 1 E 159 CS Cluster were dropped in support of the 1st Battalion, 5th Marines at (BT 090309) and (BT 104307). The three E 158 CS Clusters were improperly fused and malfunctioned. One E 158 Cluster was recaptured the morning of 7 September.

d. In a related chemical attack on 6 September, 6 500 gallon napalm tanks with CS-1 Micro-pulverized Powder were dropped along a line from (BT 105260) to (BT 105268). This line generally coincides with a trail which the enemy might have used as an escape route. The terrain denial drop was delivered with excellent target coverage.

e. On 9 September the 1st Battalion, 5th Marines recommended five target sites for aerial delivery of CS Persistent Agent in compliance with 5th Marines MSG DTG (091035H). 1st Battalion, 5th Marines recommended that a Psychological Operations tape be delivered with the chemical agent attacks explaining to the Vietnamese why their homelands were being contaminated and urging them to return to Government controlled areas. Chemicals were not delivered due to the non-availability of Micro-pulverized CS-1.

f. On 10 September the 1st Battalion, 5th Marines requested an aerial delivery of Micro-pulverized CS-1 on a confirmed enemy ordnance storage area at (BT 105291) and on a retreat area at (BT 121261). The chemical agents were delivered with good target coverage.

g. Intelligence received from an NVA prisoner revealed that the majority of enemy personnel did not possess gas masks, that the enemy believes that CS is toxic, and that on past occasions the prisoner's unit had retreated a distance of 1000 meters when struck by chemical agents. The prisoner also stated that he is extremely afraid of chemical munitions.

14. Commander's Analysis.

Operations during the monsoon season with its daily rain can seriously effect the mobility of infantry units. Normally insignificant streams become barriers and trafficability can be difficult, even for foot troops. Each squad should carry at least 50 feet of rope to use in river crossings and training must be conducted on river crossing techniques. Constant walking in the wet flooded areas will require added emphasis by unit leaders to insure that the individual Marine properly cares for his feet and prevents emersion foot.

Helicopter availability had a direct effect on the Battalion's operational capabilities. Resupply scheduling was satisfactory and presented few problems. However, on those two occasions that significant amounts of enemy equipment were captured, or friendly casualties and equipment required evacuation, helicopters were not readily available. The requirement, to provide security for casualties or equipment for one or two days, restricted the mobility of the Battalion and impaired its ability to react quickly to the tactical situation.

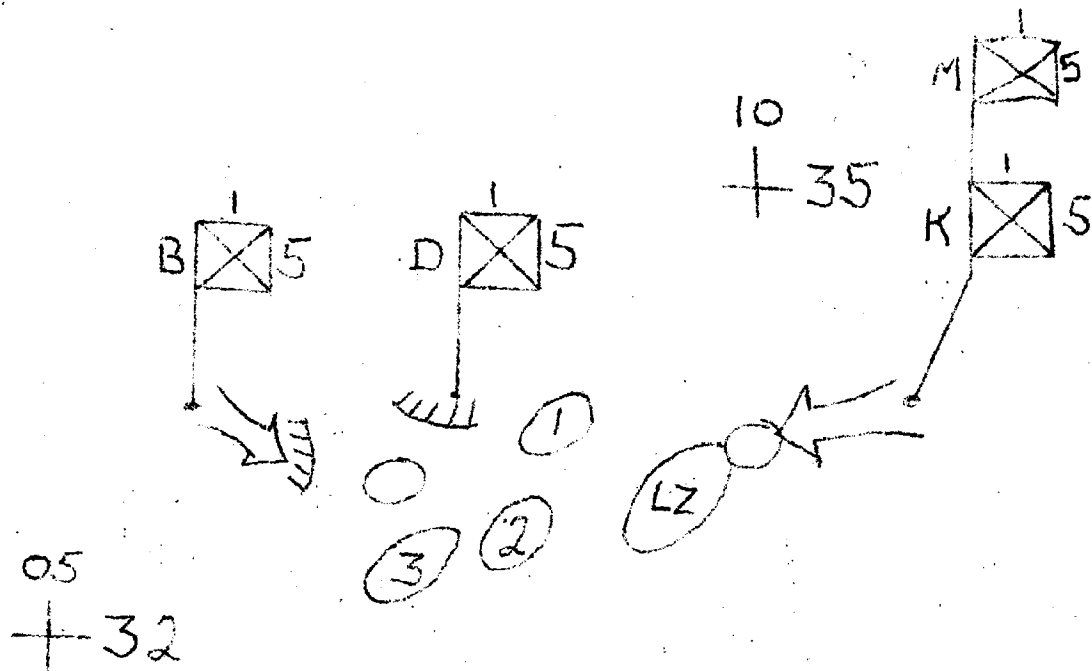
Psywar activities were planned and requested in conjunction with a proposed CS drop but non-availability of the micro-pulverized chemical agent caused the drop to be cancelled. There were a minimum of local Vietnamese encountered during Operation "SWIFT" and no refugees were evacuated. Under those circumstances the civic action program was negligible.

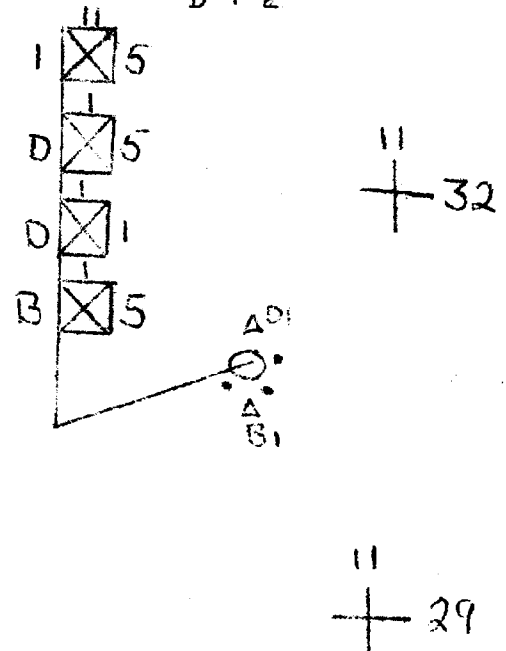
Day Movement Overlay D + 2

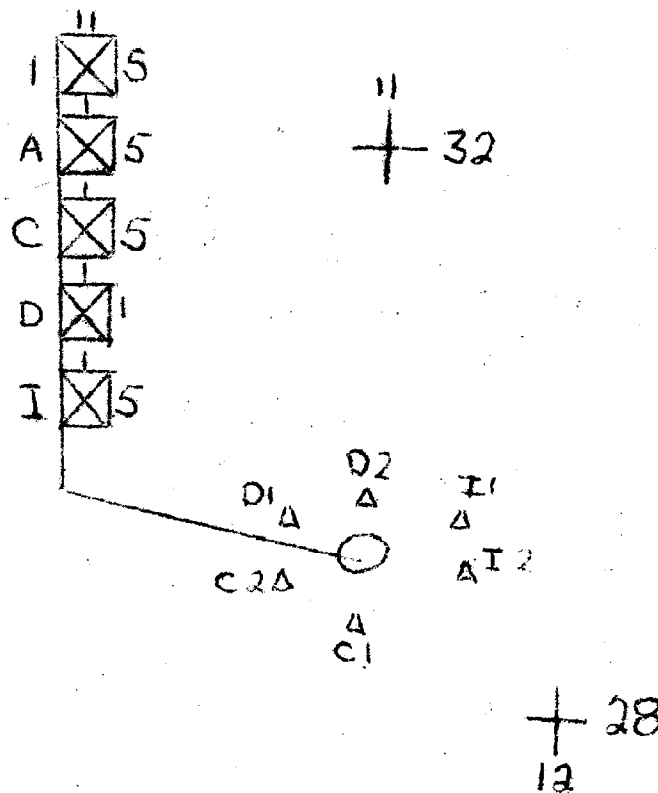

Morning Movement Overlay D + 10

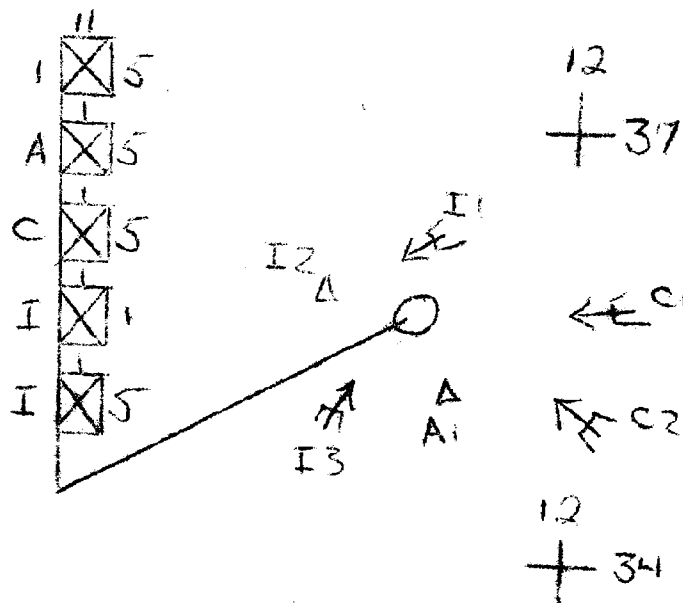



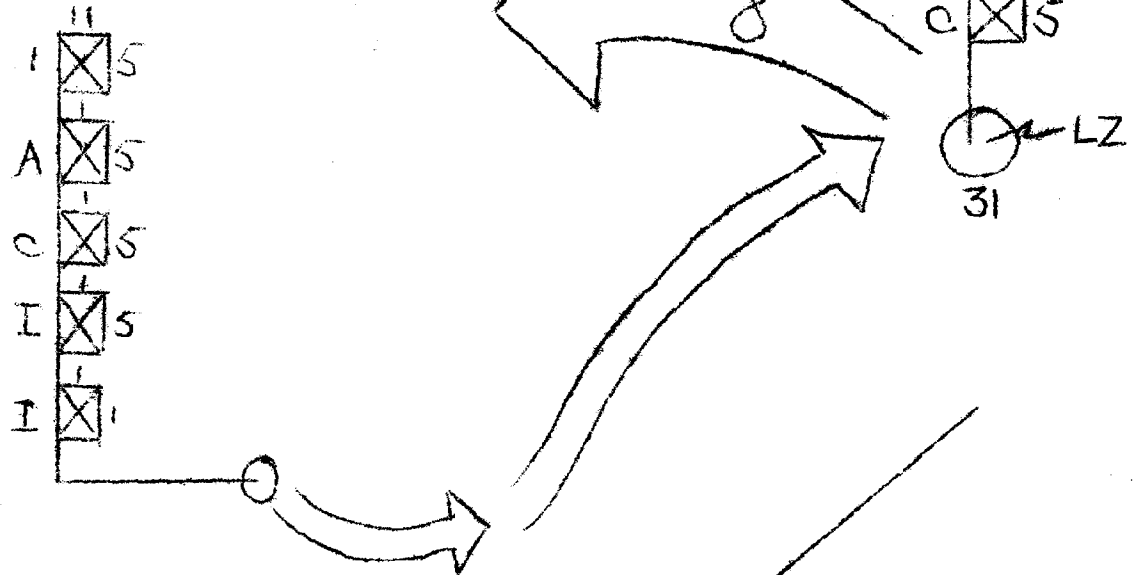

6. Supporting Forces.

a. Air. At H-Hour on D-Day Company C (-)(Rein) attacks to the west to seize and conduct detailed search of the village of Xuan Que (5), Objective 1, vicinity (AT 996334), conducts link up with Platoon blocking force, continues the attack to the west northwest to seize Objective 2 vicinity (AT 980341), and conducts detailed search of Objective 2. On order Company C (-)(Rein) continues the attack to the east to seize Objective 3, vicinity (AT 996346), conducts detailed search of Objective 3, on order establishes night defensive position and conducts night activities in the vicinity of Objective 3. On order Company C (-)(Rein) continues to sweep to the east, returning to 1st Battalion, 5th Marines Combat Base.

b. Company C (-)(Rein).

(1) At H-Hour - $\frac{1}{2}$ hour establish platoon blocking position to the west of Objective 1 vicinity (AT 990332).

(2) At H-Hour on D-Day attack to seize and search Objective 1 village vicinity (AT 996334).

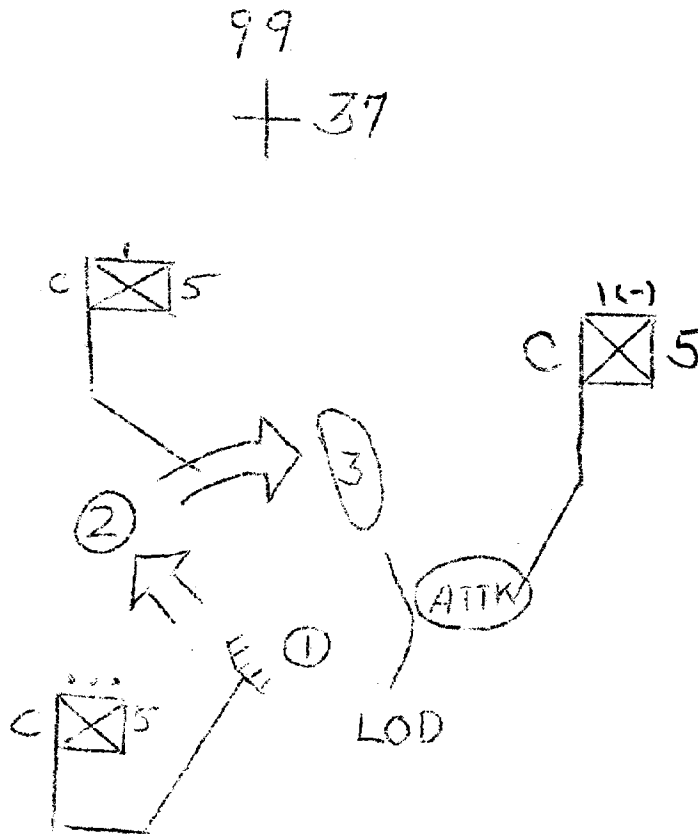

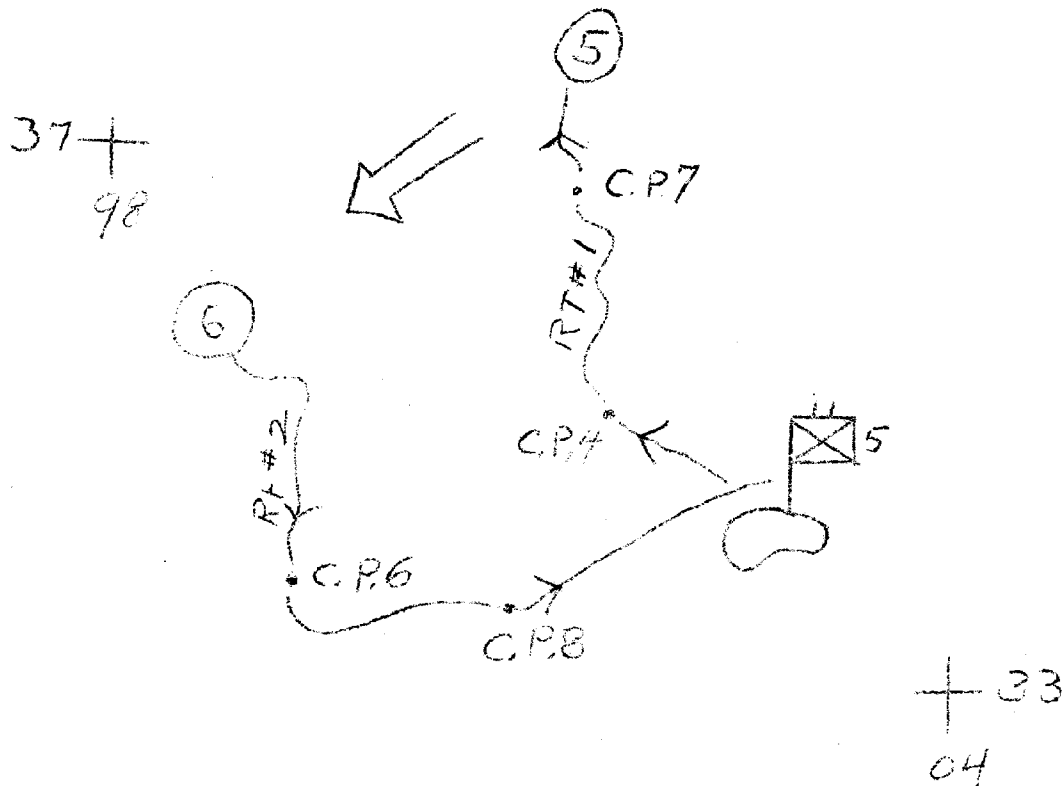
