PART II
NARRATIVE SUMMARY

1. Personnel and Administration.

a. Strengths. On board strength reached a high of 1085 Marine enlisted early in the month but declined steadily with normal rotations to 1033 on 31 October. Officer strength improved slightly with 38 Marine officers on board as of 31 October. Navy officers and enlisted strength remained constant.

b. Replacements. The flow of replacements into the battalion totaled 102 for the month, including 1 captain and 4 lieutenants. The number of joinings was higher than average, necessitated by the change in the system of computing rotation tour dates.

c. Discipline, Law and Order. During the month of October four Special Courts Martial and one Summary Court Martial were held. Six Special Courts Martial were pending as of 31 October. The principal offense was unauthorized absence. Most of the offenses had occurred prior to the battalion's displacement to Triem Trung (2).

d. POW/Detainees. During the month of October, 2 MPs were attached to manage the Battalion's POW compound. This has proved invaluable with the large number of detainees (38) processed during the month.

e. Morale and Personnel Services. The morale of the Battalion, which has been consistently high, improved to excellent during the month. Factors which contribute to the improved morale are improved postal services, daily availability of PX and club facilities, and daily piaster sales which enable troops to patronize the camp barber shop, laundry and gift shop.

f. Interior Management. The Battalion headquarters commenced displacement of its administrative echelons on 2 October. This was completed and all elements well established in their new office spaces on 5 October.

2. Enemy, Weather and Terrain.

a. Enemy. Enemy activity during the month was restricted mainly to sniping by individuals or small units and placing of mines and booby traps throughout the TAOR, especially in the northern area. However, an estimated local force of one to two platoons did probe the perimeter of CAP D-5 on three occasions and contact was made by a platoon of Company B on

28 October with an estimated platoon of Viet Cong in the vicinity of BT 127607. Reports of the Q-15 Company in the northern, the Q-12 Company in the eastern and southeastern and a company of the T-85 Battalion in the northwestern portions of the TAOR were received. Although no positive contact with or identification of these units was made, activity and sightings within these areas partially support the presence of such units. Additionally, elements of the 70th Independent Battalion and the V-25 Battalion were reported to be operating in and to the south of the island complex in the southeastern area of the TAOR. Again, no positive contact or identification was made; but sightings of military structures, fighting positions, and enemy river traffic by airborne observers indicate the presence of enemy units in these areas.

Weather. The weather during the reporting period was warm and humid with an average high and low of 85 degrees and 73 degrees respectively. There were frequent afternoon and evening showers in the first half of the month and occasional showers in the latter half. One heavy rainstorm of approximately two days duration, 9-10 October, caused serious flooding in the western and southern portions of the TAOR. Though operations were only slightly affected, administrative and resupply traffic was halted completely for a period of two days due to a bridge being washed out at coordinates (BT100583) and route 538 being flooded from coordinates (BT090504) to (BT120572). The ability of the Battalion to react to contingencies at the province or District Headquarters, or combined action platoon positions would have been seriously hampered had the need arisen.

c. Terrain. The TAOR covers a flat coastal plain varying from two to ten meters in elevation. Rivers and other waterways surrounding and within the TAOR afford excellent lines of communications for the enemy. Highway #1 and route 538 are extremely vital as the only means by which wheeled vehicular traffic can move within the TAOR. Route #1 is an all weather bituminous road in fair to good repair. Route 538 is a limited all weather intermediate bituminous road in fair condition. Short term flooding can be expected along these roads during the rainy season.

Large rice paddies predominate in the western, eastern, and southern sectors of the TAOR and can be expected to be flooded during the monsoon. Troop movement through these areas will be difficult, but possible in most cases. The large open sandy area running northwest through the central portion of the TAOR affords good drainage and should retain good foot and tracked vehicle trafficability even during the rainy season. The island complex in the southeast is predominately paddy area with moderate undergrowth. This

area presents very difficult movement during the monsoons. The northern portion of the TAOR is primarily a sandy area spotted with light to moderate treelines and paddies. This area is an excellent area of operation for snipers, a fact substantiated by the large concentration of sniper incidents occurring in this locale during the month.

3. Organization and Operations.

a. Organization.

(1) Early in the month of October, 1st Battalion, 5th Marines was relieved of responsibility for Hill 51 and the Que Son Valley TAOR by 2nd Battalion, 12th Cavalry Regiment, 1st Air Cavalry Division. Turnover commenced on 2 October. OPCON passed at 021730 October; however, completion of the equipment Heli-lift and forward displacement of the rear echelon was not accomplished until 12 October due to restrictive weather conditions.

(2) AT the same time as the above change, 1st Battalion, 5th Marines relieved 1st Battalion, 1st Marines of responsibility for the Triem Trung (2) combat base, coordinates (BT104583), and the TAOR around Hoi An, covering the Hieu Nhon District and a portion of the Dien Ban District (See Part IV, Tab A). This relief commenced on 2 October with the arrival of the 1st Battalion, 5th Marines Command Group, with companies A and B, who were immediately deployed to outlying company and platoon combat bases. Responsibility for the TAOR passed to 1/5 on 4 October.

(3) On 15 October, 1/5 commenced consolidating elements at the company combat bases, A and B, in order to reduce base security commitments, thus freeing allied forces for patrol activities, and enhancing reaction capabilities (See Part IV, Tab B). Consolidation was completed on 21 October.

(4) Significant changes in supporting units, resulting from the redeployment from Que Son to Triem Trung (2), were the loss of 3rd Platoon, Company A, 1st Anti Tank Battalion, the addition of 3rd Platoon, Company B, 3rd Amtrac Battalion, and the loss of 1st Platoon, Company B, 1st SP Battalion.

b. Operations.

(1) During the month of October, 1/5 executed three battalion operations.

(a) On 1 and 2 October 1/5 (-) conducted a

foot/mechanized tactical march from Hill 51, Que Son, to Hill 63 in order to provide security for tracked vehicles displacing from Hill 51. There was no significant enemy contact during the march, however 65 refugees attached themselves to the column at Cong Dong (BT 045347) in order to take advantage of the column's security. The tracked vehicles bogged down repeatedly due to the primitive road and wet paddies throughout the area.

(b) On 15-17 October, 1st Battalion, 5th Marines (-) (Rein) conducted Operation ONSLOW (See Part IV, Tab C). Despite a lack of enemy contact, the operation was a valuable experience in that it provided an opportunity to become acquainted with the operating area, to appreciate the difficulties of maneuvering through flooded rice paddies, and to effect coordination with adjacent ARVN units.

(c) On 31 October, 1st Battalion, 5th Marines (-) (Rein), conducted an unnamed, coordinated Battalion Search and Destroy Operation which included positioning company blocking forces by coordinated foot and mechanized marches along two separate axes, followed by the rapid insertion of a two-company search force by helicopter and an aggressive, thorough sweep towards the blocking forces. One company remained in the AO conducting detailed "hole hunting" operations. Results developed on 1 and 2 November and will be reported on next months report.

(2) The Battalion conducted numerous company and smaller unit activities on a daily basis throughout the month. By operating from dispersed combat bases, extensive area coverage was achieved.

(a) Day activity totals for the month included 46 Fire Team Activities, 154 Squad Activities, 29 Platoon Activities and 5 Company Operations. Night activities included 284 Fire Team Activities, 452 Squad Activities and 3 Platoon Ambushes. The small unit activities of the Battalion supported Operations "Baxter" and "Tattoo," provided screening and security to the Battalion's combat bases, as well as provided companies opportunities for independent operations.

(b) The Battalion attached one squad to CAP (4) from 2 October through 31 October to provide assistance of an instructional and security nature. One platoon was detailed to provide security on the Cau Lau Bridge from 3 October to 15 October when relieved by Popular Force units. Thereafter, a squad was detailed on a daily basis for daylight security and to assist the engineer team sweeping Route 1 south of the Song Cau Lau for mines. The Battalion provided

one Platoon to Headquarters Company, 5th Marines to augment the Regimental Command Post security from 5-21 October. Rough Rider platoons were committed from 18-22 October and from 26-30 October. In addition, one Platoon provided convoy security for the displacement of elements of L Battery, 4th Battalion, 11th Marines on 22 October. The Battalion provided companies to 2nd Battalion, 1st Marines from 30 September - 5 October, and to 3rd Battalion, 5th Marines from 18-21 October and 25-28 October. The Battalion also supplied the "Bald Eagle" reaction forces from 6-15 October.

c. Supporting Arms.

(1) Air. During the month this battalion used the TAC(A)/AO team to the maximum with excellent results. Using them with the companies in the field, they proved indispensable by providing excellent aerial observation of the enemy ahead of advancing patrols. They also controlled 20 flights of fixed wing aircraft and many artillery missions in support of the 1st Battalion, 5th Marines. UH1E gunships were used for a number of missions, as escorts for the convoy from Hill 51 to Hill 63, and as escorts for 37 medevacs during which they were called upon to deliver ordnance to suppress hostile enemy fire.

(2) Artillery. During October, Battery D, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines. Over 257 fire missions were fired, including nightly H&I fires on suspected areas of enemy activity, fires in support of Combined Action Platoons within the battalion's TAOR, fires in reaction to intelligence reports, and fires requested by air observers on targets of opportunity. In addition, Battery D, 2nd Battalion, 11th Marines registered the battery, 30 October, on grid (BT 021555) facilitating more accurate surprise fire in the future.

4. Training.

a. Training was conducted on Battalion and Company level with continuing emphasis on care and cleaning of the M16 rifle, familiarization firing, weapon safety, patrolling, fire discipline and commands, fire distribution, indoctrination of new personnel, mapreading and small unit tactics.

b. Special emphasis was placed on land mine warfare and a description of enemy mining/booby trapping techniques due to the characteristics of the new TAOR.

c. The Battalion continued to utilize schools provided by higher headquarters. During the month of October 1967, 24 Marines attended schools in DaNang, RVN and on Okinawa.

d. The Battalion Medical Platoon initiated a training program for Corpsemen, consisting of two - 2 hour classes per week.

5. Logistics.

a. Supply. During the month of October, supply facilities at Triem Trung (2) were improved and consolidated. A hot locker was installed in the armory for weapons storage, and the supply facility in the 11th Motors area was closed except for a small amount of semi-permanent storage of low usage items.

b. Medical/Dental.

(1) Preparations were made and supplies were received to conduct a field test of the new foot protective ointment. The program is to commence on 1 November.

(2) Improvements in base sanitation facilities continued throughout the month. A contact team from the Preventative Medicine Section, 1st Medical Battalion conducted a sanitation inspection, rating the base outstanding.

(3) A detachment from 1st Dental Company, FMF provided dental support to the Battalion throughout the month.

c. Transportation.

(1) A special allowance of eight boats with oars was received on 12 October.

(2) Highway 1 and 538 were closed by flooding and road and bridge washouts on 10 October. Repairs were completed and the roads opened to all traffic on 12 October.

d. Services.

(1) An FMFPAC Generator Contact Team visited on 17 October for the purpose of instructing and assisting the battalion's generator operators in operation and maintenance.

(2) Division Food Services Assistance Team inspected the battalion's mess facilities on 18 October.

(3) A contact team from MLC repaired the refrigerators at the battalion mess on 28 October.

(4) A new motor transport maintenance shed was completed on 30 October in preparation for the coming monsoons.

(5) Engineers constructed 9 reinforced, covered defensive bunkers on the perimeter of the Battalion's combat base.

6. Civil Affairs.

a. MED CAP. During the month of October 821 Vietnamese civilians, mostly children, were treated at MED CAP at Triem Trung (2) (BT 102582). A shower unit was installed and arrangements made to provide water on a daily basis. Provisions were also made to obtain much needed soap.

b. Scholarships. A presentation of "General Walt Scholarships" was made to needy students from the area in a ceremony at Cam Ha school (BT 133578) on 27 October.

c. Other Assistance. 200 cannisters from expended 81mm mortar rounds were donated to the Quang Nam province chief for use as rat traps. In addition, lumber was obtained and work begun on building 12 cribs for the Catholic Orphanage in Hoi An. The first crib was delivered on 30 October; remainder are to be completed and delivered in November.

7. Psychological Operations.

a. A Psy Ops team accompanied the battalion on Operation ONSLOW, broadcasting 10.5 hours during the operation.

b. A Psy Ops team showed cartoons and movies of an educational and informative nature to audiences in Hoi An and Cam Ha. Attendance at the two showings exceeded a total of 3000 Vietnamese.

8. Comptrollers Activities.

a. The battalion began the month with a balance of \$103,945, and closed the month with \$57,016. Funds were obligated for batteries, embarkation equipment, rifle cleaning materials and magazines, POL, and monsoon preparations. The major obligation during the period, \$32,200, was to replace unserviceable individual equipment and clothing.

9. Communications.

a. Construction was begun on a 25 pair cable line to link the combat base at Triem Trung (2) with the 100 pair cable on Highway 1. Completion of this installation will provide

more reliable telephone communications with regiment and higher echelons as well as the Combined Action Company and District Headquarters at Dien Ban. Construction was also begun on a 5 pair cable line to link the battalion with the Sector Advisor's Headquarters in Hoi An.

b. A courtesy inspection was held by representatives of the Division CEO on 27 October. Corrective action on noted discrepancies commenced immediately.

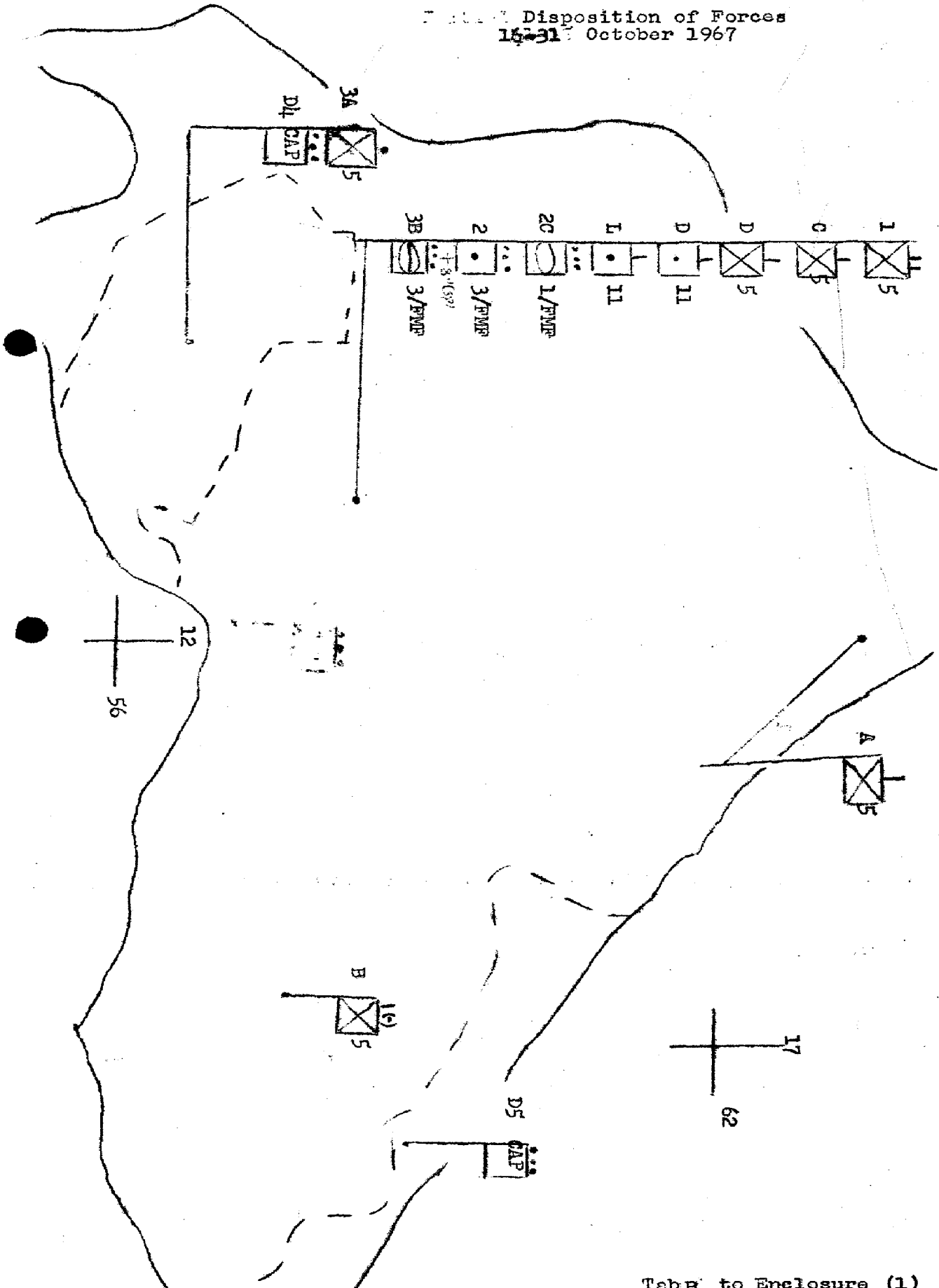

1. In accordance with references (a) and (b) enclosure (1) is forwarded herewith.

2. Operation ONGLO was a search and destroy operation in the southern portion of the DIEN BAN District of QUANG NAM Province to disrupt enemy anti-election activities and capture or destroy enemy forces, supplies and facilities. Contact was very light during the operation.

3. There is no evidence on record to substantiate the assumption that is contained in paragraph 12e(2) of enclosure (1). There is no record of any Cold Weather Batteries for FHC-25 being issued to the 1st Marine Division. Standard type radio batteries are rotated through FLC cold storage facilities to extend the shelf life of the items.

4. The problems associated with aerial broadcasts as stated in paragraph 13(5) enclosure (1) has been a recurring problem.

a. The 14th Air Commanding Operating Instructions of 11 July 1967 state that the normal altitude of planes while broadcasting is 3000 feet. However, if the aircraft briefer tells the pilot he is going into a "High Threat Area", or the pilot expects "Intense Ground Fire" he may use 4000 feet as a minimum altitude.

b. The broadcasts for Operation ONSLAW were requested between 0800-1400 on 16, 17 and 18 October. The broadcasts were made but records do not reveal the specific times of each run.

5. The aerial leaflet drops referred to in paragraph 13(6) were cancelled due to weather. A follow-up procedure has been initiated to provide notification to units when their requests have been denied, cancelled or postponed.

6. Supporting Forces

a. Air

During Operation ONSLOW the Battalion Air Liaison Officer moved with the Battalion CP. Each company had Close Air Support capability via TAC (A). The air support listed below was provided:

12. Administrative Matters.a. Supply.

(1) Due to the limited duration of the operation, provisions were made to carry all necessary resupply items in

The LVP's. When these vehicles were unable to traverse the terrain coming out of the Song Cau Lau River provisions were made to transfer priority items to the Otters. This proved to be practical and most expedient. Due to the early termination of the operation, the Otter was not given a true test of its logistical capabilities. One helicopter mission consisting of one aircraft for an emergency resupply of batteries for PRG-25's was required on D+1.

(2) Initially 6 MCI's were carried by each individual. This made necessary the requirement for issue of only one meal per person on D+2. A basic allowance of ammunition and three canteens of water were carried by each individual. No ammunition resupply was required. Water presented no difficulty although sources were reeled by recent storms. In addition to individual weapons, Machine guns, 60mm mortars and 81mm mortars were carried on the operation as well as E-2 launchers (CS).

b. Maintenance.

(1) Cleaning equipment for crew served and individual weapons was carried by all units. Weapons were cleaned and inspected on a daily basis. No maintenance problems were encountered during the operation with weapons or operation.

c. Casualties.

(1) Casualties were restricted to one anti-vehicular mine incident. These casualties were immediately evacuated to the first Medical Battalion, DaNang, RVN by helicopter.

(2) Despite continual prolonged exposure to terrain where keeping ones feet dry was an impossibility, the Battalion suffered no casualties of immersion foot category. This is attributed to attention at all levels of command in ensuring that individuals give proper attention to care of their feet.

d. Transportation.

(1) The only transportation utilized during the operation was the 45 trucks used to transport the Battalion to a position on Route #1 just north of the bridge over the Song Cau Lau where the Battalion was forced to disembark due to impassable road conditions. Twenty seven trucks again transported the Battalion from this point to the Combat Base when the operation was secured.

e. Communications.

(1) VHF communications in the field: Communications with all units by use of PRG-25 is considered to have been marginal. The RC-292 antenna was erected on the second night with some improvement in reception and transmission.

(2) Cold Weather Batteries for PRG-25: This Battalion has been receiving cold storage batteries for PRG-25 (BA-386) for some time. On resupply in the field, six cases (72 batteries) were de-

livered. It is a common assumption that these batteries will not function properly for periods normally expected of PRG-25 batteries. No substantial evidence of this was developed. Longevity tests are to be conducted on the cold storage batteries to determine feasibility of their use.

(3) Covered Voice Circuit in the Field: Regimental Frog Order 1-67 (Operation ONSLOW) directed this battalion to be prepared to operate a covered voice circuit utilizing the KY-8 cryptographic device. Since this device must have a source of supply, Plans were made to install the device in an LVTG, but wiring difficulties in the vehicle precluded this. Use of a wheeled vehicle (HSC-109) was out of the question due to the terrain.

13. PSYCHOLOGICAL OPERATIONS

(1) Ground broadcasts were made by a Psyops team from the 1st Battalion, 5th Marines on the following subjects: (1) General Chieu Hoi Information, (2) Don't Harbor VC, (3) Assist Marines by Pointing Out Booby Traps and Mines, (4) Tracked Vehicles Would Not Have To Drive Over the Rice Paddies if The People would Report VC Activities, (5) Vote for a Better Vietnam, and (6) Marines Are Here to Help The People of South Vietnam So Don't Run From the Marines.

(2) The ground broadcasts were made in the following areas: (BT 095140) and (BT 539560).

(3) Total broadcast time was approximately 10½ hours.

(4) At (BT 133525), 161130H a Vietnamese man from the operational area came to the Battalion CP and told Psyops Personnel that he had heard the broadcasts about Don't Run From Marines. He said the reason that the people in the area ran was because the VC had told them that the Marines would bring harm to them. Thereafter the people seemed more receptive to the Marines.

(5) Aerial broadcasts were made in the operational area but they were ineffective because of the aircrafts high altitude. In addition the broadcasts were not at the scheduled times.

(6) An aerial leaflet drop was scheduled in the operational area but was not made for reasons unknown.

14. Special Equipment and Techniques.

a. LVT's were programmed for use in the Song Ba Ron River as flank security and to deny enemy egress from the AO to the south and to provide logistical support where required. The inability of these vehicles to traverse beyond the Song Cau Lau due to recent flooding conditions and resultant soft sand/mud bars notably affected the battalions ability to interdict the enemy's principle course of egress south across the Song Ba Ron.

The Otters attached for this operation proved themselves capable of traversing terrain considered untraversable by both Tanks and Forces. Had the Ambush not been held up in the Song Cau Lam area, they undoubtedly would have proven valuable for resupply and junk destruction purposes, had the operation not been terminated or had the battalion made substantial contact. The Otters, despite excellent wet land capabilities, was unable to traverse dense bamboo and tree groves which comprise the periphery of the area and operations.

15. Commanders Comments:

a. The operating area for ONSLOW was almost completely inundated. Though this presented some difficulty in movement, it did not seriously restrict the battalion's maneuver ability.

b. The leading company demonstrated an entirely satisfactory capability to maintain contact and alignment on a broad front despite heavy growth and extended formation.

c. Immediate return of small arms fire in an enemy encounter was excellent. Prompt dispatch of a maneuver element and effective use of supporting arms need training and practice. This will be accomplished.

d. The LVT's in support of the operation could not negotiate the initial obstacles. They were stranded on a sand bar during the entire operation and there was no opportunity to evaluate their usefulness.

e. The M-76 marginal terrain vehicles (Otters) performed well and displayed an ability to travel in this type of terrain and wet weather. Though movement was restricted by heavy vegetation in boundary areas, it appears that the Otter will be extremely useful during the Monsoon season.

f. Communications frequently continue to be disrupted in heavy vegetation. The use of 292 antennas and relay stations should alleviate this problem. Certain problems might have been caused by the cold weather batteries, but this could not be substantiated.

g. There were no cases of immersion foot; however, this was a short operation and it is apparent that command attention to fundamentals of foot care will be essential.

h. There were no cases of malfunctioning of M16 rifles. This can be attributed to the program of pre-operation jam firing and inspections and the daily cleaning period scheduled in the field. Additionally, there was very little contact, thus offering little opportunity for malfunctions.

1. SITUATION.

A. Enemy Forces.

(1) Enemy forces currently believed to be located in the vicinity of the Onslow AO are listed below:

(a) V-25Bn: Strength 350; Weapons B40 rockets, 81mm mortars, 60mm mortars, 57mm RR. LF. Onslow AO General OP Area.

(c) 70th Independent Battalions: Strength 425; Weapons: 3-81mm mortars, 4-60mm mortars, 4-57mm RR, 5-MG, MF. Located (BT 162538), (BT 1705), (BT 149556).

(d) Hamlet Guerrilla Strength: 60-80, weapons unknown.

(2) Enemy located immediately south of Onslow AO listed below:

(a) VMI VGBa: Strength 400; Weapons: Mortars, MG's, B-40 rockets, individual weapons. Located vicinity (BT 133500), (BT 137505), and (BT 148500).

B. Friendly.

(1) 1st Battalion, 51st ARVN Regiment conducts search and destroy operations on the island complex northeast of the AO and establishes blocking positions (See Annex A: Operation Overlay) to deny enemy forces access from the AO to the northwest.

2. MISSION: Commencing H-Hour on D-Day, 1st Battalion, 5th Marines (-)(Rein) conducts search and destroy operation within AO bounded on west by Route #1 on north and east by Son Cau Lau and on the south by the Song Ba Ren to disrupt VC anti-election activities and capture or destroy enemy forces, supplies and facilities. (See Annex A: Operation Overlay).

3. EXECUTION.

A. Concept: At H-Hour on D-Day 1st Battalion, 5th Marines (-)(Rein) commences motor march to vicinity south of road junction Route #1 and Route #537 and north of junction Route #1 and Song Ba Ren River, dismounts, and with two companies abreast conducts a sweep in zone to secure Regimental Objective A and Battalion Objective 1; upon securing Objectives conducts detailed search and destroy operations for a duration of about 72 hours to the confluence of the Song Cau Lau and Song Ba Ren then north to vicinity of Thang Tay (2), then northwest to the vicinity Long Chau (2).

B. Company C.

(1) At H-Hour on D-Day depart Combat Base aboard trucks, proceed to debarkation point and be ready to immediately cross the LOD and attack in zone of action to secure Battalion Objective 1. Conduct further detailed search and destroy operations on the objective.

(2) Provide one squad to assist 1st Platoon, Company B, 1st Amtrack Battalion with right flank security.

(3) Be prepared to continue attack on order conducting detailed search and destroy operations.

(4) Be prepared to assume other missions on order.

C. Company D.

(1) At H-Hour on D-Day depart Combat Base aboard trucks, proceed to debark point, dismount and be ready to immediately cross the LOD and attack in zone of action to secure Regimental Objective A. Conduct further detailed search and destroy operations on the objective.

(2) Be prepared to continue the attack on order conducting detailed search and destroy operations in zone of action.

(3) Be prepared to assume other missions on order.

D. Company L, 2ndBn, 5thMar.

(1) At H-Hour on D-Day depart Combat Base as part of motor march, proceed to company debark point vicinity (BT 093544) to (BT 093548), dismount, conduct immediate detailed search and destroy of that portion Long Chau (1) east of Route #1, set in a blocking position generally along a line from (BT 092542) to (BT 097550).

(2) Be prepared to assume other missions on order.

E. H&S Company.

(1) General Support.

(2) At H-Hour on D-Day depart Combat Base aboard trucks, proceed to debarkation point, and be ready to follow in general trace of attacking companies on order.

(3) Be prepared to assume other missions on order.

F. 3rd Platoon, Company B, 1st AmtrackBn.

(1) At H-Hour-30 minutes depart Combat Base proceed to arrive at junction of Route #1 and Song Ba Ren River at same

(4) Be prepared to support attacking companies by fire on order.

(5) Be prepared to destroy enemy sampans fleeing the AO or attempting to ferry VC from the AO.

(6) Be prepared to assume other missions on order.

G. Platoon MTV Company.

(1) General Support.

(2) At H-Hour+10 minutes join Motor March column at junction of Route #1 and Route #538 proceed to troop debarkation point. On order cross LOD in general trace of H&S Company.

(3) Be prepared to provide resupply support on order.

(4) Be prepared to assume other missions on order.

H. Company F, 2ndBn, 5thMar.

(1) Battalion Reserve.

(2) At H-Hour on D-Day, depart Combat Base and proceed as portion of motor march column to debark point, cross LOD on order, follow in general trace of Battalion Command Element and MTV Company.

(3) Provide flank security for Battalion Command Group.

(4) Provide rear security.

(5) Be prepared to assume missions of either attacking company on order.

(6) Be prepared to assume other missions on order.

1. SITUATION. See current LSUMS and PERINTRAPS.
2. MISSION: Commencing at H-Hour, D-Day, 1st Battalion, 5th Marines will conduct Search and Destroy operation within AO 2 emphasizing three step principle of first quickly isolating area and enemy within; secondly segregate and remove enemy infrastructure and finally conduct intensive detailed "Hole Hunting" operation to uncover enemy cache sites and logistical installations. (See operation overlay).
3. EXECUTION.

A. Concept: At H-Hour on D-Day 1st Battalion, 5th Marines commences a multi-directional closely coordinated movement utilizing mechanized and helicopter troop transportation means to quickly and simultaneously seal off area of Operation 2 (See operation overlay). Upon securing blocking positions at Objectives 1 and 2, conducts a rapid two company sweep of area of Operation followed by a detailed company search and destroy, "Hole Hunting" operation of undetermined duration.

B. Company C.

(1) At H-hour on D-Day depart combat base aboard tracked vehicles, conduct rapid sweep along an axis of advance to north, on order wheel to the right and continue mounted sweep to secure Battalion Objective 1. Establish blocking positions thereat and deny enemy egress from AO 2 through your position.
