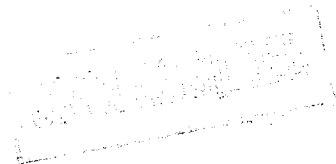

PART IINARRATIVE SUMMARY1. PERSONNEL AND ADMINISTRATION

a. Strength. Total strength at the beginning of the month was 36 Marine Officers and 1090 Marine Enlisted. By 15 April the strength had changed to 38 officers and 1085 enlisted. By the end of the month the Battalion's strength was 38 officers and 1095 enlisted. At this time there were 0 officers and 62 enlisted hospitalized. Joinings during the month were four officers and 147 enlisted.

b. Discipline, Law and Legal. There were eight Special Courts Martial and five Summary Courts Martial convened during April. This left five Specials and one Summary to be processed. Five investigations were completed, leaving three investigations pending.

c. POW/Detainees. Eleven detainees were processed during April. There were no POW's.

d. Morale. The morale of the officers and men of the Battalion has continued to be notably high. The R&R program is running smoothly and each officer and man benefits from this service.

e. Postal. Postal service has continued at an all time high. Mail is received twice daily and is quickly distributed to each company. Delivery of mail to the field has ceased to be an obstacle. The addition of another postal clerk has alleviated the heavy work load due to the large amount of incoming mail.

f. Awards. There were no awards presented to personnel of this Battalion during April, however, one Bronze Star, one Vietnamese Gallantry Cross, one Certificate of Commendation and five Purple Hearts were forwarded to former members of this Battalion. Numerous recommendations were submitted during the month for meritorious service.

g. Interior Management. The newly initiated casualty reporting procedures, order writing, and normal flow of administrative procedures continued to improve the proficiency of the Battalion's administration. The Battalion was given an administrative inspection by Task Force X-Ray and passed satisfactory with minor discrepancies.

2. ENEMY, WEATHER AND TERRAIN. During this period 1st Battalion, 5th Marines was committed to Operation "HOUSTON" and "BAXTER GARDEN". This portion of the Command Chronology is included in the After Action Reports attached hereto as Tab "A" and "B" respectively.

3. ORGANIZATION AND OPERATIONS.

a. Organization. The organization of the battalion remained substantially the same throughout the month of April. The Battalion continued in Operation "HOUSTON" throughout the month. From 211400H through 251700H the Battalion (-) (Rein) with Company M, 3rd Battalion, 5th Marines OPCON participated in Operation "BAXTER GARDEN". The following units were OPCON to the Battalion during the month:

- (1) Det, Scout Dog Team, 3rd MP Bn
- (2) Det, Scout Sniper Plat, Hq Co, 5th Mar
- (3) Det, 1st Plat., Co. B, 1st SF Bn
- (4) Det, Co. B, 1st Engr Bn

Company B, 1st Battalion, 5th Marines was OPCON to 2nd Battalion, 5th Marines 181000H to 211000H April 1968.

Company M, 3rd Battalion, 5th Marines was OPCON to 1st Battalion, 5th Marines 211200H through 302400H.

Company B, 1st Battalion, 5th Marines was OPCON to 5th Marines, assuming Bald Eagle responsibilities from 252200H to 291015H April 1968.

Company A, 1st Battalion, 5th Marines was OPCON to 5th Marines, assuming Bald Eagle responsibilities from 291030H through 302400H April 1968.

b. Operations.

(1) The Battalion continued to participate in Operation "HOUSTON" Phase I from 1 April 1968, which continued throughout the month terminating on 302400H April 1968. Phase II Operation "HOUSTON" commenced at 010001H May 1968.

(2) The Battalion participated in Operation "BAXTER GARDEN" from 21 April 1968 to 25 April 1968.

(3) The Battalion conducted numerous small unit operations during both named operations. The following activities were conducted:

(a) Day activities for the month totaled 50 fire team activities, 170 squad activities, 50 platoon activities and 17 company operations.

(b) Night activities totalled 344 fire team activities, 124 squad activities, 28 platoon activities, and 0 company operations.

c. Supporting arms.

(1) Air. During this period 40 missions were flown by Marine FAC/AO Teams for 1st Battalion, 5th Marines, controlling 12 flights of fixed wing and providing valuable aerial observation in support of the Battalion's missions of patrolling, road security, special operations and waterway denial. Other missions completed included 7 visual reconnaissance missions, 14 medevacs, and 20 flareships.

(2) Artillery. In the month of April, Battery "D", 2nd Battalion, 11th Marines was in direct support for 1st Battalion, 5th Marines. With few exceptions, most missions were fired during the hours of darkness by ground observers. Numerous TOT missions were fired by Battery "D" in conjunction with reinforcing fires from Phu Bai. During this period, numerous on-call fires were registered for prominent bridges and CAP units along Highway #1.

4. TRAINING.

a. The Battalion participated in Operation "HOUSTON" (1-30 April 1968) and in Operation "BAXTER GARDEN" (21-25 April 1968). The following training was conducted:

- (1) Weapons Safety
- (2) Ambushes
- (3) Patrolling
- (4) Fire team and squad tactics
- (5) Gun drill: 81mm; 60mm; 106mm's and M-60 Machine Gun
- (6) Small unit leadership
- (7) Mapping and compass
- (8) NBC training
- (9) Fire control, discipline and distribution
- (10) ~~Team~~ Firing cal. .45 pistol, M16 rifle, M-60 Machine gun and M-79 Grenade Launcher.
- (11) Weapons inspection

b. Replacement personnel received five (5) days training at 5th Marines Headquarters prior to being committed to the field.

c. The Battalion continued to utilize schools provided by higher headquarters. During the month, 46 members of the Battalion attended schools in Danang and Okinawa.

5. LOGISTICS.

a. Supply

During the past month, several logistical problems arose and were solved: The first was a water problem, created by the fact that the water in the surrounding rivers is considered non-potable. This problem was eliminated by the placement of lister bags at key locations throughout the Battalion AO. Lister bags are replenished twice daily and provide sufficient drinking water to the troops in the field. Another problem was the storage of ammunition in the Phu Bai Vital Area. Because no ammunition could be stored in the billeting areas, an ammunition bunker was built, allowing rapid distribution of ammunition.

Company resupply along Highway #1 was accomplished by the use of two 6 by 6 trucks which made daily runs. Classes I, III and V were furnished to the Companies. The resupply of Hill #230 was accomplished by helicopter every third day. Liaison was made with the Army and their resupply truck was used to resupply Hill #180 daily.

A rotation schedule was established to provide units in the field hot meals on alternate days and clean clothes weekly.

A monthly allocation of selected munitions had been issued to the units in the field.

6. CIVIL AFFAIRS.

a. During this period, a total of 270 people were treated at MedCap. The continuing movements of this battalion did not permit a permanent MedCap site. The MedCaps that were held were at different positions. Now that the battalion will be at its present location for a period of time, a daily MedCap site will be found at Vinh Vy hamlet, Loc Son Village. Soap was distributed at the MedCaps and some was turned over to CAP 3. The MedCap is not essential to the people of the battalions TAOB, since there are numerous CAP units in the area. However, the MedCap should be used as a sign of friend-

ship between the Battalion and the Vietnamese people of the area.

b. Volley balls and nets along with candy was given to CAP 3 for the use of the children at the village school. At the present time the S-5 is trying to procure some school kits for distribution to the children of the area.

c. General Walt Scholarships Applications have been given to the Village Chief of Loc Son Village. Project Submittal Forms will be given to the Village Chiefs of Loc Son and Loc Bon villages.

d. Solatium payments were made to a Vietnamese in Thuy Tan Village, whose house was destroyed by probable illumination; to two children who were burned by white phosphorus in Thuy Phu Village; and, to the wife of the man killed in Thuy Phu Village. Small claims forms were filled out by the Vietnamese woman in Loc Dien Village whose trees were destroyed when Company A was clearing fields of fire.

e. Personal Response handbooks were distributed to the companies along with a battalion memo on USMC/Vietnamese civilian relationships.

7. PSYCHOLOGICAL OPERATIONS. The Audio Visual Team broadcasted in Thuy Phu Village. Psyops leaflets were given to the S-2, concerning the Chieu Hoi program and rewards for weapons. Also, the Vietnamese Armed Propaganda Team was used in Thuy Phu Village.

8. COMPTROLLER'S ACTIVITIES. Total money spent for the month was \$60,291.84 which leaves a balance of \$55,080.38.

9. COMMUNICATIONS.

a. 1st Battalion, 5th Marines established a Command Post at Cho Bao Vinh. Radio Relay has been utilized for telephone communication to Battalion Rear and Regiment with excellent results. During the entire month unusual frequency interference was experienced with friendly units but was alleviated through frequency reassignments. With the availability of a steady power source, a message center was established in the field to handle operational traffic. Operation "BAXTER GARDEN" commenced with normal operating procedure supplemented by a second Battalion TAC Net for units specifically designated for the operation. Excepting poor trafficability for radio jeeps and hence occasional non-availability of a covered circuit, normal communications prevailed throughout the operation.

b. Training during the month was highlighted by a profitable 3 day field radio operator school.

a. Air

07Mar68 Pestkiller 1-7 and 1-8 (helicopter's) provided a visual recon for 1st Battalion, 5th Marines. Benchmark 1-6 (Aerial Observance) ran an arty mission.

19Mar68 Benchmark 2-0 (Aerial observer) worked 1st Battalion, 5th Marines Area of Operation.

20Mar68 Scarface 7-1 and 7-2 (Tactical Air Control Attack) controlled flight of A-6's, armed with Daisy-Cutters, on targets coordinates, (ZC 157940) and (ZC 169948) for the purpose of establishing helicopter Landing Zones. Target coverage was 100%/90% being destroyed.

Negative activity. At (YD 967055) ditches noted on west side of River. Basketball 5-22 (Flareship), dropped flares for 1st Battalion, 5th Marines.

10Apr68 Cowpoke 21 (Aerial Observer) worked with Company B, 1st Battalion, 5th Marines - Negative sightings. Basketball 816 worked with Company C, 1st Battalion, 5th Marines. Scarface 9-1 and 9-2 (Tactical Air Controll Attack) ran Hellborne 534, armed with MK 81 250lb. low drag GP bombs and MK 77 500 lb. Fire bomb Napalm, against target coordinated (YD 942129), (VC in Open). Intruders (A-1 Aircraft) had trouble acquiring target upon Roll-in due to visibility. Scarface 9-1 and 9-2 (Tactical Air Controll Attack) returned to run Hellborne 570, Containing ordnance load of MK 81 Snakeeye and MK 77 500Lb. Fire Bomb Napalm on VC Villiage. Five (5) structures destroyed. Bomb damage assesment 95%/75%. Scarface 9-1 and 9-2 then expended their ordnance which consisted of 7.62mm and 2.75 rockets.

16Apr68 Cowpoke 20 and 23 (Aerial Observors) conducted visual recon southeast portion of 1st Battalion 5th Marines TAOR.

23Apr68 Cowpoke 23 (Aerial Observer) conducted general visual recon with negative results. Cowpokes 1-2 and 0-8 also observed. Basketball 816 dropped flares for Company A, 1st Battalion, 5th Marines at (YD 967064). Troops in contact.

24Apr68 Cowpoke 12 (Aerial Observer) conducted visual recon for Company B, 1st Battalion, 5th Marines. Negative results. Basketball 792 dropped flares at (YD 900112) for Company C, 1st Battalion, 5th Marines. Scarface 9-1, 9-2 and 9-3 worked with Company C, 1st Battalion, 5th Marines and Basketball 792 had secondary explosion from Huey (Helicopter) Rockets. Spooky 14 working with Company A, 1st Battalion, 5th Marines at (YD 980049).

26Apr68 Cowpoke 16 and 12 (Aerial Observers) negative results on visual recon. Cowpoke 24 spotted possible enemy campsites at (YD 873014).

27Apr68 Basketball 689 dropped flares for 1st Battalion, 5th Marines along Route # 1 throughout entire TAO.

28Apr68 Black Tippet, replaced Basketball 689. Two (2) flights of fixed wing (Hellborne 51/52 and Ring-neck 10/11 had bomb damage assesment of 100%/75%. Ordnance consisted of MK 82 Snakeye and MK 77 500lb. fire bomb Napalm. Target coordinates were (YD 878015).

29Apr68 Basketball 814 dropped flares along highway # 1.

30Apr68 Cowpoke 21 controlled Hellborne 514 on target coordinates (YD 875015). MK 82 500lb. low drag GP bombs were dropped. Bomb damage assesment was 80%/50%.

(2) Observation by the Aerial Observer was of considerable help in the 1st Battalion, 5th Marines TAOR.

b. Artillery

(1) 2nd Battalion, 11th Marines served in direct support for 1st Battalion, 5th Marines.

(2) During this period, Delta Battery fired 342 missions in support of the infantry units.

(3) With few exceptions, most missions were fired during the hours of darkness by ground observers.

(4) Numerous TOT missions were fired by Delta Battery, in conjunction with reinforcing fires from Phu-Bai, all of these TOT's were fired South of the 02 Grid Line.

(5) Delta Battery fired an average of 55 H&I fires nightly on avenues of approach and avenues of egress.

(6) During this period numerous on call fires were registered for prominent bridges and CAP Units along highway #1.

c. Engineers. Engineer support was provided by Company B, 1st Engineer Battalion. Engineers were employed principally to destroy duds, booby traps and captured enemy ammunition, and to conduct daily mine sweeps of the road networks in the 1st Battalion TAOR.

d. Ontos. Ontos were primarily employed in the defense of bridges assigned to the 1st Battalion, 5th Marines TAOR. On two occasions Ontos were used on Company size Search and Destroy missions. Satisfactory results were achieved by the use of Ontos in both areas of employment.

e. Shore Party (EST). EST's were provided by Company B, 1st Shore Party Battalion. These attachments provided satisfactory support in coordinating and effecting helicopter resupply and movements.

8. Intelligence.

a. Estimate of NVA/VC strength, location and disposition in the objective area.

(1) Intelligence reports received from 5th Marines on 6 March 1968 and 28 March 1968 respectively, identified elements of the following enemy units, operating in or in the vicinity of the battalion's area of operation.

b. Enemy strength and Disposition actually determined during operation.

(1) HAI VAN TACR

(a) During the course of this battalion's operations within this TACR only six contacts were recorded. Four were harassment incidents (enemy initiated) and two were sighting (friendly initiated). All contacts encountered except one were with fire team size units. The sole exception consisted of the sighting of a squad size (8 to 10 men) enemy force moving along a high speed trail. During this period no documents were recovered or identification made. Only scant evidence of the enemy's existence was detected by patrols. This evidence consisted of vacated fire team size campsites, fighting holes, observation point sites and temporary harbor shelters. Some were determined to be more than two months old.

(2) Phu Bai TACR

(a) Based on information derived from POW enemy documents recovered and the nature of enemy contacts.

encountered during this period enemy strength was estimated at a Regiment plus within the TAOR. Contacts during this period were high-lighted by an enemy initiated attack in force against the Troui River Bridge (YD 949069), Bridges #4 (YD 967063) and #7 (YD 988030) on 310200H March 1968. Subsequent analysis of detail debriefing of the defenders and intensive interrogation of POW PFC NUNG VAN FRAG indicate that the force which attacked Troui bridge consisted of the entire K-2 Bn, (AKA K-4B Bn) heavily reinforced by sapper and B-40 teams and ammunition bearers (coolies). Local VC were utilized as guides.

(b) A total of forty-eight contacts were recorded during this period, thirty five were friendly initiated by ambushes and patrols. Exclusive of the enemy's attack in force on 31 March 1968, the remainder of his initiated contacts were characterized by harassment/sniping incidents of friendly isolated outposts and patrols.

(c) With the onset of the Spring rice harvest in middle April an increase in enemy resupply activity was detected as nightly columns of rice bearers escorted by armed NVA security elements attempted to cross highway #1 in order to reach the fertile rice fields of the Huong Thuy and Phu Vang District lowlands. An increase in ralliers was also recorded. At the close of this reporting period twelve had turned themselves into ARVN authorities and USMC units along highway #1. Those ralliers in the majority were students/youths impressed into service by the NVA during the "TET" occupation by NVA forces of Hue. Since their impressment they reportedly had received military and political training while later assigned to their unit (K10 Bn), they were utilized as rice bearers to resupply NVA units deployed to the south and in the interior Nam Hoa District. This type activity continues at an increasing rate at the close of Phase I of "Operation HOUSTON".

c. NVA/VC UNIT IDENTIFIED (PHU SAI AO)

(1) Interrogation of enemy POW/CHIEF HOI/DETAINÉES revealed the following:

(a) PFC NUNG VAN FRAG who was captured by the RVN DV5 on 2Apr68 revealed that he was a member of the K4C Bn, 3rd Co. PFC FRAG, 20 years old stated that the force which attacked the Troui River Bridge consisted of the entire K-2 (Possible AKA K4B) Battalion heavily reinforced. Three infantry companies of 125 men each, 3 sapper platoons of 40 men each, 3 engineer squads of 15 men each, 1 62mm mortar group of estimated 60 men, a Bn Headquarters of estimated 40 men, 3 guerilla platoons of 20 men each, an undetermined number of coolie laborers. A total strength in force of over 720 men. Weapons reported were AK-47's, SKS, 12 B41's, 36 B-40's, 7 RPD machine guns and 6 60mm mortars in direct support.

(b) Squad Leader LAN DO VAN who rallied to Company C, 1st Battalion, 5th Marines at 030730H Apr 68 with his weapon, an AK-50 with 3 magazines. VAN stated he was a squad leader, K10 Battalion Provincial Main Force Battalion, 2nd Company. The K10 consisted of 4 companies C1, C2, C3 and C4. His platoon consisted of 28 men. Subject's platoon accompanied by 1 platoon each from the K-25 and K-23 (unknown units) Battalions (Main Force) were on a rice resupply mission enroute to YD 942134. VAN defected 022200H Apr 68 vicinity YD 9008. VAN indicated all infantry companies are equipped as follows: 1 B-40 per squad with 8 rounds B40 ammunition, 1 82mm mortar per Company with 40 rounds per mortar, 1 RPD Machine gun per platoon. Estimated strength of K10 Battalion is 336. VAN indicated that troops carried 400 rounds per man for AK's and 700 rounds per machine gun.

(c) Pvt DO DAU, age 29 who rallied to Phu Bai village chief at 050630H Apr 68 was interrogated and he revealed that he was a member 1st squad, 1st platoon, 1st company of the K10 Battalion. The K10 has 3 infantry companies and 1 support company. Company strength at T/O is 100 men. A platoon has 30 men and a squad has 9-10 men. The support company has 3 B41 rocket launchers with 40 rounds, 2 82mm mortars. An infantry company has 2-60mm mortars. Squads have 1 B-40 rocket launcher and 1 machine gun each.

(d) LE DAN a 14 year old civilian conscripted by the VC to carry rice was apprehended by C 1/5 squad ambush at 052230H Apr 68. Subject revealed he was impressed by NVA during "TET" Offensive and forced to carry rice into mountains. Subject was unfamiliar with area of operations and could not give information as to the location of his unit. Subject indicated he accompanied a group of 150 rice carriers, each man carrying 12 kilo of rice with 50 NVA as security. This was subject's first resupply mission. Subject insisted he picked up rice in mountains and was scheduled to make delivery at undetermined location in area of capture (YD 924119).

(e) TRAN PHUC, 15 year old civilian abducted in Mar 68 by VC to carry rice was captured by D 1/5 vicinity (YD 945059). He revealed his unit, the 1st squad, 3rd platoon 2nd company of the 5th Battalion (5th Battalion training unit). The 5th Battalion's composition is 3 companies numbered 1, 2, and 3 respectively. Each company's strength is estimated at 200. A company has 3 platoons with 3 squads each. Squad weapons 5 AK-47, 6 SKS's, 1 B-40 rocket launcher with 15

rounds. Each platoon had 2 60mm mortars and 2 7.62 light machine guns. Subject had knowledge of K-6 Battalion which was formerly co-located with his parent unit. Subject indicated that the composition of the K-6 is identical to his battalion but that the K-6 is not designated as a training Battalion.

(f) DUONG VENT HONG, age 18; HOANG VAN KINH, age 15; DUONG VIET CHAY, age 15; HOANG CONG CHING, age 18; and LE DINH THUY, age 17 all were captured by Cap unit A3 and subsequently exploited by members of S-2 1/5 and 13 ITT. All revealed that they were members of newly organized Youth Civil Defense Force. This unit was employed as guards for local VC cadre. Later they were sent to the mountains and pressed into service as rice carriers.

(g) Soldier (Rice carrier) NGUYEN NGU, age 25 who rallied to PHU BAI Village Chief 080800H Apr 68 and was exploited by members of S-2, 1st Battalion, 5th Marines and 13 ITT revealed his unit as the 2nd squad, 1st Platoon, 3rd Company of the K10 Battalion. 8 men in each squad, 4 AK-47's, 2 SKS's, 1 B-40 with 4 rounds and 1 7.62 LMG. There are three squads in each platoon and three platoons in a company.

(h) BUU KHOI, age 51, EVA rice carrier who rallied to PHU BAI, village chief 200730H Apr 68 and was exploited by members of S-2, 1st Battalion, 5th Marines and 13 ITT. Subject revealed he was a member of 1st squad, 1st Platoon, 2nd Company, K-10 Battalion. Composition subject unit, as follows: (3) platoons to company, 3 companies compose K-10 Battalion. Each Company has 1 mortar squad attached, mortar squad consists of (2) 60mm mortars, (3) B-41 rocket launchers, 3 AK-47's each squad. Squad's consist of 9 men. Squad weapons: (3) AK-47, (1) AK-50, (1) 7.62LMG, 1 B-40, 4 SKS. K10 is at 7/8 strength.

(i) Wireman CHE VINH, age 29, who rallied to PHU BAI village chief 201000H Apr 68 was exploited. Subject identified his unit as the 2nd Squad, 2nd Platoon, Company C. His squad has 11 men with 2 AK-47's, 4 carbines, 5 M-16. There are 3 squads in each platoon and 3 platoons in each company. The 1st platoon is employed as runners, 2nd platoon consists of wiremen and the 3rd platoon is used for radio communications between Battalion.

(j) PFC LI VAN TAM (Soldier and rice carrier) age 27 who rallied to PHU BAI village chief at 220630H Apr 68 was exploited and identified his unit as the K10 Battalion, Company C-2, 1st Platoon. There are 27 men in his platoon,

75 men per company, and 300 men per battalion. The Battalion has 4 Companies. One of the four companies is a mortar company equipped with 61/62mm Mortars. TAM carried a Thompson sub-MG, other wpns in his platoon consisted of B-40 rocket launchers with 4 rounds per launcher, (3) Sub MG's, (9) AK-47's, (18) SKS semi-auto rifles. The K-10 Battalion is also equipped with B-41 rocket launchers.

(k) PVT TINH VAN BA, rifleman who rallied to C 1/5 on 270630H Apr68 identified his unit as A1 Squad, B1 Platoon, C-2 Company of the K-10 Battalion. The A1 Squad has (6) men with 2 AK-47's, 2 SKS, 1 B-40, and 1 7.62 IMG. There are 3 squads in each platoon, each platoon has 2 60mm mortars. There are 3 platoons in each Company for a total strength of 360 men in the Battalion.

d. Significant Intelligence Gained.

(1) Order of Battle. The following additional information was obtained concerning units identified in paragraph 7c.

(a) The K-10 Battalion is operating in the assigned AO with mission of gathering resupply of rice and food stores for NVA/VC units located in the vicinity of Neu Mo Tau Mountains (YD 845045) and the enemy units located to the south and southwest of the Troui Bridge (YD 968063). The Battalion moves frequently and displaces its units over a large area when not deployed. When ordered to pick up rice caches the Battalion assembles and deploys in a force large enough to carry out it's assigned mission. Normally 3 companies are committed with one remaining in the rear area. They began their movement during late afternoon from the canopy in order to arrive in the foothill prior to darkness (1830-1900). It is believed that upon moving out of the foothills the units break down to smaller groups of 50-100. Each group has a security element assigned. Prior to attempting a major road crossing, the point element is committed to find any friendly ambushes in their line of march. If no contact is made a runner is dispatched and the main body will deploy across the road and continue their assigned mission. The same procedure is used upon returning. If no contact is made, they sometimes utilize the same route of return.

(b) The 5th Battalion (Training Unit) was reported 6 days march to south/southwest in the mountainous region Nui Diau (ZC 1486), 1st Battalion, 5th Marines TACR. The battalion's mission was to procure rice from Nam Phu Cam (Location Unknown). The 5th Battalion was formerly located with its parent unit the K-6 Battalion.

(c) The K-6 Battalion whose composition is identical to the 5th Battalion but is not designated as a training unit. It was located with the 5th Battalion at one time in the mountains 6 days march to the south/south west of the TAOR.

(d) The C-30 Company. (Communication Company) had began intensive training for a future attack. Dates 1-17 May 68 or 19 May 68.

(e) The K-25 (MF) and K-23 (MF) Battalion were reported on rice resupply missions. These Battalions were reported at one time employing a platoon each in support of a K-10 Battalion rice mission.

(f) Youth Civil Defense force was moved south into the mountains and members were given the task of rice procurement.

(g) OTHER. Information derived from unrelated sources indicates that one other enemy unit and the K-10 Bn has received ammunition resupply via truck and/or air drop. Truck route #12 from DMZ via float ferry across BEN HOI River, south into RVN. C-30 Company (Communications Company) has received 15 minute warning prior to being hit by B-52 strikes. Source indicated Battalions are given as much as 4 hour notice prior to bombings. Warnings come via radio from Bangkok, Thailand when planes take off. . .

c. Terrain.

(1) HAI VAN PASS (AO)

Route 1 runs from the south to north up to the Lang Co Bridge through the Hai Van Pass. The Pass consists of a mountain belt running parallel with route #1. The mountains are heavily dissected and rugged with slopes ranging from 30 to 40 degrees. Evergreen secondary forests are predominant. Trees range in height from 25-30 meters with some as high as 50 meters. The canopy is continuous and dark green. Tree trunks are straight, commonly 2 to 16 meters apart and unbranched to great heights. Secondary forests consist of smaller trees with a discontinuous canopy and more dense undergrowth. The mountains and piedmont favor the enemy tactically. Irregular terrain and dense vegetation offer excellent concealment, routes of infiltration and defensive positions. The steep rugged, heavily forested mountains seriously hinder overland mobility. Short fields of fire, restrictive observation, and limited LOC and helicopter LZ's.

(2) PHU BAI (AO)

The Phu Bai (AO) consists of three major terrain features:

(a) The coastal area, lowland and rice fields. These areas are relatively flat. The plains are characterized by canals and irrigation ditches link together numerous streams, deltas, and distributing channels, forming a network of waterways to provide drainage, irrigation, and water transportation. In the coastal plains, wetland rice and some dry crops are the major vegetation, although dune grass and marshes are scattered throughout. Rice fields, flooded to a depth of 6 to 10 inches during the growing season, are drained prior to the harvests in March and August, and are driest in September. Mature rice forms a dense vegetation, including thick hedges between houses. Soil throughout the coastal area and in some inland areas are a sandy silt, poorly suited for construction, except to fill. In the coastal area, observation and fields of fire are generally good but impeded by local irregularities and hedges in built up areas. Air observation is good. In the coastal plains some cover is provided by paddy dikes and occasional sand dunes. Concealment is limited to that available in the built up areas and in the dense, mature rice fields at certain times of the year.

(b) The piedmont area consists of undulating hills which are cut by numerous river valleys. These waterways extend, like fingers, from the western highlands through the piedmont and into the coastal plain. Hills in the piedmont range from 30 to 70 meters in elevation with slopes between 10 and 20 degrees. The piedmont is predominantly secondary, broadleaf forest with some dense evergreen forest. Dense undergrowth is bamboo and palm thickets are very common. There are some grass areas, growing as high as five feet, as well as small cultivated areas of dry crops.

(c) Mountains. (As described Para. c (1).

(d) Weather. (1) HAI VAN TACH

Throughout the operation the weather was mild/cloudy during daylight hours and mild to cool during night hours, temperature and high humidity readings had adverse affects on movement during daylight hours. Night hours consisted of heavy overcast coupled with scattered precipitation. Illumination although favorable was markedly affected by overcast conditions, and hampered visibility considerably during operations in the mountainous regions. These conditions had an adverse effect on the use of air support, especially during hours of darkness.

Throughout the operation the weather was mild to warm during daylight hours and mild to cool at nights. Temperature and humidity had no adverse effect on movement during daylight hours. The moon was in its last quarters. Illumination was reduced from 37% on 21 April 68 to 06% on 25 April 68. It hampered, to a limited degree, night movement. In general the weather, wind and cloud conditions did not have any adverse effects on operations or the use of air support.

9. MISSION.

a. 5 March 1968 through 27 March 1968. 1st Battalion, 5th Marines keep route #1 open by establishing holding position at Lang Co bridge and other key bridges. Establish mobile security on remainder route #1 and supporting bridges and culverts in assigned AO. Provide security for bridge and road repair parties as required; provide security along MSR and reaction forces for the protection of friendly convoys. Conduct patrolling, ambushes, H&I fires and well controlled mining and booby trap operations at or near obvious targets for enemy attack or destination. Conduct limited offensive operations to destroy threatening enemy forces.

b. 28 March 1968 through 30 April 1968. 1st Battalion, 5th Marines provide security for vital bridges along MSR and observation posts in TAOR. Conduct search and destroy operations in TAOR to fix and destroy the enemy, his weapons, supplies and fortifications. Assume Bald Eagle/ Sparrowhawk commitment and other missions as directed.

10. CONCEPT.

1st Battalion, 5th Marines conducts operation to accomplish assigned mission with two companies operating in assigned AO along and adjacent to route #1, to deny enemy access to MSR, provide bridge security; other units conducting limited operations to seek out and destroy the enemy, his weapons, equipment and fortifications in the Battalion AO. Companies along route #1 will conduct saturation ambushes by night, patrols and combat outposts by day.

13. ADMINISTRATION MATTERS.

a. Supply.

(1) A logistical point forward was established with the battalion command group. Liasion was made with FLC at DaNang, and supplies were obtained from there. No problems were encountered to impair the logistical mission of this Battalion.

(2) A daily administrative run was established between the forward elements of the battalion, and the Battalion rear located at Phu Bai.

(3) During this operation, the battalion field mess was established and two hot meals per day were served to H&S (-). When operational commitments would allow, a hot meal was served to the rifle companies.

b. Maintenance. Cleaning equipment for crew served weapons was carried by all units. Weapons were cleaned and inspected on a daily basis. No maintenance problems were encountered with weapons or equipment during the operation.

c. TREATMENT OF CASUALTIES AND EVACUATION AND HOSPITALIZATION.

During Operation "HOUSTON", a forward BAS was located at Hai Ban Pass. Personnel included one doctor and three to five corpsmen. The BAS was set up in the BAS hooch of the First LAAM Battalion, A Battery, and shared with their medical personnel. Medical supplies included those initially brought by truck and trailer from the rear BAS in Phu Bai. Resupply was obtained in DaNang due to its proximity and available transportation. Med-evacs were supplied by helicopters to the landing zone at the LAAM site, by administrative truck runs to Phu Bai, and by supply truck runs to DaNang. Routine sick call was held daily as well as emergency treatment of casualties. A striking increase in the incidence of venereal disease, primarily gonorrhea, was noted while in this area.

The six day field operation included the normal complement of company corpsmen assigned to platoons and company command groups and one doctor and one corpsman assigned to the 1st Battalion, 5th Marines Command Group. Medical supplies included those items carried in unit one shoulder packs. No additional supplies were available due to the operation location in the mountainous regions.

Problems encountered included sprains and bruises from fall while climbing or descending rugged terrain carrying heavy packs and weapons. A few injuries were incurred as a result of booby traps, but there were otherwise no enemy-inflicted casualties due to lack of contact. A few heat casualties occurred but were treated with salt, water, and rest in the field.

Med-evacs in the field were accomplished without difficulty in the lower regions, but required the use of sling-litter supports for aerial evacuation in the higher elevations where landing zones were not available.

Because of the dispersion of troops in the field, the medical officer was able to see and treat very few of the casualties except those that occurred near the area of the CP group. Movement to and from platoon areas where injuries occurred required several hours in the mountainous regions, and the proper solution was med-evac from the field rather than attempting movement and treatment in the field.

Numerous cases of diarrhea developed at the close of the operation, and it was noted that many of the troops had not used halazone in their drinking water.

d. Transportation. Wheeled vehicles were the primary means of transportation during the operation.

e. Communications. Prior to commencing the Operation an extensive brief was given by the regimental staff followed by a visual Recon. The radio nets were successfully established upon arrival at the Battalion CP in Hai Van Pass. Immediately a trunk line was installed to the A Battery Lamb Switch-board allowing positive telephone communications to the DaNang area. On 6 March a MRC-62 radio relay circuit was established to allow telephone communications to the Phu Bai area and higher and adjacent units. Considerable interference was experienced on the Battalion TAC, Company B TAC, and Radio relay. This was eliminated to a satisfactory degree by the use of alternate frequencies. The use of a light-weight field expedient antenna was extremely successful with Company A. When moving through steep, dense terrain on 21 March a radio retransmission sight was established, with good results, at CAP 6, to enable the Battalion Rear to maintain communications with the operating units. A new Battalion CP was established at Cho Bao Vinh. A TRC-27 radio relay circuit was established to allow telephone communications to higher and adjacent units as well as the entire Phu Bai area. Again considerable friendly radio interference was experienced but alleviated by frequency reassignment. Upon availability of a steady power source a message center, was established to receive and send operational traffic into Regiment. Training of field radio operators was conducted with Company A, 106RR Platoon and a 3 day class for representatives from the entire Battalion. At the termination of Phase I of Operation "HOUSTON" good communications existed throughout the battalion, both internally and externally. Especially noteworthy was the excellent training accomplished.

15. Commander Analysis: 1st Battalion, 5th Marines was committed to Operation "HOUSTON" with the mission of providing security along Route # 1 and for certain key bridges and installations, and for interdicting enemy movement in the vicinity of Route # 1. The battalion operated in two areas during the Operation; from 05 March 1968 until 28 March 1968 in the Hai Van TAOR, and from 28 March 1968 until 30 April 1968 in the Phu Bai TAOR.

The Hai Van TAOR was characterized by heavily canopied, sparsely populated mountainous terrain. Little contact was made in this TAOR, despite numerous patrols and larger operations. Flak vests proved a definite hindrance on long range activities, particularly when speed and mobility were essential.

In contrast, the Phu Bai TAOR is a heavily populated lowland of rice fields and waterways. Contacts were frequently made with the enemy, usually at night. In addition to the requirement to provide security for six bridges, two of which are major bridges, the battalion was required: to establish two outposts southwest of Phu Bai; to provide one platoon as a screen south of Phu Bai; to maintain a Forward CP in the field and a Rear CP in Phu Bai; to retain the capability to provide a reaction force for the support of any friendly unit or installation, in the TAOR including seven CAPS and the Phu Bai Vital Area; to provide a Company as Bald Eagle, on order, and to furnish units for Regimental Operations.

Any concept of operations selected to meet these diverse missions, with the limited resources of a battalion, had to embrace the principles of economy of force and mass. In addition, experience emphasized the importance of the offensive when the Truoi Bridge was destroyed by the enemy on the first night after the battalion assumed responsibility for the TAOR.

The concept evolved during Phase I of Operation "HOUSTON" provides strong fortifications manned by reinforced squads at each of the six bridges. Thus two platoons are tied down

to fixed positions. The OP's and forward CP are manned by personnel from H&S Company. The remaining forces are free to operate at depth, both within the TAOR and beyond, in the Regimental Area of Operation. This is essential.

Units operating at depth react to intelligence to block infiltration routes and hamper the enemy's capability to mass. The success of this method is illustrated by the fact that of forty-eight contacts experienced in the Phu Bai TAOR since 1 April 1968, thirty-five were friendly-initiated. No attack against a bridge or friendly unit has been successful, and numerous Chieu Hoi's have reported that major units have been stymied in their attempts to pass through the TAOR.

The minimum force capable of meeting the requirements for fixed defensive and mobile offensive operations in the Phu Bai TAOR is three rifle companies. With the addition of a fourth company, deep operations in the Regimental Area of Operations can be conducted. This combination of operations is considered essential to the security of the TAOR.

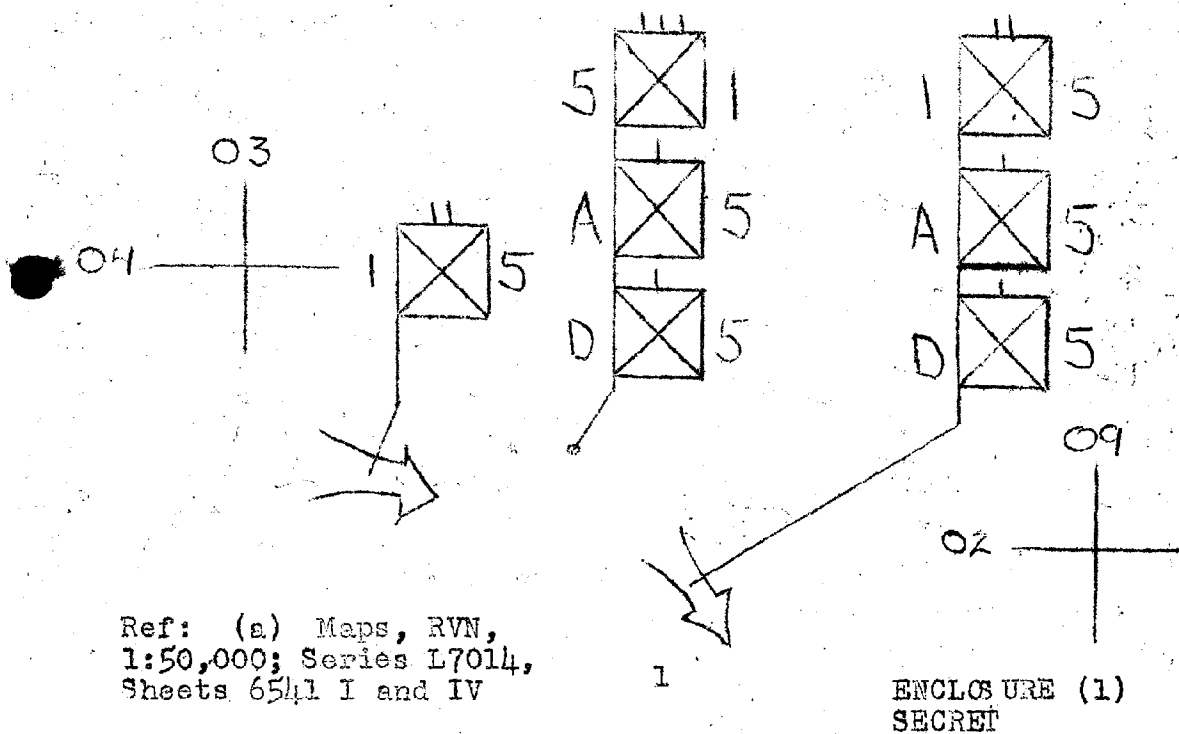
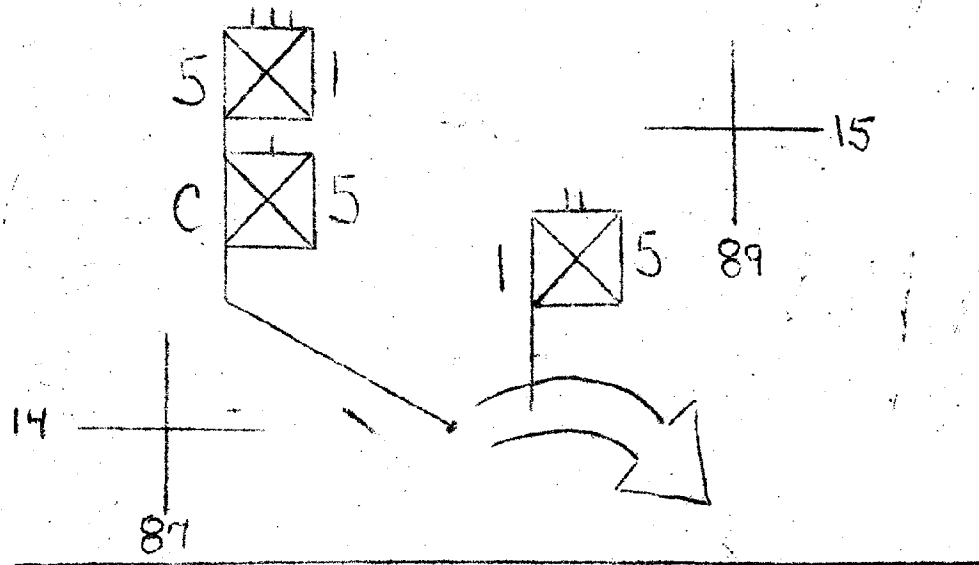

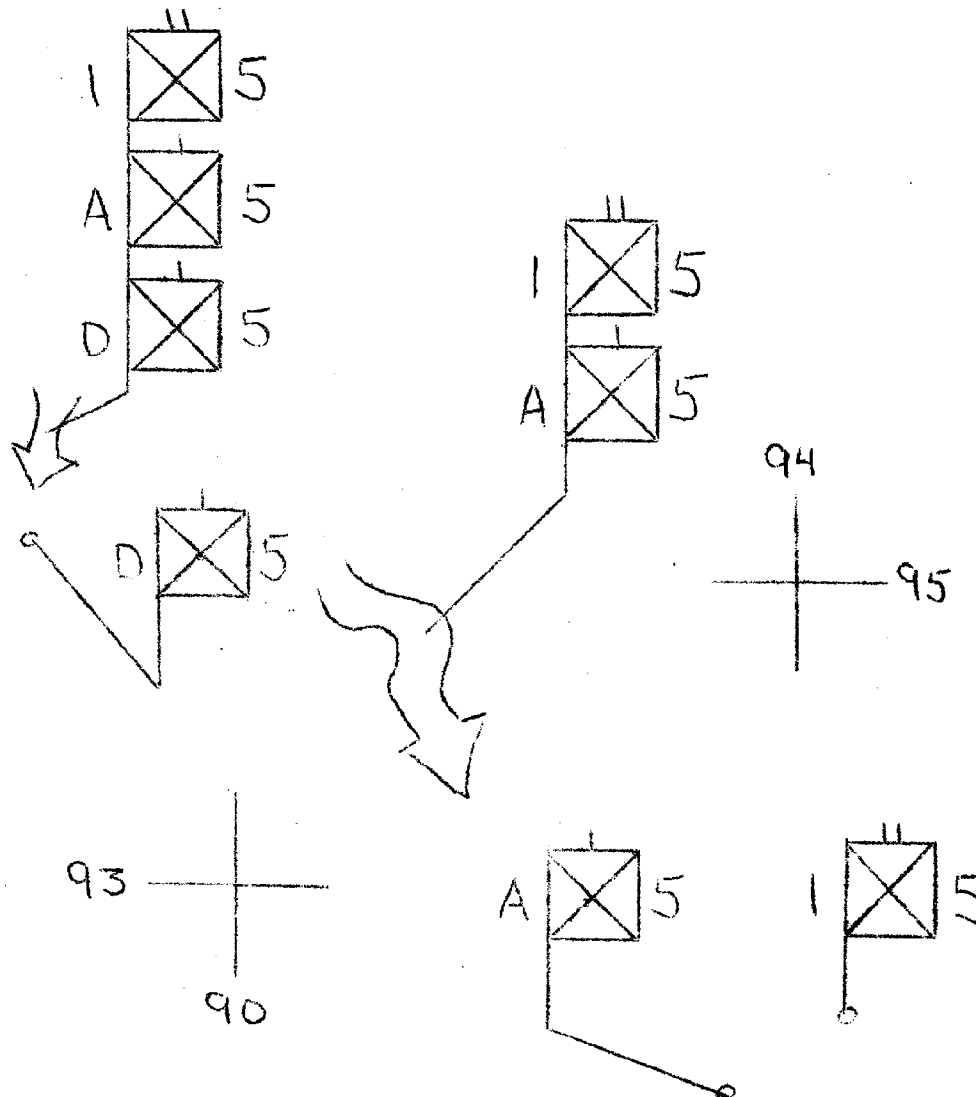
