PART IINARRATIVE SUMMARY

1st Battalion, 5th Marines continued to participate in Operation "HENDERSON HILL" which terminated at 062400H December 1968. During this period, the Battalion conducted aggressive operations to seek and destroy and capture enemy forces, weapons, material and positions; secured and protected routes of ingress and egress for movement of friendly logistical support and supported and protected US and RVN installations and convoys. 1st Battalion, 5th Marines participated in Operation "TAYLOR COMMON" which commenced at 070001H December 1968 and continues into the month of January. The mission and concept remains the same as that of Operation "HENDERSON HILL".

PART III

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTSA. TOPICS1. PERSONNEL AND ADMINISTRATION

a. Strength. The Battalion's strength at the beginning of the month was 25 officers and 1116 enlisted. On 15 December, the strength had changed to 28 officers and 1125 enlisted. By the end of December, the strength was 34 officers and 1104 enlisted. At this time, there are 1 officer and 60 enlisted hospitalized. Joinings during the month were 11 officers and 251 enlisted.

b. Discipline, Law and Legal. 6 Summary Courts-Martial and 6 Special Courts-Martial were convened during December. There is 1 Summary Court-Martial and 5 Special Courts-Martial still to be processed. During December, 4 informal investigations and 1 Article 32 investigation were completed. There are 5 informal investigations pending.

c. POW/Detainees. There were 52 detainees processed during the month.

d. Morale. Morale and fighting spirit continued to be excellent. Personnel who captured POW's received incountry RMR.

e. Postal. Postal service continued at the same degree of excellence.

f. Awards. During December, there were numerous Navy Commendation and Navy Achievement Medals forwarded to members of this Command. Also during the month, there were 120 Navy Achievement, 4 Navy Commendation, 10 Bronze Star and 1 Navy Cross Medals submitted for heroism and meritorious service.

g. Interior Management. Administrative procedures and proficiency continued to be excellent.

2. ENEMY, WEATHER AND TERRAIN

a. Enemy. The local force and VC hamlet guerilla have continued to employ booby traps with emphasis being placed along outpost positions, water points and on trails leading into or out of company positions. There was a total of 42 mine and booby trap incidents, with 33 of these occurring from 15-31 December. The NVA still continue to avoid contact with Marine forces in the AO. Numerous sightings of both fairly large VC/NVA units of 25-60 men were reported moving in the northern part of the AO toward the foothills and mountains to the southeast. A total of 5 Returnees indicate that local force VC morale is very low and that Air/Artillery strikes have caused them many losses. The enemy has employed 82mm mortars on friendly positions three times from vicinity (AT 974527).

b. Weather. During this period, the weather was warm to hot during the daylight hours and mild to cool at night. Air operations were not affected during this period by weather conditions.

c. Terrain. No change.

3. ORGANIZATION AND OPERATIONS

a. Organization. The organization of the Battalion remained substantially the same throughout the month of December, except during the following periods:

(1) Company B was OPCON to 5th Marines from 010001H Dec through 051400H Dec 1968.

(2) Company A was OPCON to 5th Marines from 101800H Dec through 151200H Dec 1968.

(3) Companies A and C were OPCON to 2nd Battalion, 7th Marines from 170805H Dec through 181530H Dec 1968.

(4) Companies F and G, 2nd Battalion, 7th Marines were OPCON to 1st Battalion, 5th Marines from 181531H Dec through 200930H Dec 1968.

(5) Company B, 1st Battalion, 1st Marines was OPCON to 1st Battalion, 5th Marines from 300645H Dec 1968 and continues OPCON to the 1st Battalion, 5th Marines into the month of January 1969.

(6) Company C, 1st Battalion, 5th Marines was OPCON to 5th Marines from 301800H Dec 1968 and continues OPCON to 5th Marines into the month of January 1969.

b. Operations. During the period of 1 through 6 December, the Battalion continued to participate in Operation "HENDERSON HILL" (Search and Destroy Operation) in the eastern part of Duc Duc District and the Duy Xuyen District in the Quang Nam Province of RVN. The operation terminated on 062400H December 1968. See Tab B "Combat After Action Report, HENDERSON HILL".

During the period of 7-31 December 1968, the Battalion participated in Operation "TAYLOR COMMON" which commenced at 070001H December 1968 and continues into the month of January 1969. The area of Operations, Mission and Concept remains the same as that of Operation "HENDERSON HILL".

c. Supporting Arms

(1) Air. The month of December showed an increase in the tempo of air operations flown in support of this Battalion. During this period, the 1st MAW rendered excellent fixed and rotary wing support, a summary of which is as follows.

(a) Fixed Wing. This support consisted of flare ships, "Spooky" gunships, TACA/AO Teams, and Tactical Air Strikes. 16 flareships provided 27.9 hours of illumination, and 9 "Spooky" gunships gave 10.6 hours of target coverage. A total of 103 TACA/AO Teams provided 139.1 hours of time on station for VR's, protective cover, and controlling Tactical Air Strikes (TAS). 158 TAS missions were flown in support of 1st Battalion, 5th Marines providing close and deep air support for contact missions as well as against S-2 targets and targets of opportunity detected by AO's. TACA/AO teams controlled 131 airstrikes. The remaining 27 TAS missions were A-6 Radar Beacon strikes, many of which were flown during the hours of darkness. These pre-dawn and post-dawn strikes have decreased, by four hours daily, the time that the enemy can be free from aerial bombardment.

Of the total TAS missions flown during the month, definitive bomb damage assessment is available for only 112 flights and is listed below:

(b) Rotary Wing. Helicopter operations, exclusive of re-supply missions, consisted of Med-Evacs, a few troop lifts, and 2 visual recon missions. 85 Med-Evac missions extracted 102 Marines (46 of whom were emergency category) and 39 indigenous personnel.

(2) Artillery. From 1 December through 31 December 1968, D Battery, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines. Reinforcing fires were provided by 2nd Battalion, 11th Marines and by 1st Field Artillery Group. Delta Battery fired a total of 658 missions and approximately 17,500 rounds in support of 1st Battalion, 5th Marines. An average of 35 M-I targets were fired daily.

(3) Engineers. Excellent Engineer support was provided by Company B, 1st Engineer Battalion. Engineers were employed principally to destroy duds, booby traps, captured enemy ammunition, enemy bunkers/fortifications and to conduct daily mine sweeps of the road networks in the 1st Battalion, 5th Marines AO. Numerous mines and booby traps were detected by visual sightings and mine detecting equipment. Loss of lives, wheeled and tracked equipment was considerably reduced by the detailed searching efforts employed by the engineers.

(4) Shore Party (HST). HST's were provided by Company B, 1st Shore Party Battalion. These teams provided satisfactory support in coordinating and effecting resupply and Med-Evacs.

(5) Tanks. A light section of the 2nd Platoon, Company B, 1st Tank Battalion was in direct support of the 1st Battalion, 5th Marines. Excellent results were achieved by using tanks to support infantry assaults.

4. TRAINING

a. The following training was conducted during the month:

- (1) Weapons Safety
- (2) Weapons Inspection, Care and Cleaning
- (3) First Aid, Self Aid and Field Sanitation
- (4) Info Lecture: Marijuana and other drug abuses (possible hazards and seriousness involved if convicted).

b. All companies during their period on bridge defense continued to have instructions and familiarization firing of all individual and crew served weapons, including the LAAW 72, hand grenades and Claymore mines.

c. Replacement personnel received four (4) days training at 5th Marines Headquarters prior to being committed to the field.

c. The Battalion continued to utilize schools provided by higher headquarters. During the month, 25 members of the Battalion attended schools in the DaNang area and Okinawa.

5. LOGISTICS. No serious problems have occurred during this period to impair the logistical support of the Battalion.

6. CIVIL AFFAIRS. During this reporting period, the Battalion continued to work with the people of Phu Da (2) and in conjunction with CAP 2-9-1 for the people of Mau Chanh (1) and Mau Chanh (2). During this period there were 3 homes burned by flares from nearby bases. The Battalion assisted the people of Phu Da (2) in reconstructing these 3 homes, and 8 additional new ones. This unit also helped to improve on a few other homes that were in need of repair, due to previous material used. A total of 126 sheets of plywood; 56 sheets of tin; 26 ammo boxes; 30 sheets of plastic; and 2 trailer loads of assorted lumber were used to rebuild, repair and waterproof homes within the hamlet. A total of 4 trailer loads of mixed size lumber and old canvas were delivered to CAP 2-9-1 for distribution to the people of Mau Chanh for building of homes.

On 24 and 25 December, a total of 15 lbs of candy and numerous toys were given to the Phu Da (2) Christian Church for distribution to the children of the church for Christmas.

7. PSYCHOLOGICAL OPERATIONS. During this period, the Battalion has received intelligence information from the elders of Phu Da (2). Intelligence information has been turned over to Battalion S-2 Section and Counter Intelligence. The following ordnance was turned in by the people of Phu Da (2): 16 M16E3 mines; 3 M18A1 Claymore mines; 1 box mine (20 lbs); 1 M-79 round; 1 NVA canteen cover; 1 NVA grenade pouch and 1 US cartridge belt.

At the present time, a 3 man NB Team (Loudspeaker Broadcasting Team) of the U.S. Army, 7th Psychological Operations Battalion is working with A Company, 1st Battalion, 5th Marines in support of the Chieu Hoi program and broadcasting to Vietnamese civilians.

A total of 37,550 \$VN has been paid from the VIP fund, with a sum of 15,000 \$VN still to be paid out for ordnance. The attitude of the people towards this battalion remains excellent.

8. COMMUNICATIONS. During the past month, communications within the Battalion were maintained in a satisfactory manner without particular difficulty. Facilities installed in earlier periods such as radio, radio relay, wire, teletype and power were expanded to offer greater service to both the Battalion CP and the rear. Communications security was again heavily stressed, showing a marked improvement on all nets.

The following units were OPCON to the Battalion during Operation "HENDERSON HILL".

(1) Company F, 2nd Battalion, 5th Marines from 231200H October through 241200H October 1968.

(2) Company I, 3rd Battalion, 5th Marines from 051530H November through 081400H November 1968.

(3) One Company of RVN Regional Forces OPCON from 201500H November through 051400H December 1968.

Units from the Battalion were OPCON to the following organizations during Operation "HENDERSON HILL".

(1) Company B, OPCON to 3rd Battalion, 5th Marines from 181200H November through 051400H December 1968.

7. Supporting Arms

a. Air. Excellent support was given by 1st MAF in providing fixed wing and helicopter support. During this period, 111 fixed wing missions were flown by Marine TACA/AO Teams, several USAF and VNAF flights also rendered close and direct support. Additionally, 9 flights of A-6 Radar Beacon strikes were flown under FAC control. Night support consisted of 16 "Spooky" gunships and 6 flareships. Rotary wing support, besides normal resupply, troop lifts and VR missions, consisted of 66 Med-Evacs and 3 flights of "Huey Gunships" used for close air support.

b. Artillery. During this operation, Delta Battery, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines. Batteries in a reinforcing status for this period included: one 155mm Howitzer battery; one 4.2" mortar battery; and one 8" Howitzer platoon, all of which were under the operational control of 2nd Battalion, 11th Marines.

A total of 580 missions were fired by Delta Battery, 475 of which were contact missions in direct support of units of 1st Battalion, 5th Marines and 105 of which were S-2 missions. Approximately 40 H&I fires were delivered daily on enemy targets.

c. Engineers. Engineer support was provided by Company B, 1st Engineer Battalion. Engineers were employed principally to destroy duds, booby traps, captured enemy ammunition, enemy bunkers/fortifications and to conduct daily mine sweeps of the road networks in the 1st Battalion, 5th Marines AO.

d. Shore Party (HST). HST's were provided by Company B, 1st Shore Party Battalion. These attachments provided satisfactory support in coordinating and effecting helicopter resupply and Med-Evacs.

e. Amtrac. A light section of the 4th Platoon, Company A, 3rd Amtrac Battalion was in direct support. The LVT's provided considerable support in transporting troops, and were used extensively as convoy security between An Hoa and Liberty bridge.

f. Tanks. A light section of the 2nd Platoon, Company B, 1st Tank Battalion was in direct support. Although the movements of the tanks was restricted to the road, they were able to move to prescribed objectives. Excellent results were achieved by using tanks to support infantry assaults and on a few occasions reinforcing outpost adjacent to the MSR. In addition, the tanks were used extensively as convoy security between An Hoa and Liberty Bridge.

8. Intelligence:

a. Estimate of NVA/VC strength and disposition in the objective area. See Annex B (Intelligence) to 5th Marines Operation-Order 301A-68(S).

b. Enemy strength and disposition actually determined during the operation. Based on contacts, POW/Detainees, and intelligence reports received from higher headquarters, enemy strength is estimated at two battalions with local force VC units deployed within the Battalion TAOR.

c. NVA/VC Units Identified. Interrogation of enemy POW/Detainees and enemy documents recovered revealed the following enemy units identified:

- (1) R20 Bn
- (2) Q83 Bn
- (3) V25 Bn
- (4) 2 Bn, 36 NVA

d. Significant Intelligence Gained. The enemy continued to utilize mine and booby traps, with emphasis being placed along the MSR in the vicinity of Marine Outpost. The M-26 grenade is the most frequently trap set, utilizing trip wires and sometimes rigged to set off other ordnance such as 105mm and 155mm duds. The enemy continued his sniping and probing actions to attempt to disrupt our efforts to keep the MSR open. On three occasions, the enemy attacked with company-sized strength. In each of these attacks, the enemy was defeated.

e. Terrain. See Annex (B) Intelligence to 5th Marines Operation Order 301A-68(S).

f. Weather. During this operation, the weather was warm to hot during the daylight hours and mild to cool at night. Air operations were not affected during this period by weather conditions.

9. Mission. 1st Battalion, 5th Marines conducted in assigned AO aggressive offensive operations to seek and destroy or capture enemy forces, weapons, material and positions. Secure and protect US and RVN installations, units and convoys.

10. Concept. 1st Battalion, 5th Marines with one company and Battalion Command Group established a holding position at Liberty Bridge ferry landings to protect that installation and to provide security for daily mine sweep operations to clear Liberty Road from An Hoa Combat Base to Liberty Bridge. One company to keep Liberty Road open and to protect friendly convoys by constant surveillance and interdiction of enemy threat to the road by daily OP's and night ambushes and patrols along the axis of the road. Two companies conducted aggressive offensive operations in the An Hoa area to destroy enemy forces, and were prepared to provide reaction forces to assist the An Hoa Combat Base and local US and RVN installations and units, and were prepared to deploy to any portion of the Regimental AO to conduct offensive operations.

13. Administrative Matters

a. Supply. Resupply was accomplished by both helicopter and wheeled vehicle. The Command Post and units near the MSR were resupplied by wheeled vehicle while the units off the MSR were resupplied by helicopter. No serious supply problems have occurred during this operation to impair the logistical support of this Battalion.

b. Maintenance. No serious maintenance problems were encountered with weapons or equipment during the operation.

c. Transportation. Both helicopters and wheeled vehicles were the primary means of transportation, supplemented by LVT's. There were no significant problems encountered with transportation.

d. Communications. Throughout this operation, radio communication between the companies and the Battalion CP at Liberty Bridge was satisfactory with the employment of normal VHF equipment and antennas. The CP maintained covered radio capability to the 5th Marines by means of the KY-38/PRC-77 voice cipher system without any outage time.

Communication facilities at Liberty Bridge were extended to include a 60 WPM HDUX teletype circuit from the Battalion Rear at An Hoa. This circuit was routed over the TRC-27 which continued to provide voice circuits to Regiment.

The Battalion nets experienced no jamming or known enemy deception during the operation. Throughout the operation, the Battalion took an ever increasing interest in radio security and procedure by holding classes and briefings, and a 24 hour a day selective monitoring of nets. By these means, the Battalion was able to significantly improve its performance on all nets.

e. Treatment of Casualties, Evacuation, Hospitalization and Medical Evaluation. Casualties in the field were treated and evacuated by helicopter for hospitalization. Some minor casualties were evacuated through the forward BAS at An Hoa for appropriate treatment and disposition. It is noted that the number of malaria and Immersion foot cases markedly decreased during this operation. The rear BAS continued to provide medical attention and facilities to the wounded Vietnamese civilians. Medical treatment, evacuation, hospitalization has been provided in an excellent manner during this operation.

15. Commanders Analysis. The enemy continued to employ harrassing tactics throughout the operation with light sniper fire and limited night probing attacks at friendly positions. His continued efforts to employ mines and booby traps along the MSR was reduced considerably from the previous operation by placing many squad-size ambushes near the MSR, and frequent H&I Fires on and near the MSR during the hours of darkness.

On three occasions the enemy attacked with company size strength. Sound defensive tactics and excellent air and artillery support defeated the enemy in each of these attacks.

During the period of 20-22 November, one company from the 1st Battalion, and one company from the RVN Regional Forces (RF Co. 116) were task organized, under the command of the 1st Battalion Executive Officer, to conduct a Cordon and Search Operation in the eastern part of Duc Duc District. Communication and control was achieved by placing liaison personnel with the Regional Force Company. The first day of operations resulted in two detainees, of which one was classified as IC and one as GD. On the second night, while in a defensive position, the Regional Force Company was attacked by an NVA company. This resulted in heavy losses to the enemy (19 KIA and 1 POW) while Regional Forces losses were light.

A highly successful company-sized attack was conducted in the eastern portion of the Battalion Area of Operations. The company employed surprise maneuvers and supporting arms to rout an estimated NVA company. The enemy suffered 37 KIA and 2 POW in the action, including one NVA platoon leader killed. Marine losses were 4 WIA.

Continued Battalion successes in this AO were a result of a combination of several factors. Aggressive small unit leadership was probably the major factor. In addition, the immediate assumption of command by junior lieutenants of two rifle companies when the company commanders were wounded in action prevented any loss of command leadership in difficult combat situations. Extensive night patrolling and company-sized night maneuvers followed by platoon daylight attacks kept the enemy off balance. Detailed search of objective areas proved to be well worth the time and personnel involved. Several enemy materiel caches were discovered, including one rice storage area containing 104 tons of rice.
