2. LOCATIONS

1. During the month of December, 1st Battalion, 5th Marines primarily operated in the Thuong Duc Valley and Charlie Ridge area. The Battalion had three permanent defensive perimeters to occupy and defend.

a. Hill 65 CM(877575) is the prominent terrain feature in the eastern portion of the valley. The Hill is occupied by the CP, H&S Company, one infantry company, Delta Battery 2/11, and 2nd Platoon 8" guns. Positions are under construction for one platoon of 175mm guns. The mission of the infantry on Hill 65 is primarily security. In addition the company conducts night and day activities, and provides security for road sweeps on Route 4 from Hill 37 to Hill 52. The bridge on Route 4 CM(866573) is defended 24 hours a day by Marines from Hill 65.

b. Hill 25 CM(839568). One platoon is located on Hill 25 reinforced by a section of 81mm mortars and one 106 Recoilless Rifle. The Marine unit in cooperation and coordination with a platoon from 193rd RF Company conduct category I and II operations along Route 4 and the Thuong Duc Valley.

c. Hill 52 CM(218553). One Company (-) in conjunction with the 193rd RF Company (-) occupies the commanding terrain feature at the western extrem-

ity of the AO. The Marines continually conduct patrols and operate in the foothills of Charlie Ridge and along Route 4. In addition, the Song Vu Gia is under constant surveillance to preclude the enemy from using the river as a LOC to the Arizona area.

Most of the month one company has operated throughout Charlie Ridge, a mountain mass characterized by steep hills and thick canopy. It is difficult to surreptitiously approach the enemy in this terrain because the number of avenues of approach are limited the the high ground provides the ability to observe troop movement from great distances.

## PART II

## NARRATIVE SUMMARY

During the past month, 1st Battalion, 5th Marines has had limited enemy contact and a reduced number of enemy kills. The Battalion used periods of the month for effectively training units for operations in mountainous jungle areas. A platoon or company operated on Charlie Ridge at all times except for the period 17 December through 23 December, when Charlie Company was OICON to 3/5 Command Group "B" employed as security for Liberty Bridge. The operations effectively served to interdict the Charlie Ridge trail complex into the DaNang vital area which is in the AO. On the 2nd of December, Bravo Company, Charlie Company, and a mobile CP, displaced rapidly on Charlie Ridge in response to an Intelligence Report from a Chieu Hoi that a large weapons cache was at the trail and creek junction AT831610. While Bravo Company was held up by booby traps and sniper fire, Charlie Company from a position on eastern Charlie Ridge, climbed to the top of Hill 722 by 1330 and Bravo Company rested Hill 886 by 1400 on the 3rd. With Bravo Company on 886, Charlie Company deployed 2nd Platoon to check out the area. An extensive search of the area was unable to disclose any caches.

Charlie Company left its 3rd Platoon reinforced on 722 and returned to Hill 65. Bravo Company and the jump CP remained one more night on 886 and were heli-lifted back to Hill 65 at mid-morning on the 4th.

While Charlie Company continued to keep a platoon on Charlie Ridge, Alpha Company assumed responsibility for Division Bald Eagle reaction commitment and the Regimental reserve. Bravo Company continued to operate from Hills 52 and 25 and Delta Company remained as An Hoa Base Defense Augmentation Company.

On the night of the 3rd, Hill 65 received 4 incoming 82mm rounds. On the night of the 6th, Bravo Company received an estimated 4-5 rounds of mortar fire. The rounds landed 150 meters outside the perimeter at Hill 52. Bravo Company rapidly responded with 60mm, 81mm, and an Arty mission on suspected grids with unknown results.

On the 7th, a squad from Charlie Company on Tam Hoi Bridge CM(866573) on route 4 was informed that 3 VC across the river wanted to Chieu Hoi. They sent a VN boat across the river and picked up the 3 Chieu Hoi's. Later that day 3rd Platoon Bravo Company, shot one of an unknown number of enemy in a camp site at coordinates 791584. They found an M1 carbine and medical gear. A large amount of shackle and crypto gear was recovered from the body of the dead NVA.

On the 8th, Alpha Company spotted one tiger (feline) at 210582. There were a few great white hunters who fired at him, but no war trophies were taken that day. 2nd Platoon, Bravo Company, while sweeping into the objective area where they had killed the NVA on the 7th, received CS gas fumes from an undetermined source to their north. No enemy contact was made but the area was searched out thoroughly but nothing significant was found.

Major General O.R. Simpson, rotating to CONUS after being Commanding General for 1st Marine Division for the past 12 months, came aboard and bid his farewell to the officers and men of 1/5.

Bravo Company exchanged missions and AO's with Delta Company. (Bravo Company as An Hoa Base Defense Augmentation and Delta as security for Hills 52 and 25). Alpha's 3rd Platoon moved onto Charlie Ridge to run aggressive patrols and night activities. On the 11th the P.F.s on Hill 52 took one Chieu Hoi who stated that an airstrike by the Marines killed ten of his comrades at 801539. The Operations Officer and other Battalion officers made a liaison visit to Thuong Duc DIDG camp (ZC140532).

3rd Platoon, Delta Company, while emplacing Mini SIDS, located a freshly dug tunnel at 798566. they also hit one booby trap, injuring 2 Marines. 3rd Platoon, Alpha Company, while set up on Charlie Ridge (872624) observed 20 VC/NVA moving west at (875625). An artillery fire mission was called an AO fired on-board ordnance on the target but the results could not be checked out because of darkness.

On the 13th Charlie Company and Alpha Company went on a joint operation to cordon and search the "Wishbone" Lake area in conjunction with one squad of P.F.s. The Marines provided the blocking forces and the P.F.s conducted a thorough search. The results were negative, security for a Recon diver team searching the lake tripped a 60mm, wounding 4 Marines.

On 14 December, 1969, two VC crossed over from the Arizona and surrendered to the Marines on Tam Hoi Bridge (AT866573).

1st Platoon, Alpha Company killed 1 VC/NVA while operating on Charlie Ridge on the 15th. He was eating chow and was flushed by the detonation of a hand grenade. When he ran from the Marines he was killed by small arms fire.

On the 17th, members of 3rd Platoon, Charlie Company were sent out in response to an intelligence report from the Loc My Village Chief that there were enemy in the area. On arriving in the area, vicinity 384557, the Marines spotted several children beginning to bury rice, fish, and kerosene. The children ran as the patrol approached. IOD was requested to scan the southern side of the river. In doing so they discovered 10 VC/NVA running south from the river bank. A subsequent fire mission (artillery) killed five of the fleeing enemy.

On the 21st, a truck resupplying Hills 52 and 25, following a road sweep detonated a 50-60lb. box mine. The truck was completely destroyed and 16 Marines were medevaced. A 4 ft. deep and 8 ft. wide crater was left in the middle of the road by the explosion. Subsequently five of the Marines died.

On the 22nd the road sweep on Route 4 observed a UNLH gunship drop out of the sky, rolling over on impact. The road sweep set up security around the helicopter and helped 3 wounded USMC into a chase plane which had landed at the scene of the incident. Earlier, Major General Wheeler, the new Commanding General of 1st Marine Division, had visited Hill 65 and inspected the area.

On the 23rd Major J.J. Sheridan supervised the distribution of gifts to approximately 1,000 Vietnamese who reside in the An Hoa area or who were patients at the German Hospital.

At 1800 on the 24th the Christmas cease fire went into effect. Numerous activations on the sensor devices were noted almost immediately after the cease fire began, conotating the enemy was still busy. Early Christmas morning found the Song Vu Gia dotted with small boats. Apper-

ently the enemy was using the cease fire to resupply troops in the Arizona with foodstuffs from civilians on the northern side of the river. A platoon from Delta Company on Hill 65 was sent down to investigate and the boat activity ceased abruptly.

On Christmas Day gifts were distributed by Special Services to all the Marines in 1st Battalion, 5th Marines. A turkey and roast beef dinner was superbly prepared by the Mess Sergeant, S/Sgt. Lescher and his cooks. The highlight of the day took place when gifts were given out by 1/5 to the Vietnamese children in the area by a Santa Claus bedecked in a red suit "constructed" from bright red mail sacks. Cease fire stopped at 1800 and fire missions began immediately.

On the 27th Alpha Company became OPCON to 5th Marines for An Hoa Base Defense Augmentation, simultaneously Bravo Company was heli-lifted to Hill 65 in preparation to conduct category II operations on Charlie Ridge vicinity AF870625 and conduct aggressive day and night acts to interdict LOC's through the AO toward the DaNang vital area. Charlie Company, Alpha Company and one platoon from the 193rd P.F.s conducted a cordon and search of HS NHA I AF8C5544. One NVA Captain Chieu Hoi'd from inside the village. A Med-Cap was held by the Battalion Medical Officer and his corpsmen in conjunction with S-5 at 863576. A total of 31 Vietnamese were treated.

Bravo Company moved to Charlie Ridge on 28 December. The 28th is the anniversary of the NVA Peoples Army, but the enemy did not choose to celebrate the occasion with any action, as had been anticipated. Bravo Company at 866628 on Charlie Ridge killed one NVA moving along a speed trail. In her pack, the dead enemy soldier was carrying rubber tubing believed to be used for tourniquets, and bottles of a clear solvent.

On the 31st, enemy movement was detected all around the AO after 1800. The Battalion was unable to take any responsive measures due to the cease fire.

1st Battalion, 5th Marines concluded a very rewarding and successful year of being actively engaged in offensive combat and defeating the enemy at every turn.

## PART III

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTSA. TOPICSPersonnel and Administration

a. Strength. The Battalion's strength at the beginning of the month was 37 officers and 1178 enlisted. On the 15th of the month, the strength had changed to 37 officers and 1101 enlisted. By the end of the month, the strength was 37 officers and 1137 enlisted. Presently there are two officers and 16 enlisted hospitalized.

b. Discipline, Law and Legal. Two Summary Courts-Martial, nine Special Courts-Martial, and one General Court-Martial were convened during December. During the same period, nine Company and three Battalion Office Hours (EOH) were also held. There were six completed investigations with three still pending for the month.

c. POW/Detainees. There were 12 detainees processed during this month. They were classified as follows:

d. Morale. Morale and fighting spirit continued to be excellent.

e. Postal. Postal service continued at the same degree of excellence.

f. Awards. During the month of December, there were 38 Navy Achievement medals, 10 Navy Commendation medals, and 8 Bronze Stars submitted for heroism and meritorious service. There were 27 meritorious promotions submitted and 10 meritorious combat promotions were approved.

g. Interior Management. Administrative procedures and proficiency continued to be excellent.

2. Enemy, Weather, and Terrain

a. Enemy. During the reporting period the enemy was a little more aggressive as noted by the box mine incident on the 21st. It is noted that 38 fire missions were called during this reporting period as a result of Sensor Activations in the lower slope of Charlie Ridge, primarily string #1. The resulting enemy casualties are unknown. Captured enemy documents, interrogation reports, and intelligence reports continue to indicate that the enemy is still hoping to launch offensive actions against the RVMAF forces during this Winter-Spring campaign, 69-70. However, it is doubtful that the enemy will be able to accomplish his mission on the

scale he desires due to hunger, disease and continuing low morale. The Battalion continues to thwart the enemy's ability to use mines and booby traps extensively by conducting an active program using V.I.P. funds to procure explosive ordnance throughout the AO. Leaflets are passed out and money is paid on the spot. Ordnance items are turned in almost daily through this program.

b. Weather. During this period, the weather was characterized by low ceilings, intermittent rain, and monsoonal mist which hampered our air operations, and restricted road travel due to erosion and wind.

c. Terrain. Unchanged.

#### ORGANIZATION AND OPERATIONS

a. Organization. The organization of the Battalion consisted of the following units being detached from the 1st Battalion and other units under operational control of the 1st Battalion during the following periods:

- (1) Company "D" 1/5 OPCON to 5th Marines from 0001 1 December 1969 to 1800 10 December 1969.
- (2) Company "B" 1/5 OPCON to 5th Marines from 1300 10 December 1969 to 1400 27 December 1969.
- (3) Company "A" 1/5 OPCON to 5th Marines from 1400 27 December 1969 to 2559 31 December 1969.
- (4) Company "C" 1/5 OPCON to 3/5 Command Group "B" 1500 17 December 1969 to 1500 23 December 1969.

b. Operations. 1st Battalion, 5th Marines from 2-4 December 1969 conducted a category II operation on Charlie Ridge. On 13 December 1969 1st Battalion, 5th Marines conducted a cordon and search of KA NH (I). The rest of the period was spent in rice denial and category I and II operations on Charlie Ridge and in the Thuong Duc Valley.

#### Supporting Arms

(1) Air. The Battalion continued to receive outstanding support from both the 1st MAW and the U.S.A.F. Since we operated from a static position in a pacified area, the overall level of support was lower than usual; but made good use of the A-6 radar beacon and added several innovations. First of all the Battalion relied more heavily on S-2 for target information since our units very seldom come into actual contact. The Battalion was able to place fire on a target within 12 hours of an S-2 report. Secondly, close coordination was developed with the IOD team from 11th Marines at Hill 65 to make corrections as small as 10 seconds of a degree radially and 20 meters in range distance on targets as far away as 7,000 meters. These improvements resulted in swifter, more accurate coverage of the targets selected. Target damage assessments were low due to the fact that the targets were hit in locations which could not be searched in a timely manner. A detailed report of air support rendered

during the month follows:

(a) Fixed Wing. A total of 55 flights of fixed wing were flown in support of this Battalion. 28 TACA aircraft provided 22.5 hours of direct support utilizing 3 flights of F-4s. There was one ground controlled flight of A-4s. A-6 beacon aircraft provided the bulk of our support with 21 missions. Basketball aircraft were utilized twice providing a total of 6.5 hours of illumination. The BDA from the above flight is tabulated as follows:

(c) Significant Developments. Although the Battalion remained in a relatively static posture throughout the month; the overall effective level of Air Support remained with the great majority of these strikes being flown against Intelligence targets in the Charlie Ridge area.

(2) Artillery. During the month of December the 1/5 AO continued to be along Charlie Ridge and Thuong Duc Valley to the south of the ridge.

Because of the pacified nature of a large portion of our AO, the majority of artillery effort has been in the improvement and usefulness of HEI fire. To this end the Bailey Team has worked closely with S-2 personnel to find the most current reports of enemy activity; the most used trails river crossings and harbor sites. Evidence exists that the efforts have been successful due to reports made by several Hoi Chanh to the effect that enemy forces along Charlie Ridge had sustained considerable losses as a result of HEI fire. From the 15th through and including the 30th, daytime HEI's were fired in the northwest portion of the 1/5 AO since no activities were allowed in the area for the period of time mentioned. Again these HEI's were worked-up in conjunction with S-2 personnel.

In order to make our HEI's even more effective they were carefully integrated with 81mm, 60mm, 106 RR, and, in some instances .50 caliber fire.

During December, Seismic Intrusion Devices (SIDS) were planted in the AO and though difficulty with clearances was at first experienced, these difficulties were overcome and artillery began firing on targets with VT, weather permitting, as activations were received.

In addition to H&I's, prep fires were called by F.O.s in support of their companies' activities. Forward observers also called several illumination missions in support of their companies for a total of 125 fire missions. Delta Battery provided excellent artillery support for 1/5 during the period with 105 and 155 Howitzers. In firing the above mentioned targets 9319 HE rounds were expended as well as 69 WP, and 59 illumination rounds. There were no confirmed artillery KIA's during this period. Artillery personnel manning the IOD tower logged a total of 48 KIA's, 16 probables, and 9 structures destroyed during the month. Their firing was done in the Arizona territory and Charlie Ridge area.

(3) Engineers. During the month of December the engineers of Company B, 1st Engineer Battalion operated out of the static positions occupied by the Battalion and attached to companies on search and destroy operations. The main body of Company B, 1st Engineers stayed with the Battalion on Hill 65, from this position their main activity was conducting road sweeps to Hills 37, 25, and 52, to discover any mines that had been laid along Route 4. On Hill 65 itself, the engineers have a continuous program of building ammo and fighting bunkers, improvement of living facilities, etc. Also in preparation for the movement of 175mm artillery pieces to Hill 65, the engineers and artillerymen have built two 20'x24' bunkers and pre-cut another 10'x24' which artillery personnel constructed.

(4) Shore Party (HST). HST's were provided by Company B, 1st Shore Party Battalion; they were primarily employed in coordinating and effecting Helicopter Medevacs, visual reconnaissance, and "Mission 14" resupply, on the various static positions and field operations of this Battalion.

(5) Scout Snipers. Detachment Scout Sniper Platoon, Headquarters Company, 5th Marines continued to provide outstanding support to the Battalion. Although the sniper did not register any kills during the past month, their support was excellent. They were utilized on O.P.s, patrols and tower watch at night and during the day.

(6) Motor Transportation. The 1st Battalion, 5th Marines has used their motor transport section, forward in numerous ways. Their services are used in the resupply of Hills 52 and 25. For the first 3 weeks of the month, two 6x6, M-35, 2½ ton trucks attached to 1/5 have resupplied the entire Battalion. This resupply included chow, ammo, building materials (i.e. wood, sand bags, wire, engineering stakes, etc.), personal gear, 782 gear, and water. The 4x4, M-151-A1, ½ ton trucks, and their M-416 trailers have performed a multi-purpose task. They have enabled the Battalion to remain self-sufficient by making it possible to transport personnel to and from DaNang and An Hoa, and have associated with the 6x6's to transport cargo over considerable distances. The M-274-A 2½ ton, platform truck has been invaluable to the Battalion. The mules have averaged over 6 hours of running time per mule, per day, transporting everything from ammo to water for the companies. The 1/5 motor transportation section forward has been running at optimum level of efficiency and has main-

tained a low deadline rate at the same time. Motor "T" personnel have not only kept the vehicles on the road, but have built several defensive fighting positions, a tire shop, maintenance shop, a shower, re-painted their living quarters and started building a lubrication rack and a POL rack. Two M116 "Huskies" were attached from 11th Motor Transport Battalion 1-10 December and were used to assist in resupplying Hills 52 and 25. These vehicles were extremely useful as the monsoons continued and the road was often hardly trafficable. However, they were retracted by 11th Motors due to other commitments within the Division.

(7) Tanks. Two flame tanks from Flame Platoon, 1st Tank Battalion provided excellent support on Hill 65. The tanks were used in the following manner:

- (1) Burning undergrowth and clearing fields of fire on sides of Hill 65.
- (2) Pulling out vehicles that were stuck in the mud along Route 4.
- (3) Provided .50 caliber machine gun fire to F&I along Charlie Ridge.

The major problem encountered with the tanks was the limited availability of napalm for the flame tanks to more effectively use this unit.

a. The following Training was conducted during the month.

- (1) Weapons Safety
- (2) Weapons Inspection, Care and Cleaning
- (3) Mapping and Compass
- (4) Leadership

b. All companies while providing security for Hill 65 continued to hold instruction and familiarization firing of all individual and crew served weapons.

c. A Mine/Booby trap lane was constructed by the Battalion at Hill 65. The lane will be used daily by one squad from the Battalion on a rotational basis. In addition all replacement personnel will be required to go through the lane as part of Battalion check-in procedures.

d. Replacement personnel received five (5) days training at 5th Marines Headquarters prior to being committed to the field.

e. The Battalion continued to utilize schools provided by higher Headquarters in the DaNang area and Okinawa. The value of the schools is recognized, however, this had an adverse effect on the rifle-companys in-the-field strength.

5. LOGISTICS. During the period 1-31 December 1969, this Battalion continued to operate from Hill 65 (AT878576). In addition to organic transportation, the Battalion utilized vehicles from Company A, 1st

Motor Transport Battalion. This normally consisted of three M35 trucks. Two of these vehicles were kept on Hill 65 where they were used as "House-keeping Vehicles" and for resupply. These trucks hauled Class I and V from DaNang, Class III from Hill 37 (AT915582), and were used for distributing all classes of supplies from Hill 65 to the company occupying Hills 52 (AT788552) and 25 (AT806553). The third truck came from An Hoa, and was used to transport Classes II and IV, mail, and personnel from An Hoa to Hill 65.

Two Mil6 "Huskies" were attached from 11th Motor Transport Battalion 1-10 December and were used to assist in resupplying Hills 52 and 25. These vehicles were extremely useful as the monsoons continued and the road was often hardly trafficable. However, they were retracted by 11th Motors due to other commitments within the Division.

The loss of the two "Huskies" hindered logistics operations and it was determined that available inorganic transportation assets were inadequate to support the Battalion by providing resupply, and transporting sufficient materials to make needed improvements in living and working spaces and field fortifications at Hill 65. Therefore, liaison was effected with the Division G-4 and FIC and arrangements were made to provide selective loading of FIC convoys carrying Class I and V supplies from DaNang, so that certain trucks, designated for 1/5 would separate themselves from the convoy at Hill 37 (AT915582) and proceed directly to Hill 65. Several problems were encountered in initiating the system. It had not worked adequately until 30 December 1969. The use of FIC vehicles made it possible for the 1st Motors vehicles to be more readily available for "Housekeeping" functions, and for resupply of Hills 52 and 25.

Field fortifications were improved considerably at Hill 65 with addition of wire, sandbags, and reinforcement of bunkers.

6. CIVIC ACTION. General: On the morning of the 25th of December the S-5 section attended a Christmas gathering at the Protestant Church in Truong An Hamlet (AT868574). In the afternoon, a Christmas Party was given on Hill 65 for 20 children from Loc My Village, 15 from Loc An, and 15 from Loc Quang. Each child was accompanied by a Marine and was given a present. Refreshments were served and Lt. Col. Griffis expressed our Christmas greetings to the Village Chief of Loc An and representatives from Loc My and Loc Quang, who returned Vietnamese greetings to the Marines. A gift of a set of tools was presented to each village representative as a token of friendship of the American people.

General Walt Scholarships: Eighteen elementary level students received 500,000VN each for the month of December. This was the last month of the four month scholarships.

**Medical Assistance.** Six Med-Caps were held - two at Ha Nha Hamlet (AT788-548) with 262 persons treated, Nghia Tay Hamlet (AT883585) with 50 persons treated, Tam Hoa Hamlet (AT863573) with 110 persons treated, Truong An Hamlet (AT868574) with 93 persons treated, and Song Binh Hamlet (AT876579) with 24 persons treated.

The Battalion Aid Station gave treatment to an average of 20 persons per week and 4 persons were evacuated to DaNang for further treatment.

**Industrial Relation Activities:** A Vietnamese gift shop contracted with a PX system was brought aboard the Hill 65 Cantonment.

**7. PSYCHOLOGICAL OPERATIONS:** Eight aerial leaflet drops were used in the Valley between Hill 52 and Hill 65 and over Charlie Ridge. The primary messages were Chieu Hoi and the V.I.P. Program.

Two aerial broadcasts were used in the Vu Gia River Valley carrying a Pro GVN message.

An audio-visual team showed 2 hours of movies at Truong An Hamlet, consisting of "Transportation - USA", 2 Vietnamese comedies, and a film showing Vietnamese Forces in action.

**8. COMMUNICATIONS.** Several innovations were made in communications during the month of December. On the 10th, in accordance with Division directives, the Battalion began employing secure voice transmission on equipment (cipher) on its chief tactical nets. No problems were encountered in initiating cipher procedures. All Communications Platoon personnel had received ample training after a partial issue of cipher equipment was made several months ago. Company officers and NCO's were given special briefings and instruction on capabilities, logistical requirements, and physical safeguards associated with the secure voice program.

The tech shop and message center also made important additions to their capabilities this month. The technicians built a hot locker, an essential item for preventing corrosion and electrical shorts in communications gear during the monsoon season. The message center had difficulty towards the end of the month maintaining its teletype link with regiment. To combat this frequent loss of a valuable communications link, message center personnel are now establishing an alternate route through the Battalion rear. When not needed for the transmission of tactical teletype traffic, the new station will be used for training purposes.

At the forward base, all communicators joined the general effort to "harden" living quarters and add supplementary positions on the perimeter. As the much-needed blast walls, bunkers, and fighting holes neared completion in the latter part of the month, daily classes were organized on subjects including weapons safety, electrical safety, malaria prevention, and safeguarding classified material.
