Company A assumed responsibility of Division Ridge on 9 January 1971 and was relieved by Company D on 30 January 1971. From 1-7 January 1971, Company C was located in the Que Son Mountains and on 7 January 1971 was returned to Hill 34. Company B remained in the Que Son Mountains from 10-31 January 1971 and was relieved by Company A on 31 January 1971 and returned to Hill 34.

NARRATIVE SUMMARY

During the month of January 1971 the Battalion continued Operation "IMPERIAL LAKE" in the Que Son Mountain area with two companies and a forward command group through 8 January. The command group returned to the rear cantonment on that date and one company remained on the operation under the operational control of the 2nd Battalion, 5th Marines. Security for the Division rear area and defense of the battalion area of operation was accomplished by two companies until 8 January and by three companies from 9-31 January.


On 9 January the battalion assumed responsibility for Hill 327, adjacent to Division Ridge complex and formerly occupied by MASS-3 of MACG-18. Units of the ASRT, 11th Marines and 1st Marines occupy the hill as tenants. On 31 January, security was provided for the USO sponsored "Miss Black America" show at Freedom Hill.

From 9 January to 30 January, Company A was assigned responsibility for Division Ridge (Hill 244) in defense of the Division CP. The company received extensive training in military subjects during the day and continued the repair of all defensive positions. On 29 January at about 1950 hours, the Assistant Division Commander visited Company A and observed a final protective fire demonstration. On 30 January 1971 Company A was relieved of the security of Division Ridge by Company D, and returned to Hill 34 in preparation for deployment to the Que Son Mountains. Prior to deployment on 31 January 1971, all Company A personnel received a class on Land Mine Warfare provided by a Contact Team from 1st Engineer Battalion.

Company B was engaged in defensive operations from 1-9 January on Division Ridge (Hill 244) and continued to improve the defense and conduct routine training. On 9 January, Company B returned to Hill 34 and prepared for assignment in the Que Son Mountains. Company B was helilifted into the operating area of "IMPERIAL LAKE" on 10 January and relieved Company D, assigned under operational control of the 2nd Battalion, 5th Marines.

On 1 January 1971, Company C's 2nd Platoon, (operating in the Que Son Mountains "IMPERIAL LAKE") discovered a cave containing one LAAW, three NVA E-tools and miscellaneous equipment. The equipment was destroyed and the cave was interdicted with CS crystals. 1st and 3rd platoons had several sightings and fired 60mm mortars without results. On 2 January 1971, C-2 platoon spotted one VC/NVA soldier carrying a pack. The enemy attempted to flee but was shot and found to have rice, tobacco, and salt in his possession. The body and supplies were returned to the CP. C-2 fire team patrol discovered a cave four feet high, three feet wide and 75 feet deep with smaller caves on both sides. They located one bicycle sprocket inside and destroyed it in place. The caves were interdicted with CS Crystals. At 2100, 4 January 1971, 2nd platoon squad ambush was fired upon by the enemy with an M16 rifle. The ambush returned fire and contact was broken immediately. The area was searched with negative results. On 5 January 1971, 2nd platoon discovered one VC/NVA base camp that had not been used recently. The large tunnel complex contained one 81mm mortar round, one



knife and sheath, one US gas mask, five pounds of tobacco and miscellaneous other supplies. Cave was interdicted with CS crystals. A squad patrol from 3rd platoon found a cave complex containing three M16 rifles, one ChiCom medical kit, grenades and green utilities. The grenades were destroyed and other equipment was sent to the platoon CP. Caves were seeded with CS crystals. CS crystals were spread at the base camp which was found on 22 December 1970 by the 1st platoon. The company continued without contact, findings or sightings through 6 January 1971. Company C was extracted at 1030 on 7 January and returned to Hill 34 (LZ469). Total enemy losses were one enemy killed. All caves discovered were interdicted with CS crystals and all supplies and equipment not of intelligence value were destroyed. On 9 January 1971, one squad from 1st platoon was inserted in Rumor Valley under operational control of Company A and conducted search and clear operations with daylight patrols and night ambushes. The 2nd platoon assumed responsibility for the external security of Force Logistic Command and nearby camps. The 3rd platoon was moved to Hill 327 for security of the cantonment. For the TET high threat period, the 1st platoon in Rumor Valley was deployed to FLC to augment the patrolling responsibility for the area and one squad from the 3rd platoon was moved to Camp VIKING to provide a reaction force for that camp. On 30 January 1971, two squads were removed from FLC and inserted in Rumor Valley for patrolling and ambush activities for the remainder of the month. During the period 7-31 January 1971, Company C conducted 78 daylight patrols, 83 night ambushes, ten night listening posts and ten daylight observation posts from Hill 327, FLC, and Rumor Valley.

Company D on Operation "IMPERIAL LAKE", on 1 January 1971, located a "Bouncing Betty" pressure release type booby trap that had been set from two weeks to two months prior to discovery. Attached engineers destroyed the booby trap in place. The morning of 2 January 1971, a squad from 1st platoon located a cave with a tunnel 30 feet long. The tunnel and cave complex were contaminated with CS crystals. At 1400 on 2 January, a squad from 2nd platoon discovered a cave complex with evidence of recent use by the enemy. Inside the caves were found soap, mosquito net, hammock, cooking pots, E-tool, jungle knife, fifty pounds of yellow corn, one ChiCom grenade, and one can of corn oil. The corn oil and the ChiCom were destroyed and the other supplies were sent to the platoon CP. Caves were contaminated with CS crystals. At 1745, the 2nd platoon had enemy movement outside the PPB lines. Unit initiated contact with M79 HE and small arms fire and the area was searched with negative results.

At 1100 on 3 January 1971, one squad from 1st platoon found one US M173A1 mine. The mine was not booby trapped and was destroyed in place. The immediate area was swept with negative results and with no signs of enemy presence. At 1400, a 3rd platoon squad located a two story cave

numerous tunnels leading in all directions. Old blood stained bandages were found but no recent use by the enemy was noted. All caves and tunnels were contaminated with CS crystals. At 1600 on 4 January 1971, a squad from 2nd platoon located a complex of caves. The cave complex was suspected to be a communications center. No extensive use by the enemy was evidenced within the last two months, but possible use within the last 24 hours by a small detail was noted. Located were radio jacks, headsets with Chinese writing, 25 pounds of salt, four pounds of tea, old BA-30 batteries, 15 BA-386 batteries, all sizes of cooking pots, one US case for a starlight scope with serial number 212248, and AK47 ammunition. The communication equipment and starlight scope case were taken to the platoon CP. Other supplies were destroyed and the caves were contaminated with CS crystals. At 1630, 1st platoon returned to previously used PPB and found one LAAW, a nine volt battery, three mosquito nets, and one knife handle with the name "DUONG SON". At 2130, 1st platoon in an night ambush heard movement and opened fire with small arms. The ambush returned to the PPB. The Platoon Commander requested 81mm mortar illumination to check the area, with no immediate results. 1st platoon observed lights and heard sticks being banged together north of the PPB. Artillery HE and illumination were fired on the enemy position. The lights were seen moving northeast. The patrol searched the impact area on the next morning and found fresh footprints, two bottles of penicillin, two hypodermic needles (all US made), and one poncho (NVA). At 1400 on 5 January 1971, a squad from 2nd platoon located a cave complex of average size (6x10). Unit also located an air parachute illumination canister, US canteen and cover, NVA belts, and assorted cooking utensils. The unit later located another cave with no significant findings and no evidence of enemy use. Continuing search of the route, the patrol found a cave complex that appeared to be an enemy officer quarters by the quality of conveniences such as wooden floors and stairs. In these caves were located sheets of paper with Vietnamese writing (later turned over to S-2). The unit located canteens, a US canteen cup, a US machette, a US mess kit, NVA belts, one dress belt with buckle, and one NVA helmet. The equipment was destroyed and the patrol employed CS crystals in the cave complex. At 2000, the second platoon received one incoming ChiCom grenade on the east side of the perimeter and spotted two VC fleeing from the area. Unit opened fire with small arms and M79 with no apparent results. At 1130 on 6 January 1971, 1st platoon squad patrol found a possible sleeping area for two people and one VC/NVA eye glass case with no identifying marks. At 1320, 3rd platoon was checking area of possible future ambush site when the point man detonated a booby trap receiving two small fragmentation wounds. There were no further findings and the patrol returned to the PPB with the wounded Marine. On 7 January 1971, the 2nd platoon squad patrol was enroute to search a suspected enemy area while the PPB provided security for the patrol from the high ground. The PPB observed enemy fleeing the area and fired machineguns and small arms. The enemy returned fire with approximately 20 rounds of AK47 fire at the patrol. The patrol returned fire, advanced to a treeline, and swept the area with negative results. The patrol continued with it's mission. The Platoon Commander requested a Cobra air strike on the area.

The Cobra pilot observed one VC/NVA after completion of the air strike. A patrol was sent to search the area but returned to PPB with negative results. Through the period 8-9 January 1971, Company D had no contacts, sightings, or findings. On the morning of the tenth, Company D was extracted and returned to Hill 34 (LZ469). Company D remained on Hill 34 in a Quick Reaction Force assignment until 30 January, at which time the company displaced to Division Ridge and assumed responsibility for the defense of that area. The 1st platoon was assigned SPARROW HAWK responsibility from 15-17 January during a visit by the Commandant of the Marine Corps, but was not committed in that role. On 19 January 1971, the 3rd platoon was tasked the mission to search and clear the Rumor Valley area in order to exploit recent intelligence received of enemy activity in that area. At 1230 on 19 January 1971, the 3rd platoon located an old booby trap in Rumor Valley. The attached engineer destroyed the booby trap in place and the unit continued the mission. At 1330, two detainees with loaded M1 carbines were apprehended and questioned by the attached S-2 scouts and ITT. Both were held overnight with one being released the following morning. The second was returned to CIT for further investigation. On 23 January to 25 January 1971, the 2nd platoon was OPCON to Company A and continued operating in Rumor Valley.

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS1. PERSONNEL AND ADMINISTRATION

a. Strength. The Battalion strength at the beginning of the month was 37 officers and 1097 enlisted. On the 15th of the month the strength was 36 officers and 1063 enlisted. By the end of the month the strength was 41 officers and 1068 enlisted. On the last day of the month there were nine enlisted hospitalized.

b. Discipline, Law, and Legal. During January, seven Special and one General Court-Martial were recommended to Division, and one Summary Court-Martial convened by this headquarters. There were 17 Office Hours referred to the Battalion Commander and 16 Office Hours were completed at the company level. Six investigations were completed and ten are still pending.

d. Morale. Morale and fighting spirit continue to be excellent.

e. Postal. Postal service continued at the same degree of excellence.

f. Awards. During January, five Bronze Stars, 14 Navy Commendation, 21 Navy Achievement, and one Navy - Marine Corps Medal were submitted. There was one Silver Star, one Bronze Star, one Navy - Marine Corps Medal, three Navy Commendation, six Vietnamese Cross of Gallantry, and eight Purple Hearts received approved in the month of January. There were two Meritorious Mast, and three meritorious promotions to Corporal during this reporting period.

2. ENEMY, WEATHER AND TERRAIN

a. Intelligence. During the reporting period two agent/source reports were received and acted upon. On 24 January, a team consisting of representatives of 3rd CIT, 11th Motors, and 1st Battalion, 5th Marines S-2, acting on a reliable source report, entered KHANH SON HAMLET at grid (AT950765) to check on VC presence, and met with negative results. On 31 January, a platoon from Company C along with members of 3rd ITT and Battalion S-2 swept through the village of AP HOA KHUONG (AT945730) with negative results.

b. Enemy. During the period 1-8 January, (Operation "IMPERIAL LAKE", OPCON Fifth Marines) there were three contacts, of which one was friendly initiated and two were enemy initiated. There were two booby traps discovered and one additional booby trap detonated. A total of three enemy were sighted. There was one VC KIA. For the remainder of this reporting period tactical elements of this Battalion were under operational control of other commands.

(1) Scout Section. S-2 Scouts continue to be assigned to companies on an as required basis. Presently there are six Scouts and four Kit Carson Scouts assigned to the companies in the field.

c. Weather. During the reporting period weather consisted mainly of light rain, low cloudiness, and poor visibility.

(1) During the month of January 1971, 1st Battalion, 5th Marines was involved in Operation "IMPERIAL LAKE" with two companies and a forward CP group OPCON to the 5th Marine Regiment from 1-8 January 1971. From 8-31 January 1971, 1st Battalion, 5th Marines had one company OPCON to 2nd Battalion, 5th Marines "IMPERIAL LAKE".

(2) Security of Division Rear and defense of the Battalion area of operation was conducted with two companies from 1-7 January 1971 and with three companies from 7-31 January 1971. On 9 January, the Battalion assumed responsibility for Hill 327 adjacent to the Division Ridge complex.

4. SUPPORTING ARMS

a. Air

(1) Troop helilift and resupply missions in support of Operation "IMPERIAL LAKE" accounted for 90 percent of all air used by this Battalion during the month of January 1971. Tactical air support for the companies OPCON to the 2nd Battalion, 5th Marines was requested through the 5th Marine Regiment and consisted mainly of the Mission 86 (administrative) package.



MORE GOOD SCOOP FROM THE X0

Proficiency marks are the subject of this final article concerning 'Pro and Con' marks and the compilation of your "cutting score." Remember, a 3.5 proficiency mark is necessary for an Honorable Discharge.

PROFICIENCY

<u>MARK</u>	<u>RATING</u>	<u>STANDARD</u>
0 to 1.9	Unsat	Does unacceptable work in most of his duties, generally undependable; needs considerable assistance and close supervision.
2 to 2.9	Poor	Does acceptable work in some of his duties but cannot be depended upon. Needs assistance and close supervision.
3. to 3.9	Fair	Handles routine matters acceptably but needs close supervision when performing duties not of a routine nature.
4 to 4.4	Good	Can be depended upon to discharge regular duties thoroughly and competently.
4.5 to 4.8	Excellent	Does excellent work in all regular duties, but needs assistance in dealing with extremely difficult or unusual assignments.
4.9 to 5	Outstanding	Does superior work in all of his duties. Even extremely difficult or unusual assignments can be given to him with full confidence that they will be handled in a thoroughly competent manner.

Any Marine who follows his oath of enlistment should have no difficulty in obtaining those marks which will assure promotion and an Honorable Discharge. The requirements are comparatively easy -- much easier than in civilian life. Regardless of how an other than honorable discharge affects your future -- jobs, schools, etc., or whether you just consider it an easy way out, it means one thing above all else: a personal failure on the part of the individual Marine. To fail while in the Marine Corps is difficult -- to succeed takes personal pride and push, but it is the best road.

"I do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to the regulations and the Uniform Code of Military Justice. So help me God."

HISTORY OF FIRST BATTALION, FIFTH MARINES

PART II

Following World War II, as part of the Regiment, the First Battalion went to China for occupation duty. In October 1949, they returned to Camp Pendleton, Calif. and stayed at that training base until the Communists crossed the 38th Parallel in Korea in mid-1950. As part of the 1st Provisional Brigade, they landed at Pusan, Korea a short while later. They served for a short time on the Pusan Perimeter and then joined the rest of the 1st Division to make the amphibious assault on Inchon and Wonsan. In November 1950, the 1st Battalion, along with the 1st Division, having been cut off by the Communists at the Chosin Reservoir, along with 2/5 and 3/5 made the deepest penetration inside enemy lines south of the Yalu River. Following the break-out at Chosin, after a short rest, the Battalion joined the rest of the Allied Forces in Central Korea to participate in operations against the Communists in 1951. With the Regiment, they also participated in many battles on positions with names such as Reno, Carson, Vegas, etc. The 1st Battalion, 5th Marines returned to Camp Pendleton from overseas in February 1955.

From 1959 to 1965, the Battalion was designated as Battalion Landing Team 1/5 and continually rotated as part of the transplacement program between the 1st Marine Division at Camp Pendleton, California and the 3rd Marine Division on Okinawa. On 1 July 1965 the BLT sailed from Long Beach, California to Kaneohe Bay, Hawaii, and became a part of the 1st Marine Brigade. The Battalion underwent an extensive training cycle prior to sailing for South Vietnam on 22 February 1966. On 3 March 1966 the BLT began preparation for Operation "Jackstay" in the Rung Sat Special Zone. The area of operation (in the Saigon River Delta) was one of the worst mangrove swamps ever encountered by Marines. From 26 March until 6 April 1966 the BLT captured and destroyed numerous munition factories, repair shops and a large VC hospital plus hundreds of thousands of rounds of various types of ammunition. Three weeks later found the BLT again hitting the beaches of Phu Loc on Operation "Osage". The BLT came ashore permanently on 2 May 1966. After sending all attached units back to their parent organizations, the Battalion became OPCON to the 7th Marines for Operation "Montgomery", which lasted from 6 May 1966 to 14 May 1966. On 15 May 1966 the Battalion moved to a Combat Base on Hill 54, twelve miles north of Chu Lai. The Battalion conducted nine battalion size operations and numerous company size and platoon size operations, in addition to continuous patrol activities within the TAOR. On 10 August 1966, while on Operation "Colorado", the Battalion became engaged with two Main Force North Vietnamese Battalions. After a five hour engagement, the enemy broke contact, leaving 236 dead. The Battalion also participated in Operations "Dover", "Sutter" and "Napa".

On 7 February 1967 1/5 participated in Operation "Clay" in the Pineapple Forest north of the Provincial Capital, Tam Ky. Again, on 17 February, 1/5 was committed to Operation "Rio Grande" in the southern portion of I Corps, south of Quang Ngai. On 5 March 1967, 1/5, along with 3/5, was chopped back to the 5th Marine Regiment from the 7th Marine Regiment, therefore being relieved of the possibility of returning to 7th Marines area south of Chu Lai. At this point 1/5 was able to work their TAOR more effectively. Although they still maintained one Company as part of the Chu Lai Defense Command to secure the perimeter around the air strip, 1/5, always on the alert to help allies in the area, conducted numerous Platoon (+) and Company (-) activities in order to hold a firm control of the Battalion TAOR. Working their TAOR on 12 March 1967, 1/5 participated in Operation "Tippicanoe" in the westernmost area of the TAOR. The end of the seasonal monsoon saw 1/5 working its TAOR with constant, aggressive patrols through late April.

SGTMAJ NEVEU's NOTES

Listed below are important excerpts from Division Order 1020.1G, Div Uniform Regulations:

All items of clothing will be clean and properly maintained. Personnel will be clean shaven, operational commitments permitting. It is recognized that under combat conditions standards of appearance must be adjusted to compensate for lack of time, water and facilities; however, when not exposed on a prolonged basis to this situation, all hands are expected to present a neat military appearance. Conversely, this Order is not intended to alter the accepted rules of camouflage in required areas.

(1) Haircuts. Reference (b) prescribes that hair shall be worn neatly and closely trimmed. It shall be clipped at the sides and back so as present an evenly graduated appearance. The hair at the top must not be over 3 inches in length. Long or conspicuous sideburns are prohibited. The afro natural haircut is authorized provided it conforms to aforementioned standards. Navy personnel wearing the MARCOR uniform while assigned to a MARCOR unit shall abide by the grooming standards for Marines. However, Navy personnel authorized to wear the Navy uniform while assigned to a MARCOR unit are governed by Navy grooming regulations. Conversely, local orders shall not prohibit personnel from wearing their hair to the limits authorized.

d. Jewelry. The only items of jewelry that may be worn in conjunction with the uniform are wrist watches and inconspicuous rings. Religious medals and medallions suspended on inconspicuous chains and beads may be worn around the neck, similar to the standard identification tags; however, they will remain concealed under either the coat or undershirt.

e. Sun Glasses. Sun glasses may be worn on leave, liberty or in garrison, but not in formation with troops. Sun glasses, when worn, shall be conservative in appearance. Chains or ribbons will not be attached to sun glasses. Personnel required to wear subscription glasses may wear an inconspicuous elastic band for the purpose of holding glasses in place.

f. Miscellaneous.. No articles, such as pencils, pens, watch chains, fobs, pins, jewelry, handkerchief, combs, cigars, cigarettes, pipes, or similar items shall be worn or carried exposed upon the uniform.

SCOOP FROM THE SECTIONSS-1DUTY STATION EXCHANGE PROGRAM
(MCO 1301.18)

Although individual preference of duty is a major consideration in determining future assignments for Marines, it frequently occurs that personnel must be assigned to locations and duty not of their choosing due to Marine Corps needs and the constraints of individual and billet availability. Where such assignments have to be effected, it has been determined that the situation occasionally exists where two individuals have been ordered to duty stations which they could mutually agree to exchange while continuing to satisfy Marine Corps requirements at each station. The afore-mentioned order provides the means for such exchange.

Personnel are authorized to request exchange of duty provided the following criteria are set:

1. Individuals concerned are of same grade and possess an MCS compatible with the duty assignment and mutually agree to exchange future assignments.
2. Both are in receipt of orders and have not moved dependents or personal effects at Government expense in conjunction with those orders.
3. Both have sufficient active service remaining to meet tour length requirements for the duty stations under consideration.
4. If the proposed exchange involves one unaccompanied WestPac assignment, both assignments in question must be unaccompanied in WestPac.
5. Both individuals must meet all essential assignment criteria for duty stations to be exchanged.

If you find someone willing to change assignments and you meet all of the prerequisites mentioned above, see your Company First Sergeant for administrative assistance in submitting your request.

1. Purpose. To publish instructions for the Combat Operations Center (COC) of the 1st Battalion, 5th Marines in the event of mortar, artillery and/or rocket attack on DaNang Air Base or other critical targets within the Division AO in accordance with reference (a).

2. Cancellation. SSDCO 3120.3F.

3. Background. In the event of an attack, it is the responsibility of this headquarters to alert/notify appropriate personnel and units immediately and to coordinate reaction within the sector.

4. Action. The Watch Officer in the Combat Operation Center, upon receiving an initial report of mortar, artillery and/or rocket attack on DaNang Air Base or targets within the sector, will initiate the following action:

a. If rounds have not impacted yet, or if rounds are impacting within the 1/5 cantonment, contact alternate COC and sound COC alert siren. NOTE: If impact outside Hill 34 is reported, there is no need to sound the alert.

b. Notify Division COC (Hot Line) where the alert came from, azimuth and approximate range. Maintain contact with the Division COC and pass on all pertinent information. Ensure the reports are complete, factual and promptly forwarded.

c. Contact OP's HAWK, CONDOR and TIGER for azimuths and send azimuth and grid of possible launch site to Division. (Use artillery radio for this).

- d. Call Hill 327, Division Ridge, and Rumor Valley for azimuths to possible launch sites and azimuths to impacts.
- e. Notify those personnel and units specified in enclosure (1) expeditiously, in the sequence listed. Use communications facilities listed, or fastest means available.
- f. Insure that a chronological record of reports received and actions taken is kept, beginning with initial notification of attack (S-3 Journal Clerk should do this).
- g. Sound the all clear only when directed.



The Secretary of the Navy presented the MERITORIOUS UNIT COMMENDATION to 1/5 for service as set forth in the following citation:

For exceptionally meritorious service from 7 to 12 June 1969 while engaged with enemy forces in QuangNam Province, Republic of Vietnam. During the early part of June 1969, captured documents, prisoners of war, and other reliable sources indicated that the 90th North Vietnamese Army Regiment was operating in the mountains adjacent to the "Arizona Area" with the mission to annihilate the Marine Battalion located there. Once accomplished, the 90th Regiment was to join with the 111st North Vietnamese Army Regiment to attack the Marine Combat Base at An Hoa. Alerted by this intelligence, the Fifth Marines (-) (Reinforced) commenced operations to find, fix, and destroy elements of the 90th North Vietnamese Army Regiment. Imbued with an unrelenting combat spirit, the Marines of the First Battalion, Fifth Marines patrolled day and night in search of the enemy that was attempting to rout them. Contact increased at every level until it became evident that the First Battalion, Fifth Marines had succeeded in locating at least one battalion of the 90th North Vietnamese Regiment. Every supporting arm was brought to bear on the enemy's positions, relentlessly pounded them, and sealed off all avenues of escape. On the morning of 12 June 1969, the remnants of the 90th North Vietnamese Regiment fled to the mountains a defeated and ineffectual combat organization. Behind them they left 275 North Vietnamese Army bodies, innumerable individual and crew-served weapons as well as irrefutable evidence that many other bodies had been dragged from the battlefield during darkness. All this was accomplished with relatively light Marine casualties. Through their continuous display of professionalism, resourcefulness, and bold courage in the face of overwhelming, numerically superior enemy forces, the officers and men of the First Battalion, Fifth Marines demonstrated performance in combat that was in keeping with the highest traditions of the Marine Corps and the United States Naval Service.

This award was presented by MajGen C.F. WIDDECKE, USMC, CG, First Marine Division, to 1/5 on 30 January 1971.

A HISTORY OF FIRST BATTALION, FIFTH MARINES - PART I

The history of the 1st Battalion, 5th Marines dates back to 13 July 1914. The battalion was formed in Vera Cruz, Mexico as a part of the 5th Marine Regiment. They served their first 2 years as a battalion in Haiti and Santo Domingo. The 5th Marine Regiment was disbanded in 1916. Less than a year later, on 27 May 1917, President WILSON issued orders to re-organize the regiment for duty with the U.S. Army in France. At this time 1/5 was reformed from remnants of the Old Fifth Marines, who had served in Haiti and Santo Domingo. The other two battalions were formed at Norfolk, Va. and the remainder of the regiment came from Pensacola and Quantico. In June 1917 the regiment sailed for France and in less than a month they were ready for action. The Marines were among the first troops to land at St. Nazaire. On 6 June 1918 the Fifth Marines and other units of the Marine Brigade captured Hill 142 in

the Chateau Thierry Sector. Following this action and for the next 3 weeks, Leathernecks of 1/5 fought in the Battle of Belleau Wood. For their action in this battle, the French Government twice recognized the ability of the Marines by renaming Bois Du Belleau to Bois DeLa Brigade De Marines. The Fifth Regiment was cited in French General Army Orders. The Germans, in grudging tribute to the Marines, gave them the name "Devil Dogs" after the Belleau Woods Battle. The Fifth Marine Regiment was awarded the French Fourragere in the Red and Green colors of the Croix De Guerre, a distinction which is still evident on the uniform of all members of the 5th Regiment. Following their return to the USA on 9 August 1919, the regiment was again disbanded. Within less than a year, the regiment was re-organized at Quantico, with the 1st Battalion, 5th Marines given the assignment of guarding Post Offices and mail distribution throughout the U.S. until March 1922. In the latter part of 1926, as part of the 5th Marines, 1/5 was sent to Nicaragua and fought bandits until January 1933. In December 1933, the unit became part of the FMF and remained at Quantico until the outbreak of World War II. A month after the Pearl Harbor attack, the 1st Battalion was detached from the Regiment and became the 1st Raider Battalion. A new battalion was formed with recruits from Parris Island, South Carolina and Marines from other battalions of the Regiment. During World War II, 1/5 participated in landings at Cape Gloucester, Guadalcanal, Peleliu, and in the Okinawa Campaign. On 29 May 1945, 1/5 seized Shuri Castle, one-time seat of Okinawa's rulers and Headquarters for the Japanese 32nd Army.

STRAIGHT SCOOP from the XO

A continuation of the promotion picture, initiated in our last issue, follows: This time take a look at the grading system for your conduct marks. As you saw in the last edition - your conduct marking is quite an important part of your cutting score. You can readily see that it is difficult to perform in an Unsat or Poor manner, that it is easy to perform in the Fair to Good category, and that it takes real work to perform in the Excellent to Outstanding area. An average of 4.0 in conduct is absolutely necessary for an Honorable Discharge.

(a) Unsat (0 to 1.9). Habitual offender, or convicted by special or more than one summary court-martial. If an unsatisfactory mark is given on the basis other than entries on page 12 or 13, an explanatory entry shall be made on the first line after the mark. A Mark of "0" shall be given upon declaration of desertion and for any period of confinement pursuant to sentence of a general court-martial.

(b) Poor (2 to 2.9). No special and not more than one summary court-martial, or two non-judicial punishments that involve confinement or reduction in grade. Considered to meet minimum standards.

(c) Fair (3 to 3.9). No court-martial and not more than one non-judicial punishment. Conduct such as not to impair appreciably his own usefulness or the efficiency of the command.

(d) Good (4 to 4.4). No offenses. No unfavorable impressions as to attitude, interest, cooperation, obedience, after-effects of intemperance, courtesy and consideration, and observance of regulations.

(e) Excellent (4.5 to 4.8). No offenses. Positive, favorable impression of the qualities listed in subparagraph (d), above. Demonstrated reliability, good influence, sobriety, obedience and industry.

(f) Outstanding (4.9 to 5). No offenses. Exhibits to an outstanding degree the qualities listed in subparagraph (d). Observes spirit as well as letter of orders and regulations. Demonstrated positive effect on others by example and persuasion.



Commercial Airlines have recently reported an upsurge in recent weeks of military personnel requesting reduced Standby and Reservation fares without the REQUIRED DD Form 1580 in their possession. Recent changes to Service policies by which formal orders for week-end leave are no longer required may tend to increase this problem. DD Form 1580 is necessary for military personnel desiring to avail themselves of reduced air fares for leave travel. So, if you don't want to have to pay the full price or be left standing watching that big silver bird take off without you, make sure that you have the DD Form 1580 in your possession. The requirement is a provision of carrier tariffs which have a full force and effect of law. Airline personnel have no alternative.

S-1 (cont'd): All Marines in RVN in receipt of permanent change of station (PCS) orders are entitled to ship personal effects (unaccompanied baggage) to their home or new duty station. Personnel in receipt of movement orders (orders issued for bulk movement of personnel) are only allowed to ship their personal effects to designated next duty station. Weight allowances for PCS and Movement Orders are as follows:

E-4 over 4 years of service and above, regardless of rank....1,000 lbs net
E-4 and under 4 years service and below.....200 lbs net

Personnel must have orders. Seven copies are required by the Household Goods Office. Additionally, in accordance with MCDO 4650.33, a copy of the individual's orders must be placed in each shipping container.

Personal Effects to be shipped must personally be delivered by owner to Personal Property Branch (Warehouse No. 2) of U.S. Army Support Command, located adjacent to the old Danang Air Force Base PX. The office is open 0730 to 1700 Monday through Saturday.

It is strongly recommended that personnel do not purchase Vietnamese made foot-lockers for the purpose of shipping gear as they afford little protection against damage in shipment. Complete packing and crating is provided.

All baggage is Customs inspected. Personnel cannot ship items forbidden by law out of country. War Trophy Firearms must be hand carried and cannot be shipped as unaccompanied personal effects.

Shipping time averages about 30 days to the West Coast, so plan ahead and ship early. Division Supply will be providing transportation during standdown.
