

NARRATIVE SUMMARY

During December the 7th Communication Battalion remained heavily committed in its support role for the 1st Marine Division, 3rd Marine Division, III MAF, the 1st Marine Air Wing, Task Force X-Ray, Chu Lai Defense Command, and the 2nd Korean Marine Brigade.

On 12 December a 13 man detachment provided radio relay support to the 7th Marines on Operation SIERRA. Three radio operators and 2 AN/MRC-83's were provided to the 1st MED Battalion for the same operation. Operation SIERRA is still in progress at this time.

A search and seize operation was conducted in the hamlet of LONG BINH on 28 December with this battalion providing a rifle squad in addition to communications support.

The Civic Action program was resumed with the assignment of the hamlet of XUAN TRUNG as the responsibility of this battalion instead of the more distant hamlet of MY HUE(1).

A comprehensive switchboard operator training program was begun by Communication Company to further the training of newly assigned 2511's and improve the quality of switchboard operation in the CHU LAI area.

10 December 1966

Nineteen (19) men attended Land Mine and Booby Trap School conducted by 1st Engineer Battalion.

Fam-firing of the M-14 was conducted to obtain weapon zeros. Thirty-eight men participated.

12 December 1966

One officer attended RPS School in JAPAN.

Two officers attended Crypto-Comm Security School in JAPAN.

One enlisted attended MUMMS School in OKINAWA.

14 December 1966

One officer attended Vietnamese Language School in OKINAWA.

18 December 1966

Two enlisted attended Vietnamese Language School in DANANG.

30 December 1966

Sixty-eight personnel attended the battalion Vietnam Orientation lecture covering history, customs and traditions of the Vietnamese and a brief introduction to common Vietnamese phrases.

Ten men attended the 1st Engineer Battalion Land Mine and Booby Trap School.

3. OPERATIONS

3 December 1966

At 1900 oral instructions from Task Force X-Ray staff directed this battalion to provide billeting and messing facilities for one hundred seventy personnel at 2200 that same evening. "A" Company, 1/7 arrived in the battalion CP at 2330 and departed at 0930. This battalion was not informed that the company was being extracted from combat and had no mess gear or bedding.

LESSON LEARNED: The requirements of units being extracted from combat differ greatly from those of transient groups. Host units should be advised of the status of the incoming unit so that, (1) The Battalion Aid Station is prepared for the number of casualties and the type treatment required, (2) Mess gear can be obtained, (3) Bedding material can be obtained, (4) Appropriate transportation is available.

The battalion was directed by CG First MarDiv to be prepared to embark on order fixed plant teletype equipment installed in the Chu Lai Communication Center for shipment to DANANG. Sixty-nine rigid waterproof packing crates were built and cargo manifests prepared.

Meanwhile, a letter was submitted to the CEO, Task Force X-Ray, outlining the requirements for continuation of Comm Center service should the action proposed by CG 1st MarDiv be ordered executed.

12-31 December 1966

Sixteen personnel participated in Operation SIERRA providing radio and radio relay support to the 7th Marines and the 1st Medical Battalion. A radar beacon team was also provided to the 7th Marines. In addition to communications support for the operation, ten M-35 trucks were committed by this battalion on four separate occasions to transport ammunition to QUANG NGAI airfield.

5. COMMAND AND CONTROL

a. Operational and Administrative control of the four companies remains with Battalion except that Communication Support Company is still under the Operational control of the 5th Communication Battalion.

b. The Battalion is under the Operational Control of CG Task Force X-Ray but remains under the Administrative Control of the CG 1st Marine Division.

6. LOGISTICS

a. The overall logistical situation remains satisfactory except for a few significant problem areas.

(1) Nonavailability of repair parts for fixed plant teletype equipment and on-line crypto equipment continues to be a problem.

(2) The efficiency of the telephone centrals serving Task Force X-Ray is reduced by twenty percent due to failure of the cord circuits on the component switchboards. Replacement cords are not available at present.

(3) Upper Torso Body Armor remains unavailable making it difficult to comply with the road safety provisions required by CG 1stMarDiv without temporary loan assistance from other organizations. This becomes a problem when short notice commitments are received to provide personnel and equipment in support of tactical operations.

(4) Only eighty-nine and a half miles of field wire, WD-1/TT remain on hand to support any immediate tactical commitments. A total of six hundred sixty-eight and a half miles of this wire is on order.

b. On 6 December MCB-40 completed construction of thirty new tropical huts. On 5 December MCB-8 began to rehabilitate seventy of eighty-two existing strongback tents, of which, forty-three have been rehabilitated to date. All personnel are now billeted under a tin roof.

7. CIVIC ACTION/MEDICAL AID PROGRAM

18 December 1966

This battalion was assigned Civic Action responsibility as well as MED CAP responsibility for the hamlets of XUAN TRUNG and AN TAY(1). The battalion was relieved of the responsibility for MY HUE (1) due to inaccessability of the hamlet.

25 December 1966

A Christmas party was given for three hundred children from XUAN TRUNG, AN TAY(1), and AN HAI. Gifts were provided by Task Force X-Ray G-5. The party was held in the primary school of XUAN TRUNG. A movie was shown and a song fest held.

27 December 1966

The uncle of the hamlet vice-chief was treated for injuries received in a bicycle accident. He appeared genuinely appreciative of the attention given his injuries.

31 December 1966

Civic Action officer held discussion with the vice-chief concerning probable reasons for the hamlet of AN HAI being declared "Off Limits". Casual mention was made of the more open solicitation now present in XUAN TRUNG and the growing number (3) of "houses of ill fame". The vice-chief stated that if certain activities might possibly result in an "Off Limits" declaration, he would so advise the hamlet chief so that they could jointly clean-up the hamlet.

Seventeen MED CAP visits were made during the month with a total of eight hundred eight Vietnamese being treated. More adults, both male and female, are coming for treatment with each successive visit.
