NARRATIVE SUMMARY

During the month of July, no major shifts were made of Battalion requirements to support the various Marine units throughout the I Corps tactical zone. Additional support was rendered to the Korean Marine Brigade to provide a greater radio relay capability throughout the Republic of Korean Marine Brigade's area of responsibility. Additionally technical assistance was provided to instruct Korean Marine telephone technicians ^{on} maintenance procedures on the MTC-1 telephone switchboard installed by the Battalion during June 1968.

A continuing problem exists in the engine generator field which has caused some loss of the Battalion's ability to deploy additional multi-channel radio equipment or to properly maintain those equipments currently on site. Through maximum effort of maintenance personnel and with parts found by the III IMAF CEO Office some improvement in the situation was made during the latter part of the month. However, the advanced age of most generating equipment precludes any major improvement until new equipment is issued to the Battalion.

The Battalion continued its relatively heavy commitment to ground defense in the Hill 34 area. Enemy activity, after a lull during June, increased significantly and it became necessary to increase the Battalion patrol force by one (1) squad to fulfill requirements laid on the command by the 1st Marine Division.

Civic Action activities were maintained although activity was largely limited to MedCaps, DentCaps and the distribution of soap and clothing. The Civic Action program had a set back when a flame tank burning brush along the Battalion perimeter inadvertently set fire to a small grass house which in turn set fire to two others. No personnel casualties resulted but the three homes were a total loss. Livestock and food losses were replaced immediately by the Battalion and maximum assistance is being provided to rebuild the houses as expeditiously as possible.

1. The following report covering the month of July, 1968, is submitted in accordance with references (a) and (b).

2. Supply Situation

a. The supply personnel situation is a problem affecting the unit. Only thirteen of the nineteen supply personnel, 17 and under, rated by the battalion are on hand.

b. Delays in the receipt of repair parts results in excessive down time for combat essential equipment, especially in the areas of communications, engineering and motor transport equipment.

3. Critical Items. These are listed in enclosures (1) through (3).

4. Significant Events

a. During the month of July the Foreign Section, Public Works, completed plans for the 3000 water distribution system. Reference (a) is the assignment of this project to the Third Naval Construction Brigade. Notification of the further assignment of the project to an area public construction battalion has not yet been received.

Tab A

b. The unit remains in a G-2 status because of generators. Requisitions for generators and repair parts for generators contained within the unit continue to arrive sporadically. Equipment jackets for three G-3's have been received from HQCO, Army, indicating that the equipment is on the way. Besides the equipment mentioned in paragraph 10 as being in higher echelon repair facilities, seven G-3's, two G-347's, two G-275's, two G-346's and one G-349 are awaiting parts in the Battalion Engineers Shop. One new G-347 was received during the month.

c. Maintenance facilities have a low capability for repair of office machinery. The result is that a larger percent is placed in a Grade II category and must be repaired. At this time there are only two Battalion typewriters in repair facilities but there are four regular and twenty telegrapher typewriters on order. Also on order are two electrical and two manual mimeograph machines. As a result the Battalion's reproduction capabilities are curtailed.

5. Maintenance. The maintenance situation remains satisfactory, except in the areas of generators.

6. Major Items of Interest.

- a. Major items of equipment, motor transport: Enclosure (4)
- b. Major items of equipment, Engineering: Enclosure (7)
- c. Major items of equipment, Communication - Electronics: Enclosure (6).

7. Significant Maintenance Problems.

a. Though the Motor Transport deadline rate for second echelon repair is only two vehicles or 20%, the rate for third echelon is eleven vehicles, or 12%. Because the return of vehicles from third echelon facilities is rather slow, the ability of this unit to perform its mission is diminished by immobile vehicles in third echelon facilities.

8. Major Action.

a. At present, seventh Engineer Battalion has been assigned to rebuild the ammunition bunker which was destroyed in the 4 March rocket attack. Work is currently beginning on this project.

b. During the current month no generators have returned from third echelon repair facilities. Total of nineteen items of radio relay equipment (14 M-12745, 4 M-12747, 1 M-12748) are contained for parts or power units on order or in repair facilities.

9. Significant Transportation Problems. None.

10. Other Area of Interest.

a. The following is a set list report of Battalion generators being
