

NARRATIVE SUMMARY

During August, the Battalion continued to provide extensive communications support throughout the I Corps Tactical Zone, in a large variety of missions. At the same time the command was heavily committed in ground defense operations.

Previous communications support activities were maintained. In addition multi-channel radio facilities were provided to the 5th Marines and more equipment was loaned to the 1st Marines. Some multi-channel radio sets were upgraded by replacing AN/FRC-62 radio sets with the newer AN/PCC-1 equipments.

The Battalion was hampered by previously reported problems with generators for multi-channel radio equipment: unduly long turn-around time for generators at 1st FSR for repair, and excessive requisition time for generator repair parts. Also the Battalion had a significant shortage of supervisory personnel during the month.

Communications Company was returned to operational control of the Battalion on 16 August, but remained in the Phu Bai area, supporting 1st Marine Division units in the area, with additional support to 1st MAW, 3rd Marine Division and 1st ARVN Division.

Communication Support Company and Radio Relay and Construction Company continued to support 1st Marine Division, 2nd ROK Marine Brigade, and 1st MAW organizations.

Ground defense operations provided sporadic contact. An NVA POW was taken in a sweep of the Battalion TAOR on 23 August, following the ground attacks on the Song Cau Do and Cam Le bridges. On 26 August three 140mm rockets impacted about 70 meters from Battalion defensive positions.

Civic Action suffered a severe setback when Cam Hoa, a hamlet in the Battalion CAAOR, was accidentally fired upon by Marine artillery and HU-1E gunships. Assistance was provided to Cam Hoa in the form of medical aid, clothing, and blankets. Usual Civic Action activities, primarily NedCap's, continued in Yen Bac and Cam Hoa.

A highlight of the month's training was the demonstration of a typical VC sapper attack, conducted on 21 August for all available Battalion personnel. The demonstration featured ordnance pyrotechnics, and some actual breaching of the wire.



1. The following report covering the month of August, 1968 is submitted in accordance with references (a) and (b).

2. Supply Situation

a. The continuing shortage of supply personnel remains a problem. There are only sixteen men, E-5 and under, available where twenty-three are rated by manning level. This shortage severely hinders the capabilities of the Battalion Supply Section.

b. The length of time between submission of requisitions and receipt of material from supply sources is excessively long. Use of MPSR requisitions and Red Ball does not lower this time to acceptable limits. The operational capability of this battalion rests on the ability to properly maintain communications, engineer (com-elec generators), and materiel transport equipment. In all of these areas lag time in receipt of repair parts causes excessive down time for pieces of combat essential equipment.

3. Critical Items. These are listed in enclosures (1) through (8).

4. Significant Problem Areas

a. This unit is still experiencing considerable difficulty in obtaining jungle clothing. Requisitions on Priority 02 for all sizes of jungle clothing are not being filled.

Tab A

b. A shortage of typewriters in some cases requires scheduling of their use between two or more offices. There are at present four standard typewriters, components of office supply sets, on order, and twenty telegraphic typewriters on order. A good many of the typewriters presently on hand and in use are barely functional. They are old and often rusty. Turning them in for general repair does not seem to improve their condition significantly.

c. Requests for status submitted to the supply source on outstanding documents in very many cases are never answered. As shown by the first three enclosures of this report, valid status is not held at present on the majority of the requisitions listed for critical items. The older documents had valid status at one time but have not been resubmitted, and the newer documents have not received automatic status within thirty days. For many of the documents listed the follow-ups submitted on 8244 are the third or forth request. It is impossible to comply with the requirement to followup every ten days after the initial followup until status is received, and the lack of response to followups does little to inspire confidence in the effectiveness of followup action.

5. Maintenance Situation

a. A large part of the maintenance problem is a direct result of the supply problem mentioned; that the lead time is much too long for receipt of repair parts which are deadlining pieces of combat essential equipment.

b. The second part of the maintenance problem is the turn-around time for generators turned-in to First F.M. for repair. Some work orders have been outstanding since December, 1967.

c. A third problem area is the present shortage of personnel qualified and experienced in fixed plant teletype equipment repair. Steps have been taken to have certain maintenance personnel receive on-the-job training at the NSA fixed-plant repair facility. It is hoped that the problem will in this way be solved.

6. Major Items of Equipment. These are listed in enclosures (4) through (6).

7. Significant Maintenance Problems.

a. The largest single problem is the shortage of generator power sources for multi-channel radio equipment. This is partly because of the difficulty in obtaining second echelon repair parts and partly because of the time lag in the return of generators from third and fourth echelon maintenance facilities.

b. At the present time there are thirty-seven (37) individual generators qualified, all power supplies for radio relay equipment. Of these, ten are awaiting second echelon parts and twenty-seven (27) have been turned in to First F.M. for repairs. Almost all of these turned in to First F.M. have been designated Red Ball.

c. Since 30 July fourteen generators have been turned in to First F.M. Only one generator was returned from F.M. during this period, and one new PL-347 was received through supply channels. Of the other 13 generators turned in to F.M., six were sent in June, four in May, and three in December, 1967.

8. In the case of these generators, as with the supply negotiations for critical items, Red Ball action has not been effective in bringing about a speedy return of the equipment. This unit is presently in a C-2 combat sustainment category because of generators.

9. General Situation:

a. The ammunition bunker begun last month by "D" Company, Seventh Engineers Battalion has been completed and a drainage trench for it was dug by First Engineers Battalion.

b. Work has just begun on a new shower in the Communication Support Company area by 10th Public Works.

c. Work has begun on the Mill 34 water distribution system, and digging should begin in the Seventh Corps area during early September.

(a) High deadline rate for MRC-63 and MRC-57 is not affecting this unit's capability to perform assigned missions because of very little usage of this equipment. Primary cause for MRC deadline is shortage of five (5) TMC-75 units destroyed by enemy action in May, 1968.

(b) MRC-62/63 deadline is linked to Conv-Elect generator problem. This problem is amplified in the narrative maintenance section of this report. There is no immediate or anticipated requirement for use of MRC-63's. All available power units are being used with the MRC-62's. The 100% deadline of MRC-63's is because of the shortage of power units.

(c) TMC-97 deadline is due to excessive time lag in receipt of critical repair parts. Parts are on Red Ball, but many of them are being procured from RCA and contract terms are often very long. Lack of operational power units, MU-346, is also a major problem. The deadline of three out of eight TMC-97's is a serious limitation of this Battalion's ability to adequately perform assigned long range Radio Relay missions.

(d) TMC-97 deadline is mainly because of the lack of power units. Present requirements for this equipment are not such that the deadline rate is a critical problem, but potential commitments could very quickly make the situation critical.

Communication Support Company continued to operate and maintain the switchboard, radio, and teletype circuits for the Battalion.
