4. Administration. No administration problems.

5. Civil Affairs/Military Government/Community Relations

a. The civil affairs program continues on a daily basis.

b. Activities were as follows:

(1) MEDCAP program provided medical treatment to 492 persons.

(2) The Battalion sponsored, Vietnamese brick yard produced 15,000 soil-cement bricks. Over 10,400 bricks were issued to Division units for use in Civil Affairs School construction projects.

(3) A six (6) room elementary school is under construction in Hoa Khanh Village (AT 9578) as a joint effort. Materials are provided thru USAID. Labor is furnished by local Vietnamese while tools, equipment and technical assistance is provided by this Battalion.

8. Logistics

a. Correspondence originated by the Battalion S-4 of special interest was:

(1) On 3 September the Commanding Officer authorized "D" Company to draw 45 upper torso body armor jackets in support of anticipated deployment South.

(2) On 4 September 1st Bridge Company submitted a report to Division concerning the testing of ten 35 HP Mercury Outboard Motors.

(3) On 6 September this Battalion ordered overhead fans for mess hall use in accordance with CG 3d MarDiv msg R650522Z.

(4) On 7 September this Battalion received notice from Commanding General 3d Marine Division concerning shipment of new T/E item: Battery Charger, T/A No 20135P, ID No 04705A, FSN 6130-903-1163.

(5) On 9 September the Battalion was advised that FLC had sufficient quantities of M105A2 Cargo Trailers to issue this unit, a quantity of four. Battalion Supply complied by ordering.

(6) On 13 September, 1st Bridge Company submitted a request for modification of allowance for a 350 GPM Pump to be used at the Da Nang River floating bridge.

(7) On 16 September the Battalion reported to Commanding General III MAF the supply action on selected items. This data was utilized in revising CA factors for selected engineer items of equipment.

(8) On 17 September this Battalion reported to Commanding General 3d Marine Division the number of CONEX containers on hand. A quantity of twelve was reported as on hand, and justifications were submitted with a request that these be retained by the Battalion.

(9) On 20 September this Battalion received a message from Commanding General 3d Marine Division concerning additional items to Combat Essential Equipment Report. In compliance with the message, the KW-7 Crypto Device was added.

(10) On 23 September a message was received from Commanding General 3d Marine Division requesting nomination to Embarkation School. This unit nominated nine personnel; five for the first class and four for the next.

(11) On 29 September the Battalion submitted LTI's on M-37 trucks for possible replacement of ones in worst condition. This was in accordance with CG 3d MarDiv msg P210930Z Sept 66.

c. Supply

(1) 7th Engineer Battalion, FMF (RUC 21300). The Supply Platoon processed 929 priority 12 and 17 requisitions, 156 priority 02 and 05 requisitions, had 1379 receipts from due, 985 issues from due and 324 issues from the warehouse.

(2) 1st Bridge Company, FMF (RUC 21325). The Company Supply Section recomputed AMRD's for all line items held. The section processed 352 requisitions, filled 53 from stock, submitted 299 to FLSG-A or FSR, and completed 206 documents. Total outstanding documents on 30 September numbers 1863.

d. Messing. The Battalion Mess Staff continued the normal mess operation of providing four meals daily except Sunday; the fourth meal being a midnight ration for night crews. On Sunday, a brunch replaces breakfast and dinner. Equipment for the establishment of a permanent 1600 man mess was received during September. However, only a small portion of that expected has been received to date.

e. Medical

(1) The Battalion Aid Station treated 901 military patients and 578 Vietnamese Nationals.

(2) The area Dental Facility treated 315 military patients and 45 Vietnamese Nationals.

f. Motor Transport. A total of 122,677 miles were logged on the Battalion's Motor Transport vehicles in support of operations. It is estimated that 60,000 gallons of MOGAS and 19,000 gallons of diesel fuel were consumed by motor transport vehicles.

g. Maintenance. The Battalion Maintenance Platoon completed 72 pieces of deadlined engineer equipment and 88 pieces of motor transport equipment. A shortage of personnel reduced the number of pieces completed for that month.

9. Training

a. Troop indoctrination continues for newly arrived personnel and debriefing for those departing.

b. One marine of this Command attended Vietnamese Language School.

c. Twenty-four personnel attended the 3d Engineer Battalion Land Mine Warfare School.

d. All other training was on the job training.

10. NBC Warfare. None.11. Command Control. None.

12. Air Defense. No change.

13. Special Operations. Elements of 1st Bridge Company and Company "C",  
7th Engineer Battalion supported two Roughrider convoys.
