NARRATIVE SUMMARY

The 7th Engineer Battalion continued support of the III Marine Amphibious Force within the Danang area. Platoons from the attached 1st and 3rd Bridge Companies are rendering additional support in the Chu Lai, Hue/Phu Bai, and Dong Ha areas.

Company "B", 9th Engineer Battalion continued engineering operations on Route 1 between Danang and Thang Binh to upgrade Highway 1 for class 50 traffic inspite of intensive enemy sabotage.

Company "C", 7th Engineer Battalion completed the Ha Dong Bridge at AT 998707, a 348' pile bent design.

1st Bridge Company, 7th Engineer Battalion placed three (3) class 60/65 M4T6 Fixed Spans at BT 048608, BT 014688 and AT 101518.

1st Bridge Company, 7th Engineer Battalion installed a 123'8" Aluminum footbridge at BT 031649.

1st Bridge Company, 7th Engineer Battalion installed a M4T6 Fixed Span with intermediate trestle for intermediate support at BT 055592.

3rd Bridge Company, 7th Engineer Battalion placed a 290' M4 Aluminum Ponton class 60/60 superstructure bridge at YD 927103.

7th Engineer Battalion FMF (RUC 21300)

The Battalion Aid Station treated 668 Military and 84 Vietnamese. During the month of November the Dental Clinic treated 412 Military and 12 Vietnamese.
