



c. Organization and Operations

(1) Officer Assignments - See TAB A, Enclosure (1)

(2) Operations

(a) On 1 February 1968 hauled 130 cu.yds. of fill on Route 33 and hauled 45 cu.yds. of rock on Route 33. Hauled 40 cu.yds. of fill on Route 1 to repair crater. Completed work on ferry site approach, hauled and spread 144 cu.yds. of rock.

(b) On 2 February 1968 hauled 126 cu.yds. of rock to Route 33 graded and rolled.

(c) On 3 February 1968 repaired blown culvert at AT 942052 on Route 5 used 23 yds. fill. Repaired one culvert and poured spillway for another culvert on Route 33.

(d) On 5 February 1968 placed 100 cu.yds. of fill in crater on Route 1. Hauled 155 cu.yds. of fill on Route 33.

(e) On 6 February 1968 hauled 675 cu.yds. of fill on Route 33 poured two spillways for culverts on Route 33 oiled road.

(f) On 7 February 1968 hauled 405 cu.yds. of fill and oiled Route 33. Repaired blown bridge at AT 944696 bridge open for class 20 traffic. Filled crater on Route 5 north at AT 945747. Blew caves and spider holes for 7th Comm. repaired Route 14 east with 25 loads of fill.

(g) On 9 February 1968 constructed culvert bypass at AT 943691 at blown bridge site on Route 5. Graded Route 5 south from AT 945707 to AT 943691. Filled craters on Route 1 opened road to Dien Ban. Repaired crater on Route 14 west used 12 loads of fill.

(h) On 10 February 1968 hauled and placed 205 cu.yds. of fill in culvert bypass at AT 943691.

(i) On 12 February 1968 spread 6,000 gallons of bunker oil on Route 5. Hauled 140 cu.yds. of fill on Route 33 hauled and placed 90 cu.yds. of fill and 30 cu.yds. of rock on Route 5 at AT 943691. Located 36 mines disarmed 30 used one load from flametank to burn off mine field area at ASP-1.

(j) On 13 February 1968 hauled and placed 295 yds. of fill and oiled Route 33. Filled craters graded and placed asphalt on Route 1 south. Placed 15 cu.yds. of rock on Route 5 bypass at AT 943691. Placed 69 cu.yds. of rock on Route 5 north at AT 937716. Located 10 mines, disarmed 6, removed 36 used 2 loads of flametank to burn off mine field. Repaired Route 5 north of Hill 37 used 15 loads of fill.

(k) On 14 February 1968 located 93 mines disarmed 24 mines at ASP-1. Hauled 120 cu.yds. of rock on Route 5 spread 500 gallons of oil.

(l) On 15 February 1968 hauled 120 cu.yds. of rock on Route 5. Located 30 mines, disarmed 79 mines removed 79 mines used 2 loads from flame-tank at ASP-1.

(m) On 16 February 1968 hauled 132 cu.yds. of rock on Route 33 rolled road continued work on headwalls for culverts. Disarmed 18 mines located 111, removed 24 mines used one load from flame tank at ASP-1. Spread 198 cu.yds. of rock on Route 5 thru Dia Loc.

(n) On 17 February 1968 hauled 144 cu.yds. of rock on Route 5 thru Dia Loc. Located 39 mines, disarmed 80, removed 52 mines, used 2 loads from flametank at ASP-1. Hauled 60 cu.yds. of fill on Route 33.

(o) On 19 February 1968 hauled 135 cu.yds. of fill on Route 5 north, graded from AT 939713 to AT 935716, spread two loads of oil from 949707 to AT 943690. Located 93 mines, disarmed 96 mines removed 96 mines at ASP-1. Placed (1) 36" culvert and hauled 204 cu.yds. of rock on Route 5. Hauled 60 cu.yds. of rock and 18 cu.yds. of fill to Route 33.

(p) On 20 February 1968 culvert at 941643 95% complete. Spread (2) loads of oil on Route 5 south from AT 943663 to AT 930619 hauled 81 cu.yds. of fill spread and graded Route 5 north from AT 945708 to AT 941713. Located 6, disarmed 44, removed 47 mines at ASP-1. Hauled 96 cu.yds. of rock on Route 5 bypass completed installation of (1) 36" culvert hauled 40 cu.yds. of fill to raise section of Route 5. Hauled 55 yds. of rock, 100 yds. of fill to Route 33.

(q) On 21 February 1968 completed construction of sandbags and wire entanglement at the Song Cau Do river bridge. Hauled and spread (1) load of oil on Route 5, hauled 165 yds. of fill on Route 5. Located 67 disarmed 39 and removed 40 mines from minefield at ASP-1. Hauled 194 yds. of rock to Route 5 spread and rolled. Hauled 55 cu.yds. of rock, 135 cu.yds. of fill, spread one load of oil to Route 33, and one load on Route 5.

(r) On 22 February 1968 spread 3 loads of oil on Route 5. Located 116, disarmed 59, removed 62 mines at minefield at ASP-1. Hauled 144 cu.yds. of rock to Route 5. Hauled 60 cu.yds. of rock, 180 cu.yds. of fill to Route 33 spread & graded spread 3 loads of oil on Route 5. Completed probing of suspected minefield at DaNang Airbase.

(s) On 23 February 1968 Spread one load of oil, spread 200 cu.yds. of fill and graded on Route 33. Located 72, disarmed 92, removed 58 mines at minefield at ASP-1. Hauled and spread 19 loads of rock on Route 5.

(t) On 24 February 1968 located 42, disarmed 89, removed 60 mines at minefield at ASP-1. Hauled and spread 29 loads of rock on Route 5, hauled 240 cu.yds. of fill on Route 33 graded replaced bridge on Route 33 with culverts.

(u) On 26 February 1968 hauled and spread 130 cu.yds. of fines and 180 cu.yds. of fill on Route 33. Hauled and spread 232 cu.yds. of fill on Route 12 west. Improved traveled way on Route 12 by spreading 900 gallons of oil. Compacted Route 5 south between AT 945692. Located 30, disarmed

92, removed 187 mines at minefield at ASP-1, removal of minefield complete. Received and spread 36 cu.yds. of rock on Route 5.

(v) On 27 February 1968 spread 102 loads of rock on Route 5 south. Oiled road from Route 5 to Hill 10.

(w) On 28 February 1968 spread 105 cu.yds. of rock on Route 33 and graded. Spread 265 cu.yds. of fines, spread oil on road between AT 946707 and AT 912743 on Route 5. At Combined Action Platoon removed wrecked plane and recovered one 20mm cannon intact. Received and spread 150 cu.yds. of rock on Route 5.

(x) On 29 February 1968 spread 190 cu.yds. of fines on Route 33 received and spread 150 cu.yds. of rock on Route 5 south. Completed sweeping and probing of suspected mine field at DaNang Airfield. Continued general support of CAP units in the 1st Marine Division TACR.

7 Invoiced 25 gas masks to 1st Marines on an emergency request from 1st Marine Division.

9 Directed by Division to provide 82 gas masks for the 5th Marines. Necessary to take 27 small masks from Headquarters Company troops.

11 Provided temporary billeting and messing for 350 officers and men of the 35th Engineer Battalion (Army/Combat) US army for a period of four days.

12 Staff visit by Division Motor Transport Office.

16 Elements of the 45th Engineer Group (Army) US Army established forward headquarters within the battalion perimeter. Provided billeting and messing facilities.

18 Received one bridge boat 61-699 from the 517th Engineer Company (Light Equip) US Army.

20 Inspection of Battalion Supply by the Division Supply Officer.

22 Received four M4T6 bridges (140') and two bridge boats from 1st Engineer Battalion 1st Infantry Division (US Army).

Provided billeting and messing facilities for C Btry 6th Battalion of 33rd Arty Group (USA) which is to establish firing positions within 7th Engineer Battalion cantonment.

28 Provided 210' M4T6 bridging to 45th Engineer Group (USA) for use in Northern DaNang TAOR. Bridge provided on temporary loan basis.

(2) Supply

7th Engineer Battalion FMF (AC 21300)

During the month of February the Battalion Supply Section processed 390 priority 02 and 538 priority 05 requisitions and 374 priority 12 and 17 requisitions. Also processed were 619 receipts from due, 511 issues from due and 153 issues from warehouse.

1st Bridge Company FMF (AC 21325)

During the month of February 1st Bridge Supply Section processed 571 requisitions. Also processed were 182 receipts from due, 152 issues from due and 20 issues from warehouse.

3rd Bridge Company FMF (AC 21335)

During the month of February 3rd Bridge Supply Section processed 389 requisitions. Also processed were 65 receipts from due, 60 issues from due, and 82 issues from warehouse.

Motor Transport

Approximately 89,322 miles were logged on the Battalion's Motor Transport Vehicles during February.

Maintenance

The Battalion Maintenance Platoon completed 33 Motor Transport work orders during the month of February. A total of 33 work orders were submitted, 12 were sent to Maintenance Battalion. Total work orders for Engineer Equipment numbered 74 with 54 completed and 7 were sent to FSR.

Messing

The Battalion Mess Staff continued to provide four meals daily except on Sunday; the forth meal being a midnight ration for night crews. On Sunday a brunch replaces breakfast and dinner.

Medical

The Battalion Aid Station treated 751 Military and 171 Vietnamese. During the month of February the Dental Clinic treated 115 Military and 3 Vietnamese.

g. Civil Affairs/Civic Action

(1) The civic action program continues on a daily basis.

(2) Activities were as follows:

(a) MED CAP program provided treatment to one hundred fifty two (152) persons.

(b) The battalion sponsored, Vietnamese brickyard produced a total of forty one thousand six hundred (41,600) soil bricks.

(c) A total of twenty thousand (20,000) bricks were released from the 7th Engineer Battalion Brick Factory during the month of February for various projects.

(d) Ten (10) scholarships were continued to be given to Vietnamese children who showed good academic ability.

(e) 11 families in Huong Phuoc were assisted by being given 600 Ammo box's to rebuild their houses which were burned down due to hostile action.
