5750PART IINARRATIVE SUMMARY

The 7th Engineer Battalion continued support of the III Marine Amphibious Force within the Danang area. The Battalion continued maintenance responsibility of 70 miles of road and conducted daily minesweeps of 25.5 miles of road. The Battalion maintained 8 water points in the Danang area producing 5,226,620 gallons of water. One platoon of the 1st Bridge Company is now in a TAD status to furnish tactical bridge support to the 9th Engineer Battalion at Chu Lai.

Company "A", 7th Engineer Battalion continued maintenance of Route 540 and Route 30 for class 50 traffic and maintenance of Route 540 from AT 899774 to AT 912743, Route 542, Route 544 and Route 10. Company "A" also conducts daily minesweeps of Route 545.

Company "B", 7th Engineer Battalion continued upgrading of Route QL-1S in preparation for paving. Company "B" is also responsible for maintenance and upgrading of Route 4 from BT 046589 to AT 968584. Due to the tactical situation this portion of the route is not being used. Company "B" conducts daily mine sweeps of Route QL-1S from AT 999707 to BT 042621, and of Route 5 from AT 953714 to AT 946731.

Company "C", 7th Engineer Battalion continued upgrading of Route 540 from AT 912743 to AT 927608. Company "C" also conducts daily minesweeps of Route 540 from AT 943663 to AT 927608 and is in the process of upgrading this section of road.

Company "D", 7th Engineer Battalion continued upgrading of Route 540 from AT 927608 to AT 874460 for class 50 traffic and maintenance of Route 4. Areas east of Hill 37 and west of Hill 65 were inaccessible due to the current tactical situation. Company "D" conducts daily minesweeps of Route 540 from AT 927608 to AT 925533. Company "D" also conducts minesweeps of Route 4 from AT 922576 to AT 968584.

d. ORGANIZATION AND OPERATIONS

(1) Officer assignment - See TAB A, Enclosure (1)

(2) Operations 1 - 5 December 1969

(a) Horizontal Construction - The 7th Engineer Bn hauled, spread, and compacted the following on the upgrade/maintenance of its lines of communication; on Route 540, 372 cubic yards of 3"(-) rock and 220 cubic yards of 6"(-) rock; on Route 545, 323 cubic yards of 3"(-) rock; on Route QL-1S, 579 cubic yards of 3"(-) rock and 418 cubic yards of 6"(-) rock; on Route 4, 170 cubic yards of 6"(-) rock; and at the Thanh Quyt bypass, 42 cubic yards of 6"(-) rock and 84 cubic yards of 3"(-) rock.

(b) Verticle Construction - Construction was continued on 11-6' X 8' bunkers, one (1) gun pad for 175mm guns at An Hoa five (5) gun pads for 3rd 8" guns and 175mm guns at Hill 65, the CON cantonment extension at Marble Mountain. This Battalion's tower construction continued with work on one (1) 30' tower for 1st Recon Bn, two (2) 30' towers for 11th Marines and three (3) 30' towers for 3/26. Also, the battalion began construction of one (1) 40' tower for 11th Motor Transport Battalion.

(c) Engineer Comments - Significant Events

(1) This battalion hauled a total of 2,853 cubic yards of rock to its stockpiles and roads during this period.

(3) Operations 6 - 12 December 1969

(a) Horizontal Construction - In the continued upgrade/maintenance of its roads, bridges and bypasses, the 7th Engineer Battalion hauled, spread and compacted the following: 476 cubic yards of 6"(-) rock and 280 cubic yards of 3"(-) rock on Route QL-1S; 706 cubic yards of 6"(-) rock, and 632 cubic yards of 3"(-) rock on Route 540; 474 cubic yards of 3"(-) rock on Route 545; and, 30 cubic yards of 3"(-) rock and 121 cubic yards of 6"(-) rock on the Thanh Quyt Bypass.

(b) Verticle Construction - During this period, the Battalion continued the cantonment extension of CON camp at Marble Mountain, five

(5) gun pads at Hill 65, one (1) gun pad at An Hoa and 11-6' X 8' bunkers. Tower construction continued with the battalion working on one (1) 30' tower for 11th Marines, three (3) 30' towers for 3/26 and one (1) 30' tower for 1st Recon Bn. The battalion began construction of one (1) 30' tower for northern artillery cantonment during this period.

(c) Engineer Comments - Significant Events

(1) 12 December 1969 - Completed one (1) 30' tower for 11th Marines.

(2) 3485 cubic yards of rock were hauled to this battalion's roads and stockpiles.

(4) Operations - 13 - 19 December 1969

(a) Horizontal Construction - During this reporting period, the Battalion hauled, spread, and compacted a total of 1152 cubic yards of 6"(-) rock and 5100 cubic yards of 3"(-) rock on its lines of communication. The breakdown is as follows; spread and compacted on the An Hoa Road (Route 540), 1152 cubic yards of 6"(-) rock and 1049 cubic yards of 3"(-) rock; 290 cubic yards of 3"(-) rock spread and compacted on Route 545; 3691 cubic yards of 3"(-) rock hauled and spread in support of MCB 121 on Route QL-1S; and 70 cubic yards of 3"(-) rock on Route 542.

(b) Verticle Construction - The 7th Engineer Battalion continued work on the 5th Special Forces Camp at Marble Mountain (CCN). Presently, we are finishing a 20' X 32' shower and head and commencing construction of a 250 BBL water tower. Another big project is the installation of a secondary distribution system at the An Hoa Combat Base for 2/11. Tower construction remains the predominant industry in the battalion. Presently under construction are 2-20' towers for FLC, 1-40' tower for 11th Motor Transport Bn, 1-30' tower for the Northern Artillery Cantonment, 1-30' tower for Liberty Bridge, and 1-30' tower for 1st Tank Bn.

(c) Engineer Comments - Significant Events

(1) 14 December 1969 - Completed 3-30' towers for 3/26.

(2) 17 December 1969 - Completed 1-30' tower for 1st Recon Bn.

(3) This reporting period showed a total of 6752 cubic yards of rock hauled to the battalion's roads and stockpiles.

(5) Operations - 20 - 26 December 1969

(a) Horizontal Construction - The Battalion continued the maintenance and upgrade of its lines of communication. The An Hoa Road had a total of 2,128 cubic yards of 6"(-) rock and 3"(-) rock hauled, spread, and compacted by 7th Engineer Battalion equipment. Two of our less important roads, Routes 542 and 544, had a total of 288 cubic yards of 3"(-) rock hauled and spread for their maintenance. Route QL-1S showed

401 cubic yards of 3"(-) rock hauled and spread in its upgrade. 12,000 gallons of oil were spread on the battalion roads to aid in dust suppression.

(b) Verticle Construction - Once again, towers remain the highlight of 7th Engineer Battalion construction efforts. Currently in the construction cycle are; 2-20' towers for FLC; 1-30' tower for Liberty Bridge; 1-20' tower for 1st Motor Transport Bn; 1-30' tower for Northern Artillery Cantonment; and, 1-30' tower for 1st Tank Bn. Also under construction are 5 gun pads at Hill 65 and the 5th Special Forces Cantonment extension at CCN, Marble Mountain.

(c) Engineer Comments - Significant Events

(1) 26 December 1969 - Completed 3 SEA huts for FLC

(2) 26 December 1969 - Completed 1-40' tower for 11th Motor Transport Battalion.

(3) 4,334 cubic yards of rock was hauled to the lines of communication and the An Hoa LSU during this period.

(6) Operations 27 - 31 December 1969

(a) Horizontal Construction - 7th Engineer Battalion vehicles hauled and spread 921 cubic yards of 6"(-) rock on the An Hoa LSU for stabilization. Also, on the An Hoa Road, our equipment hauled, spread, and compacted 304 cubic yards of 6"(-) rock and 951 cubic yards of 3"(-) rock. Routes 544 and 542 received a total of 425 cubic yards of 3"(-) rock for maintenance. Construction continued at the Little Thanh Quit Bridge, all piles are driven and caps are in place. 35 cubic yards of 3"(-) rock was hauled for the abutments.

(b) Verticle Construction - At last the long awaited 250 BBL water tanks have arrived and the battalion is able to reopen some of the work orders that have been stagnant for so long. Besides the horizontal construction underway at the An Hoa Combat Base LSU, we are currently installing a secondary distribution system for 2/11 and constructing a 30' X 30' gun pad. The tower industry continues at an ever increasing rate. Currently under construction are 3-30' towers and 1-40' tower.

(c) Engineer Comments - Significant Events

(1) 27 December 1969 - Completed 1-20' tower for 1st Motor Transport Bn..

(2) 31 December 1969 - Completed 2-20' towers for FLC.

(3) 31 December 1969 - Completed 11-6' X 8' bunkers at Company "C", 7th Engineer Battalion.

(4) 3,136 cubic yards of rock was hauled and spread on the 7th Engineer Battalion's lines of communication and in the An Hoa LSU.

(5) Starting on 15 November 1969, the 7th Engineer Battalion supplied a minimum of 10 tractors in support of the 2nd ROK Brigade on Barrier Island. This operation, known as Victory Dragon 17-31, showed the 7th Engineers, under the supervision of 1stLt R. A. MCLARTY, clearing 3100 acres of land and destroying 2450 bunkers, not including the innumerable pieces of ordnance that was captured or destroyed. From 15 November 1969 through 31 December 1969 then the operation was coming to an end, the Battalion records show 1 Marine killed (non-hostile), 3 Marines killed (hostile), 3 Marines wounded (non-hostile) and 8 Marines wounded (hostile.) All of the hostile wounds were the result of enemy booby traps, mines, and rockets. From a lessons learned standpoint, experience showed that when conducting a land clearing operation in small trees and bamboo, it is imperative to have safety cages on the tractors. Most of our non-hostile wounded and the non-hostile KIA resulted from falling trees. Because of the language barrier, coordination was a mutual problem but with constant effort it was overcome and the operation ran smoothly for the majority of the time.
