Company "A" (Rein), 7th Engineer Battalion, assumed the majority of the responsibilities formerly held by the 7th Engineer Battalion. Company "A" continued support of the III Marine Amphibious Force within the Danang area. The company assumed maintenance responsibility of 32.3 miles of road and conducted daily mine sweeps of 21.8 miles of road. The company maintained 7 water points in the Danang area producing 2,588,000 gallons of water.

a. Personnel and Administration. None

b. Enemy, Weather and Terrain. The weather in the Danang area was hot and humid with the average noon time temperature being 96°F.

c. Enemy Activities. The journal of enemy activities was handled by the 7th Engineer Battalion until the 1st of August, 1970. At this time, Company "A" (Rein), 7th Engineer Battalion, assumed this responsibility and it will be recorded in the August Command Chronology.

d. Organization and Operations

(1) Officer Assignments - See TAB A, Enclosure (1).

(2) Operations 19-31 July 1970

(a) Horizontal Construction - During the last 13 days of July, the Company hauled 996 cubic yards of earth products. A total of 764 cubic yards of asphalt were hauled to QL-1S in support of MCB 62. CBR in the amount of 168 cubic yards was hauled from Camp Love to Camp Books (Maintenance Battalion) to assist the Company in setting up a heavy equipment lot. Sand in the amount of 64 cubic yards was hauled to Camp Love in support of the 7th Engineer Battalion. Company "A" dump trucks also provided hauling assistance to the 7th Engineer Battalion on route 4E from route 540 to route 1-D.
