NARRATIVE SUMMARY

Company "A" (Rein), 7th Engineer Battalion, continues to support III Marine Amphibious Force within the Danang area. The company continued maintenance responsibility of 32.2 miles of road through 24 January 1971. On 24 January 1971 the assignments for road maintenance responsibility was reassigned. Company "A" now is assigned responsibility of HL 540 (AT899770 - AT913587), HL 542 (AT946760 - AT912743), ML-1C (AT999700 - AT988644), ML-1D (AT988644 - AT968584), ML-6 (AT998737 - AT946700), ML-8 (BT001722 - AT949707), ML-12W (BT032643 - AT991641), a total of 34.70 miles of road. Additionally the company was assigned to upgrade LTL-4 West (AT912579 - AT897569). This requires bringing up to grade and capping the road. Also, the company carried the minesweep responsibility for 5.1 miles of road, found and destroyed ten pieces of ordnance.

The company operated one water point and produced 887,000 gallons of potable water.

The company was assigned to support MCB-3 with M-51 dump trucks for repair of LTL-4 East.

The company continued the acquisition, issue, and control of TSEC materials for III Marine Amphibious Force.

1. Personnel - The company lost 48 enlisted and one officer through normal rotation and gained 34 men through normal replacements. Lance Corporal R. G. VAUGHAN died on 21 January 1971 as a result of drowning during an authorized recreation period. Nine men were promoted to Lance Corporal, two men received Meritorious Mast.

2. Enemy, weather, terrain

a. Enemy - The enemy caused damage to one abutment and one span of a bridge on ML-1C (1T993685). The company mine sweep teams found ten pieces of enemy ordnance.

b. Weather - There were nine days of rain during the month, this hampered road maintenance for four days.

(2) Company Supply has processed 611 new documents, filled 133 and 38 were cancelled. Out of 554 old documents on back orders 156 were completed and 132 were cancelled. Total of 706 documents are now on back orders of these 9 are O2 priority over 30 days old. With direct exchange, there were 63 new documents with a fill of 56, leaving 7 being placed on back order. O/S documents of 28, 12 were filled and 16 were cancelled, leaving a total of 7 documents outstanding in direct exchange.

4. Motor Transport : A total of 44,614 miles were logged in by the company motor transport vehicles. There were 10,840 tons of earth products 18,000 gallons of Non-potable water and 12,000 gallons of road oil hauled for road construction. There 4,326 passengers transported and 1166 tons of equipment and general cargo. There was a total of 34,800 gallons of fuel oil used in support of equipment.

5. Maintenance: The company maintenance platoon received 198 work orders of which 168 were completed. There were 61 work orders open at the beginning of the month and 57 of these were completed. There are 34 pending work orders 3 are combat deadline awaiting parts, 7 are in higher echelon. There are 13 work orders awaiting parts which do not deadline the vehicle or equipment, 13 work orders which are in the process of being worked on now.
