Period Covered: 1 June 1966 to 30 June 1966

I. Organization of the 7th Motor Transport Battalion

On 1 June 1966 the 7th Motor Transport Battalion consisted of H&S Company and Companies A, B, C and Transport Company. The Commanding Officer, principal staff and subordinate commanders were as follows:

II. Narrative Summary of Significant Events

1. During the month of June, the Battalion continued operations under the operational control of the 1st Marine Division. A summary of motor transport operations for the month of June is as follows:

Eleven incidents or contacts were made during these tactical convoys. During the period 1-2 June alone, an additional 195 trips were made transporting 155 troops with gear, 930 pallets of all classes of supplies and 122 tons of bulk cargo of all classes in support of the debarkation of RLT-5.

2. The continuation of the intensified maintenance effort directed toward Company A during the month of May has resulted in decreasing the overall percentage of deadlined vehicles from 30% to the present 16%. The "Motor Stables" concept, a comprehensive and systematic method of combating current first and second echelon maintenance problems, has continued to prove its effectiveness as reflected by the high availability ratio of prime movers. The overall Battalion deadline rate has been reduced to a constant 7% to 9%.

3. From 16-22 June elements of all Companies operated in support of Operation Kansas transporting 650 tons of Class V. Convoys involved in this operation made a total of 1 contact receiving no casualties and no equipment damage.

4. On 29 June Company B and elements of Company C transported 950 troops of 2/7 to the LSA at Quang Ngai in support of Operation Oakland. There were no contacts.

III. Detailed description of Significant Events

- 1 Jun Company C conducted Motor Stables on organic motor vehicles. Elements of 7th MT Bn made 104 trips transporting 556 pallets of Class II and IV supplies, 284 55 gal. drums of Class III and 10 ton of bulk Class IV in support of the debarkation of RLT-5.
- 2 Jun H&S Company conducted Motor Stables on organic motor vehicles. Elements of 7th MT Bn made 93 trips transporting 55 troops with baggage, 374 pallets of Class I and II, and 55 tons of bulk Class II and IV in the conclusion of the debarkation of RLT-5.
- 4 Jun Convoy comprised of Transport Company and elements of Companies A and B transported 116 tons of Class V Artillery to the LSA at Quang Ngai. Convoy off loaded at the LSA and picked up 10.3 tons of cement at the ARVN Camp at Quang Ngai for delivery to the ARVN Camp at Binh Son as part of the Civil Action program. There were no contacts.
- 6 Jun Transport Company conducted Motor Stables on organic motor vehicles. Convoy comprised of elements of Company B transported 10 tons of Class V to the ARVN Compound at Tam Ky. There were no contacts.

- 7 Jun Company C performed Motor Stables on organic motor vehicles. Convoy comprised of elements of Transport Company and 9 refuelers from MAG-36 delivered 11600 gallons Class IIIA to the ARVN fuel farm at Tam Ky. There were no contacts.
- 8 Jun Convoy comprised of elements of Transport Company and 12 refuelers from MAG-36 transported 15200 gallons Class IIIA to the Airfield at Quang Ngai. While convoy was proceeding south on route 1 the last security vehicle was hit by a controlled mine. The vehicle was extensively damaged and two WIA's were sustained. Upon returning to the CP, the convoy received three rounds SA fire at the same location as the mine incident. There were no casualties and the convoy did not stop.
- 9 Jun Headquarters and Service Company performed Motor Stables on organic motor vehicles.
- 10 Jun Company B performed Motor Stables on organic motor vehicles.
- 11 Jun Convoy comprised of Company A and elements of Transport Company transported 144 tons of Class V Artillery to the LSA at Quang Ngai. There were no contacts.
- 13 Jun A Post Exchange operated by the 1st MarDiv PX Officer was opened in 7th MT Bn area. Transport Company and Company A (less 2nd platoon) performed Motor Stables on organic vehicles.
- 14 Jun Company C and 2nd platoon, Company A, performed Motor Stables on organic vehicles.
- 15 Jun Company B (less 2nd platoon) performed Motor Stables on organic vehicles.
- 16 Jun H&S Company performed Motor Stables on organic vehicles. Convoy comprised of elements of Company A and Transport Company transported 70 tons of Class V Artillery to Battery K, 4/12, at BT 238318. There were no contacts.
- 17 Jun Convoy comprised of elements of Companies A and B and Transport Company transported 84 tons of Class V to Battery K, 4/12, at BT 238318. Upon return to SP it was discovered there were large rocks, boulders and logs placed on Route 1 in a serpentine pattern to divert traffic into one lane for a distance of approx. 1 mile. A serial comprised of Company A and Transport Company transported 116 tons of Class V to the LSA at Tam Ky as part of an FLSG-B convoy. While proceeding north on Route 1

approaching Tam Ky an M-26 grenade was thrown into the bed of one of the vehicles. The pin had been pulled partially out of the grenade and there was no detonation. Convoy comprised of Company C transported 64 tons of Class V to Battery L, 4/12, at BT 175418. There were no incidents.

- 18 Jun Convoy comprised of Transport Company delivered 108 Tons of Class V Artillery to Battery K, 4/12, at BT 141578. Return of convoy delayed until 191945H due to mined bridge.
- 21 Jun Convoy comprised of Transport Company and elements of Company B transported 120 tons of Class V to the LSA at Quang Ngai. There were no contacts.
- 22 Jun Transport Company and Company A performed Motor Stables on organic motor vehicles. Convoy comprised of Company A and elements of Company C transported 88 tons of Class V Artillery to the LSA at Tam Ky. Convoy unable to cross bridge at BT 430109 due to damage incurred when a 155 SP attempted to cross. Convoy returned to Tam Ky for the night. A serial formed from this convoy attempted to deliver Class I and IV supplies to 3/1 on 23 Jun but were unable to proceed more than 5 miles north of Tam Ky due to mined bridge at BT 258288. Serial returned to Tam Ky and formed with convoy to proceed to Hill 54 where they spent the night. Convoy departed Hill 54 23 Jun and returned to 7th MT Bn CP. Convoy comprised of elements of Companies C and Transport retrieved a 7th MT Bn vehicle and a 4/11 vehicle involved in an accident at BT 867185. There were no contacts.
- 23 Jun Companies H&S, B and C performed Motor Stables on organic motor vehicles.
- 24 Jun Convoy comprised of elements of Companies A and C transported 102 tons of Class V Artillery to the LSA at Tam Ky. Convoy received 3 rounds SA fire at BT 395157 while returning to CP. Negative results.
- 25 Jun Convoy comprised of elements of Companies A, B, C and Transport delivered 110 tons of Class V Artillery to the ARVN Class V dump at Quang Ngai. Convoy stopped at BS 589950 while engineers blew mine. One vehicle received a SA round with negligible damage. No casualties. Convoy spare parts kit was assembled by S-4 to be carried on all convoys.
- 26 Jun Convoy comprised of Companies A, B and Transport delivered 135 tons of Class V Artillery to the ARVN Class V dump at Quang Ngai. There were no contacts.

- 28 Jun Major A. C. Stephens, Jr. assumed command of 7th MT Bn. (See reference (a), Appendix A). 2nd Lt. Warren I. Shick assumed duties as the S-1/Adjutant. Companies A, C and Transport held Motor Stables on organic motor vehicles.
- 29 Jun Convoy comprised of Company B and elements of Company C transported 950 troops of 2/7 to the ISA at Quang Ngai. There were no contacts.
- 30 Jun H&S Company and Company B held Motor Stables on organic motor vehicles.

1. Unit Operations. Convoy comprised of elements of Transport Company and 12 refuelers from MAC-36 transported 15,200 gallons Class IIIA to the Airfield at Quang Ngai. Elements of Company 1, 3/7, provided security. Convoy departed SP (RJ Routes 1 & 22) at 080730H and returned to the SP at 081520H.

2. Contacts.

a. While convoy was proceeding south on Route 1 the last security vehicle was hit by a controlled mine at BS 585950 at 080755H. Vehicle carrying security forces was badly damaged. Convoy halted and security force dispersed to protect convoy. Engineers detected and destroyed one other mine consisting of three 105mm rounds. There were five mounds of dirt approximately two feet high on the roadway, one of which had some wire leading from the mound into a rice paddy and was the one blown by the engineers. The other mounds contained no mines. Several Vietnamese leaflets were found lying on top of the mounds secured there by rocks. Security forces captured one VCS. Damaged vehicle was recovered by wrecker and returned to 7thMFBn CP. Convoy proceeded.

b. While convoy was proceeding north on Route 1 an M38A1 vehicle in the middle of the convoy received one round SA fire at BS 585950 at 081505H. Two rounds SA fired behind last AN/MRC36 in convoy. Convoy proceeded without returning fire.

3. Casualties. Four friendly KIA, two from 7thMFBn and two from Company 1, 3/7, were sustained as a result of the mine detonation. There were no casualties as a result of the SA fire encountered on the return trip.

4. Battalion Plans. 7th Motor Transport Battalion remains in direct support of the 1st Marine Division.

checked bed of vehicle and found an M-26 grenade with the pin partially pulled. Driver reset pin and convoy continued.
