

COMMAND CHRONOLOGY

Unit: 7th Motor Transport Battalion, 1st Marine Division (Rein), FMF

Period Covered: 1 July 1966 to 31 July 1966

I. Organization of the 7th Motor Transport Battalion

On 1 July 1966 the 7th Motor Transport Battalion consisted of H&S Company and Companies A, B, C and Transport Company. The Commanding Officer, principal staff and subordinate commanders were as follows:

II. Narrative Summary of Significant Events

1. During the month of July, the Battalion continued operations under the operational control of the 1st Marine Division. A summary of motor transport operations for the month of July is as follows:

Five contacts were made during these tactical convoys with no casualties or vehicle damage sustained.

2. Systematic, supervised 1st echelon maintenance continues to prove its effectiveness as reflected by the high availability of prime movers. The overall Battalion deadline rate has been reduced to a constant 3% to 7% from last month's 7% to 9%.

### III. Detailed description of Significant Events

5 Jul The first Driver of the Quarter selection was made in accordance with BnO 1650.1 (see reference (a)). LCpl. Dennis Carstensen, Transport Company, was selected and has been recommended for meritorious promotion, awarded an R&R and an appropriate certificate (see reference (b)).

6 Jul Convoy comprised of Transport Company, elements of Company A, and 11 refuelers from MAG-36 transported 133 tons of Class V Artillery and 25,000 gallons of Class IIIA to the airfield at Quang Ngai. Convoy formed into two serials. The first serial made two contacts one half hour apart and received a total of 11 rounds SA fire with no damage or casualties sustained. The second serial made no contacts.

9 Jul Captain Herbert H. Ruhl assumed duties as Battalion Executive Officer.  
1stLt. Joseph T. Dunn, Jr. assumed duties as Company Commander, Company B, vice Captain John H. Redgate.

12 Jul Convoy comprised of elements of Company C and Transport Company transported 56 tons of Class V artillery to the LSA at Quang Ngai. Convoy received one round SA fire with no casualties or damage sustained.

14 Jul Major F. R. Smith assumed duties as Battalion Executive Officer.

15 Jul Convoy comprised of elements of Company A transported Company E, 2/7, and Company L, 3/7, from vicinity of Bihn Son to their respective CPs. There were no contacts.

19 Jul Convoy comprised of elements of Company B and Transport Company delivered 92.5 tons of Class V Artillery to the LSA at Quang Ngai. Convoy received 10-20 rounds SA fire. There were no casualties and no damage was sustained.

26 Jul Convoy comprised of Company C and elements of Company B transported 800 troops of 2/7 to The Loi (2) in support of Operation Franklin. There were no contacts.  
Convoy comprised of elements of Company B transported 360 troops of 1/7 to Long Hoi (1) in support of Operation Franklin. There were no contacts.

27-29 Jul Company A supported 3/11 and 7th Marines in displacing their respective forward CPs during Operation Franklin.

28 Jul This Battalion received 29 Truck, 6x6, 5 Ton, M-54 under the vehicle rehabilitation program. The vehicles have been issued to Company A and will be put in service as acceptance checks are accomplished. Vehicles which have been replaced will be turned-in to FMSG-B for evacuation and eventual rebuild. This turnover of vehicles replaces all the vehicles of Company A which have been in-country for approximately one year.

29 Jul Convoy comprised of Company A and elements of Company C transported 128 tons of Class V Artillery to the LSA at Quang Ngai. The convoy also transported 15 tons of reinforcing rod, 1000 bags cement, and one revival tent from Quang Ngai to Bihn Son in support of the Civic Action Program. There were no contacts. The Commanding Officer, in behalf of the Commanding General, presented the Purple Heart Medal to LCpl. Richard Alvarez. LCpl. Alvarez was wounded in action on 8 June 1966 while driving a vehicle in a resupply convoy to the LSA at Quang Ngai. The Commanding Officer administered the oath to SSgt. John W. Wheeler commissioning him a 2nd Lieutenant in the U. S. Marine Corps. The Commanding Officer awarded a Meritorious Mast to Cpl. Rudy Zarate for his meritorious performance of duty serving as a truck section leader in support of 2/5.

30 Jul Company A received a letter of appreciation from the Commanding General, Fleet Marine Force, Pacific. See Reference (c).

1. Purpose. To establish a Company Driver of the Month and a Battalion Driver of the Quarter program within this Battalion.

2. Background. This command desires to recognize the effort of individual drivers who devote long hours to the care of their vehicles. One method of accomplishing this recognition is to select, through competition, the most outstanding driver in each company each month. The most outstanding driver in the Battalion would be selected from the company nominees. The honor and recognition bestowed on selected Company and Battalion drivers will be a tangible result of their own efforts in safe driving, military and technical knowledge, and preventive maintenance.

3. Action.

a. Company Driver of the Month Program.

(1) At the end of each month Company Commanders will select three (3) nominees from which they will choose a Company Driver of the Month. The three (3) nominees will be placed in numerical sequence one (1) through three (3). Only personnel in the rank of E-4 and below will be eligible for this award.

(2) Company Commanders will select the Driver of the Month by using but not necessarily limiting themselves to the criteria outlined in enclosure (1) with the exception that items 1 and 2 of enclosure (1) need not be used at the company level.

(3) Personnel selected as the Company Driver of the Month will be eligible for nomination by their Company Commander for the Battalion Driver of the Quarter award.

(4) Personnel selected as the Company Driver of the Month will receive a plaque denoting this award which will be

mounted on the front of his vehicle for the month following his selection.

(5) Personnel selected as the Company Driver of the Month will receive a suitable certificate for their retention denoting this selection.

b. Battalion Driver of the Quarter.

(1) Nomination. At the end of each quarter Company Commanders will nominate one (1) of the three (3) Drivers of the Month for that quarter to the Battalion Driver of the Quarter board. Nominations will be submitted in writing to the Senior Member by the 20th day of the last month of the quarter and will contain the information outlined in enclosure (2).

(2) Selection. The driver nominated for the Battalion Driver of the Quarter will be selected by the Battalion Board from the five (5) Company nominees. The board will submit their recommended nomination to the Battalion Commander for approval. The five (5) company nominees will be placed in numerical sequence one (1) through five (5) by the board. All nominees will appear before the board for an interview. Prior to appearing for the interview, nominees will be administered a written General Military Subjects Proficiency and Motor Transport Proficiency test by a member of the board.

(3) Composition and Function of the Board. The Battalion Driver of the Quarter Board will consist of:

- (a) Battalion S-3 Officer (Senior Member)
- (b) Battalion Sergeant Major
- (c) Battalion Truckmaster
- (d) Each Company Truckmaster

The Battalion Driver of the Quarter Board will meet at the end of each quarter at the call of the Senior Member. The board will select a nomination for the Battalion Driver of the Quarter based on the criteria outlined in enclosure (1). Company truckmasters will not vote when the nominee from their company appears before the board. The Senior Member will only vote in case of a tie.

(4) Awards.

(a) Personnel selected as the Battalion Driver of the Quarter will be recommended for meritorious promotion.

(b) Personnel selected as the Battalion Driver of the Quarter will be awarded an R&R quota during the quarter following their selection.
