COMMAND CHRONOLOGY

Unit: 7th Motor Transport Battalion, 1st Marine Division (Rein), FMF

Period Covered: 1 November 1966 to 30 November 1966

I. Organization of the 7th Motor Transport Battalion

On 1 November 1966 the 7th Motor Transport Battalion consisted of H&S Company and Companies A, B, C and Transport Company. Company B and Transport Company, 7th Motor Transport Battalion Operational Control Task Force X-Ray. 7th Motor Transport Battalion assumed operational control of Company A and Transport Company 9th Motor Transport Battalion. II. Narrative Summary of Significant Events

1. During the month of November the Battalion continued operations under operational control of the 1st Marine Division. The following figures are based on commitments assigned this Battalion not to include Company B and Transport Company 7th MTBn but to include Company A and Transport Company 9th MTBn.

III. Detailed description of Significant Events

- 8 Nov Convoy comprised of 17 task vehicles of Company C and supporting engineer vehicles from 3rd Engineer Battalion transported 50 tons of wheat. Wheat provided by 29th Civic Action Company U. S. Army and delivered to Duy Xuyen (BT 047512) and returned. Security provided by "G" Co 2nd Bn 1st Marines. Convoy proceeded south on Route 1 from 2/1 CP and received 10-12 rounds of AW fire (BT 075517). Returned 15 rounds of AW fire to enemy location at approx (BT 075518). Vehicles did not sustain any damage and proceeded.
- 9 Nov Convoy comprised of 10 task vehicles transported "M" Company 1/3 from 3/1 to 8 miles southeast of 1/1. 7 troops from 3/1 provided security. Convoy while returning from 1/1 area received an undetermined number of SA and AW fire, 1 mortar round at BT 033640 at 08-1940H. Troops dismounted vehicles and returned undetermined amount of SA fire. Troops remounted vehicles and proceeded. Vehicles sustained minor damage.
- 11 Nov Convoy comprised of 41 task vehicles transported rice/cement and generator spare parts from Da Nang to An Hoa. Convoy of 12 vehicles transported 300 troops from Delta Company CP to 3/1 CP. Convoy received AW fire at BT 044578, no fire returned. Vehicles sustained no damage.
- 20 Nov Battalion provided blocking force in conjunction with Operation Baltimore, Southern Sector 1st Marine Division Rear Area Defense OPORDER 4-66. Operation Baltimore sweep resulted in the capture of miscellaneous publications an assorted small arms ammunition and apprehension of 26 Viet Cong suspects.
- 24 Nov Convoy comprised of 11 task vehicles transported 18 tons of Class II supplies from Naval Support Activity Da Nang to 3/7 CP (AT 920580). Convoy comprised of 8 task vehicles transported 16 tons of Class II and 18 tons of Class IV supplies from FLSG-A to 1/1 CP (BT 104583). Convoy proceeding southeast to 1/1 CP received 7-8 rounds of SA sniper fire at BT 042621 at 240835H. Convoy sustained no damage and proceeded without returning fire.

1. Unit Operations

1. Unit Operations

a. Convoy comprised of 5 task vehicles of A Company 7th, 5 task vehicles of A Company 9th, 2 task vehicles of Transport Company 9th and 1 task vehicle of C Company 7th transported 18 tons of Class II from 7th Bn (AT 984726) to 3/7 (AT 920580). Convoy was preloaded and staged for convoy on 23 Nov 66. Convoy departed SP (AT 984726) at 24-0945H and returned to SP (AT 984726) at 241830H.

b. Convoy comprised of 4 task vehicles of Transport Company 9th and 4 task vehicles of 3rd Motor Transport Battalion transported 16 tons of Class II and 18 tons of Class IV from FMSG (AT 952787) to 1/1 CP (AT 104583). Convoy departed SP (AT 984726) at 240815H and returned to SP (AT 984726) at 241445H.

2. Contacts. Convoy while proceeding southeast to 1/1 received 7-8 rounds of SA sniper fire at Check Point 29 (AT 042621) at 240335H. Convoy sustained no vehicle damage and proceeded without returning any fire. (See 1.b)
