NARRATIVE SUMMARY

1. During this reporting period, 7th Motor Transport Battalion remained under the operational and administrative control of Force Logistic Command, DaNang, RVN. Company "C" remained in the Phu Bai TAOR in support of Force Logistic Support Group Alpha. Company "T" remained in the Dong Ha TAOR in support of Force Logistic Support Group Bravo.
2. The Operational Summary shown herein includes all elements of the 7th Motor Transport Battalion during the reporting period.

In the Da Nang TAOR:

- a. Miles Traveled - 72,002
- b. Personnel Transported - 7,178
- c. Cargo Transported - 13,390 S/T

In the Phu Bai TAOR:

- a. Miles Traveled - 33,846
- b. Personnel Transported - 3,158
- c. Cargo Transported - 11,435 S/T

In the Dong Ha TAOR:

- a. Miles Traveled - 29,218
- b. Personnel Transported - 390
- c. Cargo Transported - 5,684 S/T

In addition to these TAOR runs, the Battalion conducted Line Haul operations between DaNang and An Hoa. The following is a summary of these Line Hauls.
