## NARRATIVE SUMMARY

The company continued support of United States and Korean Marine units in the Danang TAOR with POL products. There has been no significant changes in usage during the month. The company remained in a reduced readiness category due to supplies and equipment not on hand as a result of combat losses from the Ammunition Supply Point One explosion. Response from the supply system is slow in spite of priority 02 requisitions and MARES GA cards. The company is capable of maintaining current commitments, but unable to handle any significant increases in fuel handling commitments. During the period indicated, 181,370 gallons of Mogas and 272,600 gallons of Diesel fuel were issued. Because of bad weather, An Hoa received twenty (20) 500 gallon pods of Mogas and fourteen (14) 500 gallon pods of Diesel, delivered via KC-130 aircraft. A recommendation has been submitted to reduce the allowances of this company to those authorized in T/E P3333 in lieu of said allowance plus the assets of fuel systems and certain other major equipments authorized a Bulk Fuel Company, Supply Battalion. This recommendation was made in view of the reduced commitment and mission of this company.

Lack of suction hose (4" X 50') is sufficient to deadline eight (8) fuel systems, and the lack of 350 GPM pumps is capable of deadlining seven (7) said systems. Requisitions for missing components and other end items of combat essential equipment have been passed to ICP Philadelphia. However, it is anticipated that several months shall elapse before material will be furnished this company.
