During the month of August 1968, the 9th Engineer Battalion, LtCol H. E. PEREA Commanding, continued as its primary mission the maintenance and upgrading of RVN Route #1 from Chu Lai (BT 520044)

to the Song Cau Lau (BT 091554). The maintenance and road networks for the Americal Division, Supply Company (Rein) FLC, plus engineer support of free world forces in the Chu Lai TAOR continued to require a significant engineer effort.

\*Company "A" continued maintenance and upgrading of RVN Route #1 between Chu Lai (BT 520044) and Tam Ky (BT 330209), a distance of 16 miles and engaged in vertical construction in support of the Americal Division.

Company "B" (-) was located in the Hue-Phu Bai area, RVN YD 893129, in direct support of Task Force X-Ray. First Platoon, Company "B" was located at Chu Lai (BT 520044) and is engaged in bridge and vertical construction.

\*Company "C" (-) was located at Hill #10 (BT 199390) and was in the process of maintaining and upgrading RVN Route #1 from Hill #29 (BT 226320) to Thang Binh (BT 175418) a distance of 11 miles. The 2nd Platoon, Company "C" was located on Hill #29 and was in the process of upgrading and maintaining RVN Route #1 from Tam Ky (BT 300235) north to Hill #29 a distance of 8.2 miles.

Company "D" continued maintenance and upgrading of RVN Route #1 from Thang Binh (BT 175418) to the Song Cau Lau (BT 091554), a distance of 11.1 miles and engaged in construction in support of Free World Military Forces.

During the month of August, upgrading and repair of RVN Route #1 was broken down into three areas of responsibility; Chu Lai to Tam Ky, Tam Ky to Thang Binh, and Thang Binh to the Song Cau Lau.

Between Chu Lai (BT 520044) and Tam Ky (BT 330209), 9th Engineer Battalion personnel expended 5544 man hours and 4793 equipment hours in hauling 14,168 cubic yards of rock and placing 2,200 gallons of asphalt.

Between Tam Ky (BT 300209) and Thang Binh (BT 175418), the 9th Engineer Battalion personnel expended 6500 man hours and 5317 equipment hours in hauling and placing 8418 cubic yards of rock and 4170 cubic yards of fill.





2. Civic Action

Eight (8) Med-caps were held this month in Tich Tay Hamlet. The med-caps treated 92 people and assisted a Vietnamese doctor from the Ly-Tin area in Cholera inoculations. In all 100 people were inoculated, mostly children. The 9th Engineer Battalion donated 50 bags of cement to Tich Tay Hamlet for a "public improvement project" which is a Buddhist Temple. This project is 96% complete. Also this command donated two truck loads of scrap lumber to the Tich Tay Hamlet for minor repairs on homes. In addition the "Local Combat Youth Squad" received ten (10) M-2 carbines from Ly-Tin District Headquarters. They are undergoing training in combat tactics and marksmanship from 9th Engineer Battalion instructors.


