1. The 9th Engineer Battalion was under the Command of Lieutenant Colonel E. K. MAXWELL from 1 to 22 February 1970, and under the Command of Lieutenant Colonel JOHN P. KRAYNAK from 23 to 28 February 1970. The Battalion continued its primary mission of maintenance and upgrading of Vietnam Route #1 from Chu Lai (BT520044) North to the Cau Lai River (BT081546) and the preparation for placement of asphaltic surfacing material from the end of the present pavement (BT210373) to the Ly Ly River (Hill #63 BT146457) Engineer support to Americal Division, USA and Free World Forces continued to require significant Engineer Support.
2. Company "A" Located at the Battalion Compound Post (BT514045) continued to stand down in preparation for operation Blue Jay. Company "A" departed Chu Lai at 1200 hours 27 February, arrived in Danang 1830, 27 February 1970, began debarking at Ferry Landing, Staged at Deep water pier, Departed Danang 2200 hours 2 March 1970, eta Hawaii 15 March 1970.
3. Company "B" located at Hill #10 (BT199389) continued its primary mission of Mine Sweeps, maintenance and up grading in preparation of Asphaltic paving of Vietnam Route #1 from (BT210373), to Ly Ly River (Hill #63 BT146457) a total of 8.0 miles. They also continued construction support to Free World Forces, throughout the area of operations.
4. Company "C" located at the Chu Lai compound with elements of 3rd platoon located at Tam Ky (BT298230) was engaged in support of Free World Forces, in Chu Lai - Tam Ky areas, with emphasis on its primary mission of Mine-Sweeps, Maintenance of Bridges, culverts and repairs to Republic of Vietnam Route #1 from Chu Lai (BT520044), to end of Asphaltic pavement (BT210373) a distance of 31 miles.
5. Company "D" located in the First Marine Division area of operation at Landing Zone Baldy (BT136448) (Hill #63) continued their primary mission of daily Mine Sweeps, and maintenance of QL #1 from Ly Ly River (BT146457), North to Cau Lai River (BT081546), a distance of 8.0 miles. The company also carried the additional road maintenance responsibilities of Route # 535 from Huong Xuan River (BT144457), to Landing Zone Ross, (BT024345) a distance of 12.0 miles, and Engineer support of Free World Forces, throughout the area of operations.

6. During the month of February the main emphasis of the 9th Engineer Battalion was directed toward the upgrading of the 16 miles of QL-#1 from the end of the existing pavement (BT210373) to the Cau Lau River (BT081546) North of the Ly Ly River (BT144457). Mobile Construction Battalion, seven worked at reconstructing the base and subbase of the road and widen it where necessary. 4237 cubic yards of 2"(-) base rock, and approximately 10,000 cubic yards of sand for a total of approximately 14,237 cubic yards of mineral material were used in this area. For the portion of the road South of the Ly Ly River 4913 cubic yards of 2"(-) base rock were hauled from Chu Lai. A total of 8567 cubic yards of mineral products were used on this portion of road during February. On the 16 miles of road in question, a total of 22,804 cubic yards of mineral products were used in the month of February. Also during this month approximately 300 cubic yards of 6"(-) base rock and 200 cubic yards of 2"(-) base rock were used on Route #535 for maintenance and upgrade.

7. The 2nd Provisional Land Clearing Company of 9th Engineer Battalion, FMF assisted by the elements of the 39th Engineer Battalion, USA. conducted operations in the 1st Marine Division TAOR. Other units participating were elements of ROK Marines and elements of the 1st Marines, 1st Marine Division.

a. Ten Vietnamese were treated at the Battalion Aid Station at BT514046 and by field companies.

b. A psyops movie was shown at Long Phu II hamlet at BT513031 on 3 February 1970.

c. A ribbon cutting ceremony was held at Chu Lai New Life Orphanage for the completion of a three room orphanage building on 5 February 1970.

d. Food was provided for a Vietnamese Navy party on 3Feb70, and for a IRO workers party on 4Feb70.

e. Hoa Van swine were given shots by the Americal Division Veterinarian on 13 Feb 70.

f. Minh Tan orphans recieved 150 toys on 5 Feb 1970.

Long Phu I swine project recieved ten bags of cement, six loads scrap wood, thirty-three boxes of protein food for swine, four sheets tin, one sheet ply wood, and eight swine pamphlets. Ly Tin District Headquarters recieved five hundred bags of cement, two resettlers kits, one midwifery kit, one case of syringes and fifteen swine pamphlets.

h. Messhall garbage was donated to swine projects in Hoa Van hamlet (BT512048), Dong Yen hamlet (BT504055), and Long Pau I hamlet (BT506042).
