i. Civic Action:

(1) During the month of March 9th Motor Transport Battalion conducted a total of 9 Medcaps treating some 450 Vietnamese Nationals. We delivered 77 bags of cement and 3 truck loads of sand for Village project, 120 bars of soap, 800 newspapers and 1 General Purpose tent to be used as a grainery.

j. Administration: There are no administrative problems at this time.

k. Personnel: During the first two weeks of the month of March, this Battalion dropped to the C-2 personnel status. At present there are no personnel problems.

l. Intelligence: None

m. Communications: The loss of two (2) radio vehicles, one (1) AN/MRC 109 (7Dec68) and one (1) AN/MRC 83 (15May68), has detracted from our convoy control communications capability, but thus far has had no adverse effect on the unit's performance of its assigned mission.
