## PART II

NARRATIVE STATEMENT

During the month of January this command conducted intensive MOS training and required GMS training in order to maintain a state of combat readiness despite the continued high rate of personnel turnover. During January the command transferred 15 enlisted personnel while joining 15 enlisted personnel and transferring 2 officers.

A foot march to the field was conducted on 10 and 12 January for Port and Starboard sections respectively. GMS training, including the basic Marine rifleman, was conducted on the one day exercise.

Make-up General Military Proficiency Testing was conducted 18, 20 and 22 January.

A company communication exercise was conducted 23-25 Jan 68 to increase efficiency of communication personnel in Command Post communication installation. The exercise included Radio Relay sites at Camp Schwab, Hansen Training Area #2 and Camp Hansen which was tied in the company switchboard and MAG-line through the Camp Hansen switchboard. A Comm Center was positioned at Hansen Area #2 and traffic was sent from the field site to the Camp Hansen Comm Center. The Radio Platoon established three drill nets.

Cross training in voice radio procedure was conducted for Radio Relay personnel and a special class was presented to all company personnel on field message book procedure during the week of 15-19 Jan.

A second foot march was conducted on 31 Jan and 2 Feb 68 with GMS training in the field.

Operation BADGER CATCH commenced on 23 January with the landing of BLT 3/1 by helicopters and landing craft in Quang Tri Province, RVN. On 26 January OPCON for BLT 3/1 less 1st Plt Co "A", 1st MT Bn, Clearing Plt Co "C" 1st Med Bn and Dental Co 9th MAB, LSU passed to CG III MAF, who passed OPCON to CG 3rd MarDiv who passed OPCON to 1st Amtrac Bn. On 31 January the BLT was still engaged in Operation BADGER CATCH.

## SECRET

The 26th Marines continued to execute Operation SCOTLAND during the month of January. On 17 January, the Second Battalion, 26th Marines (2/26) arrived and was placed under the operational control of the 26th Marines, thus bringing the entire Regiment together for the first time since its arrival in Vietnam. The operation, which began on 1 November 1967, saw enemy sightings and contacts increased slightly during the first two weeks of the month, and emphasis was shifted from harassing and reconnaissance activities to probes. Reconnaissance teams consistently made sightings or saw indications of heavy enemy activity, and contact was made frequently. Each sighting or contact added to an evolving pattern which indicated that the enemy was increasingly interested in the defensive posture of Hills 950, 881S, 861, the Combined Action Company, the District Headquarters at Khe Sanh Village, and the Combat Base itself.

Operational control of BLT 2/4 was passed from CG III MAF to CTG 79 at 020600H Jan68, and OPCON of BLT 2/4 was passed from CTF 79 to CTG 79.4 at the same time. Embarkation of BLT 2/4 was completed at 040810H Jan68, and all ARG/SLF ALFA ships departed RVN for Subic Bay, R.P. on 6 January. Vehicles and personnel were debarked, and a ten day REHAB/TRNG period commenced immediately. On 13 Jan, CG III MAF requested ARG/SLF ALFA return to I CTZ waters as soon as possible. On 14 Jan, Colonel B.F. MEYERS relieved Colonel J.A. CONWAY in an informal ceremony, and all ARG/SLF ships were underway for RVN by 15 January. At 152318Z, COMSEVENTHFLT issued the initiating directive for Operation BALLISTIC ARMOR. The USS IWO JIMA, with TG 79.4 embarked, arrived in the I CTZ waters on the evening of 16 January. During the Vietnamese New Year Celebration (TET), ARG/SLF 79.4 was prepared to reinforce any one of a number of possible areas of employment in the event of an NVA/VC attack. On 22 January, CG III MAF requested ARG/SLF ALFA to land BLT 2/4 at Camp Evans in Thua Thien Province in order to provide security for the Camp and to commence Operation BALLISTIC ARMOR. CLF reported that BLT 2/4 (-) was firmly established ashore at 231130H. On 24 January, the SLF was reconstituted, and Operation FORTRESS ATTACK commenced at 270930H with the BLT's landing in the 9th Marines' area of operation. The ARG/SLF remained in support of operations ashore during the remainder of the month of January.

ARG/SLF Bravo underwent a REHAB period at Danang, RVN from 3 - 10 January 1968. On 10 January 1968 HMM-262 was rotated in-country to the First MAW. On the same date HMM-165 embarked aboard ARG BRAVO shipping to become the SLF squadron. From 11 - 23 January the ARG/SLF maintained a 24 hour reaction status for operations in I CTZ, RVN.

(6) Marine Corps Association Membership

Participation within the Marine Corps Association in the month of January for officers was 73.0%. Staff NCO participation showed 35.4%. Average for both staff and officers was 53.1% as compared to 47.7% in December.

b. Intelligence

(1) During this period, this section conducted daily intelligence briefings for officers and staff NCO's in transit to RVN. A total of 188 officers and 22 staff NCO's were briefed.

(2) The G-2 section also continued to conduct its monthly intelligence briefings for the officers of Camp Butler. A total of 43 officers were briefed during the reporting period.

(3) The Assistant Chief of Staff, G-2 participated in a planning conference in RVN with CTF 76/79 on 30 and 31 January 1968.

(4) Projects which required continued attention in their development during the reporting period are as follows:

(a) Special Intelligence studies.

(b) The up-dating of contingency intelligence plans and studies.

(c) Rapid Intelligence Incident Reporting System utilizing data processing assets within this Command.

(5) The section conducted two different informational lectures on "Why Vietnam" for the enlisted personnel of Camp Butler.

c. Training

(1) During the period 1-31 January 1968, Headquarters, 9th MAB continued its role of providing training support to units of the 9th MAB. This support includes the scheduling of school firing ranges, and other training requirements not available to units from within their own resources.

(2) OJT: Three officers and two enlisted Marines of 9th MAB performed OJT with III MAF during the month of January in the following fields: MASS 3, FLC/1st FSR, III MAF, 3rd Tank Battalion.

(3) Schools. The schools and courses attended by personnel of the 9th MAB are included in Appendix C.

d. Logistics

Significant tasks undertaken by the G-4 and the G-4 cognizant staff sections are as follows:

(1) The most significant coordinated program under the auspices of the G-4 during the month of January was the highly successful rehabilitation of BLT 2/4. A substantial number of major items of equipment were exchanged to include ordnance, engineer, electronics, motor transport, and general supply. In addition, certain major modifications were completed such as the installation of the AN/VRC-71 Radio Set in five (5) Ontos. A great deal of effort was displayed by the supply, ordnance, and embarkation sections under the cognizance of the G-4 in the support of the program.

(2) From 3 to 6 January, LtCol JOHNSON was at Subic Bay as an advisor to the BLT 2/4 rehabilitation. Upon his return, the staff was directed to prepare a study to determine the optimum cycle for future rehabilitation at Subic Bay from the 3rd FSR and 9th MAB standpoint.

(3) Colonel BUTCHER, ACofS, G-4, conducted a liaison trip to FMFPac in order to brief cognizant personnel on the recent BLT 3/1 rehabilitation at Subic Bay, to discuss the staff study on the rehab program, and to effect liaison with respect to Operation FORMER CHAMP.

(4) The ordnance section rendered assistance to the 9th MAB Units on various occasions during the reporting period, especially with reference to the inspection of weapons.

(5) The Brigade Embarkation Section coordinated the shipment of personnel and cargo, both surface and air, in conjunction with the rehab of BLT 2/4 at Subic Bay. The section was also instrumental in effecting the surface offload of ACB-1 and in the subsequent airlift of the unit to RVN. The Embarkation Officer accompanied the Assistant G-4 to the Seventh Fleet Scheduling Conference at John Hay Air Base, R.P.

(6) The Brigade Surgeon's office accomplished all normal administrative functions for Navy personnel of the 9th MAB. During the month, the Brigade received thirty-five hospital corpsman, most of whom were transferred to Company "A", 5th Medical Battalion, Camp Schwab. Six corpsman were reassigned to BAS, BLT 3/1 as replacements for casualties sustained during January 1968. The remaining corpsmen are to be used as replacements for units of the 9th MAB or as directed by EPDOPAC. Eight officers were detached and seven officers joined. The Brigade Surgeon, Capt R.M. MORGAN, USN, was detached on 17 January for duty at the USNH Oakland, California.

e. Embarkation

(1) In support of the Rehab of BLT 2/4, the Embark Office coordinated with PSB the movement of necessary supplies and equipment to and from Subic Bay.

(2) This section coordinated the air shipment to Subic Bay of training ammo for BLT 2/4 and VMA 223 with FMFPAC (FWD) and VMGR-152.

(3) The loading and unloading of LFORM continued to require the coordination and close supervision of this section.

f. Community Relations

(1) MACS-6

(a) Twice weekly English language classes were conducted for 45 Okinawan students and 90 children from Ginoza.

(b) During the month of January, the entire Henoko Village school house was repainted and all sanitation problems were rectified.

(a) Eight English Classes were conducted during the reporting period at the American Cultural Center in Nago.

(b) On 30 January, two pieces of unserviceable canvas were donated to the Leper Colony on Yagaji Island.

(3) PSB

(a) On 9 January, Truck Company provided a wrecker for the Kin Village fire truck and brought it to Camp Hansen for repairs.

(b) Personnel from PSB continued to conduct English Language classes for Ishikawa, Afuso, Ohna, and Okuma Schools.

(4) Hq Co

(a) Repairs commenced on the Kin Village fire engine on 9 January. An estimate of repair time required will run until late February.

(b) A nine man working party was provided to assist the Brigade Civil Affairs Officer in the distribution of Project HANDCLASP materials at the Leprosarium on Yagaji Island.

(5) MAG-15

(a) Relations were established with the Shin Sei Gakuen Orphanage in Hiroshima, resulting in three visits and the expenditure of over 180 man-hours. Projects included painting window trim, cutting fire wood, and constructing a small recreation/storage building.

(b) Over 70 man-hours were expended in ground-clearing at the Tsuda Orphanage.

(c) During a visit to the Ako Bono Ryo Orphanage, drainage ditches were cleared of materials that were obstructing proper flow.

(d) Thirty-five hours of English Language instruction was given during the reporting period by personnel from MAG-15.

The Communications-Electronics Office has conducted normal routine business during the reporting period. Planning comprised the bulk of the section's activities.

#### h. Financial

Significant fiscal transactions occurring during the month of January are as follows:

(1) BPN 01 - Flight Operations. Third quarter funds in the amount of \$1,000,000 were received. This grant is partial funding and funds were distributed to 9th MAB aviation units in a ratio where all units should run out of funds approximately 15 March. A request for additional funds is due CG FMFPAC not later than 5 March 1968.

(2) BPN 08 - Aviation Consolidated Allowance List (Supply Officers' Stores). Funds received to date for this project are \$169,134 which appears adequate for the first three quarters of the fiscal year.

(3) BPN 09 - General Aviation Collateral Equipment. This project has been funded at 100 percent of requirements to date.

(4) BPN 21 - Aeronautical TAD. Estimated third quarter requirements are \$31,394. Total funds received this quarter are \$28,000. A request for additional funds is due CG FMFPAC not later than 20 Feb 1968.

(5) BPN 50 - Aviation Maintenance. Partial funding received to date is \$70,000. A request for additional funds is due CG FMFPAC on 5 March 1968.

(6) BPN 11 - Maintenance of Aviation Expeditionary Equipment. Funds authorized for this quarter are \$168,209 for a total to date of \$486,892. This funding appears at present to be adequate but CG FMFPAC requests reassessment in early March.

(7) BPN 11 - OM&MC. Third quarter authorization for this project amounts to \$148,820 for a total to date of \$535,390. Principal areas underfunded were Program Codes "D" (Emergency Leave) \$10,000, "C" (TAD) \$8,000 and "M" \$30,000.

(8) BPN 11 - OM&MC OpBud. Third quarter authorization was \$2,463,000 for a total of \$5,655,000.

(9) Project 10 OpBud Medical and Dental. Third quarter authorization was \$29,400 for a total year to date of \$89,600. Adequacy of these funds is still under review since Vietnam based units requirements for care of the sick and Medcap have not been funded previous to the second quarter.

Camp Hansen Okinawa, Jan. 16 - Marine Corporal Gary E. Gruerman was awarded the Silver Star Medal in ceremonies conducted recently by Brigadier General Jacob E. Click, 9th Marine Amphibious Brigade commander, at Camp Schwab.

Corporal Gruerman, of Company "E", 3rd Reconnaissance Battalion, received the medal for his actions while attached to Company "B", 3rd Reconnaissance Battalion, 3rd Marine Division, in the Republic of Vietnam. Cpl. Gruerman was at the time a member of a 9 man reconnaissance patrol "operating deep in Viet Cong controlled territory in the Phu Bai area" the citation read.

When the patrol came under ambush from an enemy force of approximately 30 men, Cpl. Gruerman and his team reacted quickly and "launched a bold assault on the enemy to their front. In a seemingly impossible advance, he and his companions maneuvered across 200 meters of fire-swept terrain, continually exposed to heavy enemy automatic weapons fire.

"Firing his weapon with extreme accuracy and shouting words of encouragement to his companions, Cpl. Gruerman continued forward until he overran the enemy position. As he reached the top of the hill and came face to face with a Viet Cong soldier, his weapon jammed. Without hesitation, he dropped his weapon and advanced with only his knife which was shot out of his hand by the enemy.

"Undaunted, Cpl. Gruerman was preparing to physically engage the enemy when

-MORE-

one of his fellow Marines came to his assistance and killed the Viet Cong.

"Recovering his weapon, Cpl. Gruerman rejoined his companions and directed fire on the other enemy positions, forcing the numerically superior enemy to flee in panic and confusion."

Cpl. Gruerman was also awarded the Purple Heart Medal for wounds he sustained in that action.

## Narrative Summary

During the period covered by this report normal garrison supply operations in support of the 9th Marine Amphibious Brigade continued.

In addition this Battalion commenced the initial phases of formulating plans for an up coming Battalion field problem to be held at Kin Blue Beach on March 6-7-8 1968.

A demonstration was held for the Japanese Self Defense Forces by Units of this Battalion consisting of Aerial Delivery performance, the setting up of a tactical fuel dispensing system and Static displays organic to this Battalion with resumes given by appropriate sections. 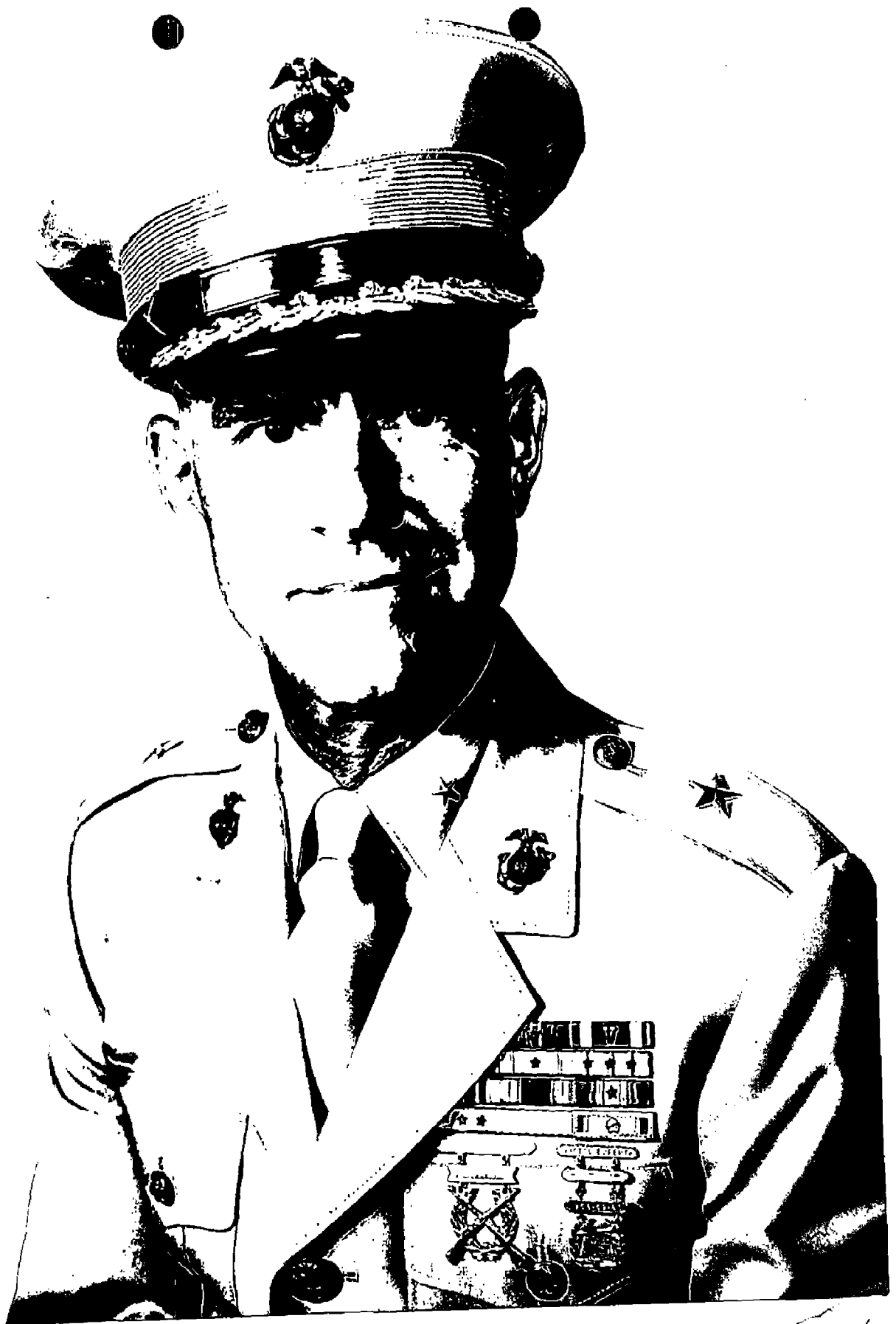

Camp Hansen Okinawa, Jan. 22- Brigadier General William C. Chip assumed command of the 9th Marine Amphibious Brigade on Okinawa at formal ceremonies here today. He is the fourth commanding general since its activation in early 1966.

The former commander, BrigGen Jacob E. Glick, has been reassigned to the Third Marine Amphibious Force in the Republic of Vietnam.

General Chip entered the U.S. Naval Academy in 1938 after attending one year at Duquesne University. Upon graduation from the Academy, he received a B.S. degree and was commissioned a U.S. Marine Corps second lieutenant.

After completing the Artillery Course at Marine Corps Schools, Quantico, Va. in August 1942, Lieutenant Chip sailed for Guantanamo Bay, Cuba, where he served as a battery officer with the 13th Defense Battalion.

Later, after a brief tour in the U.S., he became commander of the Marine Detachment on the USS HONOLULU in May 1944, and took part in the bombardment of Saipan, Guam, Peleliu, and Leyte. Returning to the U.S. in early 1946, he served briefly with the Division of Reserve at Headquarters Marine Corps, Washington, D.C.

Two years after his promotion to captain in June 1946, he was named Assistant Inspector-Instructor, 16th Infantry Battalion, USMCR, Indianapolis, Ind. This was followed by duty as I&I, "C" Company, 16th Infantry Battalion, in Evansville, Ind.

In June 1949, he joined Marine Corps Schools as an instructor, serving in this capacity almost three years. While there, he was promoted to major.

The 1st Replacement Battalion, Fleet Marine Force Pacific, Camp Pendleton, was the major's next assignment and he sailed shortly thereafter for duty in

Korea. He served as S-3 officer and later as Battalion Executive Officer of the 1st Battalion, 1st Marines, 1st Marine Division. Major Chips was awarded the Bronze Star Medal and the Navy Commendation Medal, both with combat "V" for service in Korea.

Returning to the U.S. in July 1953, he attended the Junior Course at Quantico completing the course the following June. He was assigned to Headquarters Marine Corps where he served as Head, Individual Training Unit, G-3 Division from August 1954 until June 1957. He was promoted to lieutenant colonel in December 1954.

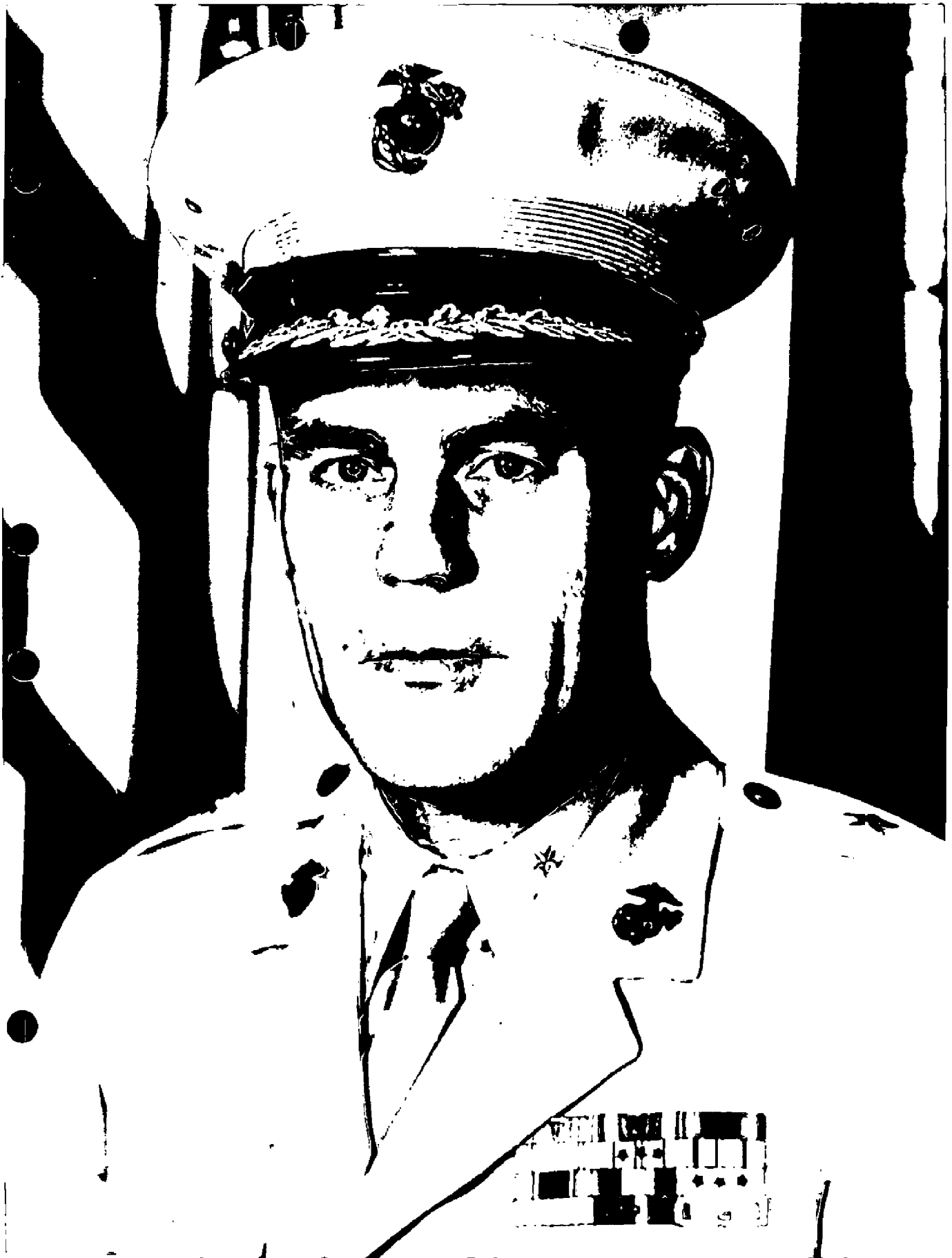

In July 1965, he became Chief of Plans Branch on the staff of the Commander, Striking and Support Forces, Southern Europe.

Upon advancement to brigadier general in September 1967 he assumed duties as Deputy Assistant Chief of Staff, G-3, Headquarters Marine Corps, a post he held prior to his assignment as Commanding General 9th Marine Amphibious Brigade.

It was this concern which prompted three 9th Marine Amphibious Brigade Marines, Lance Corporals Leonard Rice(Canoga Park, Calif.), Deacon Flick (Eau Claire, Wis.) and Gordon Klemp (Springfield, Mass.), to come up with the idea of taking three children out of children's homes each weekend to entertain them for a day.

This is one expression of the handclasp idea, and it's a good idea because, as LCpl. Klemp said, "When they bring the children in you start to wonder whether they understand what you are trying to do for them, but when the child you asked for comes up and takes your hand and looks into your eyes you know that she understands just what's going on and she's glad to see that someone does care what happens to her."

There are as many ways of expressing Handclasp as there are people, and the experience can be most gratifying.

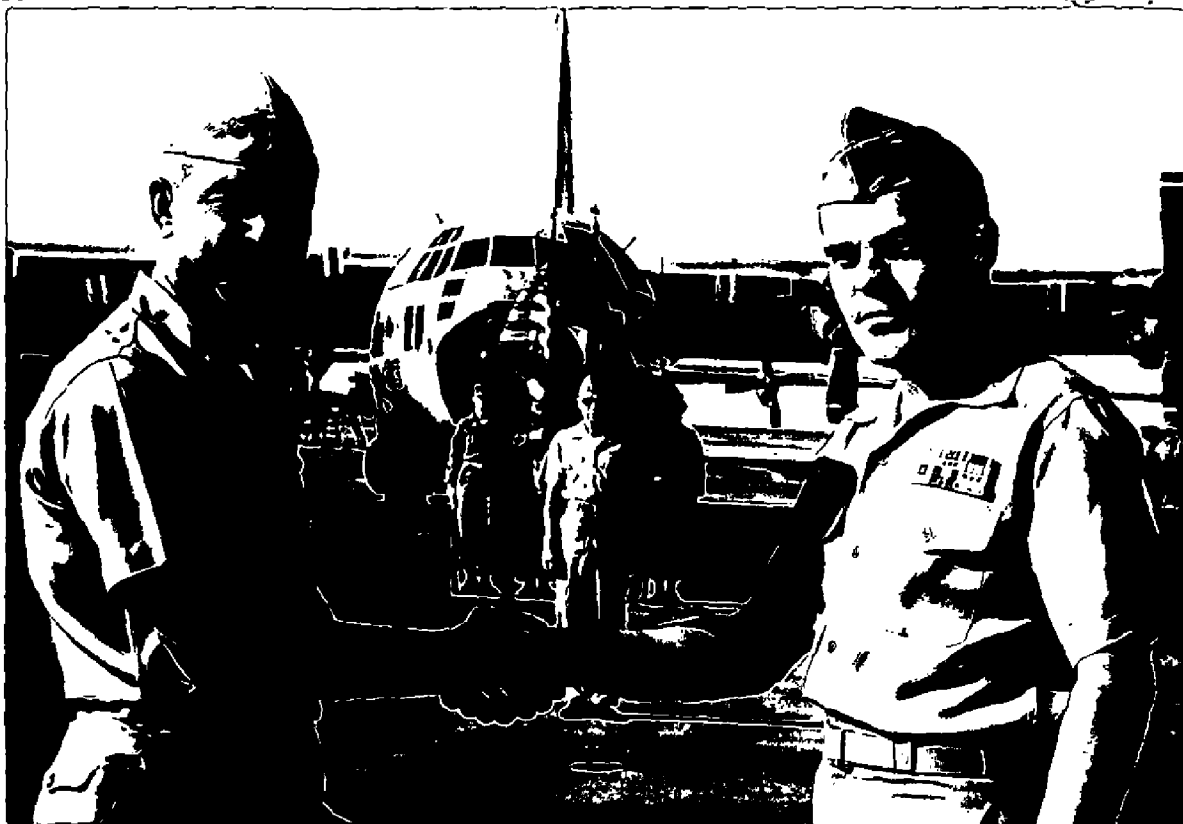

Camp Hansen, Okinawa, January 27—Major Joseph J. O'Brien, 9th Marine Amphibious Brigade (9th MAB), Logistics Section, was presented with a gold star in lieu of a second Bronze Star Medal by Brigadier General William C. Chip, 9th MAB Commanding General, in ceremonies at Brigade Headquarters on Wednesday afternoon.

The award citation, signed by Fleet Marine Force Pacific Commanding General, Lieutenant General Victor H. After monsoon weather had scattered the landing force during the initial assault and forced elements of the battalion to land on different beaches, Major O'Brien took charge of the unit organization and deployed elements to successfully maintain momentum during the attack.

Throughout the seven-day operation, Major O'Brien skillfully deployed the units within his battalion to overrun positions of North Vietnamese troops and cut off avenues of hostile escape.

"Due largely to his outstanding tactical skill and bold initiative," the citation reads, "his unit was instrumental in routing the hostile force, killing eighty-nine North Vietnamese and capturing numerous weapons and tons of equipment and supplies."

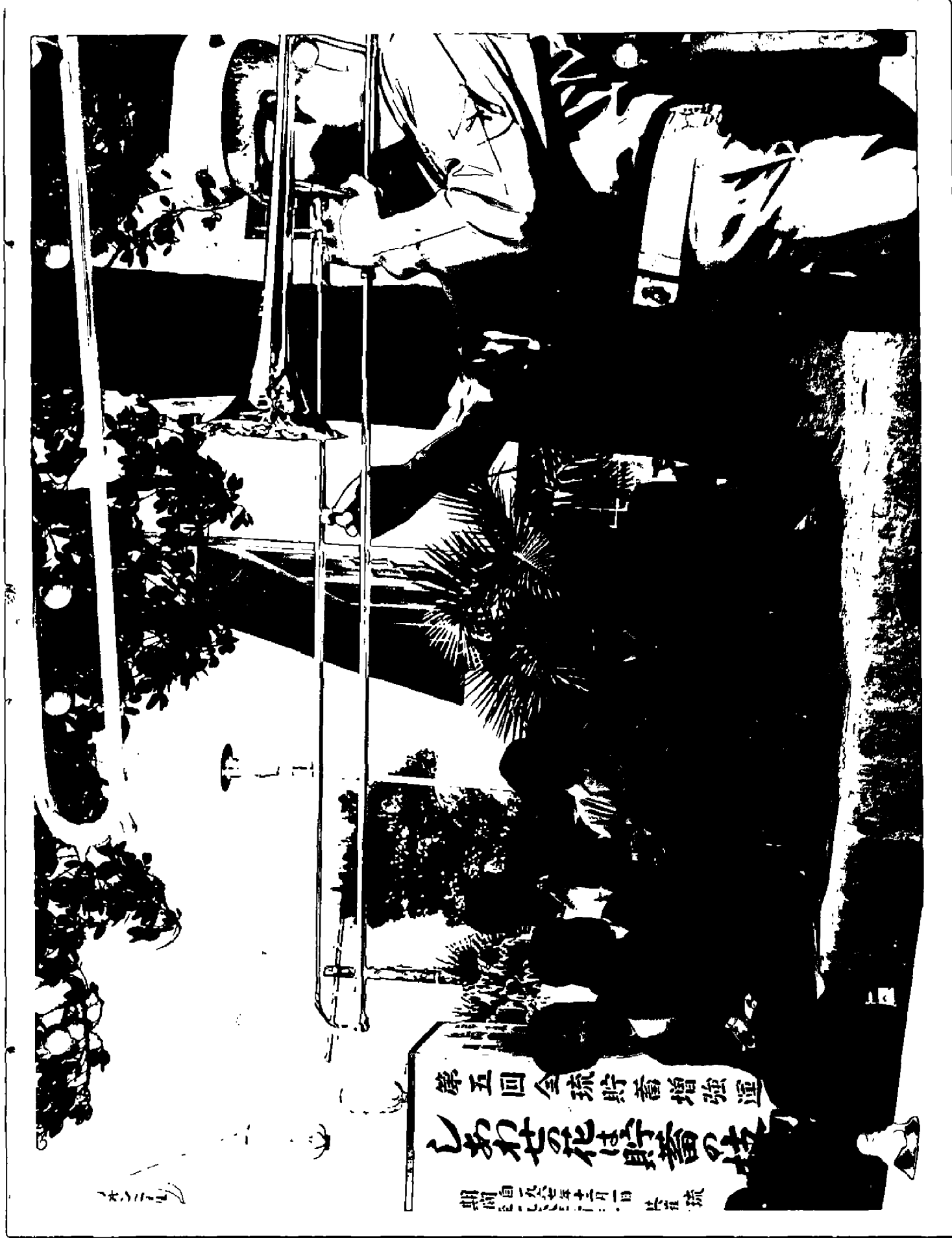
