## PART II

## NARRATIVE SUMMARY

During the month of May, 1968, the Ninth Marine Amphibious Brigade continued performance of assigned missions. These missions include rehabilitation of equipment, training and replacement of personnel, training of aviation squadrons, and contingency planning as the Fleet Marine Force component of the Seventh Fleet.

The Brigade continued to provide intelligence and friendly situation briefings for Officers and Staff NCO's in transit to RVN. A total of 253 Officers and 198 Staff NCO's were briefed during this period.

Participation within the Marine Corps Association in the month of May for officers was 54.4%. Staff NCO participation showed 14.7%. Average for both staff and officers was 34.5% as compared to 30.5% in April.

(e) Counterintelligence Orientation.

c. Training

(1) During the period 1-31 May 1968, G-3 Training, 9th MAB continued in its role of providing training support to the units of the 9th MAB. The support consisted of scheduling of schools, firing ranges and other training areas.

(2) OJT: 3 officers and 2 enlisted performed OJT with III MAF during the month of May.

d. Community Relations

(1) RLT-26 (Rear)

(a) Two English Classes were conducted each Saturday by members of RLT-26 at the Americal Cultural Center of Nago.

(b) English Classes at Nago Government Hospital are being conducted by Company A, 5th Medical Battalion.

(c) On 18 May 1968, Armed Forces Day, an "Open House" was conducted, and approximately eighty (80) persons viewed the various displays. Also, a relations meeting was held with the Kushi-Son-Nago-Cho representatives.

(d) On 31 May 1968, Company A, 5th Engineer Battalion delivered fourteen (14) loads of dirt to Kobe High School in Henoko, using one (1) M-51A2 dump truck and one (1) TL-16 Scoop Loader.

(e) The grading of the Meomori School playground in Ishikawa is still pending. Upon return of the Adams 550 grader, work will commence on this project and can be completed within five (5) days.

(f) Planned projects include the building of a basketball/volleyball court at the American Ryukyuan Cultural Center of Nago.

## (2) MACS-8

(a) Functions this month devoted to the organization of English language instructors for school children of the Henoko area in basic and intermediate level English classes. Average class attendance was eighty (80) students. One officer, three enlisted, and one civilian technical representative are involved in the twice weekly English instructions.

(b) On 16 May, 108 children from the Henoko area were guests for entertainment and refreshments.

(c) During the month of May it was noted that the personnel of MACS-8 displayed an enthusiastic willingness to conduct themselves in accordance with the spirit of Brigo 5710.2A.

## (3) PSB

(a) Community Improvement. No significant activity reported in this period.

(b) People to People Education. Activities in this area have been a continuation of the English Language assistance classes at Ishikawa High School.

## (4) CommSptCo (Rein)

(a) On 22 May, we contributed approximately 200 notepads to "SAIBO YOSH INN" Mission. Notepads were made from scrapp paper and stapled by communication center personnel.

(b) On 29 May, 10 Marines working at "SAIBO YOSHI INN" Mission painted jungle gyms and erected seesaws. Brushes and turpentine were bought and paid for by the staff and officers of Communication Support Company.

(5) MAG-15 (Rein)

(a) Orphanage Support. There were no visits to orphanages conducted during the month of May 1968.

(b) Japanese/American Cultural Friendship Association. Fifteen Marines conducted classroom sessions in English aboard MCAS Iwakuni and throughout Yamaguchi and Hiroshima prefectures.

e. Communications-Electronics

The Communications-Electronics Officer has conducted normal routine business during the reporting period. Planning comprised the bulk of the section's activities.

f. Financial

Significant fiscal transactions occurring during the month of May are as follows:

(1) BPN 01 - Flight Operations. No additional funds were received during this reporting period.

(a) On 17 May 1968 \$282,200 was withdrawn due to rotation of squadrons between 9th MAB and FMAW.

(2) BPN 08 - Aviation Consolidated Allowance List (Supply Officers' Stores). Funds in the amount of \$4,079 were received in addition to those funds which were previously provided to fund fourth quarter requirements. It is anticipated that no additional funds will be required in this project for the remainder of FY-68.

(3) BPN 09 - General Aviation Collateral Equipment. Additional funding in the amount of \$938 was requested to purchase a Jack, A/C Axle. These funds were provided.

(4) BPN 21 - Aeronautical TAD. Funds in the amount of \$4,800 were received to fund fourth quarter requirements.

(5) BPN 50 - Aviation Maintenance. Fifteen

thousand of the estimated \$39,000 additional fourth quarter requirements was received during this reporting period.

(6) BPN 11 - Maintenance of Aviation Expeditionary Equipment. Funds authorized for this quarter are \$128,195 for a total to date of \$618,839. This increase represents about 70% of this quarter's requirements.

(7) BPN 11 - O&M, MC. Fourth quarter authorization for this project, to date, amounts to \$94,000 for a total of \$639,390. Funding received, to date, is partial funding for the period 1-31 May 1968.

(8) BPN 11 - O&M, MC OpBud. Fourth quarter authorization was \$578,600 for a total of \$6,233,600.

(9) Project 10 OpBud Medical and Dental. An increase of \$15,000 for the fourth quarter authorization was received for a total, to date, of \$134,125.

Camp Hansen, Okinawa May 6 -- On the morning of May 3, a group of weary but high-spirited Marines marched proudly into a rendezvous area a few miles north of Camp Schwab. They had begun their march earlier that morning at the Northern Training Area of Okinawa, some 15 miles away, where the Marines' Counter Guerilla Warfare School is located.

Their hike was the conclusion of a five-day field exercise involving 68 Marines from "A" Company, 5th Tank Battalion; "A" Company, 5th Anti-Tank Battalion and "A" Company, 5th Engineer Battalion, all units of the 9th Marine Amphibious Brigade's (9th MAB) Regimental Landing Team 26.

The entire field exercise was calculated to help keep a keen edge on the Brigade's overall capacity, in anticipation of the day when it will be called into action somewhere in the Western Pacific.

The operation began early Monday, April 29. Following an introductory talk by the commanding officer of the Counter Guerilla Warfare School, the Marines spent the morning learning the art of "rappelling" down the side of a cliff.

Slowly at first, the men would lower themselves over the edge of the cliff, cautiously descending one step at a time. Soon, however, they had developed and mastered their technique, and anxiously awaited the chance to go over the cliff again.

The rest of Monday's training was classroom exercises: a class on mantraps and shelters, a class on arm and hand signals and a class on civic action.

Tuesday morning was spent learning about land navigation. It involved instruction in the reading of a military map and the operation and use of a compass. Then the students rehearsed the signals used to direct a helicopter during an aerial resupply operation.

After a midday break the Marines hiked to an outdoor classroom by the edge of a stream. There they watched a number of instructors demonstrate different aspects of "watermanship." The instructors, some of whom were members of the three units participating in the training, showed them various ways to cross a body of water, including how to build a makeshift liferaft capable of transporting both equipment and non-swimmers.

Several of the students were given the chance to try to cross over the water by a single rope that had been stretched across the stream. All of the students except the very last man made it across. Rather reluctantly, this man ended up swimming part of the way.

A class on combat first aid was also given Tuesday afternoon. It was made more realistic for the Marines by the use of simulated casualties that were specific examples of different types of wounds incurred in combat.

Instruction in jungle protection -- how to survive by making the elements of the jungle work for you -- was given, as was a class on the makeup of a guerilla base camp.

Tuesday night the Marines had a chance to put to use the knowledge they had absorbed from the first two days of their training. A jungle orientation movement, scheduled from 7 p.m. until midnight, was in actuality a night compass march, with the Marines broken down into squad size units led by the sergeants from among their own ranks. Movement was difficult because of the almost complete absence of moonlight. Nevertheless, each squad completed the march successfully.

Wednesday the entire day was devoted to classes. Included were classes on immediate action, Viet Cong tactics, ambushes, patrolling, the platoon patrol base, cave clearing and village search techniques.

Thursday, the Marines' last full day of training, was spent learning demolitions. Following an extensive class in the morning, 20 of the men were given the chance to set up and then detonate their own individual charges. The balance of the group set to work on a separate project: a series of charges that all exploded in sequence without a flaw when detonated.

Although application of the demolition training had taken the remainder of the day, that night the Marine students found themselves in the field once again, divided into six reconnaissance patrols. Two areas had been set up and were to be patrolled by the staff members of the units being trained.

Three of the patrols were sent to scout each area, attempting to remain undetected before returning to their base camp with the information they had gathered.

Early Friday morning the Marines broke camp and at 7 a.m. began the long walk back. Setting a forced march pace at the outset, they maintained that pace for the next three and a half hours before a halt was finally called. Only then was the field exercise considered completed.

The Marines, each with the self-satisfied feeling of having done a job and done it well, returned to their barracks at Camp Hansen.

CAMP SCHWAB, OKINAWA, May 13 - At 0530, May 7, 1968, the USS Whitfield County (LST 1169), was poised silently off the coast of Tsugen Jima, a tiny island of the Ryukyuan Island chain.

It was almost dawn. There was rain pounding on the deck and it was foggy. The wind made the 68 degree temperature seem colder. It was a south-south east wind blowing at 10 to 18 knots, making the usually-calm waters of Buckner Bay choppy and hard to navigate.

On deck this dreary morning, Marines and Navy men gathered after morning chow to observe the outline of the small island about 4000 meters off the ship's bow. Minutes later the island's beaches became shrouded as increasing rain and fog made visibility nearly impossible from any distance.

At 0545, the PA system aboard ship crackled, "Man your battle stations". Unhesitatingly and deliberately, as if some Hollywood director had given the cue for action, each man moved himself into position for what was to take place - - an amphibious beach landing.

Below, in the ship's spacious interior, more than 50 Marines prepared eleven armored personnel carriers (LVT's) for launch. The Leatherneck's represented "A" Company, 5th Antrac Battalion, a unit

of the 9th Marine Amphibious Brigade's (9th MAB) Regimental Landing Team 26, located at Camp Schwab.

At 0610, the steel bow doors of the LST yawned and the span of ramp dipped into the water like a giant tongue. Now 1000 meters from the beach, the first amphibian tractor rumbled down the ramp and momentarily sank from sight into the water. A moment later, with its 310 horse power, V-12, Continental engine roaring laboriously, the armored craft reappeared on the surface as it approached a pre-designated rendezvous area. The rendezvous area was a point at which all tractors assembled prior to "jump off" - movement to the beach.

In a "follow the leader" fashion, the remainder of the amphibious tractors negotiated the ramp and plummeted into the water making the rendezvous circle larger.

With all tractors out, the circle broke and the two lines of LVT's came abreast and churned toward the beach.

The ship's bridge maintained control of the tractor movements through a radar system much the same as the system used during the World War II amphibious assault landings. By use of the radar system and communications with the guide boats escorting the tractors, the LST was able to coordinate the timing of the beach landing.

At 0637 the bridge reported "touch down" of wave one. Three minutes later it indicated that wave two had hit the beach.

CAMP HANSEN, OKINAWA, May 21 - Major Martin E. Salter, Jr. was presented the Silver Star Medal and Lieutenant Colonel Parks H. Simpson was presented the Bronze Star Medal in ceremonies at Brigade Headquarters last Thursday. Making the presentations was Brigadier General William C. Chip, 9th Marine Amphibious Brigade commander.

Major Salter, Commanding Officer of Sub-Unit #1, HCMS-15, was awarded the Silver Star Medal for his actions while serving as a pilot with Marine Medium Helicopter Squadron 363, Marine Air Group 16, 1st Marine Air Wing in Vietnam.

On the afternoon of December 21, Major Salter set out with the helicopter he commanded on the first of six emergency medical evacuation missions. The first landing zone was under heavy fire and surrounded by 150-foot high trees. Major Salter successfully maneuvered his helicopter and evacuated two seriously injured men. Enroute to the nearest medical facility, he evacuated a wounded Vietnamese soldier.

Having completed that mission, Major Salter embarked on another to evacuate six wounded Marines. Upon arriving at the area, "he skillfully maneuvered his helicopter between three hills with his rotor blades dangerously close to the surrounding terrain." At takeoff, Major Salter carefully avoided obstacles on the ground and through "skillfully utilizing ground cushion whenever possible, successfully accomplished a translational lift out of the hazardous area and departed for the nearest medical facility."

Upon completion of a fourth mission, he was directed to another zone to evacuate three more injured men. Despite intense enemy fire directed at his helicopter, he landed and "steadfastly remained exposed to heavy enemy fire until the casualties were aboard his aircraft." As he left the area, the aircraft was struck by heavy enemy automatic weapons fire which caused an

explosion and fire that severely damaged his helicopter. Deciding to attempt an emergency landing on a sandbar, he quickly briefed his crew on procedures for evacuating the wounded. Upon landing, he helped the crew off-load the wounded, ensured that all weapons were removed and organized a defensive perimeter.

When they had been evacuated to the Marble Mountain Air Facility, Major Salter obtained another helicopter and embarked on a night emergency medical evacuation of five casualties from a company engaged in heavy fighting. The heavy enemy fire forced him to abort his first attempt, so he extracted two men from an adjacent area and returned under cover of supporting fire from gunships and evacuated the casualties, guided in by a single strobe light after he had extinguished his external lights. Again he braved heavy enemy fire and remained in the zone until all five men had been rescued.

"Due largely to his determined and courageous actions, he was instrumental in saving numerous Marine lives and inspired all those who served him."

LtCol. Simpson, Assistant Chief of Staff, G-1, 9th MA<sup>B</sup>, received the Bronze Star Medal for his actions while serving as Executive Officer of Special Landing Force "A" during the period 28 September 1967 to 24 March 1968.

LtCol Simpson's "arduous work and tireless energy" were expanded in planning and coordination of four major amphibious operations: Bastion Hill, Ballistic Arch, Ballistic Armor and Fortress Attack I, as well as related in-country operations. He contributed "most significantly" to the successful accomplishment of the SLF's mission.

He worked tirelessly to maintain "excellent smooth-working relationships" with key personnel on the staff of the Task Group, the ships within the Task Group, the embarked Battalion Landing Team and the assigned Marine Medium Helicopter Squadron. His execution of this coordination was in "an extremely efficient manner, thus permitting the Commanding Officer of Task Group 79.4 to devote his attention to operational matters."

On a number of occasions, LtCol Simpson effected personal liaison with the commands in-country to ensure the maximum support and performance of the SLF in the execution of its mission. His timely actions ensured a continuous flow of supplies and ammunition to the units, and his effective utilization of supporting helicopters "assisted and expedited the rapid evacuation of battle-field casualties.

ICpl. Doss's citation reads, in part, "...the North Vietnamese soldiers penetrated the Marine lines and under cover of darkness, attempted to exploit their success. When his section was directed to launch a counter attack.

ICpl. Doss (then a PFC) unhesitatingly maneuvered through the intense hostile fire and exploding grenades and courageously attacked the hostile position.

"Disregarding his own safety and repeatedly exposing himself to enemy fire, he delivered a heavy volume of accurate fire upon the North Vietnamese inflicting heavy losses on the enemy and forcing them to flee in panic and confusion."

Sgt. Howard R. Koenig, the administrative chief of RLT 26 (rear), was awarded a meritorious mast for the "noteworthy and creditable manner" in which he performed his duties.

Sgt. Koenig's citation reads, in part, "By your initiative and untiring efforts you have substantially reduced the voluminous administrative processing of replacements to an efficient, smooth operation. This has significantly contributed to the successful accomplishment of this command's mission."
