## PART II

## NARRATIVE SUMMARY

During the month of September 1968, the Ninth Marine Amphibious Brigade continued to fulfill its assigned missions. These missions included rehabilitation of equipment, training and replacement of personnel, training of aviation squadrons and contingency planning as the Fleet Marine Force component of the Seventh Fleet.

During 1-4 September BGen WILLIAMS visited 9th MAB units in-country and during 11-13 September he conferred with COM-SEVENTHFLT representatives in Japan. On 25 September BGen WILLIAMS assumed command as Deputy Commanding General, FMF-Pac (FWD) as an additional duty due to BGen WEBSTER's assignment TAD to RVN.

The major activity of the 9th MAB staff during September was the final preparation for and execution of Exercise BEACH BARON IV CPX involving both the staffs of CTF76/79. The CPX was successfully conducted during 26-28 September with a post-CPX briefing noting that some areas of staff functioning on both staffs needed review and clarification prior to the next CPX.

Recon training by A Co, 5th Recon Bn, parachute training by the Air Delivery Platoon of PSB and a COMDEX involving Communications Support Company, RLT-26 (Rear) and PSB highlighted training of 9th MAB units on-island during September.

The 9th MAB G-2 section conducted daily intelligence/operations briefings for 569 transient officers and staff NCOs during September. The section also initiated the development of an Air Order of Battle.

The 9th MAB NGF Team at Subic fired 411 rounds for SFCP training during September and provided spotting services for four Seventh Fleet NGFS ships, including the USS NEW JERSEY (BB-62).

All sections of the Brigade G-4 section conducted inspections of MAG-15, Iwakuni, Japan during the period 15-25 September.

The 26th Marines, with their CP at Phu Bai participated in Operation HOUSTON until 12 September, at which time they displaced to the Danang area and commenced operations in the Danang AO.

1st Battalion 13th Marines participated in Operation HOUSTON V and OWEN MESA during September in direct support of 26th Marines. The battalion was under opcon of 1st FAG and 11th Marines during this period. 5837 missions were fired expending 18,603 rounds and resulting in 12 confirmed enemy KIAs credited to the battalion.

On 6 September 1968, VMF (AW)-235, the last active duty F-8 squadron in the Marine Corps, was transferred from MAG-15 to the 1st Marine Brigade, Hawaii for redesignation as VMFA-235 and to be outfitted with F-4J aircraft:

SLF ALFA, after off-loading elements of BLT 2/26 at Dong Ha and HMM 362 to Marble Mountain on 2 September departed for upkeep at Subic Bay, R.P.I. and port visit at Singapore until 30 September. From 2-16 September BLT 2/26 participated in Operation SWIFT PLAY in the LANCASTER AO under the opcon of 3rd Marines. From 16-30 September, the BLT conducted operations in Operation LANCASTER II/TROUSDALE NORTH under the opcon of 9th Marines HMM-363 was opcon to 1st MAF from 2-30 September at which time it was relieved as the SLF HMM by HMM 363.

On 1 September SLF BRAVO reported on station for specops. HMM 165 relieved 265 on the same date as the SLF HMM. The ARG/SLF remained in the Danang area in support of BLT 2/7 throughout the month. BLT 2/7 operated ashore in the Danang area throughout this period primarily involved in missions in defense of Danang.



b. Medical

(1) The Brigade VD rate for this period was 12.6% per 1000 men for Okinawa based Units.

c. Community Relations

(1) RLT-26 (Rear)

a. Company "A", 5th Engineer Battalion concentrated all hands on work at the Technical School at Nago. Marines have been working 6 days a week during this month and have moved and leveled more than 10,000 meters of earth. The people of Nago led by the Mayor OSHIRO have been able to obtain civilian bulldozers to assist in the project which will greatly increase the prospects of an early completion of the vast construction site.

b. The city of Ishikawa requested aid in blasting large rock formations which stood in the way of a housing project and a farm road project that would allow local farmers to have easy access to their fields. A demolition team from "A" Company, 5th Engineers, spent more than two weeks blasting and removing rocks.

c. Company "A", 5th Shore Party Battalion started work at the Ryukuan American Cultural Center at Nago in September. The project is one to construct a basketball and volley ball court 84 feet by 42 feet that is to be enclosed by a 300 foot fence.

d. During September several truck loads of sand were delivered to the Kube School in Henoko. This sand was spread on the athletic field and track at the school.

e. Marines from Shore Party working with civilian officials and using civilian trucks, provided 75 truck loads of sand for a new athletic field at the Ginoza High School. The Marines provided a loader that was used in loading the dump trucks with sand for transportation to the Ginoza School.

f. Each Saturday during the month of September, English classes were conducted at the Ryukuan American Cultural Center at Nago. The class-

g. A letter of appreciation was received from Koichi SHINZATO, the principle of Kube School at Nago, thanking the Marines of RLT-26 (Rear) for their contributions and work on the playground at Kube School.

NARRATIVE SUMMARY1. Briefs

a. The Intelligence Controller/TEC G-2 representative briefed Rear Admiral LACEY/CTF 76 aboard the USS El Dorado on 28Sep68 concerning the Brigade CPX.

b. The G-2, 9th Marine Amphibious Brigade, briefed the Commanding General, Fleet Marine Force, Pacific (Fwd) on 17Sep68.

c. Two Intelligence Briefs were presented to the Commanding General, 9th Marine Amphibious Brigade, FMF during the reporting period.

d. One Special Intelligence Brief was also presented to the Commanding General on 27Sep68.

e. This Section conducted daily Intelligence/Operations Briefs for Officers and Staff NCO's in transit to RVN. A total of 454 Officers and 115 Staff NCO's were briefed during the month of September.

2. At present, the G-2 Section has two Marines with basic 0200 MOS's, one of which has been qualified as an 0231 and is currently awaiting orders for a change of MOS. The second man recently completed administrative training and will be assigned to the Order of Battle section to complete his training. This training will be completed in approximately 60 days.





## PART II

NARRATIVE SUMMARY

During the period covered by this report, normal garrison supply and maintenance operations continued.

By the first week in september, the press corps had given them a new nickname. During the wet, stifling hot summer of 1950 they called them "The Fire Brigade." The unit was marked on the situation maps as the First Provisional Marine Brigade.

Forming of the brigade began in Yellowstone National Park where a general in charge of that sort of thing was vacationing when the North Koreans crossed the 38th Parallel.

As had happened many times in the past, the Marines started to gather a fighting unit from men scattered throughout the Corps. The formation took place at Camp Pendleton, California, and in Hawaii.

Once formed the brigade was packed aboard ships and left San Diego at flank speed for Kobe, Japan, to pick up more equipment. The situation in Korea deteriorated and the brigade was diverted to Pusan, Korea, and stepped from the ships directly into the war.

Running south in front of almost three-quarters of the Pusan perimeter was the Naktong River. It was the last obstacle in the path of the North Koreans. Here the United Nation's forces must hold, or lose Korea.

There was no hope of organizing a strong line, there just weren't enough troops left for that. What few men that could be spared to act as a reserve unit were moved several miles back <sup>to</sup> be used as a stopper to plug any major holes in the line to prevent a serious breakthrough. There could be no practical hope of holding every inch of ground, but the mobility of the defenders could and would be brought into play.

Four natural attack routes lead into the perimeter. One was on the south through the port of Masan, another ran through the so-called Naktong Bulge to the important rail and highway network at Miryang. A third corridor of advance ran through the roads and rails to Taegu. Finally, on the far northeast, a valley ran down the seacoast through Kyongju.

As the enemy's plan of attack developed it became obvious that the North Koreans would attempt a push through all four corridors at the same time.

The plan was simple. The North Koreans assumed that making massive multiple attacks on the thin line would cause a breakthrough in at least one area. If the line broke, the pressure would be felt everywhere.

There was hard and bitter fighting along the entire perimeter, but the biggest threat developed against the Naktong Bulge. The action there was typical of the whole desperate month.

Fresh troops from the U. S. Army's Second Infantry Division were sent into the lines. The 9th Infantry Regiment, which had just arrived from the States, helped to beef up the depleted ranks of the division. The soldiers of the Second Division had come over as a unit three years earlier. Many of the enlistments had expired only two months before the outbreak of war in Korea leaving the division at only fifty percent strength.

As far as the Marine Corps was concerned, only ten percent had seen combat, but that ten percent was concentrated in the officer and key staff non-commissioned officer ranks. The Corps, made up largely of volunteers, had escaped the reforms instituted within the Army after World War II.

In 1950 a Marine Officer was still an officer and a sergeant behaved the way good sergeants had behaved since the time of Caesar, expecting no nonsense and allowing none. Marine leaders had never lost sight of their primary mission—to fight.

Led by Lieutenant Colonel Raymond L. Murray, the Brigade, made up of the 5th Marine Regiment and supporting units, was broken down into small teams and rushed from place to place along the perimeter by trucks and trains.

Now they moved to Miryang where the bulge was beginning to break.

They were the same as the other young men around them during that summer in Korea, but they had a certain standard to live up to. They had good training and it had been impressed upon them that they were Marines.

Except in holy wars and in defense of their native soil, men fight well because of training and pride in themselves and their service. Few men really prefer to kill or be killed.

Marine human material is not a bit better than that of the human society from which it comes. It has been hammered into form at a different forge, and hardened in a different fire. They will follow the colors from the shores of home to any place in the world, and fight well either place.

The Marine order of attack was organized. Lieutenant Colonel Harold S. Roise's 2nd Battalion would lead, followed by the 1st and 3rd Battalions in that order. Shortly after midnight, August 17, the 2nd Battalion moved into an area in front of Obong-ni Ridge.

War correspondents watching from the attack positions asked officers the name of the objective. None seemed to know. One correspondent wrote "No-Name Ridge" on his release. The name stuck.

As the 2nd Battalion was moving into position on the 16th, a British military observer at Miryang sent this dispatch:

"The situation is critical and Miryang may be lost. The enemy has driven a division sized salient across the Naktong. More will cross the river tonight. If Miryang is lost we will be faced with a withdrawal from Korea. I am heartened that the Marine Brigade will move against the Naktong salient tomorrow. They are faced with impossible odds, and I have no valid reason to substantiate it, but I have the feeling they will halt the enemy.

"These Marines have the swagger, confidence and hardness that must have been in Stonewall Jackson's Army of the Shenandoah. They remind me of the Coldstreams at Dunkirk. Upon this thin line of reasoning, I cling to the hope of victory."

Marines splashed across rice paddies and skirted a cotton field. They drew fire, not from the ridge, but from automatic weapons on their flanks. The fire grew heavier, and now gaps opened between the attacking platoons.

Only one platoon, 3rd platoon, "D" Company, led by Second Lieutenant Michael Shinka, reached the top of the ridge by charging the crest while partially protected by a rain gully which led to the top.

Only twenty of the original thirty men made it to the top. The 1st and 2nd platoons, faced with steep ground and heavy enemy fire stalled half-way up leaving Mike Shinka's platoon with no protection on either flank.

Marines who made it to the top found a line of empty enemy foxholes and jumped in them just as an enemy machinegun opened up from their right flank. Hand grenades were lobbed at them from the reverse side of the slope.

Resistance on the reverse side was taken care of by the Marines but they could do nothing about the machineguns on their flank. Within minutes five men were down.

Realizing the hill was too hot to hold without flanking support, Shinka called to his men to get the wounded down and to get off the hill.

Once off the hill he radioed his company command post and told them the hill could be retaken and held if air strikes could get the flanking fire off his back. He counted 15 men left in his platoon. He assured the company commander that with more men and the air strike that they could make it. There were no more men, but the air strike was on its way.

Corsairs roared over the spine of Obong-ni and the ground trembled as explosives ripped the ridge. When they had finished, tanks moved into the open and hurled shells into the sides and on the crest of the ridge.

Again the Marine platoons assaulted the hill. Enemy fire blazed up, much of it coming from the cloverleaf complex to the north. The North Koreans rushed back to holes along the top of the ridge and rolled grenades down the front slope.

Once more Lieutenant Shinka's platoon was the only one to make it to the top. His platoon had been cut to nine men by the enemy fire. They saw men moving along the ridge to their left. The platoon sergeant stood and called out "Easy Company?" He was answered by a blast of automatic fire. He dove for cover and returned the fire. Again Shinka's platoon was in an untenable position, enemy rounds chopped at them from the right and left flanks, and from the reverse slope of Obong-ni.

The platoon sergeant was shot through the leg, another man took a bullet in the stomach. A round shattered Shinka's jaw and choking on his own blood he motioned his men, what few were left, off the ridge for the second time. As he checked the top to make sure no wounded Marine had been left behind a bullet caught him in the arm and sent him rolling down the slope.

Obong-ni had not been taken. Late that afternoon the 1st Battalion relieved the battered remnants of the 2nd in front of the ridge.

Colonel Chang Ky Dok in command of the 18th Regiment of the North Korean People's Army holding Obong-ni knew his situation was increasingly desperate. During the fighting the regiment had suffered 600 casualties, forcing the 16th Regiment, which was defending Cloverleaf, to reinforce him with a battalion. His ammunition supply was running out, he had no medical supplies and his wounded were dying from lack of attention.

Colonel Murray knew that Cloverleaf had to be taken before his Marines could assault Obong-ni, and late that afternoon the 2nd Battalion, 9th Infantry, had pushed the NKPA from the position. At the same time the American 19th and 34th Regiments pushed attacks north of Cloverleaf with some success.

When Chang Ky Dok saw that he was about to be outflanked he requested permission to withdraw west of the Naktong. The request was denied.

Chang knew that his only hope was to shatter the American attack before it started on the 18th. He knew that he could still place numerically superior combat power against the thin Marine lines at a place of his choosing.

As night approached on August 17th he chose to attack.

Marines had continued the attack during the afternoon and had secured two pieces of high ground on the ridge, and with darkness coming on, had buttoned up for the night. They had adjusted artillery on the most likely enemy routes of approach and strung trip flares in front of their lines.

They expected a strong attack by night, but they didn't realize that the enemy, monitoring their radios, knew exactly how they were positioned.

At 2:30 in the morning a green flare rose high over Obong-ni, and the night exploded. The enemy squads rushed the Marine positions, hurling grenades and firing automatic weapons.

One platoon of "A" Company was isolated, but the other platoon positions held together. For three quarters of an hour it was touch and go, with violent close in fighting, and then the North Korean attack faltered. Within two hours the sky began to grow light and the assault ended completely as the sun came up.

The 18th Regiment of the North Korean People's Army was shattered beyond repair.

The cost had not been light to the Marines. Half of those who had watched the evening sun go down were no longer on their feet.

With daylight the Marines took up the attack once more following the path of the enemy's withdrawal. The 1st Battalion mopped up part of the ridge line while the 3rd Battalion secured the area to the north. The 3rd moved rapidly, almost without opposition.

Behind Obong-ni hundreds of defeated North Koreans streamed westward toward the Naktong. Artillery and aircraft were having a field day. Forced into the open by advancing Marines, dozens of enemy troops were brought under fire and killed.

By afternoon the NKPA 4th Division was in full flight. Marines and Soldiers pushed westward converging on the river while artillery fell continuously on the Naktong crossings.

Less than half of the NKPA 4th Division went back across the river. For all practical purposes the division had been destroyed.

The Fire Brigade had arrived. It had been burned in the flames, but the fire was out.

His parents, Mr. and Mrs. George P. Singleton of Memphis, Tenn., were presented the Nation's highest decoration today by Secretary of the Navy Paul R. Ignatius, in ceremonies at the Capitol's Marine Barracks.

Sgt. Singleton died during fighting in Quang Tri Province on March 24, 1967.

As his unit, "A" Company, 1st Battalion, Ninth Marines, 3rd Marine Division, neared the edge of a village they were hit by enemy rifle, machinegun and mortar fire.

the reserve platoon, heard a call for help to evacuate the wounded.

"He ran from the rear of the company to the front of the lead platoon," said Sgt. Earle D. Johnson, who was in the midst of the fighting.

Moving into the enemy's killing zone, Singleton made numerous trips carrying wounded Marines across open ground to a safe area.

As he was moving the casualties he noticed that a large part of the enemy's fire was coming from a hedgerow.

"Singleton picked up a machinegun and charged forward, firing as he ran," said Johnson. "He forced his way through the hedgerow and jumped right in the middle of a North Vietnamese Army squad killing at least eight of them before he was hit."

Although Singleton was mortally wounded, his daring attack disorganized the enemy and forced the remainder of them to flee from the hedgerow.

Walter Singleton was born Dec. 7, 1944, in Memphis, Tenn., and graduated from Bartlett High School, Memphis, in June 1963.

# Time Vital Factor in Absentee Voting

WASHINGTON (AFPS) -- Armed Forces personnel voting by absentee ballot in the 1968 general election risk having their vote not counted if their ballot misses the receipt of ballot deadline even by a few minutes.

Most states require that voted absentee ballots reach election officials by Election Day, Nov. 5. There are, however, some states with earlier or later deadlines.

In addition, there is a wide variation in time among the states as to when ballots are sent to absentee voters and the earliest date on which voted ballots may be returned.

Detailed information concerning absentee voting may be found in the pamphlet "Voting Information 1968" (DOD GEN-68).

# Field meet at Schwab

The clocker had to check to see if his watch had stopped when the first man in the distance event crossed the line. ICpl Albert F. Melanson turned in a 20-minute three mile run in 90 degree heat.

The pace of the meet continued with the 100 yd. dash, 220 yd. dash and the 880 yd. run. They were taken by PFC Gregory Braham, PFC Lee Butler and ICpl John B. Ray, respectively.

The more serious aspects of the field meet were broken with the start of an old and purely traditional wheel barrow race. The race was won by the MACS-8 team.

After resting up from the light events, the mile and two-mile relays got started. Fifth Anti-Tanks were helped to victory in the mile relay by PFC Larry J. Fowler and Cpl John

N. Mills. PFC Frank Coleman, as anchor man, copped the two-mile relay for 5th Tank Battalion.

For the finale, the field meet returned to Marine Corps tradition, assembly and disassembly of the .45-cal pistol and the M-14 event.

The next to last event was the egg throwing contest which was probably designed to get everyone's hands ready for the last event -- the tug of war.

When all the points were tabulated and protests decided, Headquarters Company, RLT-26 came out on top with 76 points.

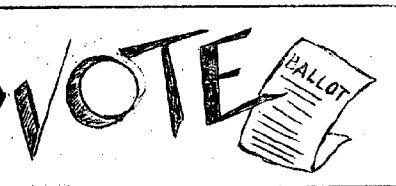
### Jewish Holy Days Message

School has started and throughout the country life has returned to the scheduled, regulated normalcy of the school year for individuals, families and communities.

Fine for kids, teenagers, parents and teachers, but what effect does it have on you? Plenty, if you're smart.

Why not jump on the education wagon yourself? You've got some great opportunities to study almost anything you want. Service schools and correspondence courses offer a wide variety of courses and subjects to increase your professional and technical knowledge.

If these don't suit your purposes, you have the facilities of the U.S. Armed Forces Institute (USAFI) at your disposal. Through USAFI you can get more than 6,000 courses covering everything from astronomy to zoology.

If you prefer to get some courses for your high school diploma or college degree from a civilian source rather than through USAFI, you can apply for tuition assistance or use in-service G.I. Bill to help pay for (See EDUCATION, page 4)

## VOTERS DAY

WASHINGTON (AFPS) - Friday, Sept. 20, has been designated as Armed Forces Voters Day for 1968.

The military vote does count! This year it can count bigger than ever—as much as 1.7 million votes come Election Day on Nov. 5.

In the 1960 General Election, only 39.4 per cent of Armed Forces members who were of voting age actually voted. In 1964, the figure jumped to 51.3 per cent. If this increase repeats itself in 1968, more than 72 per cent of all Armed Forces members of voting age will take part in the selection of the next President and Congress. This would be higher than the percentage of participation by the nation's voters as a whole in the 1964 General Election, when 60-odd per cent of those eligible actually cast their votes.

## Pieces of The Puzzle!

Despite the sophisticated and futuristic devices used by both the "good guys" and the "bad guys" in present-day spy movies, books and television shows for gathering intelligence, one of the oldest and most effective methods of picking up military information is still to eavesdrop on military personnel in the everyday conversation.

Science and technology have developed electronic detectors, long-range microphones, bugging devices and anti-bugging devices. But the one thing that can't be changed or completely controlled is the human element - the unknowing or inadvertent disclosure of a piece of vital classified information by an individual during the course of a conversation.

It's this one slip that just might give our enemies a vital piece to the intelligence jigsaw puzzle they are trying to put together. Certainly a great deal can be learned by our enemies by simply reading the newspapers, news magazines, government publications and the like. Often we read about an operation or piece of equipment in the news media that is supposedly classified.

Stop and think for a moment though. Is the complete story really there, published for all to read, or have one or two vital pieces been left out - pieces that YOU might know about because you work with that item or equipment or in that particular operation?

Those are the pieces that the enemy is looking for and can afford to sift through a lot of useless or (See INTELLIGENCE, page 4)

duplicate information to find. One slip on your part may not give them all they want, but combined with the careless slips of many others, it can help provide the pieces to intelligence jigsaw puzzles fatal to our country.

Security of information is not to be taken lightly. Our enemies have sworn to bury us and our way of life and they will use every sneaky, dirty, devious trick in the book to do it. Highly technical or classified information should not be the subject of casual conversation. Don't try to use your knowledge of classified matters to impress people and don't get careless in your conversation. Somebody is probably listening to you - possibly the wrong people.

Wisdom, whose lessons have been represented as so hard to learn by those who later were at our school, only teaches us to extend a simple maxim universally known. And this is, not to buy at too dear a price.

tightrope walker) and you don't get extra pay for that. In the Marine Corps you get Hazardous Duty Pay for the dangerous chores. Don't confuse this pay for Combat Pay, that's extra.

Let's say you're a sergeant E-5 over four years. Your basic pay is \$304.80 a month. That's all that's taxable.

As an E-5 you earn \$80 Hazardous Duty Pay for flying around in your helicopter. Because you live with your family and you don't eat at the mess hall, you receive subsistence which is about \$1.32 a day. And of course propay could be coming your way which would amount to extra money coming in, but let's forget about that for now.

Let's go back to our civilian counter-part. He is in the clothing store buying some new working clothes. If he only knew that in the Corps he receives a clothing allowance every month.

Where's he going now? Oh, he has to pay the rent on the house he's living in. That's a big chunk of his pay. In the Corps our sergeant is receiving \$105 a month to help pay for his rent.

Son-of-a-gun, our sergeant went and bought a new home. By the time he retires, the Corps will have almost completely paid for his house by giving him a Quarters Allowance.

Maybe he only wants to keep the house until he moves to another duty station. If he sells the house for what he paid for (See CAREER, page 6)
