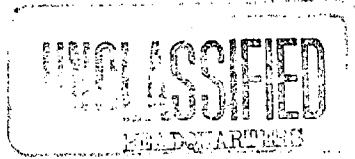

During the reporting period the Command Post location was as follows: From 010001H July 1966 to 312400H August 1966, Vicinity Hill#55, Da Nang TAOR, coordinates (AT 966617). During the period 161800H August to 170600H August Command Post (Forward) was established at coordinates 925526. From 170900H August to 181300H August, the Command Post (Forward) was at coordinates 953548. At 181300H August, the Command Post (Forward) began moving back toward the Liberty bridge site and returned to Hill#55 at 181830H August. 010001H September to 281100H September 1966: Vicinity Hill#55, Da Nang TAOR, coordinates (AT 966617). From 281100H September to 031600I October 1966 the Command Post was located aboard the USS HENRIKO (APA-45). From 031600I October 1966 to 022300I December 1966 Camp Schwab, Okinawa (Bldg 3527). From 022300I to 070900H December 1966 location was aboard the USS LANAWEE (APA-195). From 070900H December 1966 to the end of the reporting period the Command Post was located aboard the USS IWO JIMA (LPH-2), with temporary occupancy at the SLF camp, USNB, Subic Bay, Republic of the Philippines.

PART II

EXECUTIVE SUMMARY

During the reporting period, 1st Battalion, 9th Marines was involved in three distinctly different types of operation. From July through September the battalion was active in the Da Nang TAOR, South Vietnam. In conjunction with the battalion's normal mission to secure and pacify its ZOA, further responsibilities to block the Song Thu Bon (River) area from GS 9 6 5 6 to GS 9 0 5 5, provide security for the newly constructed MSR through the battalion's ZOA, and provide security for the northern landing site of the Song Thu Bon Ferry, Grid Coord. 926533 were added. The river block was accomplished by establishing two company positions along the Song Thu Bon. One CP was located at Grid Coord. 954556, the other at Grid Coord. 920547. The companies in turn established separate platoon positions within their ZOA in order to be spread enough to cover the assigned area. From the platoon positions extensive patrolling was conducted to prevent VC infiltration or movement through the ZOA. Security for the ferry site was accomplished in conjunction with the river block. A reinforced rifle platoon was set in around the ferry landing. The platoon, from its position, could defend the ferry site, watch the river, and conduct required patrol activity. Security for the MSR was attained by extensive patrolling near the road and by daily physical mine sweeps. The sweeps generally consisted of an engineer team of varying size escorted by one or two rifle squads. One check point was established on the MSR to count and keep track of passing civilians. A third rifle company was located at Grid Coord. 968586, a strategic point on the MSR. Road security was one of the company's missions. The securing and pacification of the battalion ZOA was carried out by all four rifle companies. From the three positions already mentioned, extensive patrolling of squad and platoon size was a daily occurrence. The fourth rifle company, a reserve element, also provided a rifle platoon for security in the northern sector of the battalion area. As a result, 10 rifle platoons were actively patrolling in the battalion ZOA when a special operation was not in progress. Frequent county fair operations were used in an attempt to ferret out VC in the area while various civic action programs were implemented. Two to four rifle platoons were usually used for the county fairs. In addition to the routine activities of the battalion, two battalion (-) operations were conducted and one company raid attempted. During the period contact was usually light. Squad patrols encountered light harassing action. Occasionally a platoon found the enemy willing to fight and two companies were mortared. The VC, however, chose to snipe and run during most of the reporting period. Booby traps and mines continued to be a problem to both troops and vehicles, particularly on and beside the MSR. Mine incidents accounted for a number of troop deaths and crippled tracked vehicles.

Toward the end of September, when the Battalion was in preparation to leave the Da Nang ILOC, mine and booby trap contacts increased slightly. Throughout the months of July, August, and September the battalion continued to build new and improve old semi-permanent positions. Construction was carried out at battalion, company and platoon level. From October to November the battalion refurbished and trained on Okinawa. Administrative matters which suffered in the combat zone were brought completely up to par. Medical and dental routine matters were brought up to date. The battalion departed Okinawa with fresh trained troops and new or rehabilitated gear. During the month of December the battalion engaged in training and rehearsal for special operations, with the SLF. An amphibious exercise (Mud Puppy II) was conducted on Mindoro Island, Republic of the Philippines. The unfavorable terrain interlaced with unfordable watercourse obstacles, proved highly satisfactory for indoctrination of the BLT in problem areas to be expected in special operations with the SLF. The reporting period ended with BLT 1/9 embarked on board assigned shipping bound for special operations (Deckhouse V) in the Republic of Vietnam.

## PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS1. FMF Organizations Concerned In Combat And The SLF.

a. Combat Missions Assigned. In the Da Nang TAOR, 1969 provided a block on the Song Thu Bon (River) area, provided security for the MSR cutting through the ZCA and provided security for the northern landing site of the Song Thu Bon Ferry. As the SLF, the battalion was a mobile reserve force, prepared to be employed on command.

b. Significant Operations Conducted. While three operations, Wilcox, a company raid, and Swanee were conducted during this reporting period, only Swanee was significant. The others yielded nothing of significance for reporting purposes. Operation Swanee conducted from 16 Aug-21 Aug, was multi-battalion escort of a landing craft M8, up the Song Thu Bon River. The M8 made an hydrographic survey of the river while the battalions secured the river banks to insure safe passage. 1st Battalion, 9th Marines, escorted the M8 from grid square 9954 to grid square 9253. The job was accomplished using two rifle companies supported by a tank platoon and four amtracs. An initial search and clear was made south of the Song Thu Bon River, followed by one company moving along the river beside the landing craft, while the other continued to search inland a short distance. The operation met with only light resistance. On 17 August, a platoon of Co "C", made contact with an unknown number of VC at (AT 979530) killing 17 VC. A UH-1E gunship in support, killed approximately 20 more VC. Company "A", on 19 August, in position at (AT 967548) received 81mm and 60mm mortar fire in addition to heavy small arms fire. Co "A", returned fire on both occasions. The combined VC kills came to a probable 25. On 20 August, Company "C", after completing a river crossing at (AT 901545) received heavy incoming mortar and small arms fire. In the return of small arms and mortar fire a probable 5 VC were KIA.

c. Casualties Inflicted On The Enemy. During the three months in which the battalion was in contact with the enemy 299 KIA and 41 WIA were suffered by the VC. In addition, 38 VC were captured.

d. Casualties Sustained. Twenty-Three (23) enlisted marines were killed in action during the reporting period. Three (3) officers and one hundred and six (106) enlisted marines were wounded in action. In this same period four (4) navy enlisted men and one (1) officer were wounded in action. On 24 September 1966, Lt Col JONES, the Battalion Commander, received a gunshot wound through the left thigh as he was returning from an inspection tour of frontline positions. The Colonel was med-evaced.

e. New Techniques Employed. Operation Mud Puppy II, conducted on Mindoro Island, Republic of the Philippines, provided the training vehicle to introduce the new techniques of riverine operations and the use of light plastic assault boats with outboard motors. These techniques were soon to be employed in special operations in the Republic of Vietnam.

f. Command Relations. On 1 July 1966, 1/9 was OPCON 9th Marines. This relationship continued until 3 October when the battalion entered a training and rehabilitation phase, OPCON RLT-26 at Camp Schwab, Okinawa. On 2 December 1966 the battalion was committed to the SLF; OPCON TG 79.5 through the remainder of the reporting period.

g. Equipment. Three new items of equipment have been integrated into the battalion, they are the AN/PRC-25 radio, the Starlight Scope, and the Light Plastic Assault Boats with outboard motors.

h. Logistics. During the reporting period logistics support included delivery of supplies and equipment by surface and air means. During the battalion's rehabilitation phase, logistic support included the coordination and assistance in the repair and resupply of combat essential equipment/supplies. All debarkation and embarkation procedures were directed and assisted by the S-4 staff.

i. Civic Action. During the period in which 1/9 was operating in the Da Nang TAOR an active civic action program was in effect. Primary methods used included medical assistance provided by navy corpsmen, county fair operations including Psy-Ops warfare teams, and individual effort on the company level. No further civic action in Vietnam was undertaken. During the BLT stay in the Republic of the Philippines, a civil affairs team visited the village of Nagiba and provided medical treatment as well as gifts of dolls, salt, soap, and vitamins. Between 1 July and 31 December 1966, 2400 indigenous persons received medical treatment and 68 were med-evaced.

j. Administration. Nothing significant to report.

k. Personnel. Detailed personnel data is contained in the S-1 journals submitted with monthly Command Chronologies during the reporting period. In the six months covered by this report 11 officers and 366 enlisted marines were dropped, while 29 officers and 733 enlisted marines were joined.

1. Intelligence. During the reporting period a continuing effort was made in psychological warfare. The efforts included, the I Corps Psy-Ops Field Detachment broadcasts, aircraft broadcast over the ZOA, broadcast by battalion and regimental interpreters, and speeches to the people by the village chiefs and ralliers from the hamlets.

Face-to-face persuasion was conducted by companies in the field. While operating in the 9th Mar. Regt. ZOA, mines continued to be the biggest U. S. casualty producer. There were two incidents of VC terrorists activity within the ZOA. Thirteen civilians were killed and one village was burned in these incidents. One rallier surrendered to the battalion. While the battalion was committed to the SLF, intelligence efforts were directed towards the gathering and dissemination of information concerning planned operations in RVN.

m. Communications. During the reporting period the battalion employed wire, radio and radio relay without difficulty. New radio operators were trained in use of equipment and procedures to be used in the battalion.

n. Weather. While operating in the 9th Marine Regt. TAOR the weather was typical of the geographic location and season, extremely hot, humid and subject to occasional cloudbursts.

o. Fire Support. Artillery was employed on targets of opportunity, in the preparation of the attack, and seizure of company size objectives, on known enemy mine fields, on counter-mortar missions, and in the restriction of enemy movement at night through harassment and interdiction fires. Each unit in the battalion was provided with "on call" fires and the registration of these was encouraged. Every opportunity was taken to assess and refine methods of coordination with SACC and all FSOC operations. Due to the SLF commitment, special attention was given to problem areas unique to amphibious operations. Of interest during the reporting period was the employment of a 105mm howitzer of battery "D", in a direct fire mission in support of operations located within the battalion CP complex. These direct fire missions were characterized by an intense volume of fire directed on targets with an increased degree of accuracy. The direct fire was employed within 35 meters of friendly troops and all types of fuzes and shells were used. No friendly casualties were incurred.

p. Air Support. Air support during this period was characterized by extensive use of helicopter medevacs, the use of air-borne observers in Ol-E's and UH-1E's, and the use of helicopters to transport and resupply troops. In addition, a limited number of fixed wing airstrikes were conducted. C-47 Dragon Ships were used to provide illumination and fire support on two occasions.

q. Activations/Deactivation/Redesignations. The task organization for a BLT was designated and on 28 September 1966, BLT 1/9 was activated and embarked on assigned shipping bound for Okinawa.

r. Training Conducted While Not Committed to Combat. During the months of October and November emphasis was placed upon training and rehabilitation of the battalion. General Military Subject Proficiency Tests, Physical Readiness Tests, and Swimming Qualification Tests were conducted during the reporting period. Weapon's training included familiarization firing of all individual weapons, extensive training, and firing of all crew served weapons except the 60mm Mortar. No training ammunition was available for the 60mm Mortar. Throughout the reporting period a concentrated effort was made toward small unit tactics and specialty training such as: Counter Guerrilla Warfare, Demolitions, Land Mine Warfare, Jungle Lane, and Trap Line. In addition to the above training, Companies "A" & "B", received instruction in Amphibious Raid Techniques while Companies "C" & "D", received introductory type training in the use of rubber assault boats. Formal school training was attended by 103 enlisted and 8 officer personnel.

6. Intelligence. Prior to the operation, it was believed that approximately 25 VC guerrillas and many VC cadre and sympathizers were living in the operating area. The area was also suspected of being a safe area and storage area. We were unable to patrol it as much as desired and necessary, due to troop commitments in other areas. The operation netted 7 VC confirmed and 12 VCS, many of which were reported to be VC cadre and local guerrillas.

## CONFIDENTIAL

It is believed the reason more VC were not captured was because the people in the area reportedly had advance warning of the operation. No equipment, weapons, or documents were captured. The people, from the objective area, were collected into an assembly area and subjected to intensive Psy-War indoctrination. They had explained the reason for the operation, the reason for U. S. units in the area, and the inevitable defeat of the Viet Cong was stressed.

7. Mission. At 110630H August, attack in ZOA to search out and destroy elements of VC main force and local force units, their positions, bunkers and tunnel complexes.

8. Concept of Operation. DELTA TANGO Plt, and 1st Plt, Company "I", 3rd Battalion, 9th Marines, block on SONG AI NGHIA. Company "A" to block on SONG LA THO. Company "D", 1st Battalion, 9th Marines and Company "E" 2d Battalion, 9th Marines to first cordon, then, on order sweep west through DUC KY area. All units to be positioned during the hours of darkness and by 110530H.



12. Commander's Analysis. At 0550 all units were in position to cordon the village of DUC KY, with Company "D" and Company "E" in the eastern position and prepared to search and clear on order from east to west. All units were ordered to hold until the Psychological Helicopter arrived and had passed the word for all villagers to move west toward Hill 55 and cross foot bridge in that vicinity. The helicopter was late, then flew at an altitude so great that he could not be heard from the ground. That portion of the Psychological War effort was secured, and the sweep forces were ordered to commence the sweep at 0650. Their orders were to search out and destroy all VC forces, facilities and fortifications to include family type bunkers, trench and tunnel systems, punji pits, mines, and booby traps. Two houses were booby trapped and were pointed out to the troops by Vietnamese in the area. Some six to seven hundred civilians voluntarily came across the foot bridge, while approximately 200 were forced across by the sweeping forces. All Vietnamese civilians were assembled at the collection point. Med-Cap was performed by the Battalion Surgeon and his Staff. One hundred children, 50 females and 25 males were treated. Over 800 pounds of rice was distributed to the people along with 5 boxes of soap, 1 box of canned goods, 2 boxes of toys, 1 box of clothing and 1 box of candy. A Psychological War program was conducted by the 1st Corp Army Psychological War team and Vietnamese goverment officials from THANH SON and KY MINH villages. The theme stressed was the inevitable defeat of the Viet Cong and the return of GVN influence to the area. At 1630H, all Vietnamese were allowed to return to their village. During the operation, two Marines were slightly wounded. One stepped on a steel punji stake and one tripped an M-26 frag grenade rigged with a trip wire. Though no action or no contact was made by the sweep force, Company "A", while moving into its blocking position, encountered some resistance in the form of harrassing and sniper fire. During daylight hours, while in their block, a total of seven artillery missions and six 81mm mortar missions were fired during the 24 hour period. AO was requested and upon arrival searched several GS south and reported several groups of 10 to 20 all were moving south but was unable to identify any weapons. One difficulty encountered was that the detachment from ITP and CIT secured about 1430H and were not available when the sweep force brought in some 200 stragglers. However, the Battalion S-2, Regimental Interpreter and local village chiefs screened, and were able to find, 2 VCS in this particular group. Although the number of identified VC picked up was small, they were identified because of positive sources, and in 7 instances, admitted immediately their VC affiliation. The area searched and cleared has been a source of considerable harrassment to the Hill 55 complex, as well as a suspected VC haven. The operation is considered to have been successful, aside from the VC and VC suspects apprehended, in that we demonstrated to the local villagers that no area is "safe" or a "haven" for VC forces.

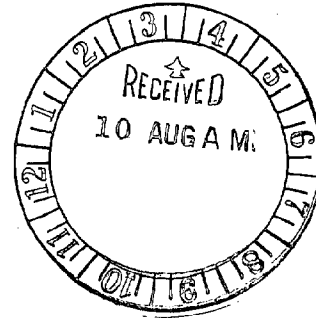
