1. General. The enlisted personnel situation remains excellent. Present strengths continue to exceed T/O authorizations and, barring unforeseen circumstances, will remain so throughout March. Only 30 enlisted detainees are anticipated. Our officer situation is very close to the critical. Present strength is eight below T/O and four below M/L. Of those presently on hand, two are on temporary additional duty and, for all practical purposes, lost to the command completely. Anticipated losses through rotation for March and April are 3 and 5, respectively.

a. Strength. The average monthly strength for the period ending 28 February 1957 was as follows:

(1) Of the battle casualties, one was WIA and six were DIA's. Of the DIA's four were returned to duty and two remain hospitalized.

(2) Of the 16 non-hostile casualties, three were transferred by Service Record, four remain hospitalized and nine have returned to duty.

(3) Four officers and 76 USMC enlisted rotate to T/5C. Transfer percentage was 65%. In addition, two officers and 22 enlisted personnel were transferred intra-Division. The transfer percentage does not reflect these figures.

c. Replacements. This Command joined three SM officers and 98 USMC enlisted during the reporting period. One SM officer and 20 SM enlisted personnel were joined for duty.

d. Administration

(1) Status of Morale. Morale remains outstanding.

(2) Significant Activities or Personnel Service. Excellent movies were being received monthly. Two entertainment groups, sponsored by the USO and Department of Defense, performed for the Battalion.

(3) Promotions, One soldier received promotion to E4 to E5 and one received promotion to 1stLT, a total of 14 soldiers personnel are promoted; one to MSgt, 26 to Sgts, 20 to E5, 14 to E4 and seven to PFC.

e. Discipline, Law and Order. One Special Court-Martial and one Summary Courts-Martial were conducted during the period. One General Court-Martial pending SA's action. A total of 30 personnel were disciplined within hours; 13 by the Battalion Commander and 17 by the Company Commander.

f. Mail. Mail service remains satisfactory.

S-2 CHRONOLOGY

1. General. During the period 1 February 1967 to 28 February 1967, 2d Battalion, 9th Marines continued its mission as defense Battalion for the Phu Bai vital area. On occasion operations extended into areas peripheral to the TAOR in response to reliable intelligence and specific security missions.

a. Area. The area of intelligence interest extends 27.5 miles along National Highway #1 from Thuy Thuong Village, Huong Thuong District to Ga Thua Luu in Phu Loc District. The land consists of sandy areas and wet rice paddies in the coastal region with rolling terrain and higher mountains to the southwest. The flat terrain to the northeast is only broken by scattered treelines around populated areas. The area southwest of National Highway #1 is open and sparsely populated, except within 2000 meters of the highway. The population is predominantly Buddhists and consists largely of rice farmers and fisherman with carpenters and other skilled laborers, being located near population areas.

b. Trafficability. The culmination of the monsoon rains made movement off Highway #1 feasible for tracked or wheeled vehicles. The 60 miles of roads, 166 miles of navigable waterway, and ease of movement across the terrain made all areas accessible to both Viet Cong and USMC forces.

c. Weather. During the month of February the weather improved as the monsoon season ended. Temperature conditions varied greatly as the summary indicates below:

2. Enemy Situation. During this reporting period, units known to be operating within or near the 2d Battalion, 9th Marines TAOR were confirmed and more precisely located. Through documents, rations, agent reports, and contacts a more thorough understanding of the enemy situation was gained.

a. Order of Battle

(1) Phu Thu District to the north and northeast contains three confirmed local force units. The C-113 local force company is based out of Vinh Phu Village (GS 9716) and hamlets within 2000 meter radius. Outposts are provided for warning and one squad is detailed to provide a delaying action for the escaping company if the village is approached by ARVN or American forces. The C-117 is based out of Luong Vien (GS 9221). This unit is divided into 5-10 man groups and can mount a sustained platoon size offensive. Five to ten man guerrilla forces from this company are located at YD 851250, YD 872253, YD 902232 for sniping and harassing purposes. Recent documents and interrogations reveal one company of the 804th Viet Cong Battalion armed with 2-82mm mortars operates in Vinh Ha and Vinh Thai Villages (GS 9714).

Recent contacts by ARVN forces confirm their size and mortar capability. Each of these units may send squad size units southwest to harass USMC units. Lack of indigenous guides, however, has prevented most infiltration into the TAOR.

(2) Nam Hoa District to the west of the TAOR contains two platoons operating out of Dinh Monh (YD 785115) supported by 15-20 NVA's. These units are from the C-116 local force company and will move to the southwest on approach of USMC or ARVN units. There is some evidence that elements of this unit traffics from Dinh Monh to Gia Le (YD 820180) but this has not been confirmed.

(3) Huong Thuy District which comprises the northeastern half of the TAOR has limited guerrilla activity. Although no organized local force unit can be found in Huong Thuy, local cadres, and sympathizers are active in Loi Nong (YD 829199 -YD 848195), Gia Le (YD 820180), Phu Bai (YD 905112) and a few hamlets on the western periphery of the TAOR.

(4) Phu Vang District northeast of Huong Thuy District has only isolated snipers and no organized units.

(5) Phu Loc District. The eastern half of Phu Loc contains elements of 804th Battalion while the western half contains elements of the 802d Battalion. Contacts have confirmed the location of at least one element of the 804th in the Ben Tam area (GS 8900). It is believed the majority of this unit is located east of this. Elements of the 802d Battalion has been confirmed by ralliers and captured documents but its size and exact location is unknown.

b. Significant Enemy Activity

(1) Royal Tombs Area. Reports from a rallier in Dinh Monh (YD 785115) on 1 February revealed that two local force platoons and 29-30 NVA would be at this location from 6-12 February. Echo Company in conjunction with the elite Hach Bau Company of the 1st ARVN Division conducted an operation 5-6 February resulting in 6 VC/KIA (conf), capturing 3-60 mortar rounds and several documents. Further intelligence indicated that these units moved back into the area and that propaganda and indoctrination lectures are being given to one platoon of NVA from the 207th Battalion.

(2) Survey Security. A platoon of Hotel Company operating in the waters northwest of Xuan Xo in the Phu Thu District (YD 855255) and Fox Company while sweeping in the district encountered sniper fire on 10 occasions. Fox Company also received 2 rounds 82mm mortars and had 4 small unit contacts on their sweep from district headquarters northwest (YD 899187 to YD 850250) and subsequently southwest to YD 915189. ARVN units later made heavy contact just south of where Fox Company was helilifted out on 25 February, killing two Viet Cong from the 804th Battalion.

(3) Mine Activity. A continued effort by the Viet Cong to destroy vehicles, road bridges, and railroad bridges resulted in 6 mining incidents and 2 bridges destroyed.

reaction to specific intelligence and intelligence requirements. They were developed in response to a need for accurate, timely intelligence. By 16 February 1967 the squads were fully trained in map reading, long range patrolling, reporting procedures, supporting arms, and communications. A summary of hours of conducted training appears below:

Since 16 February, each squad has conducted three long range patrols of 4 days duration. They have confirmed location of several trails, fighting holes, and determined enemy activity level in the southeastern portion of the TAOR (Xa Thoung Bang) village.

9. Surveillance Devices. AN/TPS-21's were at FLSU for repair until 25 February. On this date they were sent up to the Chinook operating area to be used under the control of the 4th Marines. 14 SID's were utilized during this period. Infa-red sniper scopes were utilized in the defense of the Phu Bai Vital Area.

10. Psychological Warfare. Combined action companies Alpha and Hotel distributed 25,000 leaflets. 2/9 ground units distributed 10,000. Armed propaganda teams operated in the TAOR on three separate occasions extending the CHIEU HOI program into new areas (ZD 1904 to AU 8004).

8. Battalion Reconnaissance Squads. On 1 February 1967, two 3-2 reconnaissance squads were formed for the purpose of conducting long range patrols in

5. Company "H", 2d Bn, 9th Mar. From 1-28 February Company "H" provided one platoon for survey team security at Golco Beach. From 1-3 February the Company provided security for the Phu Bai Vital Area Defense Perimeter with two platoons; and conducted squad patrols working in conjunction with CAC units. On 4 February the third platoon of Company "H" reinforced Company "E", 2d Battalion, 9th Marines for the operation in the Royal Tombs Area and Company "H" assumed responsibility for the reinforced platoon Sparrow Hawk reaction force. On the 7th of February Company "H" was secured from the Sparrow Hawk reaction force and from that date until 13 February conducted PPB's throughout the TAOR and manned positions on the Phu Bai Vital Area Defense Perimeter. From 13 February until the end of the month Company "H" operated PPB's throughout the TAOR; provided a reinforced platoon as a Sparrow Hawk reaction force; and provided squads for patrols in conjunction with CAC units.

6. H&S Company, 2d Battalion, 9th Marines. From 1 February to 28 February H&S Company provided security for MCB-62 operations at the Rock Quarry; manned a section of the Phu Bai Vital Area Defense Perimeter and manned highway check points within the Phu Bai Vital Area. On 23 February H&S Company continued above mentioned activities and in addition detached one flame section to support ARVN activities on Operation Chinook until 25 February. During the month the battalion formed two recon squads. These squads were part of H&S Company. From 1-28 February these squads trained and conducted operations as mentioned in S-2 portion of the chronology.

7. During the period 6-13 February, Companies A-C of 1st Bn, 9th Marines were under operational control of this Battalion. "A" Company, 1st Battalion, 9th Marines was Division reserve (7-13 February) while Company "C", 1st Battalion 9th Marines operated extensive patrols and ambushes in the Gia Le Area (6-12 February).

8. Combined Action Companies. CAC A & H conducted extensive small unit patrols and ambushes during the month. They totaled 743 patrols and 437 ambushes resulting in 14 contacts; 4 VC/KIA (conf) and 4 VC/KIA (prob).

9. Close Combat

a. Patrol Breakdown. During the month 170 squad size ambushes and 361 squad size patrols were conducted throughout the Phu Bai TAOR. A total of 15 PPB's were operated throughout the TAOR. Each PPB averaged 8 days in the field.

b. Sparrow Hawk. During the month Sparrow Hawk was committed three times. On all three occasions the commitment was as security for downed aircraft. On 19 February two bodies and confidential material were recovered from a downed U. S. Army Mohawk aircraft. On 24 February weapons, confidential material and 5 bodies were recovered from a downed USMC Helicopter; and again on 24 February Sparrow Hawk was committed for security of a UH-34 helicopter downed with mechanical difficulties.

c. Training. Operational commitments reduced formal military training that normally would have been accomplished. During February 338 troops completed

1. General. During the month of February 1967 the 2d Battalion, 9th Marines continued its mission at the Phu Bai Vital Area Defense Battalion; maintaining observation posts on Hill 230 and 180; providing a reinforced platoon as Sparrow Hawk reaction force; coordinating the Vital Area Defense Perimeter; providing security for various survey parties and CAC units; and conducting offensive operations ranging from squad to company size. Extensive platoon patrol base activities were conducted throughout the TAOR.
2. Company "E", 2d Bn, 9th Mar. The first three days of February, Company "E" maintained observation posts on Hill 230 and 180; provided a reinforced platoon for the Sparrow Hawk reaction force; and operated a platoon patrol base. On 4 February Company "E" (reinforced), in conjunction with the Black Panther Company (ARVN), conducted a one-day, combined, ARVN-Marine operation west of the 2d Battalion, 9th Marines TAOR. The operation was conducted in the Royal Tombs Area (YD 7811). Upon their return Company "E" operated PPB's throughout the TAOR and provided squads for reinforcement of CAC units. On 14 February the Company was used as reserve for rough rider activities. From 14-21 February the Company supported rough riders to DaNang and Dong Ha as well as continuing PPB operations and conducting patrols in conjunction with CAC units. On 20 February Company "E" provided two platoons for Vital Area Defense, and conducted activities in conjunction with CAC units. On 26 February Company "E" was relieved of its responsibilities along the Vital Area Defense Perimeter. One platoon then reinforced CAC-H6, and one reinforced CAC A-1 and CAC A-2.
3. Company "F", 2d Bn, 9th Mar. Continuing an operation that commenced 31 January Company "F" operated in Phu Loc District around the MOI KUN SAC Mountain (vicinity ZD 0102) from 1-3 February (OpOrder 5-67). On 4 February the Company conducted PPB activities and patrols in conjunction with CAC units. From 5-18 February Company "F" provided two platoons for Vital Area Defense Perimeter; PPB's throughout the TAOR; and security squads for survey operations between Phu Bai and Hue. Numerous squad patrols were used in reinforcing CAC units. On 19 February, Company "F" was assembled for an operation to provide security for MCB-62 survey activities in the northwestern portion of the Phu Thu District (OpOrder 6-67). The operation began 20 February and continued until 22 February. Several small unit contacts were made resulting in the capture of detainees and Viet Cong documents. On 23 February, Company "F" moved into a blocking position for an ARVN sweep in the southeastern portion of the Phu Thu District. For the remainder of the month Company "F" supported rough riders to DaNang and Dong Ha. On 28 February Company "F" came under the operational control of 3d Marine Division Forward to reinforce units from Phu Bai participating in operation PRAIRIE II.
4. Company "G", 2d Bn, 9th Mar. During the month of February Company "G" maintained observation posts on Hill 230 and 180; manned positions along the Phu Bai Vital Area Defense Perimeter; and operated extensive PPB's throughout the Phu Bai TAOR. Company "G" also provided squads to work in conjunction with CAC units.

9 hours of instruction on the M-16 rifle, and fired the weapon for familiarization. The completed training of this group qualified all of this Battalion for the transition from the M-14 to the M-16. Division Land Mine, Boobytrap, and Demolition School was attended by 100 troops from this Battalion. Officers and Staff NCO school was conducted twice. Subjects included Chieu Hoi/Revolutionary Development and Supply Management. Eighty-four replacement personnel familiarized fired their individual weapons for battle sights familiarization and received training in accordance with Division Order 1510.3A.

Platoon Refresher Courses were given to 170 Marines. The subjects included: patrol and ambushes (1 hr), Map Reading (2 hrs), (1 hr practicable application) Chieu Hoi/Revolutionary Development (1 hr), F.O. Procedures (1 hr), First Aid and Buddy Aid (1 hr). Company training was conducted in the following areas: First Aid and Buddy Aid, Personnel Response, UCMJ and SRB, Boobytraps, Scouting and Patroling, Terrain Appreciation, Day and Night Navigation, Cross Training of Weapons, Map and Compass Reading, Tactical Formations, Brevity Code, Crew Served Weapons, Radio Procedures, and Combat Principles. Technical training was conducted to fulfill requirements listed in the MOS Manual for each rank specialty.

11. Fire Support and Fire Support Coordination

a. During the period 1-28 February 1967, while operating in the Phu Bai THOR, 2d Battalion, 9th Marines was provided direct artillery support by Batts "E", 2d Battalion, 12th Marines and general support by 1st Prov 155mm Howitzer (Towed) Battery, and 1st Prov 155mm Gun Battery. Battery "D", 1st Battalion, 44th Artillery U. S. Army provided dual 40mm (4-42) and quad .50cal (M-55) support for perimeter defense and convoy security.

b. Utilization of artillery in support of operations for the month consisted of 2 missions fired on targets of opportunity, 2 recon-by-fire missions, 5 illumination missions, 21 training missions, 23 defensive target and adjustments, and 737 H&I concentrations. These fires resulted in the expenditure of 25 HC smoke, 114 WP, 102 illuminations and 2229 HE rounds.

c. During the period 1-26 February 1967 the 81mm mortar platoon fired 1862 rounds in support of operations which included 1239 HE-M, 21 WP, and 602 illumination.

d. Training conducted during the period consisted of classes and practical application periods on observed fire procedures for approximately 40 Recon Battalion personnel, 30 Combined Action Company personnel and 30 H&S Company Recon personnel.

e. Fire Support Coordination policies remained unchanged from the previous month.

12. Air Support

a. Med Evac Missions. Eight medevac missions were flown in support of this battalion during the month of February; evacuating 19 USMC casualties to

Company "A", 3d Medical Battalion. One CH-46 was used along with 8 UH-34's and Huey Gunship escorts. One mission was in support of Sparrow Hawk in the Chinook area and the remainder took place in the Phu Bai area. Response time remained excellent regardless of weather.

b. Logistical Missions. Eleven logistical missions were flown in support of this battalion during the month of February. This does not include the combined lifts of troops and cargo. A total of 62,569 lbs of supplies were lifted utilizing UH-34's and CH-46's. All missions were flown in the Phu Bai area in support of units on Hill 180 and 230, platoon patrol bases, company operation and units involved in security operations for survey teams. Material lifted included C-rations, ammunition, lubricants, clothing, and mule mounted 106 recoilless rifles. Adverse weather continued to effect resupply by helicopter.

c. Troop List Missions. Twenty-six troop lifts were flown in support of this battalion during the month of February utilizing 52 CH-46's and 19 UH-34's. A total of 1433 combat troops were moved in and around the Phu Bai area. Sparrow Hawk was lifted once into the Chinook operating area and twice in the Phu Bai area.

d. Close Air Support Missions. Two air strikes were flown in support of Sparrow Hawk and company operations. One required 2 Huey Gunships and the other utilized 4 F8U's and two Huey Gunships. A C-117 flare ship supported Company "F" with illumination on two occasions.

e. Recon/Observation Missions. During February, 9 Recon TAOR flights were flown using 12 UH-34's and 6 UH-1E's. A total of 41 passengers were carried on these flights. Seven O1-C's were used in support of Company Operations and CAC units.

1. General. The logistical situation of this Battalion is considered good. There are still critical problem areas in Supply, Motor Transport, Ordnance and Comm-Electronics.

a. Supply. During the past month the supply situation has improved. Battalion Supply has received fifteen H-138 handsets; tropical clothing; socks; tropical boots; rain gear; rifles; typewriters; M60 machine guns; 3.5 rocket launchers; body armor, upper; and magneto's for the Mule (M274A1). Critical shortages which exist are compasses, rifle cleaning gear, .45 cal pistols constant velocity (CV) joints for the Mite (M422A1) and long antenna bases (2L) for the radio AN/PRC 25. The battalion still lacks a PU482 (30kw) generator.

b. Ordnance. The battalion armorer has encountered difficulty in acquiring I. C. E. oil for the flame compressor as well as the lack of 3d echelon parts at FLSG-ALPHA for the repair of M-79 grenade launchers and 106 RR. The battalion is still experiencing difficulty in acquiring .45 cal pistols for those declared as unserviceable through service.

c. Motor Transport. Eleven (11) of our M274A1 mules are deadlined for R&R engines, one for front seal and one for rings. The M422A1 mites are deadlined mostly for transmissions and engines.

d. Comm-Elect. There is a critical shortage of the long antenna bases (2L) for the radio AN/PRC 25. There are seven (7) AN/PRC 25's deadlined at 3d echelon for repairs. One (1) AN/PRC 83 and one (1) AN/PRC 87 are deadlined at 3d echelon for repairs.

e. Supporting Units

(1) FLSG-ALPHA provides the bulk of the logistical support for the Battalion.

(2) EOL support is also provided by FLSG-ALPHA in the Phu Bai area.

(3) Engineer support is provided by Division Engineers. All work requests are channeled through the Division Engineers.

(4) Truck support is provided by 3d MP Battalion and is coordinated directly with the Division Motor Transport Dispatcher. During this reporting period an average of (3) trucks daily have been assigned this unit.

(5) Helicopter support is received from MOC-16 and coordinated through the battalion air officer for logistical lifts.

(6) CB's are providing support for the whole Phu Bai area and are presently laying an extensive water pipe line through the area.

f. Since the last reporting period, new urinals have been installed around this contonement. The sod being placed in this contonement has been completed. Truck support for household runs has been poor this reporting period, due mainly to the small number of trucks and number of committments within the 3d Marine Division area. Presently there is little relief in sight.

3. Operations. During the reporting period there were no major operations in which the battalion took part.

a. During the reporting period, 57 trucks moved 1226 troops in 19 lifts.

5. Logistical Lifts

COMMUNICATIONS CHRONOLOGY

1. General. The communications platoon furnish all the communications for the battalion plus maintenance and repair of communications equipment, operation and maintenance of the battalion shower unit, and lighting equipment.

2. Support. This platoon supplied the battalion recon platoon with two (2) radio operators. It furnished communication equipment and operators for six (6) "Road Runners" and five (5) "Rough Riders". Four (4) radio operators were loaned to the Rifle Companies to train company radio operators. Eight (8) AN/PRC-10 radio's were loaned to division. Division was also supplemented with two (2) 2543's and two (2) 2511's and a reproducing machine. CAC units were supplied with twelve (12) BA-386's. The Tech Shop modified six (6) H-30 handsets to operate with the AN/PRC-25's. The 1st Battalion, 44th Artillery was supplied with eight (8) miles of WD-1/PT. An instructor was provided to conduct classes on the M-16 Rifle. The FAC team was committed five (5) times during the month. The wire section has employed one (1) man with each rifle company on the perimeter for internal wire work.

3. Telephonic Communications. The wire section maintained and serviced all wire installations within the battalion CP and the perimeter. The wire section installed three (3) new lines; from COC to Hq. En., HM-163, and 3d Mil Bn.

5. Operations. A relay site was manned on hill 180. Shackle sheets, repair parts and batteries were furnished units of this battalion. Radio operators and wiremen were assigned to the rifle companies for their operations and radio operators were assigned to all "Rough Riders" and "Road Runners".

6. Difficulties. Spare and replacement parts remained critical, both for communication equipment and communication vehicles. These deficiencies have deadlined 20% of the man-packed radio equipment and 40% of the communication vehicles.

a. During the month of February, the AS personnel held military sick call for 847 Marines.

b. MEDCAP was held in the village of LOC 301 on three occasions during the month. There were 80 Vietnamese Civilians seen and treated. Recommendations were made to promote better sanitation in this village.

2. Sanitation

a. Routine sanitation inspections of the PHU MAI area were conducted on a daily basis.

b. Urine salvage pits have been relocated and shall casing type urinals are being replaced by urinoirs.

3. Disease, Injuries, Treatments in General

a. The AS continues to maintain a 6-10 bed ward for minor illnesses and injuries. This ward enables the BAS to render more effective treatment. Personnel requiring more extensive care are referred for admissions to Battalion Company for hospitalization and treatment and for possible further evacuation.

b. Most patients treated at the AS during the month of February were of a routine nature. The Battalion remains on a once-monthly Prophylactic Chloroquine tablet as a preventive against Malaria, this utilization of insect repellent and mosquito netting.

c. There was a marked decrease in the number of soft tissue injuries treated during the month. This is believed to be due to better weather conditions and the use of Silicon Foot Gribing.

b. Casualties and Hospitalization. There were 25 personnel from the Battalion hospitalized during the month of February. 12 were Marine admissions to Medical Companies and 13 were BAS admissions. Of the patients hospitalized; 3 were Fever, Unknown Origin & Shrapnel wounds; 2 Acute Tonsillitis; 4 Cellulitis; 1 Diarrhea; 1 Kerosene Poisoning; 1 Spontaneous Ulcer; 1 Edema Right Leg; 1 Edema, Eyes and Face; 1 Sprain, ankle; 1 Obstruction Eye; 1 Hematoma, Spermatic Cord; 1 Acute Thrombophlebitis; and 3 Medical Observations.

c. Training. Informal discussions were held in the AS by the Battalion Surgeon on proper technique of suturing. Two venereal disease and personal hygiene lectures were conducted by BAS personnel.

d. Health and Service Records. Routine maintenance of health and service records was accomplished during the month. Approximately 204 immunizations were administered.

7. Complement of 13. At the close of the month, the HAC had a complement of 54 Hospital Corpsmen. Of these 5 were SNCO's. There were 10 Hospital Corpsmen joined during the month. 6 were transferred by PCS or Mrs. The Battalion Surgeon, Lt. S. L. MILLER was relieved by Lt. H. L. ROSENFIELD on 15 February 1957.

8. Conclusion. There were no major problems during the month.

CHAPLAIN C. MOPOLOGY

1. In regards to the Chaplains primary duty, 23 Protestant Worship services were held with a total attendance of 530. Communion was given on the first Sunday of the month and at the individual CAC units. Aside from covering the CAC units, the chaplain gave Sunday coverage to the artillery battery and FISG-ALPMA.

2. Catholic Mass was held in the 2/9 Chapel with very good results from Catholic personnel. Chaplain McDERMOTT came over for these services at 1030 each Sunday.

3. The chaplain attended a PERSONAL RESPONSE SCHOOL at 3d Marine Division Headquarters that offered information concerning our attitude toward the Vietnamese people. On the first Sunday of the month he attended a TEF celebration at the village of Loc Bon and had dinner with the Vietnamese.

4. Three lectures were given to new battalion personnel on the subject of Religions and Customs in Vietnam. There was a renewed interest in trying to build a bridge of understanding between the Marine and the Vietnamese soldier, and these lectures are considered an important part of the Personal Response program.

5. During the month the Chaplain's assistant placed a literature table in the mess hall and has kept it up to date with a supply of literature for both Catholics and Protestants. The use of this literature by the men has been much better than had been hoped for. Many New Testaments, Rosaries and religious booklets were distributed.

6. The response to the Sunday worship services was beyond expectation and due to this response new benches were added increasing the capacity in the chapel to sixty.

7. Bible Study classes were held three nights a week with an average attendance of 10 each session. A short morning devotion was held daily at 0730.


