S-1 CHRONOLOGY

1. General. The enlisted personnel situation approached the critical. Although the battalion is currently 11 over T/O, a severe shortage exists within the Staff Sergeant and Sergeant ranks in occupational field 03. At the end of the reporting period the battalion was short 9 Staff Sergeants and 21 Sergeants. The losses in the preceding month will further compound this problem as the battalion is scheduled to lose 4 First Sergeants, 3 Gunnery Sergeants, 1 Staff Sergeant and 3 Sergeants. The officer strength is presently 9 below T/O and 5 below M/L with one officer rotating during May.

a. Strength. The average monthly strength for the period ending 30 April 1967 was as follows:

(1) Of the battle casualties, 2 were KIA's, 2 were DOW's and 46 were WIA's. Of the 46 WIA's, 18 were transferred by Service Records, 26 returned to duty and 2 remain hospitalized.

(2) On the 27 non-hostile casualties, 20 returned to duty and 7 remain hospitalized.

(3) Four officers and 72 enlisted rotated to CONUS. Transfer percentage was 6%. In addition, 1 USMC officer was transferred to CONUS by Service Records, 1 USMC officer was transferred intra-Division, 65 USMC enlisted were transferred intra-Division and 9 USMC enlisted were transferred to 9th MAB. Ten USN enlisted were transferred intra-Division and 1 USN enlisted rotated to CONUS.

c. Replacements. This Command joined 5 USMC officers, and 71 USMC enlisted, and 12 USN enlisted.

d. Administration

(1) State of Morale. Morale remains outstanding.

(2) Significant Activities or Personnel Services. Due to operational commitments, very limited special services activities were conducted.

(3) Promotion. A total of 97 enlisted personnel were promoted: 87 to Corporal, 6 to Lance Corporal and 4 to Private First Class.

e. Discipline, Law and Order. Six Special Courts-Martial were completed during this reporting period. One Special Court-Martial and one Summary Court-Martial are pending. A total of six personnel were awarded office hours by Company Commanders.

f. Mail. Mail service remains satisfactory.

## S-2 CHRONOLOGY

1. General. During the period 1 April through 30 April 1967 the 2d Battalion, 9th Marines continued to conduct operations against local force and main force guerillas in the Phong Dien TACR under the operational control of the 4th Marine Regiment. During this reporting period the unit participated in three main operations; Operation CHINOOK II which was being conducted when this unit arrived in this TACR on 9 March 1967 and lasted until 4 April 1967; Operation BIG HORN - 5 April - 21 April 1967; and Operation SHAWNEE - 22 April and as of 30 April 1967 was still being conducted.

a. Area. The CHINOOK II area of operations is bounded on the northeast by Highway #1 to the railroad at YD 5831, then along the railroad bed to the Song Bo River, on the east by the Song Bo River, on the south and southwest by the Annamite Mountains, and on the north and northwest by the area just north of the Song Thac Ma River. In the northeast portion of the area, near and parallel to Highway #1, cover is good to excellent for small infantry units. This is due to the gentle rolling nature of the terrain, stream beds, and gulleys. Low scrub vegetation grows throughout this area and with only a few exceptions, is from ankle to waist high. In the southwest portion of the TACR, encompassing the Cobi-Thanh-Tan Valley, cover and concealment is provided by cultural features such as rice paddy dikes, villages, tree lines and the rolling nature of the terrain. The mountains in the south and western portion of the operating area provide outstanding observation for both friendly and enemy units. This is due to the position and height of the mountains, and the heavy vegetation. Key terrain features in the area include Hill 51 (YD 550280), hill masses at YD 5030, YD 5131, YD 5120 and the mountains to the south. Civilians through the operating area have been instructed by GVN authorities to leave the area and it is assumed that any remaining people are VC or VC sympathizers. The civilians formerly from this area have been relocated inside the northern boundary of the TACR. All civilians encountered inside have been forwarded, after interrogation by CIT/IFT, to the 4th Marines collection point or to the Phong Dien District Headquarters at Pho Trac.

b. Trafficability. Movement throughout the area was generally good with a few exceptions, notably the Song O Lau River, which cuts through the operating area in a north-south direction and the Song O Ho River, cutting through the Cobi-Thanh-Tan Valley in an east-west direction. Crossing these rivers during the monsoon season proved to be difficult, but with the letup of rain and experience of units previously operating in these areas as to the locations of crossing points, the problem was solved. Routes offering ease of travel within the operating area are:

- (1) Highway 554 running along the southern end of the Cobi-Thanh-Tan Valley.
- (2) Hoa My Road at YD 549328 running through the center of the operating area.
- (3) Cobi-Thanh-Tan Valley leading to the valley north of Hill 51 at YD 5530.
- (4) The Song Bo, Song O Ho, Song O Lau and Song Thac Ma Rivers.

In addition, the entire TAOR is interlaced with a good network of trails and, with the exception of the rivers, is passable for tracked vehicles in most places.

c. Weather. During the month of April, good weather prevailed throughout the operating area with the exception of the period 13-17 April. Other than this period, weather had little or no effect on friendly/enemy movements or operations within the operating area. During the period 13-17 April, heavy rains seriously hampered the movements of this battalion, sweeping through the Cobi-Thanh-Tan Valley. Due to the rise in height and swiftness of the current of the rivers some of them became unfordable except by helo-lift. After this period, good weather prevailed and as the height of the rivers declined they became more passable at various points. As the good weather continues it is anticipated that the rivers will decline even more and they will be passable at more points than are now available. A weather summary for the period 1-30 April is as follows:

2. Enemy Situation. During this reporting period the enemy was active around the perimeter of the TAOR, particularly in the areas northeast and east of the TAOR and the mountains in the southern portion of the TAOR. Due to the number of operations conducted in and around the TAOR by Marine and ARVN units and the constant shifting of Viet Cong units as a result of these operations, enemy units and positions were unclear at the end of the reporting period. Operations BIG HORN and SHAMUSE (presently being conducted), failed to locate purported VC units. For the above reasons, the Order of Battle will be omitted. Enemy activity within the TAOR was limited to sniping/mining and small unit contacts and/or sightings. No large contacts were made by this unit since its movement into this area. It appears that the main concern of the enemy is to move personnel and equipment around the areas of friendly operations with as little trouble as possible.

### 3. Significant Events

a. On 11-17 April this battalion conducted a sweep of the Cobi-Thanh-Tan Valley with the mission of destroying anything capable of sustaining or aiding the enemy. Though hampered by the weather (paragraph 1c) this mission was a complete success as evidenced by paragraph 6 below. During the sweep, 34 mines and boobytraps were found and destroyed in a four day period.

b. During this reporting period, this unit continued to utilize two reconnaissance squads under the control of the S-2 Section. These squads are 14 men each and have 12 M-16's, 1 M-79, 1 M-60, and 2 PRC-25's per squad. Primarily

utilized in sustained ambush and observation positions covering suspected avenues of movement, they have greatly added to the observation and intelligence capabilities of this unit.

c. Only 1 Kit Carson scout is presently employed by this unit. During this period he performed his duties in an admirable and professional manner. During the sweep of the Cobi-Thanh-Tan Valley (paragraph 3a) he detected 5 mines and/or boobytraps. He is a definite asset to this battalion and the program is enthusiastically endorsed by this unit.

8. Sources of Intelligence. For the most part, Marines (ground forces) continued to be the primary source of intelligence information. However, the following supplemented the battalion's intelligence information on a continuing basis:

- a. S-2, 4th Marines
- b. ARVN Officials
- c. District/Province/Village and Hamlet Officials
- d. MACV personnel at Phong Dien
- e. Kit Carson Scouts
- f. Battalion Reconnaissance Squads

9. Surveillance Devices. During this reporting period, 4 TPS-21's, and 17 SIF were utilized by this command. They contributed to the security of the 4th Marines Perimeter and the combat outpost on Hill 51. Also used was 1 B.C. Scope, 6 Infra-Red Scopes, 4 Twenty-Power Scopes and 3 USA Jeep mounted searchlights (AN/MSS-3).

10. Psychological Warfare. PsyOps efforts in the area of operations were controlled and coordinated by 4th Marines S-5.

11. Items of Intelligence Interest.

a. The sweep of the Cobi-Thanh-Tan Valley on 11-17 April, revealed that the enemy had knowledge of our mission and on a number of occasions utilized double boobytraps attempting to cause injury to personnel destroying them.

b. The enemy made a continuous effort to damage and immobilize armored vehicles. Evidence was found indicating the usage of explosives devices to cause injury to personnel riding armored vehicles.

12. Comments and Conclusions. The central portion of the TAOR continues to be denied to the enemy, except small unit movements. The VC in this area are believed to be directing their efforts at the areas around the periphery of the TAOR choosing not to engage units in any type of large contact.

S-4 CHRONOLOGY

1. General. The logistical situation of this battalion improved since the last report. Supply, Motor Transport and Comm/Elec experienced some critical shortages.

a. Supply. Significant shortages that are currently considered critical are (200) first aid kits, (76) wrist watches, (1135) ponchos, and (224) canteen covers. Daily contact was made with FLSG "A" to obtain the mentioned shortages. Significant improvement was noted in the obtaining of critical shortages, i. e., jungle trousers and shirts, combat boots, rifle cleaning gear and preservatives.

b. Ordnance. Since last reporting period the ordnance situation has improved. Currently the battalion is down on the following weapons: (1) 106 rifle, (2) 106 mounts, (1) 81mm mortar tube, (2) 81 bipods, (5) 81 baseplates, (2) flame guns, (5) sniper scopes, (2) M-60 machine guns, (9) 3.5 rocket launchers and (28) pistols. The down items shown are either in for repair and/or on order. The figures change daily and the battalion armorer, forward and rear, are exerting constant pressure on sources of repair and supply.

c. Motor Transport. Since the last report the battalion has seen great improvement in obtaining and repairing of downed vehicles. Currently there are (16) truck utility M422A1 (MITE) operational, (3) deadlined for engine repair and (1) is on order. Truck, platform, M274A1 (MUE), show (21) of (30) vehicles operational with (3) on order and (6) deadlined for engine repair. Some difficulty still exists in obtaining repair parts, i. e., CV joints for Mites and Jeeps.

d. Comm/Elec. Shortages of the long antenna bases continue to remain critical. Six (6) new PRC/25 radios were received during the month.

e. Supporting Units.

(1) FLSG "A" continued to provide the bulk of the logistical support of Class II items. ISA-2, along with FLSG "A"/3d Service Battalion (Detached to Operation SHAWNEE), provided support on Class I through V items as applicable. The FLSG "A" team provided support on E.O.D., maintenance problems, consultation, and advice on all matters pertaining to support.

(2) E.O.D. and engineer support was provided by Company "B", 3d Engineer Battalion.

(3) Truck support was provided by direct requests to the 4th Marines S-4 Section.

(4) MAG-16 units continued to provide helicopter support, via ISA-2, as required for logistical lifts.

(5) A detachment of the 3d Motor Transport Battalion provided OTTER support. This was coordinated through the 4th Marines S-4 Section.

2. Camp Development. The existing defensive wire was improved by addition of

approximately 600 meters of concertina (reinforced) and 500 meters of "tanglefoot" wire placed in strategic locations.

a. As per 4th Marines directive, all tents were provided with a surrounding wall of sand bags, and/or earth to a height of (4) feet.

b. Numerous revetments for protection of vehicles were constructed.

c. White sand was locally obtained and utilized by the mess hall and other locations in the battalion area, in an effort to keep dust down and fill in washed out areas.

3. Operations. The battalion participated in Operations CHINOOK, BIG HORN, and SHAWNEE during this reporting period.

4. Troop Movements

a. Approximately 2,100 troops were moved by 130 trucks in approximately 35 lifts.

b. During the reporting period, 33 Otters moved 300 troops and 17,954 pounds of equipment in eleven lifts.

5. Logistical Lifts. During the reporting period, 31 helicopters moved 700 troops and 66,922 pounds of equipment in 37 lifts.

COMMUNICATIONS CHRONOLOGY

1. General. The communications platoon furnished radio, wire, message center, repair, and maintenance support for the Battalion and all attached units during the month. Electric power was also supplied.
2. Support. The 4th Marines was supported with the loan of one (1) AN/MRC-109 radio jeep, one (1) AN/PRC-25 radio, one (1) RC-292 antenna, one (1) AN/PRC-41 radio, one (1) PP-3240A battery charger and two (2) MX-456 retransmission cables. This battalion exchanged six (6) AN/PRC-25 radio sets for like items, enabling the 4th Marines to set up a relay retransmission station. The 4th Marines was also supported with the loan of one (1) AN/TGC-14 teletypewriter and one teletype technician. The 3d Motor Transport Battalion was supported with the loan of one (1) AN/PRC-10A radio set. The 2d Battalion, 26th Marines was supported with the loan of two (2) AN/PRC-41 radios, one (1) UHF antenna, one (1) RC-292 antenna, one (1) L5-166 speaker, one (1) AN/GRA-39 remote control unit, one (1) electric power supply for AN/PRC-41 radio, four (4) AN/PRC-10 radios, two (2) SB-22/PT switchboards, and twelve (12) telephones.
3. Telephone Communications. The wire section after Operation CHINOOK II terminated moved the switching central from the COC Dunker back into its previous position. Upon the completion of Operation BIG HORN, the COC Dunker was again relocated and the 2/9 section of the perimeter had to be completely rewired. There were a total of seven (7) switchboards, SB-22/PT, in operation at this time. Two (2) wireman maintained an additional command post at the forward artillery position using loops instead of switching facilities.
4. Training. The communications platoon trained in on-line procedures and tactical radio procedures. A very intensive training program, requiring a two (2) to five (5) day schedule was set up for company and command group operators, and both the Commanding Officer's and the Executives Officer's drivers completed this training.
5. Operations. During this month the communications platoon supported three (3) code named operations, CHINOOK II, BIG HORN, and SHAWNEE. At the end of the period the platoon was supporting two (2) Battalion Command Posts, a separate Company Command Post, and the 4th Marines perimeter security forces.
6. Difficulties. The extremely heavy commitments of the battalion caused a drain on men and equipment. Every switchboard, telephone, and almost every radio was committed; consequently, at times the battalion operated without equipment back-up capability.

MEDICAL CHRONOLOGY1. General

a. During the month of April, the DAS personnel held military sick call for 905 Marine Corps personnel and 16 Army personnel.

b. MEDCAP was held in the village of Hien Si and 20 civilians were seen and treated. MEDCAP was held in the village of Phong Dien on five occasions, with a total of 130 civilians seen and treated.

2. Sanitation

a. Routine sanitation inspections of the Shawnee Area were conducted on a daily basis.

b. Messing areas, latrines, and urinals are being sprayed with insecticide on a daily basis.

3. Disease, Injuries, Treatments in General

a. The DAS continues to maintain an eight bed ward for minor injuries. This ward enables the DAS to render more effective treatment. Personnel requiring more extensive treatment are referred to 3d Medical Battalion for hospitalization, treatment, and for possible further evacuation.

b. Most of the patients treated at the DAS for the month of April were of a routine nature. There were no new cases of malaria. The Battalion remains on a once weekly Primaquine and Chloroquine tablet as a preventive against malaria, plus utilization of insect repellent and mosquito netting.

4. Casualties and Hospitalization

a. There were 17 personnel from the battalion hospitalized during the month of April. 2 were referred admissions to Medical Companies and 15 were DAS admissions. There were 2 KIA's and 2 DWT's, and 46 WIA's during the month, all of which were a result of direct enemy action. Of those patients hospitalized, 5 were sprains, 1 cutaneous fungus infection, 1 hyperventilation, 1 diarrhea, 1 gastro enteritis, 1 bronchitis, 1 fever unknown origin, 3 cellulitis, 1 contusion, 1 gunshot wound, and 1 crush injury.

5. Training

a. Informal discussions were held in the DAS by the Battalion Surgeon on Field Neurological Symptoms. Three venereal disease and personal hygiene lectures were conducted by DAS personnel.

6. Health and Service Records

a. Routine maintenance and immunization entries of health records was accomplished during the month. There were approximately 60 immunizations administered.

7. Compliment of BAS

a. At the close of the month the BAS had a compliment of 1 Medical Officer and 53 Hospital Corpsmen. There are 8 SNCO's attached to the BAS at this time. There were 12 Hospital Corpsmen joined during the month, 10 transferred within the Division and one transferred by PCS orders.

8. Conclusions

a. There were no major problems during the month.

CHAPLAIN CHRONOLOGY

1. During the month of April Sunday Divine Services were provided for Catholic and Protestant personnel in the Battalion CP. Similiar services were conducted on Hill 51 and for the companies operating east of Highway #1.
2. Two Memorial Services and one indoctrination lecture were held. Catholic Mass was also provided for Bravo, Echo and Delta Batteries, 12th Marines; 1/9; 2/26; 2/4; and the forward artillery site in support of operation SHAWNEE.
3. Weekly services for Protestant and Catholic personnel were conducted on the perimeter, in the Sparrow Hawk area, and at the main gate.

Muster all available personnel and be prepared to conduct counterattack in vicinity of designated blocking positions on order.m. 2d Battalion, 4th Marines. Muster all available personnel and be prepared to conduct counterattack in vicinity of designated blocking positions on order.o. Coordinating Instructions

- (1) Annex A (Assembly Area and Blocking Position Overlay)
- (2) Annex B (Defensive Fire Plan).
- (3) Personnel observing enemy fire will immediately report the sector in accordance with Annex C (Counterattack Plan).
- (4) Personnel will mark positions of enemy units and blocking positions.
- (5) Defense reaction road teams will be prepared to react on order.
- (6) 2d Bn, 9th Marines will designate blocking positions to be occupied by counterattacking forces.




(7) Final protective fires for all weapons in any given sector of the perimeter will be controlled by the respective sector commander. Signal for final protective fire will be one green star cluster.

#### 4. ADMINISTRATION AND LOGISTICS.

- a. Personnel assigned to positions on the perimeter will have 3  $\frac{1}{2}$ , 6 fragmentation grenades, 1  $\frac{1}{2}$  primages and 4 illumination grenades or pyrotechnics on position.
- b. Counterattack/Reaction forces will have 1  $\frac{1}{2}$ , 2 fragmentation grenades and one illumination grenade.
- c. Flak jackets and helmets are mandatory for all personnel.
- d. Units assigned sectors of defense perimeter will construct and stock ammunition storage bunkers within respective sectors.

#### 5. COMMAND AND COMMUNICATIONS-ELECTRONICS.

- d. The reaction force in support of District Headquarters will maintain direct radio communication with the U.S. Advisor at District Headquarters in accordance with reference (e) upon activation of the contingency plan. Frequency 42.50, contact Brown Ground.

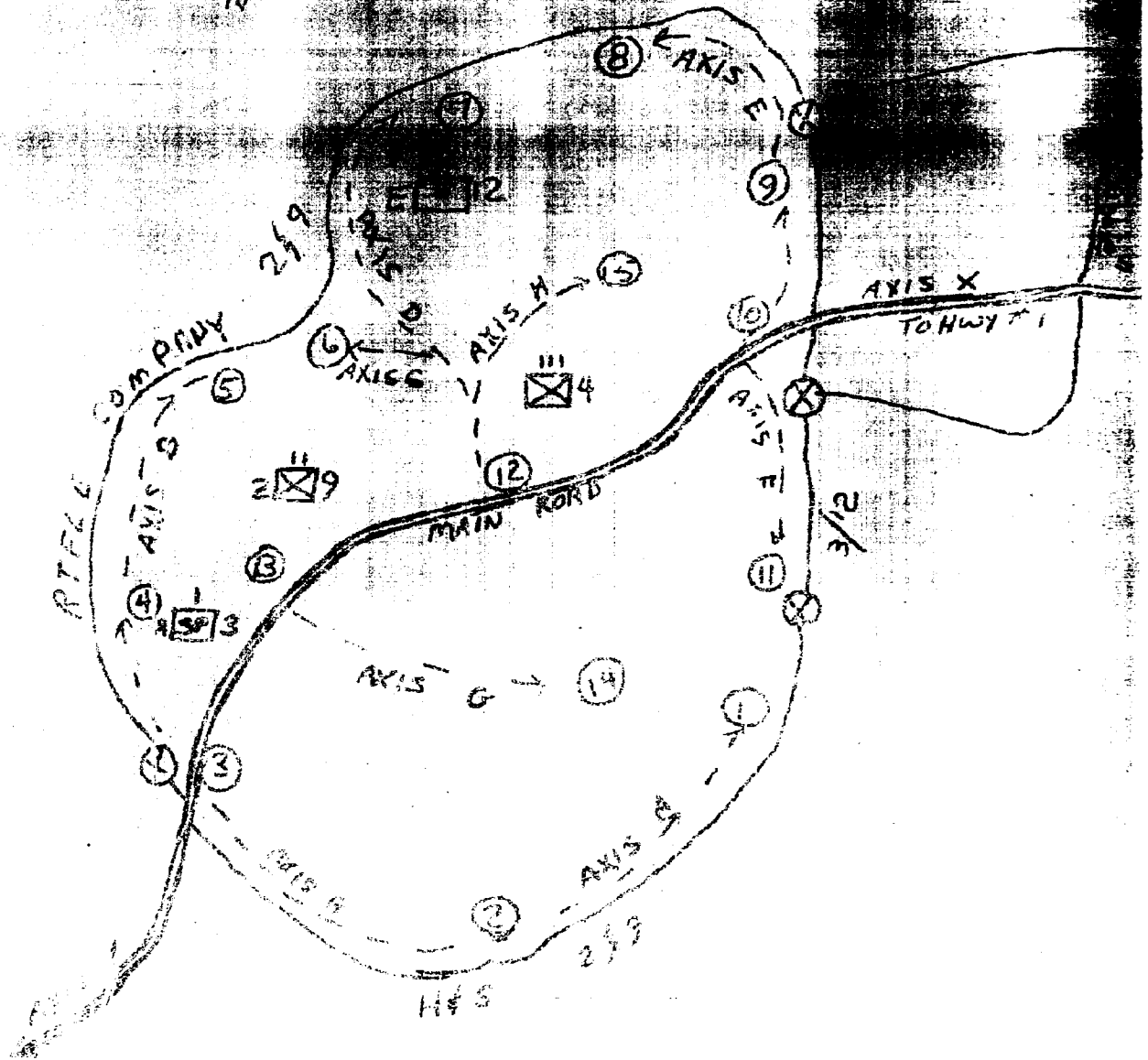

# ANNEX D (Defense Reaction Conditions)

Time Zone: H

1. This annex establishes various conditions and sets forth the duties and responsibilities of units.
2. This Headquarters will establish the defense reaction conditions commensurate with the existing situation.
3. Defense reaction conditions:

- a. Condition I. A daylight only condition; automatically set at sunrise and terminated 30 minutes past sunset.

Meaning - No known enemy threat.

Action - Units conduct normal operations, man specified daylight observation/defensive positions, keeping entire perimeter under continuous observation.

- b. Condition II. Condition assumed automatically from 30 minutes prior to sunset to sunrise or as specified by this Headquarters during daylight.

Meaning - No known enemy threat. Unit conducts normal operations.

Action - Units man assigned perimeter positions. 50% (At least one man in each position) on watch and alert. Entire perimeter under continuous observation. Patrols forward of the perimeter as ordered. Activate perimeter defense net. All stations check-in.

- c. Condition III. The condition of highest alert; all additional active and passive defense measures are initiated.


Meaning - Indications are that the enemy may attack or attempt infiltration within one to 180 minutes.

Action - (1) Perimeter positions 100% alert.

(2) Issue supplement ammunition.

(3) Vital Area Defense Battalion muster reserve forces; prepares for immediate employment.

(4) Motor transport unit dispatches vehicles (to transport 300 persons) to Vital Area Defense Battalion.
