ORGANIZATIONAL DATA

A. The period covered by this report extends from 1 October 1967 to 31 October 1967.

B. Locations: On 31 October 1967, the 11th Motor Transport Battalion was in general support of the 1st Marine Division from its base camp at AT948762.

NARRATIVE SUMMARY

A. During October the logistical support of 2nd Battalion, 5th Marines was sharply reduced because of road, bridge and ferry conditions. In the latter half of the month, the road south of check point #6 was improved and is now passable, but the bridge spanning the Song Thu Bon River at check point #6 was still not passable and the ferry has been subject to breakdowns. At best, the ferry has been very slow and averages only two vehicles per hour. The main Battalion efforts were directed at moving the First and Third Battalions of the Fifth Marines to new camp sites and at Rough Rider convoys in support of Seventh Marines' elements at check point #5 and #58.

B. Camp improvements during the period include moving three huts to new locations to provide better utilization. Two recreation huts were developed for the Battalion and a new communications center has been completed. A water tank has been constructed to provide warm water for the troop showers and a second volley ball court has been completed. To meet monsoon requirements, major ditches have been excavated and improved. Battalion perimeter illumination was improved by installing lights at the front and rear gates.

C. Civil Affairs activity was high during the period, over 1300 Tu Do newspapers and propaganda leaflets were distributed and 535 people were treated by MEDCAP. Psyops movies have been shown on three occasions with a total of 800 Vietnamese attending. In addition, 50 gift packages of soap powder, seven blocks of salt lick for cows and six truckloads of scrap lumber were distributed.

D. There have been no instances of enemy contact on the perimeter during this period but two vehicles from the Battalion struck mines, resulting in two USMC WIA.

E. The Battalion transported 24,645 troops, carried 11,050 tons and drove 101,329 miles during the month.

PART IIISEQUENTIAL LISTING OF SIGNIFICANT EVENTS

a. 1 October 1967: A convoy departed this organization for An Hoa transporting 12 tons of Class I, 75 tons of Class III, 36 tons of Class V supplies and two M422 "Mighty Mites". The convoy returned to Danang carrying five tons of Class IV (salvage). A "ROUGH RIDER" convoy of 21 vehicles returned to Danang from Hill #63. While traveling north on Route #1 at BT095507, the convoy received approximately five incoming rounds. Approximately 10 rounds were returned with unknown results. There were no USMC casualties.

b. 2 October 1967: A convoy departed this organization for An Hoa transporting nine tons of Class II and 61 tons of Class V supplies. The convoy returned to Danang transporting empty boxes and an Amtrac engine. A "ROUGH RIDER" convoy composed of 40 vehicles departed Danang for Hill #63 and transported cargo to the new 3rd Battalion, 5th Marines camp at BT015626.

c. 3 October 1967: The "ROUGH RIDER" convoy departed the 3rd Battalion, 5th Marines camp to Hill #63 and remained overnight. A convoy departed this organization for An Hoa transporting 13 tons of Class IV and 30 tons of Class V supplies (defective).

d. 4 October 1967: The "ROUGH RIDER" convoy moved from Hill #63 to the new 3rd Battalion, 5th Marine camp and remained overnight. A convoy departed Danang for An Hoa transporting 1500 pounds of Class I, five tons of Class IV and 52 tons of Class V supplies. The convoy returned to Danang with 200 pounds of empty ammunition boxes. An M-54 from this Battalion struck a mine at AU833001. There were no USMC casualties.

e. 5 October 1967: The "ROUGH RIDER" convoy departed the 3rd Battalion, 5th Marines camp, traveled to Hill #63 and remained overnight. A convoy departed Danang for An Hoa transporting 12 tons of Class I, 10 tons of Class IV, 26 tons of Class V supplies and 13 tons of general cargo. The convoy returned to Danang carrying three tons of Class V supplies (defective). A tractor trailer hit a mine of undetermined size at AT941643 resulting in two USMC WIA.

f. 6 October 1967: The "ROUGH RIDER" convoy departed Hill #63 for the 3rd Battalion, 5th Marines camp and remained overnight. A convoy departed Danang for An Hoa transporting

12 tons of Class I and 24 tons of Class V supplies. The convoy returned to Danang transporting one 155mm gun and three M-422 "Mighty Mites".

h. 8 October 1967: A "ROUGH RIDER" convoy composed of 158 vehicles departed Danang for Quang Tri and spent the night in Phu Bai. A second "ROUGH RIDER" convoy departed the 3rd Battalion, 5th Marines camp for Hill #63 but was unable to complete the trip due to an impassable section of road.

i. 9 October 1967: The Battalion carried on normal operations.

j. 10 October 1967: The "ROUGH RIDER" convoy moved from Phu Bai to check point #16 and remained overnight.

k. 11 October 1967: The "ROUGH RIDER" convoy from this Battalion moved from check point #16 to Quang Tri and remained overnight.

l. 12 October 1967: The "ROUGH RIDER" convoy from this Battalion moved to Quang Tri from Phu Bai.

m. 13 October 1967: The "ROUGH RIDER" convoy returned to Danang from Phu Bai. A second "ROUGH RIDER" convoy composed of 48 vehicles departed Danang for check point #5 where it remained overnight. The convoy transported 170 Marines of Company G, 2nd Battalion, 7th Marines to a new combat base.

n. 14 October 1967: The "ROUGH RIDER" convoy returned to Danang from check point #5. A second "ROUGH RIDER" convoy departed Danang for the 1st Battalion, 5th Marines camp where it remained overnight.

o. 15 October 1967: A "ROUGH RIDER" convoy departed the 1st Battalion, 5th Marines camp for check point #34. Because the road south of check point #22 was impassable the convoy off loaded 700 troops of the 1st Battalion, 5th Marines and returned to Danang. A convoy composed of eight tractor trailers and two M-54's departed this organization for Ah Hoa. The convoy was forced to return to this organization from check point #6A because the ferry was not operating.

p. 16 October 1967: The Battalion carried on normal operations.

q. 17 October 1967: A convoy composed of 28 vehicles departed this organization for check point #22 where it loaded 700 troops and transported them to the 1st Battalion, 5th Marines camp. The convoy returned to Danang.

r. 18 October 1967: A convoy composed of eight tractor trailers and two M-54's departed this organization for An Hoa. Because of an inoperable ferry at check point #64, the convoy returned to Danang. A convoy of six M-54's departed this organization transporting 20 tons of Class V supplies to Hill #65. The convoy departed Hill #65, moved to Hill #37 spent the night and returned to this organization on 19 October 1967. A convoy composed of eight M-54's departed this organization for Hill #10, picked up one rifle company and transported it to Hill #41. The convoy returned to Hill #10 with one rifle company, off loaded it and then returned to Danang.

s. 19 October 1967: A "ROUGH RIDER" convoy composed of 35 vehicles departed this organization for check point #5. Due to the sinking of the ferry at check point #33, only 19 vehicles were transported across the river. These vehicles proceeded to check point #5 and spent the night. A convoy of seven M-54's departed this organization for I Corps warehouse in Hoi An. The convoy loaded 30 tons of foodstuffs, transported it to the village of Dai Loc and returned to Danang.

t. 20 October 1967: A convoy composed of 10 M-54's departed this organization for Hill #65 carrying 36 tons of Class V supplies. The "ROUGH RIDER" convoy composed of 17 vehicles returned to Danang from check point #5.

u. 21 October 1967: A convoy of five M-54's transported 11 tons of Class V supplies to Hill #65 and returned to this organization.

v. 22 October 1967: This Battalion carried on limited operations because of the Vietnamese National elections.

w. 23 October 1967: A "ROUGH RIDER" convoy composed of 86 vehicles departed this organization ultimately bound for check point #58. It crossed the obstacle at check point #33 and remained there overnight.

x. 24 October 1967: The "ROUGH RIDER" convoy composed of 86 vehicles departed check point #33 for check point #58. After unloading the cargo, the convoy returned to check point #5 and spent the night. A convoy of eight M-54's and one M-543 departed this organization for An Hoa, transporting eight and one half tons of Class V supplies and 18 tons of PX supplies. The convoy unloaded and then returned to check point #6 and remained there overnight.

y. 25 October 1967: A convoy returned to Danang from check point #6. The "ROUGH RIDER" convoy returned from check point #5.

z. 26 October 1967: A "ROUGH RIDER" convoy of 85 vehicles departed this organization bound for Quang tri carrying 1st Marine equipment. The convoy stopped at Phu Bai to spend the night

aa. 27 October 1967: The "ROUGH RIDER" convoy departed Phu Bai for Quang Tri where it spent the night.

bb. 28 October 1967: The "ROUGH RIDER" convoy departed Quang Tri and traveled to Phu Bai to spend the night.

cc. 29 October 1967: The "ROUGH RIDER" convoy returned to this organization from Phu Bai. A convoy composed of five M-52's, two M-54's and one M-543, carrying 50 tons of Class V supplies departed this organization for An Hoa. Because of slow ferry operation at check point #6, the five M-52's were forced to go to 3rd Battalion, 7th Marines camp to spend the night.

dd. 30 October 1967: The convoy of five M-52's departed the 3rd Battalion, 7th Marines camp for An Hoa, and remained overnight.

ee. 31 October 1967: The convoy from An Hoa returned to Danang. A convoy departed this organization for Hill #65 transporting 40 tons of Class V supplies. After unloading, the convoy returned to Danang.




