PART I

ORGANIZATIONAL DATA

A. The period covered by this report extends from 1 January 1968 to 31 January 1968.

B. Location: On 31 January 1968, the 11th Motor Transport Battalion was in general support of the 1st Marine Division from its base camp at AT948762.

C. On 31 January 1968, the Battalion Command and Staff structure was as follows:

PART II

NARRATIVE SUMMARY

A. During the month of January, the Battalion's main efforts were directed at supporting Task Force X-ray. In addition the Battalion conducted several convoys in support of the 11th Marines at Hill #65, and also bridge and road repair/rebuild projects on national route #1 between DaNang and Phu Loc. On 31 January Alpha Company, 1st Motor Transport Battalion came under the operational control of this Battalion for an indefinite period.

B. The Battalion's old Combat Operations Center bunker was torn down. Construction was begun on a Butler Building which will be used as a vehicle maintenance facility.

C. Civil Affairs MEDCAPS have treated 320 people during the period, 800 Tu Do newspapers, and 80 G. I. cans of garbage for pigs were distributed. Also, toys were given to the children for Tet.

D. There have been no instances of enemy contact on the perimeter during this period. On 3 January, at 1415 a convoy received approximately 10 rounds of small arms sniper fire at AT965585. The convoy did not return fire. At 031530H the same convoy received approximately 150 rounds of small arms sniper fire at the same location. Fire was returned with unknown results: there were no USMC casualties. On 8 January a convoy received 50 rounds of small arms sniper fire at AT923928. 100 rounds of small arms fire were returned with unknown results. Also on 8 January an M38A1 jeep detonated a mine at AT888953 resulting in two Marines from this Battalion being wounded in action. On 9 January a convoy received 40 sniper rounds at ZD198010. The convoy returned 20 rounds of small arms, 4 M79 rounds and called in artillery. One Vietnamese civilian was killed by enemy fire, there were no USMC casualties. On 10 January a convoy staged at AU833000 received 20 mortar rounds. Counter battery fire was returned by Delta Company, 1/5 with unknown results. There were 10 Marines wounded in action, 8 from this Battalion: there were no KIA's. On 16 January at 1330 an M52/M172 tractor-trailer was hit by an unknown type explosive projectile at AT913943, this was followed by 100 rounds of small arms fire. Small arms fire was returned with unknown results. Two Marines were wounded in action. At 1420 an M52/M127 tractor-trailer detonated a mine at AT914947. There were no USMC casualties. At 1440 a convoy received 15 rounds of small arms fire at AT923928. Small arms fire was returned with unknown results. There were no USMC casualties. On 18 January, at 1330 an M54 cargo truck detonated two mines at AU816008. Two Marines were wounded in action.

At 1530 an M543 wrecker detonated a mine at AT914940. Three Marines were wounded in action. At 1700 a convoy received 50 rounds of small arms fire at AT914952. The convoy returned small arms fire with unknown results. There were no USMC casualties. On 19 January at 1120 a convoy received five mortar rounds and an unknown amount of automatic weapons fire at AU825008. The convoy returned fire with unknown results. There were no USMC casualties. At 1320 a convoy received automatic weapons fire at ZD107017. The convoy returned small arms fire with unknown results. There were no USMC casualties. At 1350 a convoy received three mortar rounds and an unknown quantity of automatic weapons fire at ZD088007. Small arms fire was returned with unknown results. There were no USMC casualties. On 25 January an M54 cargo truck detonated a mine at AT933688. Two Marines were wounded in action. On 29 January an incendiary grenade was thrown into the cab of an M54 cargo truck at AT943670. There was one Marine wounded in action.

E. This Battalion drove 85,615 miles, hauled 8,578 tons and carried 25,347 passengers during the period.

Sequential Listing of Significant Events

- a. 1 January 1968: A convoy of 16 M54 cargo trucks hauled cargo and troops from DaNang to check point #14 and returned.
- b. 2 January 1968: A convoy of six M54 cargo trucks hauled 30 tons of Class V supplies to Hill #65 and returned.
- c. 3 January 1968: A convoy of six M54 cargo trucks hauled bridging trailers from the 7th Engineer Battalion Cantonment to the 3rd Battalion, 7th Marine base camp and returned. A convoy of seven M54 cargo trucks hauled 35 tons of Class V supplies from ASP-1 to Hill #65 and returned. A convoy received 10 rounds of small arms fire at AT965585 at 1415 and approximately 150 rounds of small arms fire at the same location at 1530. There were no USMC casualties.
- d. 4 January 1968: A convoy of six M54 cargo trucks hauled 30 tons of Class V supplies from ASP-1 to Hill #65 and returned.
- e. 5 January 1968: A convoy of 75 vehicles hauled troops and cargo from DaNang to Phu Bai and stayed overnight. A convoy of 15 M54 cargo trucks and two tractor-trailer units hauled 24 tons of cargo and 250 troops from 2nd Battalion, 7th Marines Cantonment to check point #6 and returned to this organization.
- f. 6 January 1968: A convoy of 16 M54 cargo trucks hauled 300 troops for 2nd Battalion, 3rd Marines. A convoy of 65 vehicles returned from Phu Bai.
- g. 7 January 1968: A convoy of 12 M54 cargo trucks and two tractor-trailer units hauled 54 tons of cargo to 2nd Battalion, 5th Marines at Phu Bai and remained there overnight. A convoy of six M54 cargo trucks and four tractor-trailer units pre-loaded at the 2nd Battalion, 3rd Marines Cantonment and remained there overnight. A convoy of three tractor-trailer units hauled 36 tons of Class V supplies to Hill #65 and returned.
- h. 8 January 1968: A convoy of 11 vehicles hauled 104 tons of cargo and 25 troops from the 2nd Battalion, 3rd Marines Cantonment to the 5th Marine Regiment base camp. A convoy of 12 M54 cargo trucks and 2 tractor-trailer units returned from 2nd Battalion, 5th Marines carrying 12 tons of cargo. A convoy of 19 M54 cargo trucks towed 18 loaded bridging trailers to check point #5. Enroute to check point #5 the convoy received 50 rounds of small arms fire at AT923928. 100 rounds of small arms fire were returned with unknown results. The same convoy had an M38A1 jeep detonate a mine at AT888953 resulting in two Marines from this Battalion being wounded in action.

i. 9 January 1968: A convoy of 19 M54 cargo trucks moved from check point #5 to check point #58, where it delivered 11 bridging trailers and then returned to check point #5. The convoy received 40 rounds of small arms fire at ZD198010, returned fire and called artillery with unknown results. One Vietnamese civilian was killed by enemy fire: there were no USMC casualties.

j. 10 January 1968: A convoy of 19 M54 cargo trucks shuttled bridging trailers between check point #5 and check point #58. A convoy of 2 M54 cargo trucks and 1 M49 fuel tanker was dispatched to refuel the convoy staged at check point #5. Both convoys received 20 rounds of mortar fire at AU833000. Counter battery fire was returned by Delta Company, 1st Battalion, 5th Marines with unknown results. There were 10 Marines wounded in action; 8 from this Battalion: there were no Marines killed in action.

k. 11 January 1968: A convoy of 5 M54 cargo trucks and two M543 wreckers resupplied a convoy at check point #5. Elements from both convoys returned to DaNang with a total of 20 M54 cargo trucks, two M38A1 jeeps, one M49 fuel tanker, three M543 wreckers and two bridging trailers. The remaining 11 M54 cargo trucks shuttled bridging trailers north to check point #58 and returned to check point #5 for the night.

l. 12 January 1968: A convoy of 11 cargo trucks staged at check point #5 and remained overnight. A convoy of three tractor-trailers hauled 36 tons of Class V supplies from ASP-1 to Hill #65 and returned.

m. 13 January 1968: A convoy of six tractor-trailer units hauled 72 tons of Class V supplies from ASP-1 to Hill #65 and returned. A convoy of 11 M54 cargo trucks returned from check point #5.

n. 14 January 1968: The Battalion carried on normal operations in support of the 1st Marine Division.

o. 15 January 1968: The Battalion carried on normal operations in support of the 1st Marine Division.

p. 16 January 1968: A convoy of 175 vehicles hauled 988 tons of cargo and 500 troops to Phu Bai. While enroute at 1330, a tractor-trailer was hit by an unknown type explosive projectile followed by 100 rounds of small arms fire at AT913943. Two Marines were wounded in action. At 1420 a tractor-trailer detonated a mine at AT914947. There were no USMC casualties. At 1440 the convoy received 15 rounds of small arms fire at AT923928. There were no USMC casualties.

q. 17 January 1968: A convoy of 17 vehicles traveled from Phu Bai to check point #5 and back to Phu Bai.

r. 18 January 1968: A convoy of 99 vehicles returned from Phu Bai with 250 troops. While enroute at 1330, an M54 cargo truck detonated 2 mines at AU816008 resulting in two Marines being wounded in action. At 1700 the convoy received 50 rounds of small arms fire at AT914952. There were no USMC casualties. A convoy of 10 vehicles traveled from Da-Nang to check point #30 and back, retrieving one burned M52/M172 tractor-trailer, and a mined M35 cargo truck from the 1st Motor Transport Battalion. While returning, an M543 wrecker detonated a mine at AT914940. Three Marines wounded in action.

s. 19 January 1968: A convoy of 72 vehicles hauled cargo and U.S. Army troops to Phu Bai and remained overnight. While enroute at 1120, the convoy received five mortar rounds and small arms fire at AU825008. There were no USMC casualties. At 1320 the convoy received automatic small arms fire at ZD107017, there were no USMC casualties. At 1350 the convoy received 3 mortar rounds and small arms fire at ZD088007, there were no USMC casualties.

t. 20 January 1968: A convoy of 36 vehicles was dispatched to check points #30 and #5 to replace three tactical bridges with culverts. The convoy then returned to DaNang. A convoy of 6 tractor-trailer units hauled 72 tons of Class V supplies to Hill#65 and returned.

u. 21 January 1968: A convoy of 11 vehicles returned from Hue to DaNang by ship.

v. 22 January 1968: A convoy of three tractor-trailer units hauled 36 tons of Class V supplies to Hill#65 and returned.

w. 23 January 1968: A convoy of ten tractor-trailer units hauled 120 tons of cargo from DaNang to Hoi An. Six of the tractor-trailers remained overnight, while four returned to DaNang.

x. 24 January 1968: A convoy of ten tractor-trailer units hauled 120 tons of cargo from DaNang to Hoi An, and returned.

y. 25 January 1968: A convoy of ten tractor-trailer units hauled 120 tons of cargo from DaNang to Hoi An, and returned. An M54 cargo truck detonated a mine at AT933688. There were two Marines wounded in action.

z. 26 January 1968: Three tractor-trailer units hauled 36 tons of Class V supplies from ASP-1 to Hill#65 and returned To DaNang.

b.b. 28 January 1968: Two tractor-trailer units hauled 24 tons of Class V supplies to Hill #65 and returned.

c.c. 29 January 1968: An incendiary grenade was thrown into the cab of an M54 cargo truck at AT943670. There was one Marine wounded in action.

d.d. 30 January 1968: Three tractor-trailer units hauled Class V supplies to Hill #65 and returned.

e.e. 31 January 1968: A convoy of six tractor-trailer units hauled 72 tons of Class V supplies to Hill #65 and returned. A convoy of six M54 cargo trucks hauled 180 troops from the 2nd Battalion 3rd Marines command post to combat base #413 and returned to DaNang. A convoy of five M54 cargo trucks hauled 120 VC/NVA detainees from Cam Le Bridge to the III MAF detainee compound and returned to this organization.
