

~~CONFIDENTIAL~~ NARRATIVE SUMMARY

1. In operations conducted during the month of March, Eleventh Motor Transport Battalion conducted forty-four (44) convoy's in support of the 1st Marine Division. The majority of the support was for the Fifth Marine Regiment at An Hoa, and Seventh Marine Regiment at LZ Baldy. Seventh and Ninth Engineer Battalions were supported in redeployment from Phu Bai and Chu Lai respectively to the Danang area. Transportation was also furnished for personnel at Stack Arms R&R center.

2. During March, the MTV (Marginal Terrain Vehicles) M116A1/M733, were employed in support of the 1st Marine Division, with primary support to the Infantry Regiments. MTV's reliability valve and versatility was realized by the requesting units. Commitments consisted of land clearing (to deny much needed rice from the NVA/VC), redeployment of units and resupply in lieu of helicopters.

3. During March the S-5 Civil Affairs program provided 100 barrels of waste food to Khanh-Son for the feeding of pigs. On 15 March construction of a two room building for utilization as a meeting hall and dispensary was completed. Two Hundred Vietnamese received treatment under the MedCap program. In addition 20 received medical treatment at BAS and 13 were seen by the Dental Officer.
