PART II

NARRATIVE SUMMARY

1. During May 1970, the Eleventh Motor Transport Battalion conducted thirty-five (35) convoys in support of the 1st Marine Division. The Fifth Marine Regiment, located at An Hoa Combat Base, received the majority of the support provided by the Battalion. Vehicular support was also provided to the Stack Arms R&R Facility, Division Post Office, and Division Food Service.
2. The Marginal Terrain Vehicles were utilized in support of the 2nd Battalion, 1st Marine Regiment, located at Marble Mountain, and in support of the 1st Battalion, 1st Marines located at Hill 10. These vehicles were used in land clearing, redeployment of units, and to supplement the helicopter in resupply operations.
3. The Battalion traveled 118,711 miles, hauled 17,755 tons, and transported 15,624 passengers during May.
4. The S-5 Civil Affairs Program provided twenty-five (25) bags of corn, and twenty-five (25) bags of dry milk to the village of Khanh-Son. One hundred twenty (120) cans of waste food products were provided to the village for the feeding of swine. One hundred thirty (130) villagers were treated under the MedCAP, and thirty-seven (37) personnel received treatment at the Battalion Aid Station. Twenty-one (21) villagers received dental treatment.
