PART II

NARRATIVE SUMMARY

1. During June 1970, the Eleventh Motor Transport Battalion conducted thirty-five (35) convoys in support of the 1st Marine Division. The Fifth Marine Regiment, located at An Hoa Combat Base, received the Majority of the support provided by the Battalion. Vehicular support was also provided to the Stack Arms R&R Facility, Division Post Office, and Division Food Service.
2. The Marginal Terrain Vehicles were utilized in support of the 2nd Battalion, 1st Marine Regiment, located at Marble Mountain, and in support of the 1st Battalion, 1st Marines located at Hill 10. These vehicles were used in land clearing, redeployment of units, and to supplement the helicopter in resupply operations.
3. The Battalion traveled 129,288 miles, hauled 17,573 tons, and transported 17,584 passengers during June 1970.
4. Brigadier General SIMMONS visited this Battalion Cantonement on 23 June for an orientation briefing on Battalion activities.
5. Major General WIDDECKE presented the Meritorious Unit Citation to the Battalion on 24 June 1970.
6. The Battalion continued to conduct an effective Civil Affairs Program. Approximately three hundred (300) cans of waste-food products were delivered to the village of Khanh-Son, for the feeding of swine. One hundred twenty eight (128) villagers were treated under the MedCap, and thirty four (34) personnel received treatment at the Battalion Aid Station. Eighteen (18) villagers received dental treatment. Volleyball games, between young members of the village and Marines from the Battalion, were played twice during the month. The games were thoroughly enjoyed by both participants and spectators from the village.
