PART II

NARRATIVE SUMMARY

1. During December 1970, the 11th Motor Transport Battalion conducted fifty-eight (58) convoys in support of the 1st Marine Division. The First Marine Regiment at Hill 37 and Hill 65 and the Fifth Marine Regiment at Combat Base Baldy were supported daily. Vehicular support totaling nine (9) vehicles was provided daily to Division units for general support. The Battalion also committed a daily average of eleven (11) vehicles to units of the Division for miscellaneous runs.
2. The Battalion vehicles traveled 119,950 miles, hauled 20,814 tons, and transported 26,402 passengers during December 1970.
3. Four (4) Marginal Terrain vehicles were utilized by the Fifth Marine Regiment at Combat Base Baldy. From 16 December to 21 December, twenty-three (23) Marginal Terrain vehicles were transferred to Force Logistic Command for retrograde to Marine Corps Supply Activity, Barstow. It was determined that these vehicles were excess to in-country requirements.
4. The Battalion continued to conduct an active and effective Civil Affairs Program. The Battalion continues to support many projects as indicated by the following data: Approximately two hundred seventy-two (272) cans of waste food products were delivered to the hamlet of Khanh-Son for swine consumption. One hundred twenty-six (126) villagers were treated through the MED-CAP Program, while forty-seven (47) villagers received treatment at the Battalion Aid Station.
5. On 27 December 1970, one (1) M54A2C 5 ton truck detonated a mine while in a convoy to Hill 37 on route #4. The vehicle received major damage and one (1) Marine, .50 caliber gunner, was killed. The vehicle had an anti-fragmentation cab kit and the driver in the cab was not injured.
