11TH DENTAL COMPANY COMMAND CHRONOLOGY REPORT

Part I - Organization data

(a) Unit designations and locations

1. 11th Dental Co., MWHG-1, DaNang, Vietnam: The Company CP is located in the Marine Wing Headquarters Group One area and occupies a 16' X 32' tropical shelter. The mount-out gear is stored in a GP medium tent. The dental clinic is housed in a permanent building and includes two operatories and prosthetic laboratory.

2. Dental Detachment, MAG-11, DaNang, Vietnam: The detachment occupies about 1/3 of a tropical shelter 16' X 68' and a 16' X 32' tropical shelter.

3. Dental Detachment, MAG-16, DaNang, East, Vietnam: The detachment occupies a 16' X 32' tropical shelter.

4. Dental Detachment, MAG-12, Chu Lai, Vietnam: The detachment occupies a hard backed GP medium tent.

5. Dental Detachment, MAG-36, Chu Lai, Vietnam: The detachment occupies 16' X 28' of a tropical shelter.

6. Dental Detachment, MMSG-17, Iwakuni, Japan: The detachment is a tenant occupying spaces at the Dental Department, MCAS, Iwakuni.

JUL A 16' X 32' tropical hut was acquired for another Dental Clinic in MAG-11, VMFA-323 area.

(c) Civic Action - Dentists of this company treated 424 patients and accomplished 952 dental procedures and 107 medical treatments in support of the civic action program. Two Vietnamese are being trained in exodontia and regional anesthesia. The treatment was accomplished at the following locations:
