



**Secret****PART II****COMMANDERS NARRATIVE SUMMARY**

On 1 January 1966, the 11th Marine Regiment was stationed at Camp Hansen, Okinawa. The 107mm Mortar Battery, 2/12 and Battery I, 3/12 were under control of the 11th Marines until 31 January.

On 4 February 1966, Battery E, 2/11 arrived on Okinawa.

On 5 February 1966, Headquarters, 4/11 and Battery L, 4/11 arrived on Okinawa. The Headquarters of 4/11 came under Opcon/Adcon of the 11th Marines. Battery L, 4/11 remained under control of the 5th Marines.

On 19 February 1966, the 11th Marines CP at Camp Hansen was closed and elements of the Regiment embarked aboard ships for RVN.

On 26 February 1966, the 11th Marines CP opened at Chu Lai, RVN and the Regiment came under Opcon/Adcon of the 3rd Marine Division.

**Secret**PART IIICOMMAND CHRONOLOGY1 January 1966 - 28 February 1966

3 Jan 1/11 came under Opocon of RLT-1. CMR Section (-) and Metro Section (-) were included with 1/11.

15 Jan The Regimental S-3 Officer and two enlisted men departed for RVN as an advance party.

18 Jan Artillery firing exercise in Northern Training Area, Okinawa, was conducted to assist in determining the feasibility of establishing a live ordnance impact area. The exercise was eventful in that it was the first time since the end of World War II that any firing had taken place in this area.

25 Jan The Commanding Officer, 11th Marines, departed for RVN.

30 Jan The Commanding Officer, 11th Marines, returned from RVN.

31 Jan The 107mm Mortar Battery, 2/12 and Battery I, 3/12 came under control of 3/4 for D/L equipment and supply.

4 Feb Battery E, 2/11 arrived on Okinawa.

5 Feb Headquarters, 2/11 advance party arrived on Okinawa. The Headquarters of 4/11 and Battery L, 4/11 arrived on Okinawa.

11 Feb Change of Command effected Camp Commander, Camp Hansen; Colonel WIDDECKE, Commanding Officer of 5th Marines vice Colonel HAHN, Commanding Officer, 11th Marines relieved.

17 Feb Elements of the Regiment departed from Naha Port, Okinawa, for RVN aboard the LST USS Washoe County and LST USS Snohomish County.

19 Feb CP, 11th Marines (-) closed at Camp Hansen, Okinawa; opened aboard APA-208 USS Talladega. This ship and the AKA-97 USS Merrick departed from White Beach, Okinawa with the remainder of the Regiment.

20 Feb The advance party departed for RVN by air and arrived the same day.

22 Feb The LST USS Washoe County and LST USS Snohomish County arrived at Danang, RVN.

23 Feb The LST USS Washoe County, LST USS Snohomish County, APA-208 USS Talladega, and the AKA-97 USS Merrick arrived at Chu Lai, RVN.

28 Feb Received night H & I fires from 1/11; 21 missions with 4 rounds per target of shell mixed, fuze quick.
