2. Commander's Narrative Summary of Significant Events

This Regiment provided close and long range fire support for U. S. and Government of Viet Nam Armed Forces (GVNAF) utilizing the light, medium and heavy artillery weapons presently available. During this period, subordinate units were deployed on combined operations outside the Chu Lai Combat Base in conjunction with Vietnamese offensive forces in Operations MONTGOMERY, MORGAN and MOBILE. Battery K, 4th Battalion, 11th Marines remained in Quang Ngai (BS 604722) at the conclusion of Operation MONTGOMERY in order to support the local action of the 2nd ARVN Division. In concert with the observation post established at Nui Tron (BS 515780), this mission was augmented by the excellent opportunities for interdiction of Viet Cong movement and trade through the Song Tra Khuc Valley. Despite recurrent technical difficulties, largely due to firing maximum charges, the long range 155mm Guns and 8 Inch Howitzers continued to provide efficient and timely support for Special Forces camps and Vietnamese Popular Forces (PF) outposts isolated in the Song Tra Bong River Valley as well as delivering surprise fires for Reconnaissance Observers deep in Viet Cong territory.

To illustrate the magnitude of fire support provided during this period, the following ammunition expenditures are tabulated:

b. Intelligence. The Intelligence Section continued its target acquisition efforts within the Reconnaissance Zone, resulting in an increase of unobserved fires being delivered during the hours of darkness. Maximum utilization of patrol reports from the 1st Reconnaissance Battalion afforded a wide spectrum of unobserved, harassing, and interdiction missions whose effect restricts Viet Cong night movement. Imagery interpretation reports are used to keep a current plot of all recently reported targets.

c. Special Operations

(1) MONTGOMERY. This operation commenced on 6 May and terminated on 14 May. It was a combined operation with U. S. Marine and GVNAF units participating. The initial unit displacements of 3rd Battalion (-) (Rein) were:

On 14 May, 3rd Battalion (-) (Rein), with the exception of Btry K, 4th Battalion, 11th Marines, which remained in support of the 2nd ARVN Division in Quang Ngai, returned to their Tactical Area positions (See Tab (5) to Appendix B).

Summary of Surveillance. Cumulative surveillance reports from U.S. Marine units and U.S. Advisers with ARVN forces listed 41 (confirmed) Viet Cong killed in action, 24 (possible) Viet Cong killed in action, 2 (possible) Viet Cong wounded in action, 2 (confirmed) Viet Cong wounded in action,

5 weapons destroyed, 1 bunker destroyed, 14 structures destroyed with two secondary explosions noted, and 2 Viet Cong suspects captured. Since Artillery fires were closely coordinated with air and infantry fires, no precise casualty figure resulting from artillery fires alone is available. A total of 13,081 rounds of artillery ammunition was expended.

(2) MORGAN. On 20 May, Battery I 3/11 displaced to BS 55148872, direction of fire 5400 mils, to support Marine and ARVN forces. This operation ended on 22 May; at which time, Battery I returned to the Tactical Area position (Tab (5) to Appendix B).

Summary of Surveillance. Casualties reported by Marine units and U.S. Advisers with ARVN Forces were 15 (confirmed) Viet Cong killed in action. A total of 567 rounds of artillery ammunition was expended primarily as preparation fires on Infantry objectives.

(3) MOBILE. During the period 250430H to 281700H, 3rd Battalion (-) (Rein) displaced in support of Marine and ARVN forces. The below positions were occupied during the period and the units returned to their Tactical Area positions upon conclusion of the operation (Tab (5) to Appendix B).

Summary of Surveillance. Casualties resulting from artillery fires reported by Marine units and U.S. Advisers to ARVN forces were 10 (confirmed) Viet Cong killed in action, 24 (possible) killed in action and 1 (confirmed) wounded in action. A firm accounting of casualties caused solely by artillery fires is unavailable. A total of 999 rounds of artillery ammunition was expended.

(4) CHEYENNE I. At 240730H, Battery D, 2nd Battalion, 11th Marines (OpCon 1/11) displaced to coordinates BT 39601471, principle direction of fire 5300 mils, to support Company C, 1st Battalion, 5th Marines during a one day operation against Viet Cong forces. Battery D returned to coordinates BT 441083 at 241900H with a principle direction of fire of 5600 mils.

Summary of Surveillance. No contact was made with Viet Cong forces and only 1 artillery round was fired.

(5) CHEYENNE II. At 310550H a Command and Control Group, 1st Battalion, 11th Marines and Battery C, 1st Battalion, 11th Marines displaced to coordinates BT 299234 with a principle direction of fire of 0300 mils in direct support of 1st Battalion, 5th Marines. At 311800H the Command and Control Group returned to coordinated BT 440085 and Battery C returned to coordinates BT 518058 with principle direction of fire of 5600 mils.

Summary of Surveillance. No contact was made with Viet Cong forces and only seven artillery rounds were fired.

d. Command and Control. Location of Command Posts and battery positions as of 31 May are shown on the overlay attached as Tab (5) to Appendix B. The 2nd Battalion (-) reported from Regimental Landing Team 5 on 270530H May 1966.

e. Logistics. The primary logistics effort centered around the movement and storage of ammunition and rations in support of operations. A forward ammunition/ration dump was established at Quang Ngai Airfield and at the conclusion of Operation MONTGOMERY, the ammunition was relocated at the RVN Ammunition Dump in Quang Ngai for future operations. During Operation MONTGOMERY 15,000 rounds of artillery ammunition were transported. Inspections of ordnance, motor transport and supply continued throughout the month for units recently arriving in CHU LAI. During the month the percentage of deadlined motor transport equipment declined to 10% and supply support was excellent.

f. Civic Action

(1) Medical personnel treated 47 patients for minor ailments during the period. The patients were from the village of LONG PHU (2) (BT 509031).

(2) Dental personnel treated 187 patients during the month of May. Dental treatment was provided in several areas with extractions being the predominate service rendered. A summary of dental service rendered is attached as TAB (6) to Appendix B.

g. Aerial Observation. The Aerial Observation Section flew 78 aerial reconnaissance missions during the month of May 1966. These missions were flown in support of Operations MONTGOMERY and MOBILE and in support of 1st Marine Division operations within the CHU LAI Tactical Area and Reconnaissance Zone. Aircraft support was provided by VMD-6 at CHU LAI and the Detachment, 220th Aviation Company at Quang Ngai (BS 6573). On 29 May, one aerial observer was sent to Quang Ngai to provide daily aerial observation for Battery K, 4th Battalion, 11th Marines.
