2. Commander's Narrative Summary of Significant Events

Supporting fires were provided throughout the reporting period for U.S. Marine and Government of Viet Nam Armed Force (GVNAF) units. Operations APACHE, KANSAS and OAKLAND were conducted outside the CHU LAI Tactical Area in conjunction with GVNAF units. A Provisional 155mm Howitzer Battery (towed) was maintained at the QUANG NGAI Airfield (BS 604722) supporting the 2d ARVN Division. Observation Post NUI TRON (BS 515780) was continuously manned to conduct fires along the SONG TRA KHUC River Valley. Long range fires were also provided the GVNAF outposts at TRA BONG (BS 345883) and AN HOA (BS 474863) in the SONG TRA BONG River Valley. A platoon of 105mm howitzers from Battery D, 2d Battalion, 11th Marines was helo-lifted into the Special Forces Camp at TIEN PHUOC (BT 107142) to provide direct support artillery fires for units operating in the SONG KHANG River Valley and surrounding terrain. The diversification of the artillery assets have enabled artillery fires to be delivered deep into Viet Cong held territory. Observed effects of this employment has been to deny freedom of movement along principal supply routes of the Viet Cong forces within range of the emplaced artillery.

c. Intelligence. During the month of June 1966, the Intelligence Section provided target intelligence for support of Operation KANSAS, along with continuing its regular target gathering procedures. First Reconnaissance Battalion Patrol Reports comprised a major source of enemy activity information, together with Aerial Observer Reports and 1st Marine Division INTSUMS. Special studies of the following nine Special Forces Camps within the general area have been nearly completed:

These studies are specifically aimed at evaluating various possible artillery firing positions and recommending the most desirable for support of each camp. Much of the analysis is from hand held photography accomplished by Aerial Observers of the 11th Marines.

d. Special Operations

(1) APACHE. This operation began on 9 June and ended on 12 June and was a combined operation with U.S. Marine and GVNAF units participating. On 9 June Headquarters Battery 2/11, Battery D 2/11 with four 105mm howitzers, and Mortar Battery 2/11 with six 4.2" Mortars M-30, were helo-lifted to the below listed positions. The initial displacements of 2d Battalion (-)(Rein) units support of Operation APACHE were:

On 12 June the operation ended and Headquarters Battery, Mortar Battery and Battery D returned to their Tactical Area positions by helicopter (See TAB (5) to Appendix (B)).

Summary of Surveillance. U.S. Marine or U.S. Advisors to GVNAF units reported surveillances of damage due solely to artillery fire as follows: 5 Viet Cong KIA (confirmed), 12 Viet Cong KIA (probable), 25 Viet Cong WIA (probable), 2 Viet Cong defensive villages partially destroyed with 2 secondary explosions noted. Due to the coordinated supporting arms fires and close supporting fires for maneuvering infantry an accurate count of all casualties due to artillery fire was not possible. A total of 1138 rounds of artillery ammunition was fired during the operation.

(2) KANSAS. Operation KANSAS was primarily a reconnaissance operation heavily supported by air, naval gunfire, and artillery. This operation was conducted from 17-22 June. The unit displacements of 4th Battalion (-)(Rein) during the operation were:

The artillery units remained in support of ARVN and reconnaissance operations after Operation KANSAS was terminated. See TAB (8) Appendix (B) for the After Action Report.

Summary of Surveillance. Cumulative surveillance reports from U.S. Marine units and U.S. Advisors with GVNAF units were 29 KIA (confirmed), 37 KIA (possible), 7 WIA (confirmed), 21 structures destroyed, 13 structures damaged, 1 fortified trench line 40% destroyed, and numerous secondary explosions were noted. A total of 4162 rounds of artillery ammunition was fired for Operation KANSAS.

(3) OAKLAND. This operation commenced on 29 June and terminated on 1 July. It was a combined operation with U. S. Marine and GVNAF units participating. The initial unit displacements of 3d Battalion (-)(Rein) on 29 June were:

Battery M (-), 4/11 returned to BS 604722 and resumed its mission of supporting 2d ARVN Division units in that area shortly after arrival in the OAKLAND area of operations. The following displacements occurred on 30 June to effect better support for infantry forces.

On 1 July 3d Battalion (-)(Rein) returned to the Tactical Area positions illustrated on TAB (5) to Appendix (B).

Summary of Surveillance. Cumulative surveillance reports from U.S. Marine units and U.S. Advisors with GVNAF units were 3 KIA (confirmed), 2 KIA (possible), and 2 WIA (possible). A total of 413 rounds of artillery ammunition was expended on this operation.

d. Command and Control. Locations of command posts and battery positions as of 30 June are shown on the overlay attached as TAB (5) to Appendix (B).

e. Logistics. The primary emphasis in logistics has been to provide continuing support for one battery of 155mm How (TD) located at Quang Ngai. The support provided has been limited to Class V. Regiment provided all 155mm Howitzer ammunition supply support for Operation KANSAS. Repair parts for engineer equipment continues to be a problem; however, on 30 June a survey of Division assets has been initiated by the Regimental Supply Officer to try and locate 1 and 2 echelon parts to remove all TD-15s and TD-18s from deadline. The overall logistical evaluation of the Regiment is considered excellent.

f. Civic Action

(1) Medical personnel treated 940 patients for minor ailments during the period. There are also 19 Vietnamese personnel under medical training under this program.

(2) Dental personnel treated 51 patients. A summary of patients treated by locale is listed in TAB (6) to Appendix (B).

(3) A summary of personal assistance rendered to the Vietnamese people in the surrounding area is set forth in TAB (6) to Appendix (B).

g. Aerial Observation. During the month of June, 1966 the Aerial Observation Section of the 11th Marines flew 56 missions for a total of 99.5 hours. Missions flown were in support of the Tactical Area/Reconnaissance Zone and for Operations KANSAS and OAKLAND. Aviation support was provided by VMO-6 based at CHU LAI and by the detachment of the 220th Aviation Company based at QUANG NGAI.







6. Supporting Forces

Third Battalion (-), 1st Marines - 2 companies (reinforced) used as security for artillery battery positions.

First AT Battalion - 1 platoon 106mm rifles S., M50 & TOS employed with infantry units in security for battery positions.

Detachment, 7th Communications Battalion - Provided Radio Relay facilities throughout the operation.

Detachment, 7th Engineer Battalion - Approximately 30 persons. Employed repairing roads and constructing bridges and by-passes.

USS MONTEREY (DD 948) - Fired 384 rounds of 5"/34 naval gunfire in direct support of the operation.

Battery D (XRay) 2/11 - Two 105mm Howitzers employed at TIEN PHUOC.

7. Intelligence. See 1st Marine Division INTCOM's.

8. Mission. Provide direct support artillery and naval gunfire support to 1st Reconnaissance Battalion units inserted in the KANSAS area of operations as required and the area of operation for ARVN forces.

9. Concept of Operation. Artillery units were located on Hill 29 (BT 2231), TIEN PHUOC (ST 1014) and vicinity BT 133367 to support reconnaissance operations and patrols in the area of operations and ARVN forces in a concurrent operation.

10. Execution.

a. Operation KANSAS commenced at 171200H June 1966.

b. At 161900H Headquarters Battery (-), 4/11, arrived at Hill 29 taking operational control of Battery K, 4/12 in that position and of Battery Y (Prov) 4/12 positioned at THANG BINH.

c. At 181030H, Battery K 4/11 arrived at Hill 29. Subsequently, Battery K, 4/12 was displaced to a position 6000 meters southwest of THANG BINH and Battery Y (Prov) 4/12 displaced to Hill 29.

d. Battery D (XRay), 2/11, with two 105mm Howitzers was lifted by CH-46 helicopters into the Special Forces Camp, TIEN PHUOC on 19 June 1966, to support reconnaissance outposts from that area.

e. Security for artillery units was provided by ARVN forces in the TIEN PHUOC and Hill 29 areas. The Third Battalion (-), 1st Marines, provided security in the THANG BINH area.

f. Operation KANSAS ended at 210000 1 June 1966, with artillery units providing further support for 1st Reconnaissance Battalion elements and the 5th and 6th ARVN Regiments until 27 June 1966. All artillery and U.S. MC infantry units returned to CHU Lai by 271800H June 1966.

11. Results. KANSAS - 29 Confirmed LA, 37 possible KIA, 7 Confirmed WIA, 21 structures destroyed, 13 structures damaged, 1 fortified trench line 40% destroyed and numerous secondary explosions noted on targets fired throughout the Operation.

ARVN/Recon 22-23 June - 5 possible KIA, 1 structure destroyed and numerous secondary explosions noted.

12. Administrative Matters

a. Supply. A Logistic Support Area was established at KY MA Airfield (BT 525115) for initial lift of 105mm howitzers and ammunition to TIEN PHUOC. A Logistic Support Area was also established at TA KY for resupply for the operation.

b. Maintenance. One 155mm towed howitzer required replacement of a left trail when damaged by a mine. An ordnance contact team and trail were helo-lifted to effect repairs.

c. Treatment of Casualties. Corpsemen were available in each battery. A Doctor and a Corpseman were available at the BAS.

d. Transportation. No comments.

e. Communications. A radio relay link was established between Headquarters Battery (-), 4/11 and the 11th Marines FDC which operated excellently. No communications difficulties were experienced.

f. Medical Evacuation. There were two (2) non-battle casualties evacuated.

13. Special Equipment and Techniques. Two specially prepared CH-46 helicopters were used to lift two 105mm howitzers with gun shields removed approximately 30 miles deep into VC controlled country to a Special Forces Camp at TIEN PHUOC. These CH-46 aircraft had removed all armor and flight gear not essential to flight safety. Standard CH-46 and U-34 helicopters were used to lift section equipment, ammunition, and personnel.

14. Commanders Analysis

This operation was noteworthy for its employment of artillery support of reconnaissance forces operating deep in Viet Cong territory. In order to provide this support, displacement of artillery batteries was accomplished from 11th and 12th Marines resources to the objective area by road convoy and by helicopter lift. Resupply of ammunition was accomplished by both helo-lift and road convoy as the situation dictated. This operation demonstrated the ability of firing units to displace rapidly to remote firing positions and be resupplied by multiple means to enable accomplishment of the assigned mission. Radio Relay was utilized throughout the operation and proved invaluable in expediting rapid and effective communications over the widespread areas.

15. Recommendations

a. That the use of helicopters to lift 4.2" mortars and 105 and 155mm howitzers be exploited at every opportunity in order to increase the range and flexibility of fire support available.

b. That amphibious lift of heavier caliber, longer range artillery units be undertaken when appropriate to further enhance the fire support capabilities of the Regiment.

c. That Radio Relay equipment be made available to the artillery with the force and utilized in all such operations to ensure reliable communications. A recommended T/RL change which will provide this capability organic to the Artillery Regiment is being submitted.

d. That engineer support be continued to the maximum extent possible in order to increase the surface mobility of artillery units and to facilitate ammunition resupply.
